

Introduction

A fascination with the heavens has characterized humanity since well before recorded history. The precise orientation of structures as ancient as Stonehenge and the great Pyramids of Egypt clearly betray a profound knowledge of stellar configurations on the part of their builders. With the emergence of the high cultures of antiquity – India, China, Sumeria, Egypt, Mesoamerica – astronomy remains a central concern, making it the oldest of the natural sciences. Comprehensive in its scope, it was applied to all areas of human life: the calculation of the calendar; the regulation of agriculture; astrological prognostication and the development of religious cosmologies. Kept alive by Greek and Arab philosopher/mathematicians the systematic observation and study of the heavens passed into Europe, and thence into the modern world. As one of the four mathematical sciences of Pythagoras, astronomy became one of the seven Liberal Arts which formed the basis of the medieval curriculum. The rediscovery of Greek and Arabic manuscripts during the renaissance re-established the importance of astronomy during the earliest days of western science.

In the modern world, the difference between the "hard" science of astronomy and its application to the prediction of human affairs, known as astrology, has hardened into a distinction that the ancients would neither have recognized nor understood. In recent years, however, serious and dedicated researchers have demonstrated the profundity of these ancient sciences. Thus John Michell's 1973 statement that: "The entire surface of the earth is marked with the traces of a gigantic work of prehistoric engineering," is gradually being substantiated by the extensive and painstaking research of Michell himself, Alexander Thom, Gerald Hawkins, John Anthony West and others, to the point where Michell could write in his 2001 A Little History of Astro-Archaeology that this field is now going ". . . from lunacy to heresy to interesting notion and finally to the gates of orthodoxy." Over these same

years, his Holiness Maharishi Mahesh Yogi, working with teams of scientists, has shown that the writings of ancient India, known as the *Vedas*, far from being the superstitious uttering of primitive tribesmen, as they are characterized by traditional scholars, are in fact a compendium of profound and highly systematic insights into the deepest structures of both the physical universe and human consciousness, spawning the emerging science of consciousness studies that is now capturing the attention of modern cosmologists and neurophysiologists alike.

Two scientists have been involved in these areas of research for 38 and 32 years. Drs. Heinz Krug and Robert Thurston, both trained as physicists and engineers, have been particularly interested in the branch of Vedic literature known as jyotish. Neither astronomy nor astrology is a satisfactory translation of *ivotish*; it is a combination of both of these and a good deal more. In common with the other branches of Vedic literature, *ivotish* proceeds from an understanding of the relationship between microcosmic and macrocosmic realms. Unlike Hellenic and subsequent western forms of astrology. however, jyotish does not limit itself merely to the casting of horoscopes and the making of predictions. *jyotish* also includes prescriptions whereby the destiny of the individual can be enhanced and his aspirations fulfilled. To accomplish this, *ivotish* works in co-operation with other branches of Vedic knowledge such as ayur veda (medicine), sthapatya veda (architecture), and gandharva veda (music). It also incorporates the knowledge of another ancient area of human fascination – precious gems.

The value placed on diamonds, sapphires, rubies, emeralds, etc. throughout history does not depend merely upon their beauty or their scarcity. These stones have been valued since ancient times because of their effects on the individual and the environment when worn, rather than displayed. Krug and Thurston have made a special study of these effects, so much so that in this little book they are able to, as they put it in Chapter One: "For the first time in this

modern age . . . reveal a complete understanding of the secret effects of *jyotish* and *jyotish* gemstones." They do so primarily from a practical point of view. Rather than a theoretical treatise on cosmology and gemology, 19 Big Secrets About Astro Gems is a primer into the selection and use of *jyotish* stones, their integration with the *jyotish* birth chart and – one of Krug and Thurston's specialities – the difference between man-made and "natural" stones. Considering the practical before the theoretical is often a wise course of action. As Maharishi once told me: "If a man has a headache, give him an aspirin. When he is feeling better, then we can give him a tour of the factory." With Krug and Thurston, the test of their writing will lie in the application of their recommendations.



Secret 2

Use Original Jyotish Rather than Western Astrology

Astronomy, which stands at the origin of modern science, owes an enormous debt to astrology. Some of the earliest western scientists like Galilei and Kepler were actually astrologers. Indeed, at times, Kepler made his living casting horoscopes. It was their fight, in the early 17th century, to make science independent of religious authorities, thus laying the foundation for modern astronomy.

Unfortunately, however, even today, astronomy rejects astrology. Consider the sciences to be very old persons, and you will find it amusing to see the adult and – seemingly – self-sufficient son still struggling for his freedom against his father.

In reality, the father has a wealth of experience that is more than 5000 years old. Therefore we recommend using the original astrology called *Jyotish* (light) or Vedic astrology. Vedic comes from *Veda*, the Sanskrit word for knowledge.

What are the advantages of this original system of astrology?

Jyotish is far more accurate than any western system of astrology. When an individual horoscope is calculated from correct data – such as birth date, birth time and birth place – future predictions can be accurate to within a day. While western astrology tends to focus on descriptions of character of a person, accurate predictions are not its strength. Jyotish characterizes life events; it explains the fundamental causal

factors leading to events that occur at specific times in the life of the individual.


The greater accuracy of *Jyotish* arises from its use of the sidereal zodiac, as opposed to the tropical zodiac used by most western astrological systems. The sidereal zodiac comprises the real star constellations that can be see in the night sky. Apart from some tiny fluctuations, these constellations are immovable over thousands of years.

The sidereal and tropical zodiacs coincided about 1,700 years ago – exactly on 5th November, 285 – but since that time the tropical zodiac has slowly drifted away. As a result, today (2011) they are more than 24° apart – exactly 24°00'00" on 4th December, 2009. This is a very large discrepancy; it is responsible for many other astrological inaccuracies. Slowly, over the centuries, western astrology has developed more into a belief system than the accurate science which *Jyotish* has been and still is today.

In fact, western astrology developed from Vedic astrology. Probably the knowledge traveled along ancient trading routes, initially from India to Mesopotamia/Babylonia. It contributed to the foundations of Byzantine and medieval Islamic astrology, before arriving in Greece from where it spread throughout Europe, and later to America. It is very possible, however, that a great deal of the knowledge – probably around 80% to 90% – was lost en route. If one compares Vedic to western astrology, clearly there are some similarities, but the differences are considerable.

There have been several scientific evaluations of the validity of astrology. Unfortunately these have been done on western astrology. These researches have always proven that the claims of western astrology are untrue and in the best cases statistically insignificant.

Now, you may be astonished. We completely agree and we ask those scientists to redo their researches and examine what we call a science, namely Vedic astrology.

Secret 3

Use Your Individual Birth Chart

No two people are the same. Even twins born only a few seconds or minutes apart will have somewhat different destinies. Their lives, passions, careers and attitudes will differ. You can locate those differences in their individual horoscopes as long as you enter their proper birth time – the exact second of their first breath – accurately to the second. With this first breath an individual starts to interact with the Earth's environment and will continue to do so till the last breath. This is called "Living on Earth".

From this exact time of birth a Vedic astrologer can calculate the timing of good opportunities for love, success, happiness, money, and career. Once you know the calendar of all those good opportunities ahead of time, you will be able to plan for the changes you wish. With such a unique knowledge you can become the master of your own destiny. Properly chosen gems can help you achieve that. However, a birth stone chosen simply according to your birth month does not have any useful effect. 



Secret 5

Effects of Gems on the Aura

The gem effect is not magic; we would rather call it the latest science. Our lives are governed by quantum energy fields much more than yesterday's science would want us to believe. Knowledge of these fields, their relationship to our bodies, mind and soul, and how they are entangled with the cosmic planetary quantum fields, is the untold secret of selecting the proper gem. It really needs an expert Vedic astrologer, expert with years of training to do it properly.

Traditionally, these quantum fields have been known as *auras*. They are energy fields surrounding the body. Very sensitive persons can see them with their eyes and describe them in various colors. A variety of measuring devices for the aura have also been developed. Some of them can picture the aura in a way very similar to a photograph.

Gems filter the white sunlight and enrich the aura with their specific colors. These colors are connected with the cosmic quantum fields of the Sun, Moon and planets. A gem, when properly selected from one's individual horoscope – including relocation – reconnects one's individual quantum fields to the cosmic quantum fields. This results in a balancing of the quantum fields, thereby warding off negative influences and strengthening the positive.

When the gem is large enough, nearly everybody who wears or holds one can physically feel its vibrational influence. A sort of charging-up effect of the gem occurs over a period of several months. During this time the gem grows more and

more efficient. The overall result then is an improved destiny for the person.

Secret 5 Summary

Gems filter out certain frequencies from white sunlight. When correctly chosen, it improves the individual quantum fields known as aura and creates a better destiny for the individual.

Correct selection of gems should never be done according to birth month or the Zodiac sign of the Sun. This has no significance for changing the quantum fields.

You must look at your individual birth chart to change your quantum fields and aura and to improve your destiny. See Secret 3. Always use the relocated birth chart.

Secret 7

Story of the Creation of Natural Gems

Geologists do not really know how the various naturally-occurring precious gems have been created. They speculate that some types of gems have crystallized out from molten magma under the influence of high pressure and temperature. Yet, they cannot explain why gems occur only in certain deposits rather than being uniformly distributed over the Earth. Moreover, they are aware that these crystallization processes may not have taken millions of years. They may have occurred millions of years ago, but they could have happened fairly quickly – within a few weeks or months.

In lieu of a complete "scientific" explanation it is interesting to note the ancient Vedic tradition on this subject which is found in the *Purāṇas*. It is the best explanation we have found so far, and it is reproduced in its entirety in Appendix 2, below:

An ancient race of very advanced space travelers (called gods) saved Planet Earth from an event that threatened to extinguish all life on the planet. A gigantic asteroid – identified as the demon *Balasura* – was on a path that would have lead to a direct impact on the surface of the planet. They attached the asteroid to their space ship in order to alter its course before it moved around the Sun and hit the Earth.

The Earth was saved from the full impact of the asteroid, but the ship was moving too fast and the asteroid came loose, breaking up into several large pieces which did land on the planet. The result was the creation of deposits of precious stones, of different kinds owing, in each case, to the influence of different natural laws. Such influences, according to the *Purāṇas*, were:

- One fragment, moving close to the Sun, melted into fluid red magma (appearing like blood). It was then pushed out of orbit and impacted the Earth. Quickly cooling down in the evaporating waters of rivers, these fragments of the asteroid formed the origin of rubies.
- Other fragments impacted in the oceans forming tiny crystals like molten glass dropped into water. These sharp crystals can be seen in the oceans today and form the seeds for pearls in oysters.
- Fragments that impacted on ocean shores cooled slowly by the evaporating waters of the nearby ocean, were the origin of blue sapphires.
- 4. The sound of the impact of other fragments echoing from mountains created such intense pressure that it transformed crystal structures, the origin of cat's eye.

Secret 7 Summary

If you believe in the ancient Vedic Purāṇas then you can read that even the so-called "natural" gems were created a long time ago. They came out of fragments of an asteroid hitting Earth. See Appendix 2.



Out of the Ground or From the Lab?

Gems from the ground are very expensive, due not merely to an intrinsic, material value, but because they are so rare, especially when they are very clean and well colored.

A common myth holds that natural gem stones have been formed during millions of years in the womb of the Earth. But in reality, it takes exactly the same amount of time (3 weeks to 6 months) and temperature (up to 3,500°C) to form a lab created gem as it takes to form a gemstone in the Earth. The same laws of nature apply when crystals are grown in magma or, for example, from the impact of an asteroid. Even crystals within the magma do not take hundreds of years to form, although many stones from the ground may have been formed millions of years ago! It is just really romantic conception of the jewelery industry that helps them sell expensive gems.

Any crystal that has the same geometric structure will resonate the same way. It is simply the atomic lattice that influences and modifies any vibration or electromagnetic fields, including visible light. Based on this knowledge, the major difference between lab-created and natural gems is really the higher purity of the former.

As it is created in a controlled, non-disturbed environment it has less inclusions (foreign crystal material), color zone changes, pressure fractures and other flaws. This really makes the lab-grown crystal more valuable for astrological

purposes. This is due to its perfect symmetrical harmony, supporting coherent quantum fields. Laser light is one example of this. A mined ruby would never create this highly orderly coherent light, and therefore cannot be used to manufacture lasers. Only lab gems support this highly orderly wave function.

Most astrologers know very little about gems because they are not trained gemologists. They have an incorrect viewpoint towards man-made gems, categorizing them all as "imitation" stones, disregarding the wide range of quality found in gems of this sort.

A good lab-grown gem (also called a "created gem") has exactly the same material, color and chemical composition as the natural gem, without the imperfections found in the "naturally" occurring stones. Our experience clearly shows that such gems have astrological "power". They change the destiny of the wearers, and do so very quickly in higher carat sizes – 50, 100 or even 200 carats. (See the various testimonials.) On the other hand, many gems of far lower quality are also artificially manufactured; we would call these the true "imitation" stones. While they can appear very similar, often with the same color, for example, these stones are made from different materials with a different crystal lattices, and mostly are of no value for the purposes of *Jyotish*.

Only when carefully selected, therefore, lab-created gems allow individuals to achieve fast improvements in their destiny at an affordable price. One does not have to spend gigantic amounts of money for gems the size of crown jewels. Today, in our technological age, with fast travel by cars and airplanes, natural gems are as useful as donkeys pulling their little cart! Just keep feeding them 1 or 2 carrots.

One further consideration is significant here – the amount of suffering caused by the mining process of natural gems. Hundreds of thousands of poor people and even children have to labor in mines, sometimes under life threatening conditions.

This is well documented in the 2006 movie *Blood Diamond* which is based on real conditions in the natural gem industry. Consider how much negative *karma* you have supported before trying to mitigate your own *karma* with a so-called "natural" gem! This, in itself, is a sufficient reason to prefer a laboratory-grown gem.

Some traditionalists and superstitious in spite of a wealth of real life testimonials still cannot be convinced of the lab-created gems' astrological "power". The more scientific minded of you please analyze the following comparison chart of emeralds as an example. Measured variations in the chart occur in natural gem deposits the same way they do in the labs.


Secret 8 Summary

Gems grown properly in the lab are cheaper, far superior for astrology, available in larger sizes and larger quantities and they do not cause any suffering or hardship for the workers in natural gem mines.

Avoid Treated Natural Gems

Driven by the increasingly lucrative jewel market, the natural gem industry has many dark secrets to hide. Since the beginning of the new millennium, for example, gems are increasingly being treated to make them appear more valuable.

Today 99.9% of rubies in the market are heat-treated. A large proportion of red or pink rubies mined have flaws, purple and black spots and other color variations. Through the process of heating them to nearly melting temperature these flaws disappear. But the result is that the crystal structure of the ruby is destroyed. This effectively converts the ruby crystal into glass at those flawed spots. Heating dissolves the molecular crystal lattice which is so important to create the quantum field effect. So, basically a heat-treated ruby in its qualities is more like red colored glass. It may look pretty but has no astrological effect.




Corundum crystal lattice Photo © public domain from Wikipedia

This is the orderly crystal lattice of corundum Al₂O₃. Aluminum and oxygen atoms form regular patterns. Rubies and sapphires of any color are basically corundum.

Heat-treated rubies and sapphires on the other hand are similar to glass. It is really cheating to call these items "rubies". One could save a lot of money by buying red glass instead of heat-treated "rubies".

The amorphous structure of glass on the right is more like a fluid rather than a regular crystal. Heat-treatment of gems close to their melting temperature usually creates such disorderly structures.

The same story applies to all varieties of colored corundum, like blue and yellow sapphire. Honest gem wholesalers will tell you that today 97% of all blue sapphires are heat-treated to intensify or deepen the color, and to amalgamate any inclusions. Most yellow

sapphires on the market are heat-treated as well. But color created by heat-treating often fades within a year or two.

Green natural emeralds are subject to some of the worst manipulation. Most of them are fracture-filled with plastic resin or green oil with the same refractive index. The fractures are vacuum acid-cleaned and then heat-treated and oiled. The whole process is designed to enhance their appearance and justify their high prices. Actually, it only disguises the heavy flaws of those natural gems and completely disrupts their orderly crystal structure. We would call these processes deceifful

Also red coral is mostly dyed. The basic material sometimes is white coral or bone or ceramics or glass beads. These dyes actually leach out into clothes and skin. Of course they have no effect on your aura and destiny.

If you want to avoid all those traps, emptying your pockets without delivering any value, why not go for lab-created gems right away? They are designed to have a proper crystal lattice. The best quality of rubies we use, can even support laser light function. This happens <u>only</u> when the crystal lattice is perfect.

A 42-year-old English business man spent £6,000 on a 4-carat emerald and felt no effects. He later found out from another jeweler that this gem had been heat-treated and injected with oil. Then he got a second 5-carat natural emerald that cost him £8,000. This still had no effect.

Secret 9 Summary

Natural gems are increasingly subject to processing, such as being heat-treated and oiled, and as a result have no astrological benefits. Since 99% of natural gems on the market today have these created faults, it is simpler and cheaper to buy a good lab-created gem with a correct crystal structure.

How to Fulfill Your Desires

There are gems that have a good effect on your destiny and others have a bad effect. Obviously you only want good effects. Most horoscopes suggest the choice of two, three or even four positive gems.

Gems are not just for general well-being but can also be specific to your wishes and desired destiny. By making the right choice you can influence the changes in your destiny. Here free will comes in again. For example, you can choose to have an increase in wealth as a first priority, improved happiness as second priority and improved health as third priority. These priorities should be told to your Vedic astrologer before he chooses the proper gem for you.

In case you cannot afford several gems immediately, we found it to be a very intelligent route to choose increased wealth first. This will put you in a position to acquire more and larger gems to increase your wealth further, and to have all the other positive effects in your life. See Secret 14 for more details.

Even if you call yourself a very spiritual person, be practical and put yourself into a situation where you can afford all those positive effects of many gems. This will include increased spiritual experiences as well.

We want to give you an idea on the pricing of inclusion free, large natural gems. When publishing this book there were two offers for large yellow sapphires in Ebay from Thailand. One

of them was a 101-carat yellow golden natural sapphire offered for sale at \$19 million (£ 12 million). The other one was also a yellow sapphire with 104 carat offered at \$12 million (£7.6 million). Of course both of them are very rare, highest quality gems. They are totally inclusion free.

We are well aware that most of our readers cannot afford such expensive natural gems. Therefore it is interesting to note that we believe, the same astrological effect can be created from lab-created gems with a similar clarity and totally inclusion free. They generally cost less than 0.1% compared to those large natural gems that have been offered on Ebay. With lab-created gems you can afford to get the power of the crown jewels without having to pay a king's ransom.

Real life testimonial

A 47-year-old English mother and property speculator during her brief career had acquired three of her own houses. Before the end of her career she wanted to own five houses altogether. This would give her one house for each of her four children and one of her own.

We analyzed her horoscope for the specific purpose of acquiring more property and recommended a 22-carat labcreated yellow sapphire. She purchased it but did not give us much immediate feedback. Secret 10 Summary

Be the master of your own destiny. Fulfil all your desires with the proper gems.

Selection Method: Strengthen Positive, Not Negative

Do not fight the darkness – increase the light! Research performed on 5,000 people has shown that it is far better to strengthen positive traits by selecting the right gem for the functionally positive planets. See the Real Life Testimonial below.

A gem always increases the power of the heavenly body with which it is associated. Now, this is not quite true. Actually, the quantum field of the heavenly body isn't changed at all. What is changed by the gem is the way in which the individual's quantum field interacts with the quantum field generated by the heavenly body. That interaction can be positive or negative, and a good Vedic astrologer or Jyotishi would see it in an individual horoscope. Only the positive interactions should be strengthened by wearing the correct gems. See the planet and gem table in Secret 6.

The oldest astrology scriptures like the Brihat Pārāshara Horā Shāstra have a clear formula for calculating the power of a heavenly body, like the Sun, Moon, planets or lunar nodes. These are called *graha* in Sanskrit. The power calculation – *bala* in Sanskrit – depends on positions, angles, etc., but one term of the calculation describes the natural power exchange between the heavenly body's quantum field and the quantum field of the individual. This power factor can be increased by wearing a gem.

Arising from the increased power influence of a heavenly body, or *graha*, the whole individual horoscope shifts due to the altered planetary strength. The positive effects from a beneficial *graha* increase when the person wears the correct gem. This will effectively alter his horoscope and consequently his destiny.

Secret 11 Summary

Strengthen positive heavenly influences by wearing the gems for functionally positive planets in your birth chart relocated to your place of residence.

Gem Combinations

Some individual's horoscopes allow only one good gem to be worn, others two, three or even four. If you are able to wear several gems you have a choice as to what you want to achieve with them. A good Vedic astrologer should be able to tell you the specific effects of each gem and its possible side effects, too. By choosing the right gem or gem combinations you can fulfill specific desires that are important to you in your life.

Make sure that you tell those specific wishes to your Vedic astrologer before he chooses the right gem for you. Unfortunately, too many astrologers choose gems from a very superficial perspective, such as, for example the 1-5-9 method. Talk with your Vedic astrologer about the method that he uses and do not accept superficial recommendations. This is an additional rule to the fundamental selection method of Secret 11: *Strengthen Positive, Not Negative*.

If you have moved away from your birth place you also should take care that your astrologer uses only the relocated chart. See Secret 4. If you miss that point you may create a lot of wealth, health and happiness for an imaginary person who doesn't live there any more. You have to create the effect at the place where you are. This means that the gem selection must be based on your relocated chart. Unfortunately, 99% of all Vedic astrologers have neither heard of this nor studied their original literature in Sanskrit. The sage Pārāshara knew this relocation secret, but most of his followers today use wrong translations.



From our clients we have observed that gems work differently when they move around the planet. So now we recommend specific combinations of gems depending on where they are. That means you take off some of your gems when you go on a holiday. All this can be accurately calculated.

Another very important aspect of wearing several gems are possible clashes between the various quantum fields of the gems. These clashes would clearly show up as physical tensions, such as headaches and all sorts of unlucky strokes of destiny.

This too can be calculated in advance, and a good gem recommendation would tell you what gems should not be worn with other gems. It is all based on the *friendship* between the *grahas*, i.e. the Sun, Moon, planets and lunar nodes. This *friendship* depends on relative angles of the *grahas* in your native horoscope. The *graha friendships* stay constant even when moving around the globe. There is a general *friendship* matrix between each *graha* and each other *graha* and also an individual *friendship* matrix, specific to the individual's horoscope. Make sure that your astrologer uses this individual *friendship* matrix only.

A US family with South-Asian origins equipped themselves completely with gems including the two parents, who were both medical doctors, and their two children. Secret 12 Summary

Use gem combinations to fulfill specific desires. Make sure your astrologer considers all side effects, relocation and planetary friendships, based on your horoscope.

The Square Law: Size Does Matter

Physicists have discovered a square law in many areas involving fields. The achieved power is the square of the amplitude. This applies to all sorts of quantum fields, including light. It also applies to the power of sound developed by a loud speaker.

The experiences of gem wearers show this square law. What does this mean practically?

It means a gem double the size has four times the effect. With triple the size it has nine times the effect. In practical terms, this effect is revealed in the speed with which a gem brings about positive changes in someone's destiny. A 24-carat ruby, for example, is 12 times larger in volume than a 2-carat ruby therefore the effect is $12 \times 12 = 144$ times. That means any positive effect that the 24-carat ruby would bring in 3 days would take more than a year with the 2-carat ruby.

Because of this square law, therefore, we recommend to our clients that they obtain the largest possible gems they can afford. You physically experience the vibration of a large gem when placed in your hand. Larger gems improve your destiny much more quickly.

Many Indian and other Asian astrologers recommend specific gem sizes in terms of *ratti*, which is an old measure of weight. They believe that certain *ratti* sizes bring good luck and other sizes bring bad luck. We believe this is pure superstition. The laws of physics tell us: the larger, the better.

A highly spiritual, 60-year-old British man knew from his astrologer that a cat's eye gem would release all previously acquired good karma. He started with a "small" 60-carat labcreated gem which manifested all sorts of business benefits. A year later he got another cat's eye with a 180 carats weight. This did the trick immediately. Secret 13 Summary

Larger gems do work quicker, sometimes within days rather than years.

Increase the Size Over Time

From our experience with clients we have learned something very simple and practical. You will love this one! As the large lab-created gems create effects very quickly, the simplest way to afford many gems is as follows:

First get a gem which you can afford and which has the specific effect to bring you more money. This "starter gem" will very quickly improve your financial situation, and then you can afford to buy the same gem in larger sizes to create much more wealth. The minimum "starter gem" size should be 24 carats.

Based on your larger wealth, you can now afford all the other gems, those that make you happy, healthy, improve family live, spirituality, etc. We found this to be a very practical and enjoyable sequence. It is far more practical to own ample wealth so that you can buy your most spiritually active gem, rather than long for it for the whole of your life, while you sit and meditate in poverty.

A young English entrepreneur of Indian origin found some good ways of earning money on the internet. He got a 36carat emerald and within days his business really took off. His earnings multiplied many times. Three months later he got another lab-created emerald of 208 carats. According to the square law this has 33 times the effect of the smaller one.

Authors' comment: Diamonds are hard to produce in the labs beyond 5 carat and even those are very expensive. We have found that large lab-created white sapphires have similar destiny improving qualities to diamonds. These can be produced in labs with sizes up to 200 carat at reasonable costs.

Secret 14 Summary

Large gems are very powerful. Therefore it is wise to increase the size gradually to allow the body to get accustomed to it. Don't worry about the costs. The gems will bring the money.

Do Not Have it Too Big

We have found an upper limit for large gems. At around 200 carats the effects of the gems become so intensive that most owners cannot handle them. These over-sized gems can change their owner's destiny in unforeseen ways which are not practical while living on this planet.

In this context, also make sure you do not increase the gem size too quickly. Allow your physiology to adapt to the aura changes gradually. Generally, individuals with a heavier body type can handle larger stones more easily. Slim people should increase their gem sizes in smaller steps.

Here is the story of a very embarrassed, rich client from the UK. 600 carats of emerald is definitely toooooo much! First he purchased a 200-carat gem. Impressed with its brilliance he obtained another 200 carats. Life started to get really amazing. But this man was very greedy; he tested another 200-carat gem.

Here is what happened: He wanted to sign an official document. For that he had to travel 150 miles on the motorway network with his passport and other documents. First he wore the gems around his neck. He then found this was too intense so he put them in the pockets of some trousers at the back of his 7-seater people-carrier.

How to Wear Gems

Gems are most effective when worn correctly. The goal is to optimize the interaction between the cosmic and individual quantum fields. For this to occur, the light of the Sun, representing totality, has to shine through the gem onto your skin.

The gem has to be set correctly. The metal setting of the gem should be minimum and the visible area of the gem, both front and back, should be as great as possible. In this way you maximize the Sun light that can shine through the gem and improve your aura, and thus your destiny.

Ask your astrologer what would be the best metal for the gem setting. For some charts this is gold, for others silver or other precious metals.

Also, it is a great advantage to wear clothes that maximize the amount of sunlight penetrating or reflecting from the gem. When you wear dark colors you reduce the sunlight. Wearing light colors, and colors similar to the gem, brings the best benefit.

Red coral and pearl are reflective gems, whereas the rest are sunlight penetrated gems.

The minimum size of a gem we ever recommend to our clients is 24 carats. All of them, without exception, have experienced immediate improvements in their lives. With smaller gems this does not happen so guickly; some improvements could take a

whole life time to occur. Be happy and keep feeding your donkey 1 or 2 carrots for a whole life time!

OK, now back to the big boys and girls. You can wear large gems either on a pendant or an arm bangle. It would be impractical to wear them on a finger.

You should never let anyone touch your gemstone as you run the risk of introducing foreign and unwanted frequencies into your gems. This will negatively affect any benefit to you.

Secret 16 Summary

Wear the gem so you maximize the sunlight shining through it. The effect is created from the filtered sunlight touching your skin.

When to Wear Gems

There are astrological phases in your life, called *dasha* in Sanskrit. These phases outline the auspicious and inauspicious periods in your life. Each phase is associated with a *graha* (Sun, Moon, planets, lunar nodes) and brings back that part of your destiny which is connected to the *graha*.

For example, in the Jupiter dasha all those elements of your destiny connected to Jupiter are brought to you. When these elements are good and favorable it is advisable to wear the gem yellow sapphire for Jupiter in that life period.



Every horoscope has a house of loss. It is the last one of the twelve houses. There are also some other unfortunate houses. Appendix 2

Cited below, the complete chapter on jewels from the *Garuḍa Purāṇa* as told by Romaharshaṇa, a student of Veda Vyāsa:

Jewels

"A long time back, there used to be a demon named Balāsura. He defeated Indra and the other gods. Balāsura was invincible. Not knowing what to do, the gods arranged a yajna. They then went to Balāsura and asked him for his body so that it might be offered as a sacrifice at the yajna. The demon was generous and he was not going to refuse a request. He gave his body to the gods.

The gods ascended a vimāna (space vehicle) and were traveling through the sky with Balāsura's body. But the vimāna was moving so fast that Balāsura's body fell off. It broke into many parts which got scattered throughout the Earth. Wherever a part of the body fell, earth, mountain or garden, that place became a source of jewels and precious stones.

There are many types of jewels. Some of the more important ones are vajra (diamond), muktā (pearl), mani (ruby), padmarāga (ruby), marakata (emerald), indranīla (blue sapphire), vaidūrya (cat's eye), puṣparāga (topaz, yellow sapphire), karketana (chrysoberyl), pulaka (garnet), rudhira (carnelian), sphaṭika (quartz crystal) and pravāla (coral).

Vajra or hīraka was formed from Balāsura's bones. Diamonds can be of many colors, coppery, milky-white, blue, golden, yellow and dark. Red and yellow diamonds should be worn only by a king, not by anyone else. A multicolored and round

diamond should not be worn indiscriminately. It can cause great suffering, and due precautions have to be taken before such a diamond is worn as adornment. Even Indra takes care before wearing such a diamond. A hexagonal diamond is extremely rare and brings good fortune. A diamond is valuable because it can cut and mark any other object. But a diamond cannot be cut or marked except by another diamond.

Muktas (pearls) can be obtained from eight different places. from elephants, clouds, boars, conch-shells, fishes, snakes, oysters and bamboos. But oysters are the most common source. Pearls got from bamboos, elephants, fishes, conchshells and boars are not at all bright. Balāsura's teeth fell into the ocean. There the teeth entered the bodies of oysters and became the seeds for pearls. A pearl which weighs half a tola (weight) is worth 1305 coins. There are several other grades for pearls, the worths being 800, 783, 325, 200, 110, 100, 97, 40, 30, 14, 11 and 9 coins respectively. If you need to polish a pearl, put it inside the stomach of fish. Cover the fish with clay and roast it. The pearl should then be taken out and washed with milk, wine and water. It will become bright and shining. What happens if one suspects that a pearl is not genuine? It should be kept in saline water for a night and then dried. If its color does not fade, it is a genuine pearl.

Balāsura's blood fell into a river. In fact, at first it had not fallen into the river at all, but was retained by the Sun. But Rāvaṇa, king of Lanka, once decided to attack the Sun. And in the process, the Sun dropped Balāsura's blood into a river which came to be known as Rāvaṇagangā. This blood became rubies (padmarāga). Rubies are red. Some of them may be tinged with a little bit of black or blue. A good quality ruby should never be worn with a bad quality ruby. The wearer of a good quality ruby is protected from all misfortunes.

The king of the snakes is Vāsuki. Vāsuki accepted the bile (pitta) that came out of Balāsura's body. The snake was traversing the sky when he was suddenly attacked by Garuḍa. Garuḍa too wanted to possess the bile. While the two were

fighting, the bile fell into the valley of a mountain. This bile gave birth to marakatas (emeralds). Emeralds are generally green in color. The herbs which grow in emerald mines are cures for sorts of poison. A true emerald never fades in color.

Balāsura's eyes fell on the shores of the ocean. And these eyes became indranīla jewels (sapphires). Sapphires are tinged with blue. A sapphire should never be flung into a fire. The person who does this deed suffers great misfortune. A special sort of sapphire is known as mahānīla. It is dark blue in color and if it is kept immersed in milk, the milk turns blue in color.

Balāsura roared before he died. This roar echoed in a mountain range named Vidura. And from the roar was born a gem known as vaidūrya (cat's eye), so called because it can be found on the mountain Vidura. Vaidūryas are green or blue in color.

Balāsura's skin fell on the Himalayas. This skin was the origin of puṣparāga (yellow sapphire). A puṣparāga is light yellow in color. But if a yellow sapphire is also tinged with red, it is known as kuraṇḍaka. And if a yellow sapphire is slightly tinged with blue, it is known as somanaka. A woman who does not have any son will give birth to one if she wears a yellow sapphire.

Another type of jewel is named karketana (hessonite). It originated from Balāsura's nails. These nails fell into a bed of lotuses and there created this gem. Karketana can be of many colors, red, milky-white, yellow, copper-colored and blue. This jewel becomes brighter if it is wrapped in gold leaf and burnt in a fire. Karketana is a good jewel to wear if one wants to stay healthy or prolong one's life."
