## PROLOGUE.

Undoubtedly the worst of all wars in our history was the Second World War, which claimed the lives of sixty million human beings. When it ended, fact-finding missions began to scour the defeated Germany. The reports of those missions were published. The catalogue alone counts three hundred pages. Within twelve years, the technical evolution of the *Reich* had taken uniquely divergent courses.

Besides differences in technical matters, there were even more striking philosophical differences.... They had rejected relativity and partly forgotten the theory of quanta. They believed in the concavity of the earth. Their cosmogony would have made allied astrophysicists' hair stand on end.

If in twelve years such gulfs could open up in our modern world, despite exchanges and communications, what are we to think of the civilisations that may have developed in the past? To what extent are our archaeologists qualified to judge the state of science, technology, philosophy and knowledge, for example, among the Mayans or the Egyptians?

***If the investigations of ancient civilisations have been carried out by men who are of the opinion that modern civilisation is the only possible technical civilisation;*** then, when contemplating a megalith of 1200 tons cut cubically by human hands, moved and placed next to or on top of another similar one, also by humans, one has no choice but to imagine, either the help of God, or a colossal and shocking work of ants-man-slaves, who had as their only tools, ropes, crowbars, tree trunks and a few metal utensils.

However, it is possible that an entirely different way of thinking could have devised techniques as sophisticated as ours, but also different: measuring instruments and methods of manipulating matter that have no connection with what we know, and which would have left no visible trace ***to our eyes***. It is possible that powerful science and technology could have provided different solutions to the problems posed than ours and disappeared completely with the world of the Pharaohs or the Toltecs.

It is hard for us to believe that a civilisation can die out, that it can be completely erased from the memory of the people. And it is even more difficult to believe that it could be so different from our own that we can ***no longer recognise it as*** a civilisation.

Something different from our "political normality" happened in Nazi Germany. The economic and social circumstances following their defeat in the First World War in Europe, coupled with the perversity of the Versailles Treaty against the German people, were the fertile soil in which germinated the ideology that propelled the people who accompanied Adolf Hitler to the top of the government. Such an ideology really was and is from another world. A world forgotten and resurrected by the *Third Reich*. A world to which today's culture closes its eyes and strives to shut it out of its vision.

Few people know that Nazi Germany spent more resources on esoteric research than the Allies spent on developing the atomic bomb. The *Anhenrbe* (*an institution dedicated to*

*The study of the past and the recovery of Germanic ancestry*) literally "combs" the globe in search of ancient "secrets".

The Nazis might be fanatics but they were not imbeciles. If they invested such enormous resources, it was because they were likely to find them.

What, or Who, or by what technique or discipline did they obtain information that after study became security to search for something hidden across the face of the planet?

The answer; however ridiculous it may seem to the contemporary reader, is:

They retrieved myths, legends, traditions, folklore, scattered all over the world. Such information added to archaeology, semantics and the knowledge kept by secret societies such as the *Thulegesellschaft*, or the *Vril Society*; are the source from which they obtained the information that led them to search for a door that they finally found in the icy and forgotten Land of Queen *Maud: Antarctica*.

Why can't there be a new religion?

Because just as science starts from an original fact, which is the *Big Bang*, every legitimate religion starts from an original fact: Creation, or the appearance of the human being, who through the generations leaves his testimony to his descendants. And in terms of legitimisation, the older it is, the more legitimate it is.

It is only in this context that the viciousness with which the new religion, through the church and those behind it, destroyed every vestige of ancient cultures and religions that were within its reach for centuries becomes understandable. It is only from this point of view that the destruction of treasures such as the library of Alexandria is understandable. The new religion had to destroy everything within its reach that undermined its legitimacy.

But not everything was destroyed. The world was still big enough for the hands of those who want to destroy it. Under the earth, in the sands of the deserts, in texts that managed to survive and in the memory of the people, there were and are still traces of a legitimate history.

That the first human beings were the result of mixing the blood of a hominid native to the planet with the blood of beings who came from beyond the stars.

In the 70's *Erick Von Daniken* dazzled us with an image of the alien manager of worlds, omnipresent and creator, who pretends to be a "god", leaving traces of his presence throughout human prehistory. In the 80's, in Spanish-speaking countries, *J.J. Benítez* moved ufology with the vision of the angelic extraterrestrial, subordinate to "God", who seeks the spiritual evolution of humanity through brotherly love and sacrifice. His series of books "*Trojan Horse*", in which he reveals an extraterrestrial Jesus belonging to a galactic order, shook esoteric circles of the most diverse nature.

This vision of the sweet and beneficent extraterrestrial executing a great "Cosmic Plan" was taken up to a greater or lesser extent by numerous end-time sects such as *Sixto Paz's "Rama Mission"*.

Recently, however, a new version of the origin of the "UFO" phenomenon has emerged and has begun to be widely spread. We will say that today's world can accept living side by side, well together, all sorts of things, good and bad, it doesn't matter, are tolerated by the system. Democrats, communists, believers and agnostics, heterosexuals, bisexuals and homosexuals, puritans, satanists, freedom of religion, free speech, multiculturalism, interracialism, etc., etc., etc., etc., even "racism" is tolerated, but there is only one thing it does not and will not tolerate under any circumstances: Nazism.

## 2. WHAT THE WORLD HIDES.

Let's see, at a glance, without looking too hard, almost all of us are able to notice distortions and anomalies in the fabric of official history that has been inculcated in us through generations and generations. There are many cultural facts and historical records that have been deliberately omitted or changed.

In general terms, let us highlight some of the most notorious and obvious ones.

- The Origin of the Universe.
- The Origin of Man.
- The Origin of Civilisation.
- The Origin of Religion.

In view of the complexity involved in the presentation and classification of these contents, we believe that through these four categories we can expose with a certain simplicity the filigree of the gigantic framework, the manipulation that the system has exercised in various fields and from different perspectives, to disorientate humanity; with this we will try to encompass as far as possible, all or almost all that has been omitted, distorted and distorted by culture.

### *The Origin of the Universe.*

The culture of the system proclaims two positions in this respect, the theory of materialistic uncertainty which affirms that the universe has always been, and always will be; that everything is the result of chance and accident, so that in the face of this natural entropy it is only for humanity to develop the possibilities to the limit of the progress we can achieve in order to get anywhere; and the theory of teleological finality, disguised as spirituality but equally materialistic, which asserts that the universe has been created for some unknown reason that will be revealed to us at some point, when it has fulfilled its purpose and the end comes.

However, scientism believes to see in the *big bang* a generation and a dissolution of an expanding and contracting universe, and religions a beginning and an end of time; as you will see the same face with a different mask, as scientism and faith converge at the beginning and the end.

And well, the question: What is hidden from us? It is evident that something is hidden, for in both cases the universe makes no sense, whether it is destroyed because it is, or because a higher will has so designed it, in any case we are powerless to know the first cause, the theological postulate par excellence of all religions.

Before answering the question posed, let's reflect on this: the universe is too big to pretend to reduce the distance to the nearest star by

an eminent law that postulates that nothing can be capable of travelling at the speed of light making empirical verification of life beyond the limits of the solar system impossible and that in the face of this uncertainty, either the universe is composed of gases and there are no other forms of intelligent life besides our own, or it exists but is too far away for us to ever make contact.

On the other hand, the technological direction of the world does not foresee the factual possibility of interdimensional travel, which would be millennia away, if we survive our technological infancy and do not destroy ourselves first in a massive nuclear hecatomb.

To get a glimpse of this vision, I recommend watching and analysing *Robert Zemeckis'* science fiction film "*Contact*".

The theory of relativity is just that, theory, and we will never see a wormhole, or a time machine, and for most of humanity, except for the odd astronaut, we will never have the possibility of leaving this planet except by dying, which does not guarantee anything at all either, since what awaits us after we die is also hidden from us. In this sense there is really not much difference between a caveman and a *Wall Street* executive travelling in luxurious private jets. Both are constrained by the same impossibility.




Now, let us answer the question: what is hidden from us?

The answer may seem obvious and even too simple, but it is completely verifiable if we have the capacity to accept the weight of evidence: that we are in a prison of planetary proportions; a gigantic concentration camp, carrying the illusion of a life induced by psychological factors and a system of social control.

### ***The Origin of Man.***

As for the origin of humanity, we encounter the same problem: a strategy of confusion has woven a cloak of concealment whether we accept the theory of evolution or the creationist theory if we are believers.

Palaeoarchaeological remains suggest the existence of a gigantic humanity of colossal antiquity, which has nuanced the "UFO" theory; *Sacharia Sitchin* presents interesting evidence for the presence of an extraterrestrial race, the "*Anunnaki*" in the progression of Sumerian civilisation. Even so, his claims are dismissed as itinerant and fanciful by a scientific community that does not believe in the presence of an extraterrestrial race, the "*Anunnaki*".

a blind eye to megalithic traces such as *Sacsahuaman* and *Baalbek*, stubbornly turning a blind eye to the


in finding the "missing link", the hominid-humanoid that would prove the evolutionary transition from *Neanderthal* to *Cro-Magnon*. Needless to say, the existence of giants in the remote past would in itself disprove the whole Darwinian theory, which is still taught in schools and universities de facto without any empirical basis.

The trail of giants is hidden from us, the reptiloid phylogenetic origin of *homo sapiens* is hidden from us, which can never be explained by evolutionary theory. Why?

Because *homo sapiens* are the product of an artificial genetic mutation. *Sitchin's* thesis suggested earlier by *Daniken* is an evidenced anomaly of the phylogenetic origin of mankind, which is deliberately hidden; and although creationists and the creation myth suggest that "divinity" operated a genetic mutation, all religions omit any reference to the extraterrestrial origin of the human being, ensnaring man in a biased sacred vision that explains the natural aversion to religion felt by the increasing number of agnostics in the world.

### ***The Origin of the Civilisation.***

According to *Paul H. Koch's* thesis in his work "*The Hidden History of the World*", the planet is virtually littered with palaeoarchaeological remains of Atlantis, visible and abundant, but deliberately labelled as the remains of much later cultures, thus detracting from their true antiquity. It is of no use that *Arthur Posnansky*, the greatest expert in Tiwanacology, dated *Tiwanacu's* antiquity at more than 20,000 years; official archaeology deliberately teaches that they are recent remains no older than 2000 years and that they were the work of Indo-American cultures whose technological capacity to erect colossal megalithic monuments has so far not been demonstrated.

To this day the same colour-blind people with the most incomprehensible stubbornness continue to maintain that the modern Egyptians, a Semitic culture lacking the technological degree to manipulate such monoliths, have built the pyramids using primitive and rudimentary tools, wooden logs as ramps and the human traction of slave labour to erect them. With the

modern techniques and machinery, even today it would be impossible for mankind to erect a pyramid building using 1,300,000 bricks of hewn stone weighing 2 tons each.

What is hidden from us?

For the possibility of glimpsing a superhumanity capable of feats that would now seem impossible. And that we are descended from that humanity, so we would have at hand a legacy that can be rescued.

If we knew where we came from, the whole range of theories that humanity, coming from barbarism, would move towards progress by evolving through time, would collapse. All progressive theories would be branded as fallacious, and man would glimpse what he is really capable of doing because it has already been done by his ancestors.

There would undoubtedly be a revolution and man would reclaim his place in the heavens.

### ***The Origin of the Religion.***

We will now pose a very important question.

From where could that hominid, now man, according to history and official science, have conceived the need to base his behaviour on theological principles, i.e. "gods"?



To answer this question we must digress and look at what theological principle means. And here it gets really interesting, because a theological principle always represents an active behaviour. And an active conduct can only be channelled through a self-aware physical entity, and not only that, but to serve as an inspiration,

creativity, imitation, a community also composed of conscious and thus social entities, must come into DIRECT CONTACT with such a principled entity.

In this sense it is easy to understand the claim of almost all the peoples of the world in their ancestral traditions to have come into direct contact with their deities. The Inga claimed descent from the "Orejona" from "Venus", the Sumerians from "Innana", "Enki" and "Enlil", the Indo-Aryans from "Brahma" and "Shiva", indeed there is even a *Brahmanic* or priestly line or caste and a warrior or *Shivaist* "Kshatriya" line or caste. Germanic and Nordic traditions claim that *Wotan* and his *Aces* lived side by side with the *Vannir*, and the peoples of the blood covenant.

In the Bible, *Jehovah*, the most important theological principle, is depicted as human, superb, misogynistic, vengeful, and speculative, eating meals in the open air, fasting with women of flesh, fighting physically with his acolytes, accompanied by angels, archangels and demons, like most of the deities of the Greek pantheon, always in trouble with skirts, quarrels and unwanted children.

But even the most recent incarnate god walked alongside humans, bequeathing to us a principle that if it had been assimilated by humanity would have changed the world. Let it not be said then that we are talking rubbish, and that we are not right to criticise the sacralising attitude of religions that have

The result is the dissociation of their followers and believers from the very principles on which they are based.

All to hide from us the reality of the existence of entities living on higher planes of this universe controlling all cultural variables to keep us in the prison-prison in which they have locked us.

In any case, taking a look at the real world we live in, we should be inclined to think that these deities have contempt for human beings. But by delving into the ancient tradition and mythology of various peoples and cultures, we would at least have a chance of gaining their favour. For example, the Germanic gods ensure that men who die for defending a just cause are granted entry to their abode and the fruit of immortality. Others instead demand submission, humiliation and worship from their followers; as we will have the opportunity to review later, paganism and monotheism itself revolve around this duality, a rivalry between antagonistic deities.

### 3. A BIT OF HISTORY.

Very few people know anything about history; and if they "know" anything at all, it is based entirely on what they have learned about it at school, university and cable television.

A serious estimate claims that 91% of humanity is functionally illiterate, i.e. learned to read but does not read, learned to write but does not write. Of the remaining 9% who read, only one fifth write, and of those who do read, the average number of books read per year is less than 3.

OK, now let's look at this. Out of 8 billion people living on the planet, 9000, i.e. 0.000001125% are in the highest echelons of power, i.e. governmental, non-governmental (NGO's), corporate and transnational, holding 95% of the planetary wealth. Of these 9000 people 89% are Jews, NOT ISRAELITES, living in different countries of the world, owing no civic allegiance to any of them.

All these agents, who rose to prominence after the French Revolution, encouraged, financed and supported the Bolshevik movement, which was made up of European and Russian Jewry. A similar movement led by *Kurt Eisner*, in coordination with the Bolshevik movement, provoked the abdication of the *Kaiser* in the midst of the German offensive during World War I. Zionist agents in the new German government that led to the Weimar Republic arranged the German surrender when *Kaiser Wilhelm's* armies were 18 kilometres from Paris. Meanwhile Red power was consolidating in Russia; 90% of the Soviet state apparatus was made up of Russian and non-Russian Jews. The Treaty of Versailles deprived Germany of Silesia, awarded to Poland, the Sudetenland to Czechoslovakia, and Alsace-Lorraine to France.

The Second World War began with the excuse of the Nazi invasion of Poland, provoked by the violation of a bilateral treaty that allowed the construction of a railway to link Germany with its East Prussian province separated from German territory by the imposition of Versailles; this treaty was endorsed by the Polish premier *Pilsudsky*, who was later assassinated to avoid any reconciliation, and provoke a German-Polish war. Why?

Because the betrayal of Germany and the Versailles treaty were brought about by communist Jewry and capitalist Jewry in the West, and the Nazis knew it and were preparing an invasion of the USSR, and Poland was the only obstacle to such a contest; and without a world alliance to save Bolshevism the USSR was lost if it stood alone against Germany.

The "9000" understood that Germany was a threat to their world domination based on the economic model of the gold standard, and the monopoly of the money flow system, which they controlled since the fraudulent passage by the US Congress of the Federal Reserve Act, which gave Jewish bankers, during the *Woodrow Wilson* administration, control of the issuance of the dollar by privatising the *Federal Reserve*.


So there were two causes for provoking a world war against Nazi Germany, to save Jewish banking and Jewish-led Bolshevism sponsored by Jewish New York bankers.

The political and social conspiracy sustained by Zionist propaganda succeeded in rallying 134 nations against Germany, which was reduced in a war of attrition.

Meanwhile the Germans were operating in France, in territories that were once strongholds of the Cathars, the famous heretical sect of the 13th century, embarking on a search for the keys to decipher an ancient knowledge rescued by the **Ahnenerbe** that would allow them to develop a novel technology that they would use to balance the scales in a world war that was becoming unfavourable to them in the face of the overwhelming power of the greatest coalition the world had ever seen.



Germany during the Nazi regime invested enormous sums of money to support research into Germanic ancestral heritage. The *Ahnenerbe* was a kind of National Service of higher than ministerial rank, which the Nazis institutionalised for purposes that could be framed as a national priority. In the book *'Lucifer's Court'* Otto Rahn a



a leading expert in Catharism in the service of the SS *Ahnenerbe*, recounts the expedition he undertook in *Languedoc*, France, commissioned by *Heinrich Himmler* himself, *Reichführer* of the SS, to unravel the Cathar mystery.

Until mid-1944, the Germans managed to push the technological limits of conventional science in vogue at the time, developing jet aircraft of various kinds, rocket planes, stratospheric guided missiles, electric submarines of great tonnage and incredible speed that even entered combat, as well as the "*Wunderwaffe*" or atomic bomb, which was never used for strategic reasons. All this technology would fall into Allied and Communist hands at the end of the war, triggering the arms race between East and West known later as the "cold war". German atomic bombs would be used by the US to force Japan to surrender.



Faced with the Allied advance and the withdrawal of the German armies, exhausted but not defeated, an attempt was made to gain time for a major evacuation; destination: the Antarctic continent. The statements made by Admiral *Dönitz* in his memoirs highlight this possibility, making it now understandable why the Germans were determined to delay the Allied armies that were converging on all fronts towards the *Reich*.

In their eagerness to take the German capital, the Allies forgot that powerful, intact forces of the German navy, army and air force remained virtually unoccupied.

to undertake the Antarctic enterprise from the Norwegian fjords aboard huge submarines and devices never before seen by human eyes.

When in May 1945 the Americans reached the *Elbe* and the Russians took the German capital, no trace of the *Führer* was found; then the Allies, with great concern, on gaining access to official *Reich* archives, noted that hundreds of selected SS squadrons had disappeared, as well as 120 submarines, and entire factories producing those unknown devices that thousands of witnesses had had the opportunity to observe in the last months of the war.

The interrogation of prisoners of war revolved around two fundamental questions: where was the *Führer*, where were the 120 U-boats, and where were the 120 U-boats? The Bunker, a network of tunnels covering almost the entire Berlin area, was lost in an endless labyrinth, overwhelming the Allies; several scouting teams arrived at forks, finding to their great disappointment that the entrances had been sealed. All of Berlin is a labyrinth of tunnels hundreds, perhaps thousands of kilometres long.

Since 1939 the Germans have been carrying out expeditions to the Antarctic, bringing the Allies more than 6 years ahead in the exploration of those regions, and since they were now in need of verifying the existence of German bases on that continent, they decided to call on Admiral *Richard Byrd*, one of the few experts in polar lands, to advise a large-scale expedition with a large military contingent or tactical task force in anticipation of encountering armed resistance, which would be led by Admiral *Richard H. Cruzen*; this was 1947.



Operation *Highjump* will be executed by *Task Force 68*, which is composed of 13 ships, including icebreakers, destroyers, cargo and supply tankers, hydrofoil launchers, a communications ship, a submarine, the *Sennet*, and an aircraft carrier, the *Phillipine Sea*; the total number of personnel embarked is 6,000.

The strange declarations of *Byrd* in the face of the lurid mission that returns with serious casualties from the expedition; the secrecy of the governmental bodies, suggesting that the Nazis are behind everything, the matter will become classified state secret material, as it really happened, and in 1948 the *Roswell* case will attract the attention of a confused public opinion.

The Cold War serves as a cover for the superpowers to embark on a major programme of technological expansion in armaments. They must be prepared to counter the new Nazi threat looming in the Antarctic at some point. Meanwhile the "UFO" sightings increase and the campaign of disinformation and subliminal messaging intensifies.

This campaign to discredit Nazism included the reprogramming of Allied war propaganda revolving around the "Jewish holocaust", the gradual demonisation of the German people, and the deification of the Jewish model with a new form of Israeli nationalism. The state of Israel was born, sustained by the war reparations paid to it by Germany.

In Argentina, Bolivia, Brazil, Paraguay and other South American countries, a "Nazi network" is beginning to operate, consisting of specially commissioned echelons which have escaped Allied control. The mission is clear: to create the conditions in those countries for future political action groups to form a new national socialism oriented towards the possibility of a potential German revival. These conditions will depend to a large extent on the economic, social and political independence that these nations can sustain in the face of the globalising onslaught of the super-capitalist juggernaut and its world organisations.

Argentina will be the biopolitical base, Bolivia the base for economic independence free from the financial and stock market control of the superpowers, as well as Peru, Colombia and Venezuela, which cushion capitalist pressure with the growing cocaine market, as well as being the source of major strategic resources.

In the 1980s Argentina was seen as a third world power; it had rich human resources, great industrial and technological development, but also great nationalist reserves that could be linked to the Antarctic refuge.

The superpowers are alerted by "Chilean" leaks, in which Miguel Serrano plays an important role, and they design the "*Condor Plan*", precisely so called, to clip its wings. The Falklands War is an excuse to establish the bases that the superpowers need to gain a foothold in the Antarctic threat.

## 4. THE WONDERS OF THE THIRD REICH.



30 January 1933, *Adolf Hitler* is appointed the new *Reich* Chancellor; A *Reich* burdened by forced unemployment - there are more than 7 million unemployed - hyperinflation and the devaluation of the *Weimar* Republic's currency, a completely dismantled heavy industry, social fragmentation promoted by German communism, political chaos mitigated in part by the strong parliamentary presence of the NSDAP, and the worldwide economic depression brought on by Jewish bankers in America known as the "Great Recession".



The *Führer* faced strong political opposition. The miracle of German revival is made possible by a revolutionary economic system, in the first instance, and by a peculiar administrative management revolving around national pride driven by a psychosocial spring, Honour as a guiding principle of individual and collective conduct.

The new monetary system replaces the gold standard with the hour/labour standard. The abolition of the gold standard serves to free the issuance of the new currency from the limiting burden of international reserves, completely nationalising the flow of money which would now be regulated by the hour/labour standard. 
An army of workers was recruited from among the seven million unemployed through a new National Labour Service, the "*Reichsarbeitsdienst*", which became compulsory for all Germans between the ages of 19 and 25, restoring the nation's work ethic and culture. Just to equip these seven million unemployed with tools, boots and uniforms, German small and medium-sized industry was revived.

In the first five-year plan these new systems transformed Germany into the world's leading power. The total rehabilitation of German industry was achieved, 2 million houses were built, agricultural production increased fivefold, 12,000 kilometres of new roads, the famous "*Autobhan*", were paved, forced unemployment obviously ceased, to the point of generating a large number of new jobs.

Excellent international relations were established for trade and barter, and many Latin American countries benefited from receiving German technology, machinery, training of technicians and engineers, in exchange for raw materials and strategic resources, without borrowing money, without the need for foreign exchange and without the help of financial intermediaries.

Germany was conquering the world, without armies, without firing a shot.



## 5. THE SOCIETY THULE.



Nothing is accidental. Everything is the product of a long distillation that has a culminating point. It is the story of the "secret" Society known as the "*Thule Society*".

Thanks to a text only circulated in initiatory circles by an extraordinary Argentinean scholar<sup>1</sup>, "*The Secret History of the Thulehesellschaft*", we now know that the genesis of this secret society goes back to the 16th century and the Holy Roman King *Rudolf II*, who was known as the Alchemist King because of his great fondness for the occult sciences.

Spain and England were at war; Queen *Elizabeth*, in order to have an agent to inform her of the movements of *Philip II* the Catholic, arranged for *John Dee*, an adviser to the Elizabethan court, to go to Prague, capital of Bohemia and Moravia, and infiltrate the court of *Rudolf II*, a relative of the King of Spain.

Doctor *Dee*, renowned for his knowledge of mathematics, astronomy, astrology, hermetic wisdom and alchemy, was well received in Prague and quickly gained the confidence of the Alchemist King.

*John Dee*, thanks to the study of the works of *Tritheim* and *Cornelius Agrippa*, managed to decipher what would be known in occultism as the "*Enochian Language*", the simple knowledge of these signs and symbols would be enough for him to acquire an inhuman knowledge, with which he was able to verify and make a third type of contact with entities that inhabit the higher spheres of the material universe.

These "superiors", whom *Dee* referred to as "angels", would order the constitution of a secret society; *Rudolf II*, who experienced in a ritual session their terrible presence, played a preponderant role in the foundation of the *Sapiens Donibatur Astris*.

Already in Poland and Germania, *Dee* and *Wilhelm Rosenberg*, as well as selected members of eight families of the highest and purest aristocracy of those fiefdoms would found the *Einherjar Order*. This order would last for almost two centuries; one of its most prominent initiates was *Frederick William IV* of Prussia; the legacy would later pass to a new group of initiates who would found the *Germanenorden* at the end of the 19th century.

In 1918, one of the *Germanenorden* circles founded the *Thulegesellschaft*, or *Thule Society*, the mother of the *SS Black Order*. The initiates of the *Thulegesellschaft* formed the senior cadres of both the National Socialist Party and the Nazi Praetorian Guard, or *Shutzstaffel*.

### ***The Runes.***

We said that Dr. *Dee*, with the help of alchemical books on *steganography*, was able to rediscover the "*Enochian*" language, and that with it he was able to contact entities from a higher sphere of existence.

*Steganography* is a kind of semiotics applied to cryptography, which in *Thitheim's* case, was concerned with a type of symbolism that at the time was outlawed by the inquisition, which was repulsed by everything pagan that was

condemned by the Church as heretical.




It is now safe to say that these symbols were runic.

The runes have come down to us through a Norse alphabet called "*Futhark*" which has 18 signs. Some include other derivations up to

24. This alphabet operates exoterically, assimilated to the letters of the Latin alphabet, and is only used in that sense. Some runic "shamans", moreover, confer a singular significance to each rune, and although the sense is more esoteric, since the meanings are attached according to

to a peculiar interpretation of Norse cosmogony, it is more akin to a kind of *mancia* or divinatory art, which assigns random meanings to the

runic symbols in the style of the *Tarot* or the *I-Chin*. Although each rune has a Latinised name and is pronounced semantically the same as any name using Latin phonemes, it is obvious that we do not know the original phonetics of each rune, its sound, and thus the idiomatic syntax; and without these elements it is impossible to understand it as a phrasal, i.e. phonetic, language. The "*Enochian*" language or language of the "angels" has become incomprehensible.

It is in the Norse and Germanic myths and traditions, for example, that the great heroes, such as *Siegfried*, must understand the "*language of the birds*" before they can perform their deeds. And this is an important key that will allow us to explain the subject of the runes in more depth.

In the case at hand, Dr. *Dee* not only accessed the approximate conventional meaning of the runes, like the runic "shaman" of our day, but their deeper meaning, to such an extent, that he was able to verbalise them with their original phonetic acoustics, and produce strange parapsychological phenomena.

And that is exactly what an INITIATIC chain aims at, to transmit the keys that will allow the initiate to access the transcendent senses and realities that lie behind the visible symbol; in the case of the "*language of the birds*" or the *Enochian* language, if achieved, the leap is not only gnostic, but interdimensional, MUTATING the psychological nature of the initiate, opening the doors to pure possibility: THE VRILL.

### ***Tartessos.***

*Tartessos* or *Tarshish* was a powerful nation located in the Iberian Peninsula, modern day Spain. It is very interesting that it has biblical references; in *Genesis 10:4 Tarshish* is a lineage that descends from *Javan*, one of the sons of *Noah*; (Take into account that *Noah* is NOT JEWISH, *Judah* does not exist yet, neither does *Israel*, and that very possibly the flood myth has been taken from the much older *Summer* tradition, where "*Noah*" appears with the name of *Uptanishpin*). To avoid sensitivities in this regard, we will say that the lineage of *Javan* is CAINITE. Let's see: *Noah* father of *Javan* is the son of *Lamech*, who in turn is the son of *Methuselah*, this son of ENOC<sup>2</sup> (the one who spoke face to face with the angels), and whose ancestor was CAINAN, that is, *Cain*.

From the same biblical reference we know that *Tarshish* lasted for millennia as it possessed a powerful merchant fleet in the time of King *Solomon*, long after the flood.

The culture associates the runes with the Indo-Aryan race, and rightly so, but that is not their origin. The origin of the Indo-Aryan tradition is not *India*, but *Atlantis*, since the Indo-Aryan stock comes from that very remote civilisation of which we are told by the

*Vedas* and the *Mahavarata*, which are the sources of the *Baghavat Gita*, the holy book of India.

In reality, *Tartessos* would be an Atlantean colony, just like *Noah* and all his descendants who survived the flood that drowned their ancestors. And this is important, since we are talking about the runes, they have their origin in *Tartessos*, from where they spread to the rest of Europe first, and then to the Urals, Mongolia and the Indokush.

According to the Tartessian myth, which coincides with the Norse, Germanic and Pelasgian myths, the runes were conquered by *Navutan* (Tartessian name for the god), *Wotan* (Germanic name), *Prometheus* (Pelasgian name) who voluntarily self-crucified himself in the tree of dread *Yggdrasil* for nine nights and its days, in order to penetrate the secret of death and gain immortality, then bequeathing this knowledge to the

Aryan peoples. However, according to the myth, *Navutan* fails in his task and dies before achieving it. It is his sister *Freya*, his wife, who reveals to him the runes that make his resurrection possible.

Clearly the myth contains the implication of a transcendent meaning of the runes. Approaching the mystery is not easy, but fortunately we have the biblical myths at hand to make some inductions. The myth of the Tower of Babel suggests that the gods had to confuse the language of men to prevent them from "achieving whatever they set their minds to". For those who believe that the bible affirms only one god, the divine sentence is very contradictory in this regard: "Let us go down and confuse their language"; *Nimrod*, who is credited with building the tower is also a Cainite, a close cousin of *Tarshish*, for his father is *Cush*, *Javan's* grandnephew.

To confuse a language, you have to degrade its symbols. We can see the tremendous degradation of our language today,

It goes without saying, and examples abound, but for explanatory purposes we will only take one that concerns our democratic culture plagued by corruption and lies. All politicians today claim that ethics is a good thing, when in fact ethics is neither good nor bad a priori, since ethics, from the Greek *Ethos*, means conduct, and conduct can be either good or bad, depending on how you look at it. This example is enough to show the misuse of language, and the ignorance of the true meaning of words. And beware that it is not just a question of carrying a dictionary under one's arm.

To avoid this cultural degradation, which is the strategy used by the enemy to destroy nations by degrading their symbols, the Tartessians formed an elite to guard *Navutan's* legacy. In this sense, the initiates made use of a symbol very dear to the pagan peoples of the blood pact: *Navutan's* sister wife, *Belicenna* for the Tartessians, *Freya* for the Norsemen and Germans, and *Venus*, among many other names, for the Pelasgians.

The Goddess was carved in the shape of a Gorgon to preserve the symbolism in her serpent hair. The Tartessian alphabet consists of 13+3 *Vrunas* or runes and therefore the hair of the Tartessian Gorgon is made up of 16 serpents that represent those significant principles. But for generations the Tartessian initiates guarded the legacy, until the destruction of *Tartessos* by the Carthaginian invasion commanded by *Amilcar Barca*.

Then the arrival of the Romans brought the Goths; the lords of *Tarsis* became related to the Gothic royalty, and thus arose the *Tarstein* lineage, which lasted in Austria and founded together with the initiates of the *Sapiens Donibatur Astris* the *Einherjar*.

## 6. THE SUPERMAN.

We have come a long way to reach this point, the reunion of man with THE PRINCIPLE OF SUPERIORITY.

To achieve a higher state of being, an integrated state, is the goal proposed by *Friedrich Nietzsche* and a whole *Völkish* Aryan philosophical current, promoted by orders, closed societies and brotherhoods such as the *Thule Society*, and which was taken up as a challenge to the political administration of the state by the Black Order SS in its quest to form a nationalist elite.

We are a far cry from the misrepresentation that the establishment culture pigeonholes as "racism", pretending to justify its denialist stance against Nazism.

As the issue of race is taboo in a democratic culture based on the paradigm of extreme egalitarianism, it is necessary to take care to clarify this subject, which is very easy to explain but difficult to understand because of the moral and sentimental implications it generates.

What should we understand by superman?

What the common people of our day think about this reflects a state of confusion bordering on the most childish cretinism: Germans "THINK" they are superior because they are tall, blond and blue-eyed (note that this poor opinion deliberately omits the word BEAUTIFUL), something very typical of those who suffer from an inferiority complex.

Let us reflect a little. Given the marked degree of materialism that corrupts humanity, it is not unusual to find that when we speak of superiority its reference point is aesthetic, and also economic. The most beautiful is superior, and if this is not the case, the one who possesses the most things.

And it is true, materially speaking; the white race may be one of the most beautiful and prosperous on the planet. BUT IT HAS NOTHING TO DO WITH THE PRINCIPLE OF SUPERIORITY, which the *Völkish* and Aryanophic initiates in Europe in the 20s and 30s, and which referred to a beauty or loveliness that only an integrated superman or woman, awakened to his or her racial potency, that is to say, ancestral, is capable of expressing, which would imply the reintegration of the flow of pure blood of the primordial ancestor. A whole recovery of meanings and meanings.

So the concept we must learn to use in order to understand the phenomenon that stirred the resurgent German pride of the Nazi "era", is that of

SPIRITUAL RACE. That is, to understand what is meant by an Integrated State of Being, which in mythical language, would be the legacy of the Germanic *Wotan*, that semi-divine man.

who became a god by self-crucifying himself in the tree of dread, attaining the secret of immortality, in the manner of the Greek *Prometheus* who stole the fire of the gods Well may the deed be seen as pointing to the conquest of an Integrated State of Being.

People sensitive to metaphysical realities, intuit this power as inner beauty, but if it is inner, then it cannot be contemplated, as we contemplate a playboy model, a suggestive bikini, or the hedonistic ostentation of a tycoon or millionaire. No.

It is necessary for the bearer of inner beauty to EXPRESS it through a manifest conduct in whatever act he or she performs. As we said before, we are far away from the simple aesthetic or quantitative concept. Now we are talking about VALUES, about VIRTUES.

And, obviously, when we speak of integration, we allude to the fact that the plexus of man is composed of three agents, and that only integrated will express the highest rung of them, that agent who can connect with the VRILL and assert himself in that centre.

And although it is somewhat odious, it is necessary to make comparisons in order to understand this issue, which will be of vital importance in reviewing the "UFO" phenomenon.

### ***General psychological physiognomy of present-day man or not Integrated.***

When we speak of today's man, we want to refer strictly to the globalised citizen of the West, whose existence unfolds in a post-World War II era and who is shaped in a society that exalts above all nationalism a global democratic culture. Let us not forget that this globalised man, in whose image we must all reflect ourselves, since we live in the same reality and context, lives completely disoriented about the true nature of the Nazi phenomenon, due to the constant media and educational propaganda campaign to which he has been subjected during the last 66 years.

With the help of this scheme it will be easier to explain the psychological physiognomy always in general terms, it should be noted.

Well, psychobiological processes generally operate on a subconscious level, and although we either intuitively sense or perceive the mind-body interaction, it is difficult to

to understand and accept the reality of psychosomatic integration. This error, more than simply gnoseological, has made man dependent on the physical stimulus to *cognise*, but we say that it is his only semi-conscious reality, because he has no possibility of identifying the cause of the stimulus, which is always metaphysical, or if you prefer, psychological, with the exception of the external phenomenon that could stimulate his senses. In this case the external stimulus works the other way round, i.e. the effect and no longer the cause is psychological and equally subconscious.

Let's see, today's man is unable to detect psychosomatic dysfunction, perceiving only the symptom, which results in his clinical dependence. Hypochondria, lack of resistance to illness, physical weakness, and MENTAL. Of course, the mental is here only a subconscious perception of its ontological reality.

The soul manifests itself as energetic tension; that is why it is difficult to perceive it, it is energy, and although a culture of peace doses the tension in the collective subject, passions must always be channelled by systems of social control, in this democratic and globalist context, religion and entertainment are the only escape valves allowed. However, social conditions should be optimal for this to work, and they are far from optimal. Poverty and misery are variables that the system cannot do without when it comes to generating tension, because the tension of the individual and collective soul, feeds and coheses the superstructures in which man lives inserted; this tension, which is reflected in social unrest, insecurity, high crime rates, etc., are necessary for the system, and that is why corruption and lies are endorsed as a cultural model.

Man, not knowing that tension is a conditioned reflection of his soul, feeds the superstructures incessantly; reflecting upon this, we can appreciate that the soul functions, that is, is functional, but the individual is unconscious to its process, though to some degree self-conscious. If that self-awareness is heightened by the practice of some form of meditation, yoga, mind control, etc., the soul becomes semi-conscious to the individual, achieving, if evolution on these paths of "enlightenment" is constant, some control over the tensions.

For these reasons we affirm that the common man is a manipulable subject for the techniques of social control, because his volitional force only obeys the conditioned stimulus, or is simply too little to dominate his plexus.

As we have seen, while the average man may be relatively conscious to the agents of his plexus, body and soul, he is completely unconscious, at a deep level, to the most important agent of his complexion, the spiritual; and we say it is the most important because it is extrapsychological, it does not participate in the psyche, though it manifests through it. We will try to give some guidelines on this mystery below.

### ***General Physiognomy of the Semi-integrated Man .***

Before we begin, let us make a clarification. When we refer to integrated man, we will assume that he is a model recovered from the original ancestor, or in his

to what the indications lead us to assume was an initiate of the *Thule* or the *Black Order SS*.

Let's try to portray a semi-integrated individual.

For the ancestor, his environment is a closed community of blood and race. In the case of a German SS aspirant, a biopolitically homogeneous nation, with a strong sense of nationality. This subject, either because of the interference of a foreign religion, remember that Judeo-Christianity has detached him from his racial gods, and supplanted them by a purely Judaic theological principle, or because of a multilateral imposition that has dispossessed him of the control he had over his own nation, for example, the Germany humiliated by the Versailles treaty, will feel that the context in which he lives loses meaning, and that if he does not rebel, he will have to endure an imposed existence; In other words, his strategic situation has changed from the relative freedom he enjoyed in his closed community to a state of utilitarian slavery, which is evident in the obligation to live according to a psychological type that no longer corresponds to his sense of fulfilment.

Logically, outside the closed community of blood and race, there is a world marching towards globalisation, and the price of globalisation is high, for it demands that all think and feel equally in political, social, economic and religious matters. Stripped of their royalty, of their monarchy, democracy is imposed on them, stripped of their currency and their economy, the dollar and the free market are imposed on them, stripped of their closed political nation, an open economic community is imposed on them, stripped of their national pride, a humanist culture is imposed on them, stripped of their individuality, communism is imposed on them. Stripped of their fighting spirit, a poverty of spirit based on the moral obligation to express tolerant love is imposed on them.

A man or woman who has recognised this situation, marches in the opposite way to the world, and is a serious aspirant to become an integrated man.

Now the question: Why do we claim that a man who has glimpsed this situation has a semi-conscious plexus?

Starting from always general guidelines, we will say why such a subject manifests a greater psychobiological robustness, because of his or her evident attitude of defiance to the prevailing system. A man or woman who marches against the world must become accustomed to fighting, fighting, fighting. And if he has not yet unravelled his strategic situation which disqualifies him from taking a political stance, he will seek the fulfilment denied by the system by following all the paths he considers will lead to it, always on the move,

pulled or pushed by a powerful FORCE OF WILL. He is then said to be semi-conscious of his spiritual plexus.

Evidently, this VOLITIVE agent is a differentiating factor, which enables one individual to be distinguished from others. There is no doubt that people who excel in their applications and activities belong to this type, perhaps one in twenty or thirty.


### ***General Physiognomy of the Integrated Man or Superman.***

The goal of Initiation is to achieve the Integrated State of Being. As we have been able to appreciate, reaching semi-integration is in fact an achievement, imagine achieving an Integrated State, such a feat was envisioned in Nazi Germany, the psycho-social strategies that the Hitler regime managed, were aimed at shaping that elite that would be the ruler of the German National Socialist nation.

The national structures that were to recruit the applicants, the best human element of the *Reich*, operating as selection filters, were based on the *Hitler Jüden*; this was the starting point for selection; In order to receive the most suitable element of this youth group, the NAPOLA or *Nationalpolitische Erziehungsanstalt* political schools were created, which were endowed with a comprehensive curriculum that would be inconceivable by today's Western educational standards, and already far, far superior; physical education at all levels, military training, survival, forensic investigation techniques, language faculty, social psychology, Germanic history, oriental cultures, engineering

aeronautics, as well as philosophy and literature, mathematics, astronomy, social sciences, political science and, of course, occultism. 

That is to say, initiation empowers him to be conscious of the volitional agent, making it the centre of his microcosm. ## 7. THE GRAAL.

The *Graal* would be an *interdimensional* agent of an extraterrestrial, or if you prefer *extra-universal*, nature, and indications suggest that it is indeed an agent outside the material universe.


How?

We are going to explain it step by step, as it is a very important key to the whole UFO phenomenon, from our particular point of view of course.

We said that the *Anhenerbe*, a firm specialising in the research and recovery of Germanic ancestral history and traditions, commissioned the formation of a technical commission to investigate the Cathar legacy, in *Languedoc*<sup>3</sup> in the south of France.

### *Who were the Cathars?*

According to initiatory traditions, the Cathars are the most recent trace of the *Grail*. Well, the Cathars were, according to the official culture, a "famous" heretical sect of the 13th century. For us, the Cathars were a politico-religious movement that brought the nation of *Oc*, better known as *Occitania*, in *Languedoc* in the South of the current Republic of France, to its peak.



Although it was not a strictly political movement, we could now say that it could easily be classified as a political tendency, rather than a sectarian and religious one, which is how culture shows it to be. Yes, the Cathars belonged to a closed order of men and women who professed a way of life based on a peculiar vision of Christianity, but with political aims, since during their pilgrimage throughout the country to spread the Cathar principles, the great majority of the Toulouse royalty and the Occitan people converted to the Cathar faith.

Catharism; a state was consolidated and governed according to a novel political postulate that revolved around the social, political, economic and religious autonomy of *Languedoc*, i.e., strictly speaking, the Cathars were the creators of modern nationalism.

Of course, his doctrine put into practice generated tremendous friction with the suprapower constituted at that time by the Catholic Church, which had tuition over royalty, that is, it was above the State, and therefore controlled the financial system; the Church had gradually become a supercapitalist instance, which planned to form a kind of world banking that would be

by a specialised order, a kind of priestly militia known as the Templars, in order to introduce the flow of their enormous capital through new forms of financial intermediation and borrowing.

How the Cathars managed to "nationalise" religion is a fascinating story, which we will try to explain very briefly. The importance of religion is that it imposes the psychological type of a community, and this is the basis of its domination. This is why the Cathars, if they aspired to the social, political and economic autonomy of *Lanquedoc*, first had to control the psychosocial levers, which were in the hands of the Catholic Church, which at that time, in the 13th century, was imposing the Judaic type by adopting the form of Judeo-Christianity, causing great unease among the peoples, most of whom were still pagan, who were under its orbit after bloody wars of conquest that forced their obligatory conversion to this religious model.

Logically, the early church fathers had turned primitive Christianity into a purely Jewish religion, making Christ, the fundamental theological principle of the original Christianity, a face of the Jewish *Jehovah*, a deity totally opposed to the ancestral traditions of the pagan peoples. And this imposition not only created a growing social unrest, provoking violent reactions and wars, but was a clear demonstration of the hegemony that a priestly caste with great influence within the Holy Catholic Church, acolyte of *Jehovah*, intended to impose on the world.

The Judeo-Christian church was thus faced with three obstacles in carrying forward its project of globalisation: the Muslims, who competed with it in their quest for religious hegemony; the heresies, who sought to return to primitive Christianity of the Gnostic type and to be ruled by another psychological type; and royalty, which from time to time produced a king of pure blood who sought to assume temporal and spiritual power over the pope.

These three "obstacles" were inspired by a "principle" that has come down to us under the name of *Graal*. Let's see, Muslims were guided by two essential guidelines: to always orient themselves towards a STONE of extraterrestrial origin, kept in the *Kaaba*, and to follow the holy war or jihad as a way of life. The "heretics", on the other hand, questioned the misrepresentation of Christianity, to which they opposed the legacy of their initiatory schools that were still kept underground, and which, under the precepts of a primordial tradition, impelled them to deny the reality of this material world for that of a spiritual world, free from any kind of determinations; As for the kings who rebelled against priestly rule, they claimed to remember by blood a direct lineage with their racial deities, which urged them to reject the cult of the One god and his all-encompassing religion.

Now, the Gnostic heresies always referred to a STONE, which would be the proof of man's divine origin, a lineage that would make him equal to any deity,

including the Jewish creator god. And that, precisely, was the claim of the rebellious kings. Manichaeism, another Gnostic source from which all heresies drew, also refers to a gem.

So this, let us call it "essential rebellion", would be inspired by a stone; the church knew of its existence, and tried by all means to eradicate it, and argued, not without reason, that this stone of scandal belonged to Lucifer. Hence it is claimed to this day that everything "bad" in the world, in particular Nazism, comes from the Luciferic legacy.

And let us clarify, **Lucifer is not Satan**; for those same heretics we are talking about, **Satan would be Jehovah**, the creator of the illusory world of matter, the demiurge. Not for nothing did the Cathars call the church of the Popes, the **Synagogue of Satan**.

### ***Misrepresentation of the symbol of the Graal.***

The *Grail* is better known today as the "*holy grail*"; the Judeo-Christianised myth has removed the stony character of the symbol, turning it into a cup with which *Joseph of Arimathea* manages to collect the blood of Jesus Christ, and then embark to Druidic territory in order to preserve the legacy. *Dan Brown*, in his famous esoteric novel "*The Da Vinci Code*", has further nuanced this change of meaning, claiming that the grail would be the descendants of *Jesus*; that is, Jesus had the Magdalene as his wife, who after his crucifixion fled to France where her lineage would have persisted to the present day.

OK, now let's look at the original *Graal* myth, but be prepared for a big surprise.

According to the "original" myth, and this is in quotation marks because those who spread it have also distorted the myth, their initiatory schools being notoriously *anti-Lucifer*, teach that the *Grail* is indeed a stone, torn from its crown in a stellar combat, and that in its fall it dragged down a third of the stars in the sky. In this version of the "original" myth *Lucifer* would be a "loser" in the celestial combat against *Jehovah* and his hosts.

However, the much older Tartessian tradition teaches a very different version of the myth; and for reasons that at this stage of the story seem to us to be quite different.

obvious, we consider a much more reliable source than the culturally accepted ones.

This ancestral myth shows us a *Lucifer* completely outside this creation; this because he would be the great chief of an extra-universal race, this affirmation about the origin of Lucifer outside the created universe, is very important, since the culture takes him

always as a secondary power of lower rank, and moreover, created by the god of this creation.

According to the Tartessian source, his presence in this universe is due to a principle of LOYALTY, towards other members of his own race who had been imprisoned through deception and betrayal of the animal-men, creatures of the god of this creation, in order to take advantage of their volitional contribution, that is to say, their energy, to accelerate their slow evolution. *Lucifer* decides to install himself in the universe as the BLACK SUN behind *Venus*, after he has been the protagonist of his own descent into the world, in order to manifest himself to the men who bear his racial sign, and to teach them a way of liberation; the enchainers, among whom are some chiefs of his own race and who were the protagonists of the original betrayal that caused the mystery of the spiritual enchainment with the stated purpose of making a place for himself in the created universe to remain indefinitely, provoked a terrible struggle that ended with the sinking and destruction of Atlantis.

The survivors of the great war, including many peoples who bore his sign, a clear sign that many had not yet been able to free themselves, would live in confusion, resisting the seduction of the powers of matter, and it was at that moment, when the enchainers considered their victory over *Lucifer* to be certain, that Lucifer dropped a stone from his crown in ARRAS, which would tear the veil of the 600,000 worlds of illusion and would serve as a sign until the end of time of the HONOUR and MEMORY of the fallen from the Origin as a record that they would never be forgotten or abandoned, until the last of them achieves liberation; so that whoever points out and recognises that gesture will in turn be recognised as a legitimate member of the *Court of Lucifer*, the great spiritual leader of the race, endorsing him to carry out the great deed of spiritual liberation.

So much for the Tartessian myth. It undoubtedly reached the Cathars through contact with the Occitan and Iberians, at the right historical moment, since, as we have seen, the *Grail* manifests itself when there is a group of semi-integrated men who sense its presence because they see that there are several aspirants to the royal function who can lead a collective strategy of liberation. Let us remember that the coexistence of *Frederick II of Hohenstaufen* in the West and of *Genghis Khan* in the East coincide and synchronise with the Cathar rebellion, both bearing the sign of the Luciferian race on their banners, they are conquerors, warriors and anti-priestly.

This is why the Cathars had to implement a strategic encirclement around *Languedoc*; for the *Grail* to become visible, a square had to be liberated, that is to say, to make the whole kingdom share in the possibility of liberation, by restoring the rediscovered symbols to their collective psyche, which would give a new meaning to Christianity, which is always accompanied by a mysticism that instilled in the people a powerful will to AWAKE from the deception; This fervour is so great in the Cathars that they are capable of channelling it as *Paraclete*, the holy spirit<sup>4</sup>.

In addition to criticising the materialism of the Church, which they called the "*synagogue of Satan*", they preached that the material universe was a hell that had been the work of a demiurge or imperfect second-rate god; they practised asceticism because

They considered the hellish world to be sustained by the fleshly work of the clay bodies, which the "fallen angels" were led to commit without understanding that it was sin.

To spread these meanings, the Cathars made use of the *Trovar Clus*, with the marked intention of bringing the language of "Oc" closer to an unprecedented semantic precision. The Church considered this language heretical and encouraged its disappearance after the bloody and genocidal crusade it launched against the Cathars and Albigensians of *Languedoc*. But what matters to us is that the semantic precision achieved by the Occitan language has to do with the presence of the 13+3 *Vrunas* or runes of *Navutan* in the strategic action of its initiates.

The Cathars convey their message through the romance that exalts the symbol of the couple. There is a very important detail about the Tartessian myth of the *Grail*; *Lucifer* is summoned to free his companions by the *Virgin of Agartha*, that is, the goddess *Belicena*, the Tartessian Gorgon. Once again it becomes clear that in order to access, or contact the *Grail-bearers*, one must first master the meaning of the 13+3 runes and express the *language of the birds*.




***Montsegur, the last Cathar stronghold. Its strange strategic wall technique can be seen.***

## 8. THE WALHALLA.



According to Germanic and Norse traditions, *Walhalla*, or *Valhalla*, is the "heaven" of heroes; it is also called by other names: *Asgard*, *Agart*, *Agartha*, which is a walled city where the *Äses* or *Äesir* reside. What is interesting is that this myth is repeated in other cultures, for example in Greek culture, which, although it speaks of *Olympos* as



residence of their deities, it also refers to *Hades* as the "heaven" of the warriors. The Romans referred to this place as "*the Elysian fields*"; the Tartessians called it *katagar*. For the Muslim world, those who die in the Jihad or holy war go to a paradise filled with beautiful Virgins. In Norse *Valhalla*, warriors are chosen by Valkyries, who are not only beautiful virgins but also fierce warriors.


Another interesting fact is that the *Äses*, or *Äesir*, would have lived among men; in the traditions of some Nordic peoples such as the Cimmerians, a remote war between the *Äses* and the *Vannir* was remembered; among the ancient Greeks the pattern is repetitive, the Olympian gods would have fought the Titans. The Hindu *Bhagavad Gita* narrates the battle of *Khurukshetra* between the *Kuru* or *Kauravas* and the *Pandavas*.

In the "code" of a disembodied warrior, who died in heroic struggle, with honour and chivalry in a waste of will or spirit, cannot be the same as for the "saint", who bows his knee to a deity, dies peacefully humiliated, expressing poverty of spirit. Hence there is one heaven for warriors and another heaven for priests. Again we see the dichotomy between ancient paganism and contemporary Judeo-Christianity. As the latter has become

culturally imposed, it is very difficult for modern man to assimilate this intrepid vision of man fighting against his destiny in search of an honourable death. Besides the fact that the ancestral myths have almost been lost by the action of the culture of the system, the globalised monotheism already expunges the existence of other heavens or abodes.

Fortunately we have the Tartessian source; and the conception of a single god and a single sky would be correct were it not for the strategic action of a virtuous maiden, who, according to the Tartessians, performed a feat that would be marked in blood in the collective memory of the people.

***The Virgin of Agartha.***



The myth tells that in Atlantis there was a very virtuous maiden, whose virtue lay in her unheard of yearning for the unknowable. Outraged by the terrible famine and misery that overwhelmed her people, she cried out to the unknowable with such fervour that she was heard and he showed her a way to *Venus*. When the maiden arrived at *Venus*, an envoy of the Unknowable awaited her to give her some cereal seeds, with which she would satisfy the hunger of her people, and a stone seed, which to her surprise would impregnate her with a stone child who would become a great liberator.

The stone child was born with a grace, the lithic wisdom with which he taught men how to build great stone walls.

With this, the origin of *Navutan*, who would be the stone child, is now clear. Now, we will try to unveil the myth, which clearly shows us the presence in this universe of beings from another superior universe, infinitely superior, who, by deception and

The treachery was trapped here and chained to the cycles of life and death of matter, animating a very limited and primitive hominid whose existential reality is pain. At the same time we will try to understand the meaning behind the symbol of *Walhalla*, which in turn will give us a glimpse into the strategy of the initiates of the *Thulegessellschaft*.

### *The Wall Strategic.*

It is of course very difficult to represent to ourselves the nature of an extradimensional being that is outside the temporal and spatial laws of the known universe. But we must make the effort since the understanding we can extract from this deduction will be very useful to improve our vision of this tremendous web.

We affirm that an extradimensional being who is not subject to the laws of time and space enjoys a state of total freedom. If this being crosses the threshold of the material universe, he will immediately sense danger, that is, determination, and if he decides to enter, he will do so clothed in hostility; covered, shielded, garrisoned; we must take it for granted that this being transits in a higher sphere, in which his state is divine, indeterminate, pure spirit.

Although we seem to be speculating, the explanation we have given in this regard seems to us to be extremely logical in order to induce a metaphysical reality.



## 9. THE BASE ANTARCTICA.

According to *David Pascual*, German exploration of the Antarctic continent dates back to 1873, under the patronage of the *German Polar Travel Society* or *Deutsche Polar Schiffahrtsgesellschaft*; the great voyages of the "*Grönland*" under the command of *Eduard Dallman* in Antarctic waters were full of new discoveries.

Eight expeditions were made up to 1925, and it was so important for the Germans to establish sovereignty there that even before the First World War there were plans to establish a permanent base in Antarctica.

But it was with the powerful impetus of the new Nazi regime that the largest expedition up to that time was prepared; by 1938 a polar ship, the "*Schwabenland*", specially equipped with steam catapults for seaplanes, had been prepared; the *Lufthansa*, with vast experience in the use of seaplanes for postal traffic in South America, was to take part in the venture.

What few people know is that *Richard Byrd*, then a US national hero, who had made daring exploratory flights over Antarctica in 1929, was invited for advisory purposes, He was to take part in several seminars and conferences of the *Schiffahrtsgesellschaft* held in Hamburg beforehand. In 1947, *Byrd* commanded the largest military operation in Antarctica in order to neutralise the German bases.

*David Pascal* states in his report: "The year 1938 saw the famous **German Antarctic Expedition**, which culminated in the seizure of an extraordinary territory, which was given the name of "*Neuschwabenland*" ("*New Swabia*"), inspired by the "*Schwabenland*" itself. "



From then on, the transit between Germany and "*Neuschwabenland*" increased steadily, carrying both civilian and military personnel, ultra-modern excavation and tunnelling machinery, as well as construction equipment.



specially designed to withstand temperatures as low as minus 60 degrees Celsius.

The transfer of personnel and correspondence to Germany was so fluid that even today, documents, letters and postal receipts are leaked from various sources, which are said to have been made by military personnel stationed in Antarctica, with stamps, values and special stamps; the trace of these personnel in their

Most are mysteriously listed in official records as "missing in action", or simply not listed at all.

During World War II, the *Kriegsmarine*, the German Navy, would have installed and regularly used the

Antarctic caves to refuel and shelter their submarines. One of these underwater accesses would lead to a large subterranean freshwater lake; recently satellite tracking has confirmed the existence of an underworld of gigantic proportions and particular climatic characteristics. These discoveries coupled with the bizarre statements recorded in the memoirs of Admiral *Karl Dönitz* suggest that the existence of such an Antarctic paradise may be more than speculation and conjecture: "*Die deutsche U-Boot Flotte ist stolz darauf, daß sie für den Führer in einem anderen Teil der Welt ein gebaut hat, eine uneinnehmbare Festung*", the literal English translation of which would be: "*The German U-boat fleet is proud to have built for the Führer, in another part of the world, an impregnable fortress*".

Julius Evola, a scholar of the esoteric background that permeated National Socialism, states that: '*The first expedition undertaken by the SS would have sought a connection with a secret centre of tradition, the other would have aimed at a contact with the occult Hyperborean Thule*'.

In fact, all scholars of this cultural version of Nazism's occult underpinnings take *Hans Hörbiger* as their point of reference, exploring the meaning of his peculiar worldview of a polarised universe of fire and ice, catastrophic moons and the hollow earth; it would seem that at least as far as his hollow earth theory is concerned, and from what we have seen so far, it would be true, at least in part.




The dissemination of recent "findings" supported by "satellite photographs" clearly indicates that a kind of vortex capable of generating a space-time anomaly of similar characteristics to the one found in the *Bermuda Triangle* is located in Antarctica. Unfortunately, for mere mortals like us, this information is not easily verifiable, even more so in the age of *photoshop*. However, we can argue that a serious analysis of the information we are considering suggests the factual possibility of the dimensional intersection, which would allow interdimensional transit accompanied by spatial and temporal anomaly phenomena. And just as we cannot prove its

existence, nor can we prove otherwise. That is, it is within the conceivable possibilities.

It is important to note that only Argentina and Chile have sovereignty over Antarctic territories under international law. However, the signing of the Antarctic Treaty in 1959 stipulates that Antarctica is a zone of free access for scientific research; although Britain has contested the sovereign territorial rights of Argentina and Chile, the Antarctic Treaty guarantees to some extent the sovereign claims of these countries over Antarctica. There were serious incidents between Argentina and Britain, but these were mitigated by the British presence in the Falklands. Significantly, the Antarctic Treaty System prohibits the militarisation of Antarctica by all signatory countries; only Argentina and Chile have military bases but for civilian purposes.

One of the main disseminators of the Nazi presence in Antarctica, the Chilean *Don Miguel Serrano Fernández*, considered among the most prominent promoters of "Esoteric Nazism", participated in 1947-1948 in an exploratory trip to Antarctica as a journalist, an experience that became one of his main literary sources. A convinced Marxist at first, *Serrano* would become deeply involved with the occult side of Nazism in the mid-1930s when he became involved with certain occultist groups in Chile steeped in the racialist mysticism so much in vogue at the time, when fascist philosophy was on the rise.

Also in 1973, one of the greatest scholars mankind has ever produced, the Argentinean *Felipe Moyano*, set foot on Antarctic soil, staying for a year at the *Orcadas* base, the oldest permanent human installation in Antarctica. Given the magnitude of his work and the unprecedented erudition it expresses, it is possible that that journey generated in him a kind of

catharsis, due in part to the proximity of the interdimensional anomaly, or perhaps the "*Neuberlin*" base. It is a mystery.

The truth is that he wrote twenty books since 1974, only two were published and three or four circulated in some circles by leaks within the esoteric groups that he formed; but for those of us who have studied his published work it is surprising to corroborate the statements that **"he had to evacuate 5000 books", "that he had eaten, "5000 books"..... "that he had in his head, the infinity of dates, places, where they happened, the how and the why, all that was a tremendous odyssey, and always, prepared to flee, since it is well known, that the occult and sinister forces, block everything and want to scare us or better yet, to frighten us.**


***They wanted to scare us into giving up, to move on, I have to admit that".<sup>5</sup>***

It is clear after a serious review of the works of these two authors that they know "something more", especially Felipe Moyano, who notoriously brings to his books a sense of strategic preparation for "**what is to come**". Both announce the resumption of hostilities at a time of maximum dramatic tension in the world, under a curious symbolism, the return of the *Wildes Heer*, the furious horde of *Ödin*, the last battalion of the "eternal SS".

In this context, Moyano is clear in affirming that the world war is not over yet, that the battle of Berlin was just that, a battle; and that since 1945 the Allies have been preparing to face it by developing a long term arms race, which is not justified, given that the USSR no longer exists and the military power of the USA over all the nations of the planet is total.

We would say that a reflective look at the current world context is obviously enough to realise that the war against Nazism is not over. That since 1945 the world has repressed any resurgence of this tendency by means of an extensive campaign of defamation, propaganda and laws; something which would have had no reason to exist if the Allied victory in the Second World War had been truly "total", which is the idea that has been tried to impose on public opinion and on the peoples of the world ever since.



## 10. UFOS NAZIS.

We have thus far provided sufficient guidelines to try to explain with some degree of certainty what this super-science developed by the Germans during the Second World War would consist of. The task is by no means simple, and both researchers and authors knowledgeable in the field, who have made great efforts to explain and disseminate elements that go far beyond any kind of cultural speculation and pseudo-scientific conjecture, deserve our deepest respect. This is the case of the Spaniard *Ignacio*



*Ondargain*, whose analysis of the issue on the website "*National Socialism and Myths*" is by far worthy of recognition and admiration.

### *Glimpsing the possibility.*

*Viktor Schauberger*, a brilliant Austrian inventor and scientist, was born in 1885 into a family of generations of foresters. Between 1926 and 1930, he patented a series of



applications in hydraulic engineering and turbine construction. Far removed from the "narrow margins" of conventional "mechanistic science", he devised a novel theory of power generation based on the **vacuum**. To arrive at this principle he worked tirelessly on the first **repulsion** engine. So far removed was his reality from cultural canons that in 1941 he was committed to a psychiatric institution in *Mauer Ohling*, Germany. He would later work at *Messerschmith* developing a turbine cooling system; and sure enough, his

provided a major impetus for his research, which ended in 1944 with the construction of a prototype of a vertical take-off aircraft.

According to the leaked "*Omega File*", supposedly from confidential files captured by the Allies, it is reported that *Schauberger's* research on **anti-gravity** devices had been successfully completed, serving as the basis for the development of spacecraft with this type of alternative propulsion, known as the *Haunebu* project.

### *Project Haunebu.*

*Hauneburg* is a village in the northern German province of *Hassen*, which would have served as the site of the *Haunebu* experimental programme. When the discoveries on *anti-gravitational* propulsion were well advanced, the engineers of the **Spezial Forschung und Entwicklung** set themselves the task of

select the most innovative aerospace designs that were capable of meeting the aerodynamic specifications required for *anti-gravity propulsion*. The circular model was the best suited to these specifications and designers such as *Rudolf Schriever*, *Arthur Sack* and *Andreas Epp*, who were working on circular wing aircraft designs in other conventional projects, would have been recruited to shape the first prototype of the *Haunebu*. *Kammler* would come to light recently made public on educational cable channels, as the alleged project "*Die Glocke*" (*The Bell*), along with speculation that this was associated with a kind of time machine or a "UFO" indistinctly.




The truth is that, incredible as it may seem, there is "abundant" photographic material of various *Haunebu* prototypes, including ground and in-flight images, as well as copies of basic structural design plans.<sup>6</sup> But perhaps the most striking photographs are those that were originally cut from film footage, showing details of the

model in test sessions, behind closed doors. In these tests, the engineers in charge were uncertain that the device's capacity exceeded their most ambitious expectations, and could not establish how it was possible that without acceleration, completely static, it was able to perform a **hyperdimensional transposition**. Moreover, some wondered whether it had actually jumped into another *hyperspace* dimension.

The *Haunebu* was also capable of achieving impossible accelerations and decelerations, with an ascent speed of 15,000 metres in three minutes and a cruising speed of 6,000 km/h, without effort; no critical performance data are available. In addition to the first prototypes, which according to the German historian *Stevens* had flown as early as 1939, other versions with notable structural improvements were built, such as the *Haunebu II and III*.

It is worth mentioning that one of the earliest and most famous photographs of unidentified flying objects was taken by *Goerge Adamsky* on 13 December 1952 from his telescope; interestingly, it fully matches the *Haunebu* model.

### *The alleged project "Vril".*



It seems that the "Vril" project was part of a larger strategy for the purpose of popularisation, though evidently driven by a very special circle of the **Thulegesellschaft**. According to some speculations, such as those of the Spanish writer José María Fernández (*Patric Ericson*), this circle was composed of the so-called "esoteric ladies" or "sisters of light" headed by *Maria Osríc (Maria Orschitsch)*, a "famous medium" who possessed special parapsychological abilities. *Osríc* was to show the Nazis texts that she had channelled and received from some beings


extraterrestrials, as well as the keys to decipher them, accessing the knowledge of an amazing technology.

It is possible to obtain several photographs showing *Osríc* in test installations of the "Vril", which is the name given to this model by the jargon of the aficionados of the study and collection of material about Nazi UFOs.

According to the report "*The Enigmas of the Third Reich*" by *JM Lesta* and *M Pedrero*, based on confidential files allegedly leaked after the disintegration of the KGB, 17 aircraft of the Vril-1 series with a wingspan of 11.56 metres in diameter and armed with a remote-controlled cannon were built.

However, it is important to note the following: *Osríc* was known in both internal and external circles of the **Thulegesellschaft** simply as *María*; and this is very significant since her representation was to serve as an argumentative support that would sustain the

mysticism as a possibility in rational minds of **what was to come**, a tremendous revelation that would overwhelm every conceptual continent, forcing an enduring door into the Origin, that is, into the possibility that the *Third Reich* would embody during and after the total confrontation with the powers of matter.



In this sense, it is no coincidence that now "another" *María*, the mother of *Luis Felipe Moyano*, has played the same role, announcing "**what is to come**", the reorganisation of the bases to actualise in this time and space the convergence of all of us with the terrible mystique of that possibility.

### *The Andromeda- Gerät.*

This UFO model was the protagonist of many sightings recorded in the 70's and 80's, in various parts of the world. Its most impressive feature is its large size and unusual cigar shape. Although there are some sketches of plans attributed to the *Andromeda Gerät* that date back to the times of

In the Second World War, scholars and connoisseurs claim that it was built and tested in "*Neuschwabenland*", i.e. at the Antarctic base.

On January 8, 1956, several researchers on a Chilean scientific expedition in the Antarctic observed, for several hours, cigar-shaped and disc-shaped UFOs evolving in the sky over the Weddell Sea area.

The sheer size of the *Andromeda-Gërat* suggests that it is a mother ship, an argument that cannot be ruled out given the enormous dimensions (approximately 150 to 200 metres) deduced by ufologists from the data provided by hundreds of eyewitnesses. However, some eyewitnesses agree that the sightings of the "cigar" are accompanied by other sightings of the "cigar".

smaller unidentified flying objects in the form of luminous balls, which evidently, according to the testimonies, come out of the mother ship. Later on, we will provide details of one of these incredible sightings that were witnessed by a large part of the city of Santa Cruz de la Sierra and many surrounding towns. The important thing to note is that the unidentified flying objects with the most sightings during the Second World War correspond to this type of "small luminous ball" baptised by the crews of Allied bombers and fighters as "*foofigthres*".



### *The Foofigthres.*

In 1944 Germany was being subjected to an increasing wave of systematic bombing raids by huge formations of heavy bombers. During the raids, sightings of strange objects in the shape of luminous spheres increased dramatically, causing disruption in the airspace.

crews who had been suffering for some time from severe psychoses brought on by the sudden appearance of powerful German secret weapons, such as the *Me-262* jet fighters or *Me-163* interceptor rockets, which were unreachable by the defensive fire of the flying fortresses and devastating to Allied morale. Although crews were initially instructed not to disclose these facts, they soon began to leak out to the public, who reacted with alarm at the possibility that the Germans could reverse the course of the war with their secret weapons.

According to testimonies of allied airmen, the strange contraptions described a very strange flight behaviour, and notoriously superior to the possibilities.

of a conventional aircraft; ascents, descents, spins, and even the possibility of remaining static and then disappearing at mind-boggling speed, were the characteristics most frequently reported.

It was thought to be a natural electromagnetic phenomenon, but this speculation was soon dismissed, as the luminous spheres often unfolded in formations, or described notoriously directed flight patterns.


After the war, other hypotheses were put forward; the most widely accepted among scholars and experts on the phenomenon of the luminous spheres is that it was a phenomenon caused by a complex system developed by the Germans to interfere with electronic devices with electromagnetic pulses.

Other speculation suggests that the *foofighters* were unmanned, spherical, electromagnetically propelled, spherically shaped devices that were remotely controlled from the ground. The irony is that apart from creating paranoia among Allied and German crews, such devices would have had no wartime utility, and their intended application is as yet unknown.

However, the sightings of *foofighters* next to gigantic motherships suggest an interesting possibility that we will deal with in detail when we address the subject of the *Vrill*, for the moment we will only advance that, although at first it seems too irrational and fanciful, it is very likely that the luminous spheres were the **manifestation of the Vrill** in transmuted men and women of the *Black Order SS*.

### ***The Moonbase "Alpha".***

According to *Bladimir Terzisky*, president of the *American Academy of Dissident Sciences*, who wrote an article entitled "*HALF A CENTURY OF THE GERMAN MOON BASE (1942)-1992*", the Germans together with their Japanese allies reportedly began construction of the first lunar base in 1942. *Terzisky* includes in his article bizarre statements on record



from the Apollo 11 lunar mission, which would confirm the sighting of UFOs and "something else" on the moon. Although the photo of the alleged moon base is unbelievable, it is nevertheless very suggestive for inclusion in this report.

On the other hand, it is important to note that there is classified information that has been leaked on the web about the probability that a *Haunebu III* of enormous proportions would have made a flight to Mars; the report even proposes that its anti-gravity engine would allow it to cover the colossal distance of 75,274,000 kilometres.





*Vril" model in flight.*

## 11. HERE AT ANDES.

The Andes are one of the most important and active ufological areas in the world. The proximity to the Antarctic base is undoubtedly a determining factor.

The millenary trace of Hyperborea, with abundant vestiges, which would corroborate its links with the Tartessians and Teutons, is the III *Tiwanacu* Empire of the Eighth Inga *Wirakocha*. In the third volume of the monumental and so far the only strictly scientific work on this "culture", "*Tiahuanacu the Cradle of American Man*", *Arturo Posnansky* demonstrates the traces of the Vikings on the Island of the Moon. The distinctly European architectural style of dwellings and public buildings is an extraordinary legacy. The *Vrunas* or runes of *Navután*, known in the Andes as *Cacique Voltan* or *Vultar*, are also present.



It's not the Peruvian high plateau, it's the remains of a Viking palace in Greenland.



The *Atumuruna* or *Atumruna*, descendants of the Danish house of the *Skiolds*, who abstained for reasons of purity from racial mixing with the *Quechua*, performed initiation rituals that brought the chosen ones closer to the principle of **emptiness**, maintaining the ancestral Tartessian, Nordic and Germanic symbolism of the labyrinth and the cold stone or altar of *apachetas* marked with runes. Some of those who were exposed to the rituals experienced the **gelid of emptiness**, a principle represented by *Pachamama*, the venusine; then the **apachetas (cold stone) or altar**<sup>7</sup>.

The *Tiwanacu* empire of the Eighth Inga *Wirakocha*, according to *Posnansky* a Viking married to an Inga princess, would come to an abrupt end in the 13th century, when an uprising led by the *Kari chieftain* and the *Diaguita* priestly caste, mobilised hundreds of villages against them; the *Atumuruna* were surrounded in the region of the ancient *Omasuyos*, and defeated by starvation. They were slaughtered as a sacrifice on the shores of Lake Titicaca.

A small elite initiated in the *Vrunas* or runes of *Navután* would escape the extermination, entering underground shelters or *chinkanas*<sup>8</sup>. After a few years they would embark on a long journey with the survivors to the *Calchaqui* Valley and the *Sierras de Characato* in Argentina.

With the arrival of the Spanish conquistadors and, accompanying them, waves of Judeo-Christian priests, the pagan "idols" of their millenary altars were destroyed. As we have been able to ascertain, the great ufological activity the ancestral legacy that the peoples of the blood pact that bear the sign of



Lucifer, left along the Ande. Ruins, as far as we have seen so far, very possibly Atlantean, of colossal antiquity that extend not only in the high plateau, but also in the subtropical and tropical valleys of the Amazon.

Carl Brugger's *"The Akakor Chronicle"* refers to a series of elements and patterns about the location of large underground cities built by the "gods" and remains of "ziggurats"<sup>9</sup> that could be considered as traces of an Atlantean past of mankind in South America. One such landmark is *Samaipata*, in the department of Santa Cruz de la Sierra Bolivia, located 120 kilometres southwest of the capital Santa Cruz de la Sierra, is currently one of the most active UFO-sighting centres in the world. *The main avenue did not even have any names, nor did the main avenue, and there were no pavements or cobblestones, etc. Only water and electricity to maintain some respect for that place.*

*Our house, a single storey, cottage-like house to the left two more similar houses and then the hill that led us down a path to the Country Club. To the right the street and the house of our very dear and remembered neighbours. In front of our house a small wood and more bush (North).*

*As I already mentioned at the hour when it is neither day nor night a large luminous object approached at great speed and stopped above the trees in front of my house, it had the shape of a cigarette and emitted a nobly beautiful white light and remained in this motionless state for a long time until from its right end - from my point of view - another ship emerged which also emitted a white light but intermittently. What was peculiar and characteristic of the villages in those years was that the electricity was cut off at 12:00 at night. Just imagining having to go to the bathroom at that hour and at the other end of the house was an adventure: leaving the room, crossing the courtyard, entering the shed, turning right, running, with the risk of falling into the well of the main bathroom which, by the way, was full of what you can imagine, so, quite an adventure. Add to that the total darkness and the cloudy night. Already up at 4am I had no choice but to urinate in one of the channels in the courtyard. Suddenly it was light and when I looked up I saw a luminous object that in a matter of seconds ascended vertiginously.*


*With the passing of time and the life of the city the visits passed, now only the memory remains in the memory, mind and heart".<sup>11</sup>*

## 12. TWO BANDS.

### *The Alien Traitors and the Liberators.*



Let us recapitulate some aspects of the dualism that permeates all this cosmogony. We speak of the Gnostics, the Manichaeans, of paganism in general, and we see that there is an essential war for the liberation of the spirit chained to matter.

We also insinuate that the "creator" of this universe (wrongly called creator according to primordial traditions, since in reality he would be a cosmocrator or demiurge, a simple computer of matter, which would not have been created by him) is not alone, as the only power, operating all the variables from a single centre; the arrival of an extradimensional race and its subsequent fall, through betrayal, in order to take advantage of its volitional contribution to accelerate the evolution of the terrestrial hominid, poses a serious dilemma, as this original betrayal would have been propitiated by

is in the hands of large financial and media corporations, whose leaderships are indoctrinated from closed lodges such as Freemasonry, which in turn is run by priests and masters, who ultimately seek to earn a place in "heaven" by elevating themselves at the cost of man's pain and suffering; all such macro-structures, no longer nations, would no doubt be controlled by powerful telepathic forces emanating from *Chang Shambhala*.

before locating the metaphysical engine that drives its manifestation.



The latter, to a lesser degree, suffers from this strategic confusion that has perverted its value judgement. This is the main cause of their gnoseological blindness.

How can we judge people's behaviour without having an idea of the axiological, i.e. metaphysical, motive that gave rise to it?

How can we judge the *Third Reich* without understanding the values that motivated its manifestation in the world? The unwary, the gullible will launch the usual critical barrage, "*they hated the Jews*", but they do not even ask themselves why they were "hated" for any reason, reason or circumstance. On a whim? "No..." will say many others who persist in holding this position, "*they hated them because they were an inferior race*", and if on top of

everything else the parameter they use to measure the alleged inferiority of a race is biological, all those who do not have blue eyes, blond hair and a height of 1.90 m. will be hated, including *Hitler* himself, *Goebels*, *Göering*, *Axman*, *Borman*, and hundreds of other Nazi hierarchs, as well as millions of German, European and Latin fascists who surely thought of dyeing their hair one day without fail, in order to lie to themselves.

They think, then, that this absurd image must be the "truth" because it is so taught at school, university and on television: but who teaches it? A handful of colour-blind psychological Jews, amputated from their metaphysical referential centre of thinking for and from themselves, before making value judgements, and who for personal interests, in order not to swim against the tide and risk their reputation, persist in disseminating the biggest lie in history without the slightest modesty: the "holocaust".

The sun cannot be covered with a finger. Although we must recognise that in this satanic world, the demiurge can. Let us see.

The metaphysical engine that drove the *Third Reich* is represented by a symbol, the **Black Sun**, the one that the demiurge tries to cover up. Now, what does the *Black Sun* represent, what does it mean?

primordial tradition, in order

repeats and repeats itself tirelessly in every material portion that is going to unfold manifesting an evolutionary process. That is to say, it is an operative tool, which enables it to **precipitate** matter into archetypal form. This is how the demiurge creates entities, from a sun, planet or galaxy, down to the smallest particle. This "*precipitator*" is, appropriately enough, a gravitational force.<sup>14</sup> As will already be intuited, the processual march of the precipitated entity in this kind of spiral needs a dimensional, spatial and temporal plane in order to arrive at Being in Itself, which is the perfection or entelechy sought by the pantocrator. **That is why every entity is subject to time and space.**

First, who is the demiurge, how does he manifest himself; so far we have only mentioned him by some of his names, *Jehovah*, *Satan*, *demiurge*, but we did not expose his manifest representation. Why, it was not the physical Jew per se, whom not only Germans, but all the peoples of the world rejected or rejected at the time (*Note that rejection is not the same as hatred, rather it is the rejected who, if he does not overcome it begins to exude hatred*), but his metaphysical engine that is who is behind the physical Jew, driving him towards a psychological type, determining his way of being; It is undeniable at this point, that he who is behind the physical Jew, determining his ethics is the *Demiurge*. The answer is simple; He is the compiler of matter. The Gnostics and Theosophists call Him. Well, according to the



To create his hominid, the demiurge conceived an archetype to clothe this seed atom. It is to this archetype that the primordial tradition assigns the name of monad or, to simplify, soul. The soul would rush into space/time to become Being in Itself, the entelechy of the hominid, which is to become superhominid Being. But failure, its evolutionary process was too slow after millions of years. It was then that the unexpected arrival of an extradimensional race into the universe of the demiurge occurred, and through treachery, they chained members of their own race to the soul.




They did indeed glimpse something great, something wonderful; **an idea of**

## 14. CONCLUSIONS.

It is important to stress at the time of drawing the conclusions of this report, that all this data collection, putting the pieces of the puzzle together, and putting it together, has taken six years of continuous study, not only of the "UFO" phenomenon, but of Germany under the Nazi regime and the Second World War.

Hundreds of books and documents support this version, as well as the qualified work of experts in different fields, gnostic, historical, philosophical, etc., which have allowed and facilitated the *Circulus Domini Canis* to undertake such a titanic task. Strictly speaking, this report is the culmination of an extensive work of cultural and historical revisionism.

There are undoubtedly many conclusions that can be drawn from this report, but we will only present those that in our view are most relevant:

1. 2. The current system's great fury against anything that appears to represent an actualisation of Nazism, the great susceptibility it shows to any possibility of its resurgence, however slight, clearly indicates that the metaphysical struggle is still in vogue, that it is not over; the orientation of some nations towards National Socialist principles, especially their hostility to the Zionist model, and the Judaisation of societies, are unmistakable signs of the preparation of a new conflict, already in sight, which will be decisive and inevitable, since the tension generated by this unresolved dispute is destabilising the democratic structures of the leading countries of the new world order, in which more and more social movements hostile to the system and its globalising current are emerging.

3. By all accounts, the system's disinformation campaign that has stigmatised Nazism is aimed at preventing at all costs the "neo-Nazi" movements from reorienting themselves with the knowledge of a reality where the *Führer* has not committed suicide in the bunker, where Germany has not yet been defeated, where the factor of racial supremacy is meaningless, but above all, to hide the conspiracy directed from the great centres of world power, corporate empires in the hands of agents who are aware of the situation and work in close collaboration with the Western governments of the day and the intelligence services in order to prevent the existence of extraterrestrial beings who manage all the variables from coming to public knowledge.

and social policies from a higher sphere. This is tantamount to recognising that there are no rulers in this world, only middle managers and the ruled, that democratic culture, official religions, free will, a sense of individual and collective autonomy and freedom, would all be just a cover, a sham, a lie. Undoubtedly, all the cultural structures that sustain the known world would collapse.

4. The facts of World War II reveal that many nations, albeit in the background, supported the Allies, allowing their propaganda to take hold of the collective mind, allowing anti-Nazi and anti-fascist positions to become official; In this way, they undermined themselves by depriving themselves of the possibility of allying with the Nazis instead of fighting them, and thus gaining access to cooperation agreements that would have allowed them to apply the revolutionary political, economic and social models that made Germany the world's leading power in the 1930s. There is no doubt that a great National Socialist Pact would have enabled the signatory nations to reach levels of collective prosperity and happiness never before imagined; There is therefore a heavy responsibility on all those political actors, who sold out to the interests of the Allies and caused damage very difficult to assess to their own countries, by persecuting, confining, torturing and murdering men and women supporters of Hitlerism who tried by all means to open the eyes of communists and liberals corrupted by the Jewish-Masonic conspiracy, Jewish Bolshevik, Jewish liberal and Jewish Christian conspiracy which, using the power of the state, tried to crush the nationalist and fascist movements which advocated a strategic alliance with Germany. If the report is true, and it appears to be true, when the conflict resumes, all the traitors, including many apathetic and indifferent societies lacking values and nobility, unconscious and politically unenlightened, which served as tools to raise covert enemies of the people to political power, will inevitably be taken as enemies, and fought. It is time to rectify the moral wrongs, for it only takes one look at the framework to understand that we must make a choice: reject the lie and restore honour, or continue to live in it, at the cost of our own dignity.

5. In closing, we will conclude that there is a current of recovery of these pristine truths; a new elite of men and women is emerging in search of kindred spirits with the pointed purpose of awakening the peoples and showing the threat to humanity. All those who feel called to fight in this just cause must contact them, and support them. It is the only way to create an opportunity to right the wrong and win freedom, which is ultimately the only thing we have left. Because hell exists, we live in it; and if hell exists, so must wonderful worlds free of pain, disease and death. The fact that this report exists undoubtedly means that there is still an opportunity to choose.
