Prologue.

When we embarked on the task of carrying out the *"UFO Project - The Antarctic Base"*, we did not know for sure if there would be public acceptance of the subject of Nazi "UFOs", and what is more, we could not know if there would be recipients for the report, outside the still small esoteric circles that for some time now have been formed around the hyperborean wisdom, specifically, around the work of Luis Felipe Moyano.

It is also true that we were able to realise that the fruit of our work in disseminating the Magical Novel of *Nimrod of Rosario* had caught the attention of many people, more than we had supposed, and that they were waiting for some manifestation to glimpse what, at the time of disseminating *"The Mystery of Belicena Villca"*, we had not been able to show them. That is, a glimpse of the magic that we all, whether gnostic or agnostic, hope to feel and touch one day in this now empty reality of wonders, heroes, gods and flying saucers. Yes, it was the signal that many were waiting for to make room for the dissemination and assimilation of this kind of information.

Evidently, since the publication of the *"UFO Report"*¹ we have noticed that people are beginning to take an interest in the books published by the *Publishing House of the House of Tharsis*, but above all, in *"The Mystery of Belicena Villca"*, and surprisingly enough, in *"The Fundamentals of Hyperborean Wisdom"*, even without the Publishing House having published them on paper.

It is also true that many experts on the subject saw these possibilities before we did, and alerted us to the expansion it could generate, as well as the need to complement the *"UFO Project"* with information that had yet to be gathered, structured and disseminated in a kind of addendum. One thing we should point out is that the "*UFO Project*" was adapted by its format to serve as the basis for a narrative script, making it possible to produce it on video; it was really hard work to edit almost four hours of documentary, but it resulted in a significant boost for the dissemination of the report; the present material carries the same possibility, so we are pleased to inform readers that very soon we will launch the second video book of the UFO Project.

Then the director and operator of this effort, which originated in the heart of the *Circulus Domini Canis*, Pablo Santa Cruz de la Vega, will present a fascinating subject in the style that characterises him as the promoter of this dissemination strategy and author of the UFO Report, setting the scene for all those who are willing to walk the winding road of fantastic realism out of conviction. Introduction.

World War II was, appropriately enough, one of the last manifestations of a millennia-old Essential War that has been waged since the very ORIGIN of mankind between two factions of extraterrestrial beings; and here we are not referring at all to the alleged "anthropoid origin" of man, so much vaunted by evolutionists who try by all means to justify it empirically, without succeeding, by assigning an absurd chronology to the history of the world. No. It has been demonstrated ad nauseam that humanity does not have its origin in a primitive hominid that by dint of evolutionary leaps has managed to become another species, but rather, in an artificial genetic mutation operated by an extraterrestrial or alien intelligence that was the cause of the appearance of *homo sapiens* on the face of the planet. Since then, the singular world of the ONE, of the "monkey", has suffered a dichotomy that has been the ORIGIN on earth of a dispute between essentially irreconcilable forces: monotheism and polytheism.

The problem is that both positions are TRUE; this world was MONAL, that is, ruled by a single power, its creator, but that reality was drastically altered by the arrival in this *uni-verse* or mono-universe of an alien race completely alien to creation and its creator. From then on, monotheism gave way to polytheism, which was the main reason why ancient peoples worshipped many deities and not just one, as we can evidently corroborate in the remnants of many ancient religions and cultures of the East and West.

But what is the true face of these "*avatars*"² who periodically manifest in visible "reality" to procreate the "*manus*"³ or root races? What are these "angels" of the One-God really like? From where do they operate and why do they no longer show themselves to humanity? In "***The UFO Project - The Antarctic Base***" we provided some guidelines on this, but did not go into them in depth, only referring to the treacherous aliens as a counterpart to explain the context in which the liberating aliens made contact with the German *Third Reich* through a secret society of initiates, the ***Thulegesellschaft***, which enabled the Nazis to obtain the keys to the development of hyperspace technology.

And this possibility in turn raises fascinating questions about the true nature of the surrounding worlds, both sentient and subtler, abduction, transit through multi-dimensional spaces, paranormal activity, intersecting fields, the astral world, realities that are alien to an overwhelming majority of the human population, turning this material prison into a formidable prison of which we can only perceive a tiny part, which is nothing compared to the colossal structure of the phenomenal world.

Delving into the nature of an extradimensional being completely free to transit into higher spheres outside of space-time, served to rectify that cultural image we have of the alien; a being of various shapes and colours, very similar to us in many respects, which erroneously reaffirms that it is subject to the same limitations, preventing us from accessing a cooler and therefore accurate gnoseological approach. If the *Nephilim Seraphim* clothe themselves in near-perfect, entelechial humanoid bodies to copulate with selected specimens of all human races in order to bring about the emergence of the new human races, then who are those deformed, big-headed, causimonstruous beings that are painted as the protagonists of an ever-increasing number of close encounters? Chupacabras, Greys, Reticulians, Reptilians, Humans, Draconians - can they really be aliens? Or are they something else, the product of an unimaginable biotechnological capacity or a wild imagination?

If aliens are present from the very origin of humanity as we know it, then they are operators of this macrocosmic system for some purpose that we must unravel, otherwise we are subject to interact in the most extreme conditions of pain and suffering, in a major psychogenetic experiment of which we are totally unaware in the manner of mere laboratory guinea pigs.

Likewise, if two million Germans were evacuated to an intraterrestrial base in Antarctica out of the field of action of this colossal psychogenetic experiment, free from human dependencies and the influence of demiurgic designs⁴, then can we access the same possibility by escaping the cycles of life and death in matter? CHAPTER ONE

Our Source: The Hyperborean Gnosis

1. Unheard of information.

The idea of this second part of the "*UFO Project*" is the same as the first saga: to present to you in a simple way a dissertation designed to provide you with the most relevant aspects of the information we have collected and analysed on the true nature of the alien phenomenon, syntactically, so that you can assimilate very complex arguments and concepts that are outside the cultural horizon that is usually used on this subject.

We will begin with a brief review of the "*UFO Report*".

There was information of vital importance that we had to socialise, and although this information came into our hands six years ago, the very background to it was invisible to a cultural gaze; that is, we had to break down the structures, the rational moulds that pigeonholed us in order to be able to understand it; It was only by studying, revising, rethinking, threading, experimenting, that the subsequent verification process was able to clarify, and still continues to clarify, the meaning it has, and the relevance that makes it the most important message humanity has received, and this, because its origin corresponds to a higher sphere of existence.

We refer to the work of *Nimrod de Rosario* published by *Rosalía Tagliavore* and the *Order of Tyrodal Knights of the Argentine Republic* (OCTRA) at the beginning of 2001. To reduce such a huge amount of information, thousands and thousands of HTML pages, would be a very difficult task.

very oblique, coded, alien-inducing work by Rosalia herself and others by OCTRA, which proposed important symbolic reductions in order to prepare the "chosen ones" to enter into contact with realities unimaginable to the "uninitiated", laymen and agents of the system.

Evidently, in order to assimilate and reduce such a quantity of information, we founded the *Circulus Domini Canis*, and embarked on the task of "rehearsing" to achieve the much sought-after reduction of the proposed meanings; we began by opening internet sites, from blogs to web pages; this is how "*The Serpent*" of *Lupus* came into being.

of the Invisibles", "Metaethics Social Psychology", "Veganism: The Strategic Act", "Veganist Manifesto", "UFO Project - The Antarctic Base", and the present second instalment, which in turn has added the proposal of related circles, the *Colombian Veganist Movement* and its essay: "The Synarchy", and the Amethyst Circle with "The Arch of Artemis" and "The Language of the Pasu", all works with a marked hyperborean tinge. "The American Integralist Movement, although exoteric, is also within this framework of union, teamwork, camaraderie and pan-Americanism.

A case apart is the failed proposal of a former Argentinean circle: "AMA Acción Metapolítica Argentina" and the "Informe Ovnis Adendum", now "de-veganised" and therefore strategically useless because its ORIGINAL foundation was the *Veganist Movement* that spun, edited and endorsed those works for their dissemination in Argentina.


It is in this context that the book "UFO Project - The Antarctic Base", launched a year ago, was developed and deployed as a strategy to disseminate this information within the strategic framework of socialisation proposed by the *Vegan Movement*. And so the idea of turning the book into a comprehensive audiovisual documentary was also born, in order to facilitate its comprehension. The documentary is now being disseminated on the web, to our surprise, with an unexpected response from the public. As a result, experts in the field suggested that the report should be expanded with data that we had not covered for reasons of time and space, and which were of great importance. Thus was born the failed "Addendum" to the "UFO Report" that we have already mentioned, and that "sterile", without its argumentative counterpart, the Veganist Movement, pushed us to make this Part Two. A limited edition, which now, thanks to the efforts of the *Editorial House of Tharsis*, will be available in digital and paper format. With this second installment, the "UFO Report" is undoubtedly one of the most serious contributions in the world on the UFO phenomenon and aliens.

2. The Hyperborean Gnosis.

It is now appropriate to provide the ufologist public with a brief, but necessary, introduction to the work of *Nimrod de Rosario*, which is encompassed under the denomination of **hyperborean gnosis**. In the previous essay "Proyecto Ovnis" we mentioned several books by *Felipe Moyano*, namely: "El Misterio de Belicena Villca", "Los Fundamentos de la Sabiduría Hiperbórea" and "La Historia Secreta de la Thulegesellschaft", which are the basis on which we have built the argumentative framework of the present Report. It should be made clear that these documents are unique in the unprecedented semantic and historical precision of their postulates. In another section of this report we will duly expand on the information about *Rosalía*, the mother of *Moyano*, the main protagonist of this essay, and of *Felipe*. In this sense, now, we will expose some aspects of the hyperborean gnosis in order to place the reader in that argumentative importance it has.

When, many years ago, we embarked on "gnosis", we noticed that it was steeped in Judeo-Christianity, depending on the school or guru behind the position, regardless of the trend, they all offered the public, with minor differences of form, the same thing: maximum psychological type, *Jesus*, maximum

paradigm, "love", ultimate goal, elimination of the Ego; be it Rosicrucians, Theosophists, *Hare Krishnas*, Buddhists, *Samaeleans*, Metaphysicians, *Raelians*, Angeologists, *New Ege*, etc. or its "Satanist" counterpart, Freemasons, New Templars, Umbanda, Santeria, Druidism, the psychedelic culture of *Anton Lavey* or *Aliester Crowley*, the *Church of the Last Judgement*, *The Trial*, these more aberrant to a greater or lesser extent, were all animist, and although "love" was exchanged for a sense of extreme liberality, where everything was permitted, they maintained the same tangent: maximum psychological type: an androgynous homunculus, maximum paradigm, unrestricted sensitive experience, maximum goal, the perversion of the ego; the other side of the same coin. If the ego cannot be eliminated, it must be perverted. Why?



Before answering the question, let us dwell on the *Samaelian gnosis*, from which we drank in those years of confusion and uncertainty. In general terms, the Universal Christian Gnostic Movement founded by Master *Samael Aum Weor* (*Victor Manuel Gomez Rodriguez*) revolved around three points: to die, to be born and to sacrifice oneself for humanity, in which "dying" consisted in the elimination of all vestiges of the ego, which was considered the source of all errors; being born, the transmutation of the sexual energy to raise seven consecutive *kundalini* serpents corresponding to the physical, vital and astral bodies, also said to have been a Gnostic movement of the Gnostics, who had been taught that Hitler was an initiate, a black piece on the macrocosmic chessboard, who had strayed from the path at a certain point in time, coinciding with Michael's *Michaelic Michaelism*, and that he was an initiate of the *Gnostic Movement*. In some circles of the Universal Christian Gnostic Movement it was said that *Hitler* was an initiate, a black piece on the macrocosmic chessboard, who would have strayed from the path at a certain moment, agreeing with *Miguel Serrano Fernandez* who states that this would have caused the Fraternity of ascended masters to withdraw their initial support from him during the Second World War.

Very well, we have hit upon the crux of the matter; a point of agreement in the esoteric schools of thought of all present-day Gnostic schools: Hitler was evil, Nazism was evil. And even outside the esoteric schools, the coincidence here is almost absolute, for, with a few exceptions, everyone is convinced of this fallacy.

On the alien issue, they claimed that the extraterrestrials were more evolved beings of light, that they were in charge of creating the new human races and that this was their main function; they abducted people to perform genetic experiments for that purpose, and they watched over the evolutionary development of humanity. On this point we must admit that they were not so far off the mark.


What is important here is that this gnosis, let's call it "officialist", is designed to cover with a cloak of concealment an ancestral knowledge, a primordial gnosis that the ancients had very clear: a celestial reality, that is, an existential superiority populated by gods and goddesses who manifested themselves visibly in the world and in the world of the ancients.

interacted with humanity. These superiors would have taught the fittest men the secret of immortality, the biased legacy of which has come down to us in the form of today's esotericism. Why biased?

Simple, because the cosmogony on which it is based only contemplates one point of view, represented in an indisputable theological axiom: There is only one God, and this "god" and his creation are good and man is the one who has perverted it. And the other Gods and Goddesses? Well, neither the modern esoteric currents nor the established religions have anything to say about them, for all of them, without exception, revolve around the monotheistic dogma. The question now is, what is it that has been biased? From our point of view, more than half of it, let us see: the evil side of the deity - because we have to have the honesty to admit it, that "only" deity is erratic, with an intrinsically evil side, the contextual world we live in is evidence of that - is not addressed by the official gnosis more than glancingly, as it has fabricated a sort of alter ego of God to whom it blames all that evident evil, *Satan, Ariman, Shiva, Azazel, Moloch, Azathoth, Huitzilopochtli*, etc., leaving aside, without explanation, his real opponents, who do not fit into the black type of this alter ego, *Amon, Apollo, Wotan, Osiris, Kukulcan, LUCIFER*.

And now if we are in conditions to answer the question we posed above; if the official cultural gnosis is determined to neutralise the EGO, and that knowledge comes by revelation or celestial instance of that ambivalent and monotheistic god, the heretical, biased gnosis, which comes from other sources, the pagan gods alien and hostile to the creator god, reveal, on the contrary, a knowledge to exalt and guide that EGO in its transit towards the liberation of the world of matter. In other words, that egoic agent is a divine legacy of those deities, which manifests in a relevant way the EXTRATERRESTRIAL ORIGIN of the human being.

Therefore, this primordial gnosis, this persecuted knowledge, this "forbidden religion" would teach man with a divine legacy, i.e. EGO, several ways of liberation that the official cultural gnosis has distorted. Let us prove it syntactically: sex magic would not be used to drain the Ego, since the kundalini serpents fulfil a stabilising function of the demiurgic designs contained in the functional matrices of the microcosm, the "*chakras*" and ultimately the mystical phagocytisation or union of the microcosm with the logos aspect of the demiurge. The Theosophists who




The teachings of *Helena Petrovna Blavatsky*, the *Count of Saint Germain*, *Rudolf Steiner*, *Fulcanelli* alias *Gurdief*, and *Arnorldo Krumm Heller*, the latter, supposed promoter of modern *Rosicrucianism*, maximum representatives of the official Gnostic current of our days, under different banners, maintain that the demiurge, "god", would be evolving through his creatures, monads and submonads (souls) emanated by him for that purpose, and that the subsequent phagocytosis of all that experiential experience that they accumulate through millennia and successive metempsychosis or reincarnations, is something "good", when in reality it constitutes the most aberrant, and not only that, but, strictly speaking, the only real case of

vampirism that exists and about which no film or TV series has been made.

Hyperborean gnosis, on the contrary, reveals to us the true face of "The One", Jehovah Satan, and of his real opponent, that is to say, of the One who is not a simple Alter Ego of the same demiurge, a schizophrenic splitting of the same deity, but the true antagonistic and hostile power to all his insane work or material creation, **Lucifer**.

We will go deeper into this later, but for now we will only say that the great spiritual leader of this alien race that opposes the creator and his alien "angels" is *Lucifer*, and his lost, erased, distorted and hidden history is preserved in this primordial gnosis that we will call from now on Hyperborean Gnosis.





CHAPTER TWO:

The Extraterrestrial Origin

1. The Universe of the Gods.

In this introductory part we will use ancient myths to explain the beginning, that is, where it all began with the arrival of an alien race, completely alien to the material universe. And let's be clear, we must understand that aliens are not local, as culture shows them to us, arriving from distant stars, other galaxies, or dimensions contained within this universe. No. They come from another "universe".




Let us consider this for a moment. It is very important to understand what we mean by our previous statement. According to the biblical myths, which in turn were inspired by myths from other sacred books much older than the bible, for example, Sumerian, Hindu, or Egyptian cosmogony, to name but a few of the ancient traditions older than the bible, this universe would have a 'creator', an author, structuring, ruling, or whatever you want to call the 'first cause' that would have generated it, or created it. This "being of fire", infinite, omnipresent, omniscient, all-powerful, comes, according to the traditions, in this case, rabbinical, from a place that is beyond everything created by him. This place, this other universe, is marked on the *sephirotic* or kabbalistic tree, as the *Ein*

Soph, the world of the gods, or the universe of the gods. For the ancient Greeks the *Ein Soph* was *Uranus* "father of the Gods", who would have been, according to the myth, castrated by *Cronus*, one of his sons, and by whose name the Greeks called the creator of the material universe and who would later, in turn, be castrated by *Zeus*, in a similar way. Undoubtedly, this first induction is very coincidental. The sacred myths are very clear in this regard, before the light, which was created by the creator, let's make it redundant, there was only the "darkness", in inverted commas, which would be the world of the gods. The "Other side"; the created light is proper to this material universe.

In the books of the extraordinary *Inmanuel Velicovsky*⁶, full of mythological interpretations to explain the origin of the solar system and the catastrophes that devastated the planet in ancient times, very coherent theories that alone disprove all the pseudo-scientific lucubrations woven by orthodox mechanists like *Carl Sagan*, we find the proto-history of the Earth, when it revolved as a moon around *Saturn*. *Saturn* at that time, billions of years ago, was a sun radiating enough energy to activate the primordial soup in which rested the prototype *manú ictis*, one of the functional matrices of the primitive hominid. Evidently coinciding with the myth described above (the castration of *Uranus*), Velicovsky claims that

Jupiter (Zeus) in a Dantesque collision would have absorbed part of its neighbour's mass, destroying many of its moons which then formed *Saturn's* rings. The interesting thing here is that, leaving aside the mythical language interpreted in the light of astrophysics, where we could affirm that *Uranus*, castrated by *Cronus*, as we have already seen, is assimilated to the true Celestial World from which the divine cosmic powers or "gods", such as "*Cronus*", come from, we manage to understand the context of the arrival of other gods who in turn displaced "*Cronus*" *Saturn* (when "*Zeus*" castrates him) signifying the setting up of *Chang Shamballa*, a gigantic extraterrestrial base that stands between *Cronus*, the real Sun, and his creation, the yellow "sun" that we see, "*Sun*", being only



a tapasigno, a simple holographic illusion, a sort of entrance chamber to the alien abode of *Chang Shamballa*, where "*Zeus*" and the Olympian "gods" reign, a face of the traitorous aliens who made a pact with the demiurge *Jehovah-Satan-Saturn-Chronos-Saturn* to rule their creation. For readers' better understanding, we refer them to the first installment of "*UFO Project - The Antarctic Base*" chapter 12 "*Two Sides - The Traitor Aliens and the Liberators*", page 62 of the digital version.

To recapitulate, "*The Serpent*" (the treacherous aliens) also come from that god-generating world or "super-sun" of a universe unimaginable to us, called in Greek mythology "*Uranus*", as well as *Cronus*; and betrayal by other members of their own race (*Zeus*) whom they chained to the cycles of life and death of the hominid whose *ichthyic* matrix has been modified (for that the base of *Chang Shamballa* is built) now governs the material creation. However, let us remember that "*Zeus*" also represents the liberator who together with *Hades* and the Titans or Cyclops fight against *Cronus*; it is that "*Zeus*" is also the face of the great chief of the chained alien race that would have manifested itself in remote Atlantis (*Poseidon*) and that together with *Hades*, a liberating alien, defeated *Cronus*, freeing many of them. It is the great epic battle that narrates the *Mahabaratha*, the terrible Atlantean conflagration that ended that civilisation, and whose echo reverberates cyclically, when the pure blood of the peoples descended from the race of "*The Serpent*" (*Zeus*) turns to the Origin claiming liberation. The penultimate battle of this essential war was that which we know as World War II... the final battle is yet to be fought.

2. The Serpent.

The next induction is a little more complex to understand. Let's look at this statement from the holy scriptures: "*The serpent was more intelligent than all the animals that Jehovah God had created*". It is clear that "the serpent" would not have been created by "god". What is not clear is, what would a snake be doing in the garden of Eden? Would you put a poisonous vermin, a cobra or a tarantula in the middle of the garden?

their children? Evidently, the myth suggests to us very esoterically, that "the serpent" would be an alien race arrived in this world and alien to creation, that is to say, a stranger in someone else's house, and we cannot overlook the fact that nobody, nobody enters to live in someone else's house without the consent of the owner. In this sense, through the report, we will see that a faction of this extraterrestrial race would have made a pact with the creator of the material universe. As for the "serpent", let us remember that one of the most renowned scholars of aliens, the Englishman *David Icke*, maintains that this alien race has reptiloid characteristics, that is, they would be "snakes". Many ancient peoples speak of the



Innana, the Sumerian deity.

Snake-Gods. Perhaps the most famous reptilian gods are the Sumerian *anunaki* and the Mesoamerican *quetzatcoatl*. *Kukulcan*, the serpent god of the Papan princess who manifested through a stone polished from black basalt, a hyperdimensional transduction technology developed by the Atlanteans.

As for the Sumerian symbolic myths which have as their protagonists *Enlil*, another of the names of *Chronos-Saturn-Jehovah-Satan*, and *Enki*, his sometimes collaborator and subordinate, though *PRIMOGENITE*, and sometimes his bitter opponent, they suggest that he would have the same ambivalent sign as *Zeus* in the Greek myths. Both *Enki* and *Enlil* are represented with humanoid features, however there is a third Sumerian power, very important, which is always represented notoriously reptiloid, we refer to *Innana*.

Why the liberating aliens choose to enter the gateway to Venus assuming a reptilian form is a question not only interesting, but vital to understanding a sign that has been distorted by agents such as *David Icke* and "*Commander*" *Clomro*, among others, and has become a favourite cultural speculation of a large portion of UFO aficionados.

3. The reptilian form of some aliens.

Well, let's get this issue straight now: it is not that aliens, or some of them, belong to a reptilian race or species or biotype, NO. Referring back to the first part of this report, we have already demonstrated that the vision of a universe teeming with alien races of the most diverse form, psyche, and colour is a strategy of confusion that the culture has erected to hide the Origin of Humanity and the true purpose of its permanence in matter.

The material universe is constructed with universal archetypes. A superstructured animate and inanimate universe. Its animate architectural foundation is bestial or animalistic existence. In other words, all axial matrices correspond to animal forms from which a myriad of possible variables or matrices are operative in certain cosmic ages or cycles; the

Hinduists call these cycles of cosmic manifestation, *manvantaras*. There was once a reptiloid world, the *Jurassic*, supposedly 60 million years ago, in whose highest phylogenetic link it is reasonable to assume that there was a highly "evolved" creature capable of developing culture or making sense of the world, a species of rational reptiloid-type being that became extinct along with its coarser, more bestial brethren, the dinosaurs. The context of the present "age" that followed that failed attempt of the demiurge that ended with a mass extinction, is our present warm-blooded mammo-animal world with "n" biogenetic and formal variables, among them a humanoid-type species capable of becoming an intelligent and autonomous sense-making creature. That is to say, ALL these possible worlds correspond to matrices of this universal architecture, they are pre-existing models created, and which the aliens drew upon, for these cosmic powers come from another universe far superior to this one we have described, and in which the aliens have been able to create a new world, and in which



world. which forms are a misplaced constraint. These **extra-universal** Beings cannot be encompassed by a formal matrix.

Let's put it more simply. To enter this formal universe, aliens had to "formalize", and for what we claim were strategic reasons, they decided to do so in the cold-blooded reptilian form. It is not that, as culture shows them to us, they belong to a reptilian race, since being UNCREATED BEINGS, not created by "god", they would be outside of

any archetypal determination.

At the outset we will say that the motor of this context world, THIS MANVANTARA, is PASSION which, as a complex psycho-biological function, can only manifest itself through a vehicle: HOT BLOOD. Evidently, reptiles have an essential characteristic, their cold blood, which predisposes them to a hostility towards the world context either in the form of aggressiveness or indifference, FOR THAT REASON THEY WERE EXTERMINATED. Logically, a creature can hardly make sense of the world or develop culture if its morphology does not require a complex cerebral-spinal system and therefore possesses an INCIPIENT ANIMISM only referred to a basic instinct of self-preservation.

A mammal, unlike a reptile, has a larger cerebrospinal structure, therefore a lymphatic system with a greater flow capacity which implies a much more developed CARDIACO organ, all of which produces an organic constant, THE HOT BLOOD, a more sensitive nervous system capable of serving as a physical counterpart to a more complex psychic sphere. With this, animism, in principle a simple act-reflection of the organism, can mutate into a kind of self-consciousness. It is at this point that the psychic structure already has the capacity to register the experiences as part of the context. That is, it can never question its existence outside of it. THAT IS WHY THE LIBERATING ALIENS

THEY CHOSE THE REPTILOID FORM, to avoid confusion of existential states. In other words, to avoid entering the system as a mere part.

We will expand on this lurid question later, when we address the alien creation of human beings.

4. Dissension on the alien side

This induction refers to a dispute that would have arisen between the chiefs of this alien race, and which is also clearly reflected in the ancestral myths of ancient peoples. The *Mahabaratha* war of the Indo-Aryan tradition, the war between gods and titans in the Greek tradition, the conflict between *Osiris* and *Seth* in Egyptian, the war between fallen angels and rebellious angels in Judeo-Christianity, etc., suggest this possibility. What is not clear is why the split between the aliens occurred. But from the sacred myths we can surmise that it was due to the decision of some of them to remain in the material universe and descend to the lower worlds to experience an animalistic existence, animating a genetically modified humanoid body from a very primitive hominid native to the planet. Hence the myth of the fallen angels who fell in love with the females of the hominid, previously modified by them to be pleasing to their gaze, taking them as mates and copulating with them.

The dilemma was that this alien race did not procreate, since being immortal and not requiring reproductive processes, it was alien to this animal condition. That is to say, the sexual function for them was not reproductive, but the functional matrix of the telluric creature was. So, if incarnating a mammalian body with a developed psychobiological structure implied the confusion of states of Being, we can now understand the tremendous hostility that aliens experienced when interacting as humans in the created world, but also the willingness of some of them to remain here for the enjoyment of those states, which is why they were rightly called traitors to the extraterrestrial Origin of Spirit.

Let us look at this revelation from the Cathar gospel: "9. *And, reflecting among himself, he willed to make man in his own image, and commanded the angel of the third heaven to enter into a body of clay. 10. And taking a portion of this body, he made another body in the form of a woman, and commanded the angel of the second heaven to enter into the body of the woman. 11. And the angels wept, when they saw that they were clothed with a mortal form different from that which had always been theirs. 12 But he commanded them to perform the carnal work in their bodies of clay, and they knew not that they sinned.*

In the created world, characterised by bestiality, and mortal existence, copulation has a cost, offspring. According to the same bible, *genesis 6*, this interbreeding would have generated a race of giants and/or heroes. This chaining, the fall of many members of this alien race to the lower worlds, caused the rupture with those who had not made a pact with the creator, and they set out to free the fallen, initiating the war.

Hence *Innana*, who opposes the *Enlilite* and *Enkilite* designs, is depicted as a **reptile woman**, symbolising the cold blood that counteracts the hot fire.

of animal passion. In this regard, it is time to clarify an important cultural distortion. This poor vision of Sumerian mythology assimilates *Innana* as a deity of love and war, attributing to her the construction of "Temples of Love", when in reality *Innana* establishes the first brothels on earth, precisely to orient the fallen towards the non-reproductive function of sexuality. As for her hostility, the symbol of war that she carries, the culture attributes to her the epitome of "Goddess Trouble", precisely because she incites rebellion against the created world. Since then many peoples have raised the banner of "*Venus*" the Goddess of Love and War, perhaps the most famous people who radically followed this **strategic way of life** were the Spartans, so fashionable now thanks to the film "300". It is important to note here that today all peoples of the planet have accepted a cultural way of life encouraged by the treacherous aliens, forgetting the strategic way of life bequeathed by the counterpart, the liberators. However, when the conditions exist for this ancestral memory to resurface, the incredible framing of some nation to the strategic way of life occurs, a clear example being *Nazi Germany* only a few decades ago, which means that it is very possible that this legacy could be updated at any moment, hence the tenacious campaign of defamation and stigma that the synarchy sustains from the centres of world power, always ready to repress this serious threat capable of destabilising their hegemonic plans, as has already been made evident.

5. Gnoseological approach to the characteristics of an Alien Race.

The following clarification refers to a very important aspect of form, which we will explain syntactically. This alien race would not require any kind of craft or artefact to move interdimensionally between universes. But the decision to descend to the denser lower planes, that is, to manifest in the animal world, would have forced them to clothe themselves in bodies, and it is in this instance that they would have constructed spacecraft to move interdimensionally with those bodies in these infernal regions or lower worlds. Here we have the origin of the "*vimanas*", flying ships, and "UFOs".

It is a grave strategic error to imagine aliens, who are in reality immeasurable and terrible extraterrestrial powers, corporeal and humanoid, moral, even emotional beings. That would be tantamount to taking them for creatures, which is what actually happens; it is enough to watch the series "*Ancient Aliens*" to notice how specialists measure these "beings" from cultural parameters, being that they are far beyond the translation capacity that vulgar and common language has to express superior realities, no matter what language is involved.

If aliens had the ability to enter through a hyperdimensional "Portal", called in hyperborean wisdom **the "*Venus Gate*"**, if they can transit dimensionally at will in the contextual worlds that make up the illusory reality of this material universe, if they are outside of spatio-temporal determinations, and even if they need to choose a form to manifest, all these faculties evidence that they do NOT REQUIRE MATERIAL BODIES, or rather, that they are beyond form. So here's how it goes: the liberating aliens are

are forced to assume archetypal forms, mainly of pagan deities antagonistic to the creator god, and other hostile forms, in order to pursue liberation strategies with peoples who assume a strategic way of life. Conversely, aliens, traitors to the extraterrestrial Origin of Spirit, assume angelic and beautiful archetypal forms to neutralise liberation strategies undertaken by strategic life-form peoples, as well as to interact with humans primarily in the role of carnal council with the females of the human species.

In *"UFO Project - The Antarctic Base"* we go deeper into this encompassing metamorphology of the extradimensional power or "being" in several chapters, we suggest the reader to refer to the aforementioned work to close with the integral understanding of this section.



The Mystery of the Venus Gate

CHAPTER THREE:

The Creation of Humanity

1. The Native Hominid or Pasu.

We are now going to address an extremely important topic to understand the "Alien" phenomenon, *we are* referring to the creation of man. The biblical *Adam* would not be a human being, but a telluric or terrestrial creature originating from the planet, created and perfected by trial and error through eons and multiple extinctions by an extraterrestrial intelligence that we call "god". The arrival of other aliens (the serpent) came on the brink of further extinction because "*Adam*" did not produce culture, i.e., he was poor in self-will. He was a gregarious animal with a bland sphere of consciousness. These visitors realised that the creature's error lay in the lack of individuality, and this was the result of a common creator. That is, all the "*Adams*" and their "individualities" were sustained by a single will emanating from their creator. The solution brought by the aliens was the enchainment of spirits alien to the creation and the creator to the souls of the "*Adams*". For this they would have used a genetic mutation, in which they themselves became involved with the bodies they used to clothe themselves; and this would be the origin of the human being as we know him today. A being half terrestrial and half extraterrestrial, or in other words, the soul of an animal and the spirit of gods.



Thanks to the Hyperborean Wisdom, we now know that the *pasu* or telluric hominid is a phylogenetic project very dear to the creator of the material universe, for it was conceived to make sense of the world and to develop culture, therefore, the demiurge that seeks its perfection has sustained the *pasu* project in successive manifestations that spanned enormous periods of time, millions of years of unfolding of the *manu* archetype. It was in that instance that beings from another universe arrived in creation, finally discovering the creature's defect; we will now briefly describe the psychic morphology of the *pasu* at the time of the arrival of the treacherous aliens.

The creature was very interesting; it had developed some higher functions of the psyche, i.e., it had an insipid conscious sphere. This characteristic can be deduced from the account of many ancient myths, for example the Sumerians; when the *anunaki*⁷ began to collect animal specimens from the planet, *Enki* observed with admiration how one of those creatures deactivated traps by helping other animals to escape; that the creature in question had a developed gregarious instinct, indicating the existence of a tenuous social principle or collective mind, including some tendency to differentiation by family branch. This convinced the *anunaki* to select this creature for a genoarchetypical experiment;

but permission had to be sought first. Evidently, the experiment involved not only genetics, but the modification of the *manu* archetype, sustained by the logos of the demiurge from a higher sphere. This involved intercepting the logos channelled through *Saturn's* solar plasma, and altering it from a new centre of irradiation, or new Sun, hence the origin of *Chang Shamballa*, a gigantic extraterrestrial base for intercepting solar plasma.

In short, according to the Hyperborean Wisdom, before the alien intervention, the creature presented this morphological biopsychic picture:

A highly developed sensory sphere (Multisensory Biological Body) which in turn encompassed three incipiently tenuous psycho-biological spheres, i.e. subtle energetic-magnetic spheres activating sensory, motor and organic centres; evidently, the rational sphere despite having the capacity (encephalic mass) to contain complex archetypal programmes sufficient to develop languages, only received a slight instinctive stimulus or primary push to emerge them; similarly, the emotional sphere, with no semantic springs to activate itself, a function of the rational sphere, could only emerge a kind of empathy strongly underpinned by a basic instinct of conservation; therefore the sphere of existential or conscious autonomy could only emerge a tenuous pre-consciousness, lacking senses of value referring to cultural objects; concretely, it had no possibility to create culture: IT DID NOT HAVE THE POSSIBILITY OF CREATING CULTURE.

However one looks at it, the *anunaki*, or treacherous aliens, realised that the creature's error was an energetic problem, the instinctual sphere was far too insufficient to cohere and give functionality to the psychic structure. The creature therefore lacked drive.

As a secondary problem, the form of the creature, and we can say this unabashedly, clashed with the aliens' aesthetic sense; already in dealings with the demiurge, if they were to make a pact, they had to control the formal variables or control over the form;

would fix creation, and set the stalled *Jehovah-Satan* macrocosmic entelechial project back on track.

2. Result of the mutation: Virya or Homosapiens Sapiens.

In biblical mythology, the correlate of not just "one" creation, but two well-defined and, above all, well-differentiated creations, is evident at a glance. Let us see: Genesis 1:26-27: "*Let us make man in our image, after our likeness... male and female created he them*". Notice that there is no "*garden of eden*" ... "*nor man to till the ground*"... Genesis 2: 4-5; then, ergo, the biblical account tells us about the creation of the *pasu*, since in genesis 2:7-8 "*the Lord God formed man of the dust of the ground, and breathed into his nostrils the breath of life, and man became a living being*"... It is clear that the biblical account alludes to a second creation, since this man is already enabled to till the ground. He is no longer the *pasu*, he is now something superior. But the interesting thing comes now: Genesis 2:18: "*And the LORD God said, 'It is not good that the man should be alone; I will make him a helper fit for him'...*" And among other things, created the woman! But...wait a minute!... Notice that this "woman" is NOT THE FEMALE PASU. So, what happened?

In the first instalment of this report, we said that in order to enhance the *pasu*, the aliens used the womb of the female *pasu* to embody the uncreated archetypal code of the alien race in the hominid's sphere of consciousness. In the Sumerian myths we see *Enki* performing this operation; *Sitchin* initially interprets the mythological picture as the engraftment of an ovum previously fertilised with alien essence into the womb of several *pasu* females; the result would have generated monsters, i.e., no vehicle suitable to support the alien uncreated archetypal code. In a second sequence, the engraftment is performed on an alien female, resulting in the first "*Lulu*"⁸ and the first human woman with beautiful features, the appropriate vehicle to embody the uncreated code, radically modifying the original *manu* archetype. "*And it came to pass, when men began to multiply upon the face of the earth, AND DAUGHTERS WERE BORN TO THEM; and when the sons of God saw that the daughters of men were fair, they took them wives of their own choosing, and chose them all*"... Genesis 6: 1-3.

Evidently, the Sumerian myth is very clear in this respect, the 200 *Igigi*⁹, WHO HAD NO COUPLES, took human females as wives and copulated with them. They are the treacherous aliens, assuming the role of *manu* prototypes, giving birth to the human races. That is the true origin of *Homo Sapiens Sapiens*; Our Origin.

It is now appropriate to look syntactically at the psychological morphology of the *Virya* or *homosapiens*, of the microcosmic man with divine legacy, in order to clearly differentiate this extraterrestrial agent in us.

First of all, let us note that the scheme follows the general guidelines of the previous figure describing the psychological morphology of the *pasu*; it also contains some elements that will allow us to explain in detail, but syntactically, the difference between the *pasu* and the *virya* with alien heritage without the need to delve into the Hyperborean Wisdom, which we recommend to all readers of this report who wish to refer to the purest source.

With this clarification, let us examine the picture: We said that the problem of the *pasu* was energetic. The lack of an autonomous source of energy prevented the creature from achieving the objectives for which it had been created, that is, to make sense of the world, and to create culture. If we recall what was stated on page 27, all the "Adams" were sustained by a single will, a general source of energy which in turn sustains all material creation. Although this source of general energy is unlimited because the demiurge, as infinity, is unlimited, it will not escape the reader that the *psyche* or soul, which is animic, dynamic, needs an extra, particular note, which drives it beyond its general function to develop consciousness; in this sense the will of the demiurge could not provide this differential note because he sustains the general function, and is inoperative when it comes to particularising the differential function, that is, to question his creation, to discover it and to give it meaning. This is the problem of the *pasu*.

An external agent, alien to the general function of all creation, was thus required to provide the differential note. It is at this point that the treacherous aliens perpetrated the chaining of members of their own race to the soul or psyche of the already human hominid by effect of genetic mutation. In the first part of this report, chapter eight, page 68, we have already raised the question of enchainment.

spiritual: *"How is something infinite like the spirit chained to a finite entity like the hominid and the soul?"*

Although it is beyond the scope of this report to try to explain it, we must provide some guidelines to answer the questions raised. And we will do it, as it cannot be otherwise, syntactically: through betrayal he was exposed, opening himself internally to the universal entities that are found in dimensions contained in another infinity, that of the demiurge, dispersing himself irremediably. So what was captured were its dispersed vectors, shaping in the females of the hominid a sign, a sign of that extradimensional race. That is why we said that he was vilely deceived. That lost vector, of the dispersed extradimensional being, reflected in the consciousness of the hominid where the sign or signal is embodied, was enough to illuminate it, and accelerate its evolution".

Returning to the picture, we will say that the green sphere (volitional force) is the product of the reflection of one of the vectors dispersed in the Symbol of Origin, which produces a reflection of the Self that potentiates the Self-Scheme or *Self* (purple ball), which was previously non-existent in the *pasu*. However, there is the notorious confusion of both agents, and it is inevitable that this should be so, for it was foreseen beforehand by the perpetrators of the betrayal who were counting on both agents to walk on the bed of an immense repository of mnemonic contents, the labyrinth or subconscious (sphere of shadows), confusing their existential states which belong to completely opposite and antagonistic orders: the uncreated Self confused with the created soul.

Since then, man has fulfilled the two objectives of his purpose, a macrocosmic one, to create culture, and a microcosmic one, to be a provider of meaning.

3. Chang Shamballa, an extraterrestrial base.

To conclude this section on the creation of humanity, it is now appropriate to refer briefly to the celestial abodes of the alien traitors, on the one hand, and liberators, on the other.

The upper and lower spheres of the created world would be connected through dimensional doorways. Evidently, we can assume for didactic purposes that the 600,000 illusion worlds of the One resemble a large mirrored structure made up of overlapping worlds, like the layers of an onion. Any macrostructure, like any entity, is the actualisation of a functional matrix that differentiates it from other context worlds. Let us imagine the Rome of *Octavian Augustus* inserted in a usual context, surrounded by barbarian nations in an environment brimming with paganism, violence, wilderness and backwardness with hundreds of peoples amnesiac of their Atlantean past, trying to survive in order to march towards a better future. Now imagine the contextual world of the *pasu*, a flat, jungle world where animals, including the *pasu*, live oblivious to any responsibility, fertilising the fertile soil with their excrement, and eating each other without even thinking about marching towards a future that is not on the horizon, the functional matrix of the macrostructure before the arrival of the aliens on this planet, and the world of the *pasu*.

What is the essential difference between one illusory framework and the other?
Answer: the making of meaning.




Image alluding to Chang Shambhala

Thanks to this sense-making, it is possible to imagine other contextual worlds built semantically on the basis of the obsolete *pasu* matrix and to add complex entelechies to it, futuristic worlds, from that updated at the beginning of the 19th century in a mechanistic Europe heading towards the industrial and scientific revolution, to the current globalised world where national borders are no longer limiting for the establishment of a financialocratic world government, and then, worlds where *cyborgs* will do the heavy lifting in the midst of an obese, pusillanimous and vicious humanity driven to the compulsive consumption of all kinds of sumptuary and banal goods that will turn the planet into a huge rubbish dump.

Now, these overlapping worlds, like the layers of an onion, pass under the aegis of space-time, actualising themselves through their march towards entelechy.

And what is the entelechy? A lurid question with an even more lurid and terrible answer, which we have reserved for the end of this report.

To return to the subject we will say that in order to control these macrocosmic variables the treacherous aliens needed to operate from a base located in a higher sphere, beyond the onion layers, outside of space-time. That is the origin of *Chang Shamballa*, which we said is a huge alien base engineered to intercept solar plasma and resign the solar logos in order to modify the formal matrices of the created universe. We know from rabbinic traditions that this centre is located in the *Sephira Tipheret*, the seat of the treacherous alien perpetrators of spiritual enchainment. It is a general microcosmic and macrocosmic control centre operating with a system called *kalachakra*; monitoring operations in the regions found in space-time are executed by other control systems, a kind of police of paranormal activity. We will explain this better in another section. From *Chang Shamballa* they can enter and leave at will from any of the 600,000 worlds of illusion.

As for the base of the liberating aliens, the abode of the rebels, we call it *Agartha* or *Walhalla*, also known as *Asgard*, the characteristics of which we detail in chapter eight page 43 of "*The UFO Project - The Antarctic Base*"; In this regard we will only note that, just as the *virya* can actualise macrostructures with their sense-making, the liberating aliens or *Loyal Siddhas* can isolate any portion of the created universe from time-space, and assert a liberated square, wall it off, and operate spiritual liberation strategies from there.

CHAPTER FOUR

The Alien Liberators.

1. The Hyperboreans.

We will now turn to one of the alien factions that for the purposes of the Report we have termed liberationist aliens. Why liberators? Because they simply want to leave the infernal regions of this material universe for good, taking with them their own kind who were chained to the life and death cycles of the hominid, already man by effect of genetic mutation operated by a group of them with the stated purpose of remaining in the created world and with whom they are in conflict.

To refer to aliens we must start with Atlantis as the context of origin. We have already said that the aliens came into dissension in response to the hasty decision of some of them to interbreed with the genetically modified hominid and interact in the world in confusion with human beings. This resulted in the appearance on earth of the root races: red, yellow, black and white. We will explain this step by step. The first action of war by the rebellious extraterrestrials, that is, those who did not make a pact with the creator, was the adoption, if the term is valid, of the Cro-Magnon men or Cro-Magnon race. From this race would descend the hyperborean peoples who have their origin in Atlantis and would give rise to the peoples of the blood pact, that is, those men who would make a pact with the rebellious aliens in order to free themselves at the right time from the bonds of matter by pursuing a strategic way of life.



It is important to note here that the liberating aliens never mixed their blood with the *viryas*, nor did they procreate hybrids with the human females. They did not participate in the genoarchetypal experiment. Liberator aliens feel a halo of essential hostility towards matter, and furthermore, they HAVE PARTNERS, divine potentates of a female nature who second them and to whom they are bound by superhuman values incomprehensible to us. That is why they did not betray their own, and came into conflict with the perpetrators of spiritual enchainment. That is why we said that they "adopted" the *Cro-Magnon* race, in order to point out to them a

This story of how the *Cro-Magnon* race forged contact with their Hyperborean guides, the liberating gods, has passed down to posterity in the form of a myth, the myth of ***the Virgin of Agartha***, which is the *Cro-Magnon* race. Let us extract it from the "*UFO Project - The Antarctic Base*": "*The myth tells that there existed in Atlantis a very virtuous maiden, whose virtue lay in her unheard of yearning for the unknowable. Outraged by the terrible famine and misery that overwhelmed her people, she cried out to the unknowable with such fervour that she was heard and it showed her a way to Venus.*

When the maiden arrived on Venus, an envoy of the unknowable awaited her to give her some cereal seeds, with which she would satisfy the hunger of her people, and a stone seed, which to her surprise would impregnate her with a stone child who would become a great liberator. The stone child had been born with a grace, the lithic wisdom with which he taught men how to build great stone walls".

Now, let's unravel the myth a little so that the reader understands the importance of this event for humanity.

According to the biblical myth Genesis 6:4 *"There were giants in the earth in those days, after the sons of God (the Seraphim Nephilim) had known the daughters of men and begotten them sons. These were the valiant ones who from ancient times were men of renown."*¹⁰ Men of renown like King Kassite Nimrod, who defied the traitors and attacked them in their own dwelling, we note. Undoubtedly, at first, the *viryas*, the newborn in creation, were most pure, that is, the **symbol of the** inherited **origin** of the mutant female, shone clearly in their consciousness, or rather, illuminated their consciousness. They quickly realised that they were semi-divines or demigods; we know from ancient myths that they were in contact with their alien progenitors, and if we go back to the Sumerians, that the gods were very pleased, for this new humanity would carry on their shoulders the burden of the hard work that had previously been theirs. It was a Golden Age.

At some point men, who were mortal, claimed their place in the heavens to outwit death. But they had been created as bidders for meaning and many realised that the gods had dark designs. With time, population explosion and racial mixing, the purity of the memory of extraterrestrial origin waned and oblivion ensued; the confusion of existential states drifted into the affirmation of illusory life in the created world of matter and its destiny filled with sorrow, famine, pain and death. It was then that from among those who still remembered the origin, a people arose willing to fight for the lost immortality, and this gesture was enough for the gods who had not made a pact with the demiurge to decide to come to their aid. There was war in the heavens and in the
In the cataclysm, an entire civilisation perished, b
gaining immortality.



Among the survivors, this legacy would be passed on from generation to generation, the kings would teach their children that there was a time when giants lived on earth and that

In the darkness of chaos they deceived the gods and snatched from them the riddle of steel. The enraged gods made the earth tremble; fire and wind hurled those giants into the void and the gods in their fury forgot the secret of steel and left it lying on the battlefield... that secret would be picked up by men, no longer gods, no longer giants, only men... who would try to solve the enigma, understand the riddle and learn its discipline... for it was clear that no one in this world could be trusted, neither men, nor women, nor beasts... only steel...

This is the origin of the peoples of the blood pact who lived a strategic way of life. Iberians, Dorians, Etruscans, Cimmerians, Kassites, Hittites, Pelasgians, Turanians and Ainians. In their time they all participated in some liberation strategy with different missions entrusted by the Liberator Gods. The Iberians held for millennia, until today, the secret of the *runes*; the Dorians and then the Etruscans forged great empires like the Macedonia of *Alexander the Great*, until the imperial Rome of *Octavian Caesar Augustus*, from the Caucasian Cimmerians would descend several peoples of very pure blood who settled in the North, *Ruskis, Gauts, Saxons, Helvetians, the Turanians* gave the world one of the men of the purest blood, *Genghis Khan*.

All in their time remembered that they were children of gods and it is for that reason that they were racialists¹¹, to maintain that legacy it was necessary not only to live a strategic way of life, but to avoid falling into racial sin, the mixing with peoples who will not carry in their blood, so clear, the sign of the race of origin, the one that heroically liberated itself from the world of death.

2. The Blood Pact and The Cultural Pact.

Let us recapitulate, from the aliens who made a pact with the creator would descend all the peoples of the world, both the peoples of the blood pact, who, having the memory of their origin so vivid in their genetic minority, decided on a strategic way of life and therefore made a blood pact, that is, a pact of honour, with the liberating aliens; And so are their descendants the peoples of the cultural pact, who are, for that very reason, those who have accepted to submit to a cultural life model, assimilating themselves existentially to the world of matter, becoming protagonists of the great historical milestones for our culture, from the establishment of monotheism and its eastern and western monasticism, which denies the existence of the liberating gods, to the depaganisation of the peoples of the blood pact, the inquisitions, the great revolutions, etc.

To begin with, we will say that today, ALL the peoples of the world have succumbed to the Cultural Pact. Terrible reality, but we cannot delude ourselves about it.

However, it should be noted that, although extraordinary, there are still men and women who suddenly awaken to the memory of their extraterrestrial origin, and it is not uncommon for these *viryas* to assume control of some nations at key moments in history, re-establishing the blood pact. It happened recently with *Nazi Germany*.

But what identifies whether a people is adherent to the cultural pact?

Answer: the existence of a priestly caste embedded as an institutionalised elite in the power groups that exercise social control.

This is so because the liberating gods of the blood pact do not admit intermediaries of any nature when it comes to contacting a group of men willing to tread the warrior path that leads to the uncreated origin of the Spirit. That is why it was sought to depaganise the peoples of the blood covenant in order to attach them to the cultural covenant. Although the social structure of both types of peoples, those of the cultural pact and those of the blood pact, is similar, there are notable differences. For example, both had a ruling caste that was in direct contact with their alien guides or progenitors; the difference was that the blood pact peoples had their royalty as a nexus or contact with the gods, while the cultural pact peoples used a priestly caste rather than royalty as a nexus or contact with superiors. That is to say, while the aristocracy of a blood covenant people came into contact with the superiors through the memory of blood, the memory of origin, the priests of the cultural covenant did so through worship, sacrifice and the affirmation of matter and the created world.

After the war between the peoples of the blood pact and the peoples of the cultural pact that destroyed Atlantis ended, the remnants of both sides engaged in a war of movement, these survivors began to march eastward, mixing their blood with the aristocracies of many peoples loyal to the blood pact and many others to the cultural pact, and of various races, red, yellow, black and white.

One of those peoples were the *Iberians*, who founded the great empire of *Tartessos*, the most visible trace of Atlantis. At that time, the post-diluvian era, the peoples of the blood pact maintained contact with the gods through gems or transducers. The aristocratic elites trained initiates who had to prepare themselves for a lifetime to operate the transducers and communicate with the gods. The functioning of the transducers depended on the blood purity of the initiates, hence the peoples of the blood pact did not mix with others who did not have the same racial sign. These gems, or transducers, were guarded by expert initiate elites, not

The gems were usually set in royal objects such as crowns, swords and shields, and it is safe to say that the real oracles of the ancient world possessed these gems. The ancient Greeks

of Pelasgian race were also blood pact peoples, and had in their possession several of these stones known in occultism as "*serpent eggs*"; the most famous one was kept at *Delphi*, and through it they could contact *Apollo*, who would be an alien of the liberating side. This deity was known as *Navutan* to the Tartessians, and as *Wotan* or *Ödin* to the blood covenant peoples of the Norse and Germanic races.

As for the cultural pact peoples, those who had the nexus with the matter-affirming aliens, as we have already said, were the priestly castes specially initiated into the worship of the One God under his different aspects or faces, and who, to communicate with them, erected temples with an area or sanctuary specially conditioned with transducers and to which only priests of the highest hierarchy had access. The blood covenant peoples were characterised by being mainly aristocratic and warlike. That is, they had a caste system where the warrior aristocracy formed the ruling caste and the farmers and artisans, a civil or citizen caste; they occupied a territory, which they always considered foreign, and walled it in, in other words, they did not believe in land ownership for strategic reasons. The peoples of the cultural pact, on the contrary, had a priestly caste above all ranks, then a mercenary militia under the command of an aristocracy subject to the priesthood, and castes of shepherds and merchants, they believed in land ownership, and their settlements were located in vortices of telluric energy, plexuses of the *kúmara* or planetary ruler, which would last until our days, *Cairo*, *Rome*, *Jerusalem*, are clear examples that confirm these statements of the Hyperborean Wisdom.

3. Tartessos, a people of the Blood Pact.

Having made this clarification, we will now follow the thread of this report, which has its reference in a people of the blood pact, the Tartessians, whose history is perfectly woven in "*The Mystery of Belicena Villca*". The Tartessians were among the last people to persevere in the strategic way of life and the blood pact. In the 3rd century BC, they formed an alliance with a powerful Pelasgian people, the Lydians, to resist the siege of a cultural pact people with a high culture and a powerful mercenary army: the Phoenicians. When the Phoenicians finally invaded *Tartessos*, the priests of God One arrived in Europe with the invaders, with a mission specially entrusted to them by the treacherous aliens, those who made a pact with the creator and the powers of matter, to find the transducers with which the Tartessians and other peoples of the blood pact contacted the liberator gods, to seize them by any means and destroy them.

Thus the initiated elites who guarded the gems went underground. With the arrival of the Romans, the lineage of *Tharsis* became related to their aristocracy, disguising their heretical doctrine in the cult of *Vesta*, the Roman goddess of fire, until the third century AD, when the Catholic Church was born and pagan cults were forbidden; behind this prohibition were the priests of the One God, who were still looking for transducers. We have already said that the initiated royalty of the blood covenant usually set these gems in royal objects, for example in crowns and swords.

The Judaeo-Christianisation of pagan Europe began. In the 10th century only the Tartessians and some Anglo-Saxon and Viking peoples still kept their transducers, which the Judeo-Christian priests had not yet been able to take away from them.

Some of these people sailed to America escaping from the anti-heretical crusades, bringing their transducers with them. The Judeo-Christian priests arrived in the 15th century under the aegis of a high priest of the white brotherhood: *Christopher Columbus*, searching for their trail throughout Mesoamerica and South America. And it is here that they came across a transducer that was in the hands of Princess *Papan*, daughter of King *Monctezuma*. It is a polished black basalt stone. The Franciscan priest *Pedro de Gante*, who had it in his possession, died, leaving it in a chest which, by a chance full of meaning, found its way into the hands of Queen *Elizabeth*, who in turn gave it to her court advisor *Jhon Dee* to study its rare properties. It would take years for this great scientist to understand how it worked, and he managed to contact the "angels", as *Dee* called them, who were none other than the liberating gods called *Kukulcan* by the *Papan* princess.

But... What happened to the lineage of *Tharsis*? Their initiates managed to keep the sword of *Tharsis*, where the "Stone of Venus", the Atlantean transducer, was set; for centuries they acted as exemplary Catholics, disguising their heresy in the cult of the *Virgin of the Grotto*. Legists, they advised great Ghibelline champions, anti-clericals such as *Frederick II of Hohenstauffen* and *Philip IV "The Fair"*, who in their time, the high Middle Ages, disarticulated the synarchic plan to establish a world government with the "chosen people" of the One God at its head. Together with Cathars and Bogomils, they achieved great influence in the Catholic Church through the *Dominican Order*, which they promoted. A branch of their lineage that persisted in Austria made contact with *John Dee*, a fact that would profoundly change the history of Europe and the whole world in the centuries to come, as we will have the opportunity to see in the following chapters of this report.

4. Secret Societies.

The "angels" would order *Jhon Dee* to form an initiatory order with members of the Austrian aristocracy. We are in the 16th century, the *Sapiens Dominobatur Astris* would arrive through the orders *Einherjar*, *Germanenorden*, and *Thulegessellschafft* to the 20th century, the exact moment that the "angels" indicated for the manifestation in the world of the first arrival of the envoy of the Lord of War; evidently this event was awaited for four centuries, since the foundation of the Order *Sapiens Dominobatur Astris*... the envoy of *Odin* would come to power in Germany on January 30, 1933. His name, *Adolf Hitler*. His mission: to stop the offensive that the powers of matter and the traitorous aliens who claim the created world launched with the establishment and propagation of a version of the Jewish *kahal* and *kibbutz*, among the non-Jewish gentile peoples, seeking to collectivise humanity through dialectical materialism and political and atheistic hegemonisation, the name of this doctrine was called Marxism-Bolshevism. In this connection there is the letter which an envoy of the White Brotherhood of *Chang Shamballa* entrusted to *Nicholas Roerich* to send to *Lenin*, congratulating him on the triumph of the Bolshevik revolution.

It is in order to oppose the white fraternity that the *Thulegessellschaft* formed the **Black Order SS** in 1931. The *Black Order SS* is said to have channelled from the superiors a

prodigious knowledge which, in the hands of the SS *Special Forskrung unt Entwicklung*, achieved anti-gravity propulsion and interdimensional jumps or hyperspace transpositions. Together with *Victor Schaubberger* and engineers of the stature of *Andreas Epp*, *Arthur Sack* and *Roudolf Schriver*, among the most important, t h e *Haunebu* project was conceived.

After the end of the phase of the war in which the *Führer's Third Reich* waged total war against the material powers between 1939-1945, specially commissioned cadres who had escaped Allied control began to operate outside Germany. Peronist echelons together with supporters of *Getulio Vargas* and *Carlos Ibañez*, advised by undercover SS agents, formed the ANAEL Order, whose exoteric face was constituted by a kind of left-newge-pan-Americanist doctrine; This commission, which brought together prominent figures from the governments involved, such as *Luis Carlos Arias Valera*, served as a link to contact members of the SS in Argentina who provided the necessary information to an envoy of the liberating aliens, who would eventually form the most recent link in the esoteric chain that began four centuries earlier with the *Sapiens Dominobatur Astris*; This Order would have been charged with supporting the strategic deployment of *Nimrod of Rosario*, locating the "chosen ones", and if they took up the revelations, preparing them to face the end of History with Honour. We will expand on some aspects, as appropriate, of this "secret society" in another section of this report.

CHAPTER FIVE

The Antarctic War

1. The 15 operational models of Nazi UFOs.

The "*Huanebu*" is perhaps the most famous Nazi "UFO"; according to data obtained from various sources, four series were developed, one of large size that would have made a hyperdimensional journey to *Mars*. In the "*UFO Project - The Antarctic Base*", we carried out an extensive sampling. However, we have collected new information, not only about the *Haunebu*, but also about the most frequent unidentified flying object in UFO sightings all over the world, the so-called "*Andromeda Gërat*", a cigar-shaped UFO of enormous dimensions, which would be a "mother ship", designed and built in *Nauschwabenland* or "New Swabia", the Antarctic base of the Nazis.



Kapustin Yar is a secret experimentation and development base for advanced missile and spacecraft prototypes of the former USSR, located in *Astrakhan* and *Volgograd Oblast* in the village of *Známensk*. The purpose of this huge facility was to house all German projects captured by the Soviets in Germany at the end of World War II. However, UFO enthusiasts claim that the project of


Air Force *Migs* shot down a large cigar-shaped craft whose wreckage landed in *Známensk*; it was then that in order to rebuild the craft or recover as much of the technology as possible through a process of reverse engineering, the huge facility was erected in late 1946. The amazing thing is that there is photographic evidence of this type of German craft flying over *Kapustin Yar*; some claim that a very intense aerial battle between Soviet forces and UFOs has been going on uninterruptedly for decades; it is also speculated that *Stalin*, the cruel dictator of Hebrew origins, would have been discontinued from the supreme government of the Soviet state because he was obsessed with the enormous post-war "UFO" activity that brought him dangerously close to a sense of convergence with National Socialism relocated to Antarctica.



The point is that there must be some truth in all the information about Nazi "UFOs" was filtered mainly from sources belonging to the Soviet secret service during the *glasnot* and *perestroika*. It was digested, the synarchic system foresaw to alert the public in doses.

The work of Miguel Serrano Fernández emerged "surprisingly" and practically out of nowhere in Chile, through its measured dissemination among government circles that at some point were linked to ANAEL.

The Soviet Air Force possessed a kind of "dossier" with detailed specifications of several different models of German aircraft which were frequently sighted in the USSR. We are not only talking about the *Haunebu* models, nor about *Maria Orschric* who, together with the wise men of the *Thulegesellschaft* and the **SS Black Order**, worked in parallel on the "*Vrill*" models, but about at least 15 different types of fully operational German aircraft. Let's see:



As for Nazi Germany's possession of this super-technology, there is no doubt that in the face of the overwhelming documentary evidence that has been leaking out, the Germans informed Allied high circles of the possession of these secret weapons in order to negotiate their withdrawal to the Antarctic oasis. The cover story of "*Tunguska*", which *Stalin* himself and the "*Stavka*" allegedly devised in order to misinform public opinion about the explosion of a Nazi atomic bomb of persuasion in late 1944, precisely in the Siberian tundra, is very illuminating. Falsely concocted arguments were then invented to cover up this fact, from the supposed fall of a meteorite in 1908, to the accident of an extraterrestrial spacecraft, theories that were designed to explain the *Tunguska* incident.

Likewise, faced with the reality of an invincible Germany because of the technological leap forward it would have achieved, the Allied teams tried to obtain these technologies when they occupied German soil, to no avail, since all that was obtained were advanced but conventional technologies that made the post-war space and atomic race possible. In other words, the Germans themselves would have handed over nuclear bomb technology to the Allies in order to direct their technological development towards that field, diverting them from research in other areas such as anti-gravitational science, hyperdimensional leaps and alternative sources of energy with antimatter, studies and technology that the Germans took with them to the Antarctic base.

2. The Dimensional Doors.

Now for something very important. The Nazi regime, by high-priority directives emanating from the *Thule* and the *Anhenerbe*, planned the largest expedition to Antarctica ever undertaken. The Germans would have been pointed by their superiors to two dimensional gates leading to their celestial abode of *Agartha* or *Walhalla*. One would be located on the summit of Mount *Elbruz*, the other in Antarctica. Hence the military priority of the German army in the war with the Soviet Union was the Caucasus and not Moscow, in spite of all German generals. That is also why this gigantic German expedition to Antarctica was prepared in 1937. The Germans succeeded in opening both dimensional gates.

As for the *Elbruz Gate*, the enterprise of reaching it was entrusted to the 1st *Gebirgs* Mountain Division, led by a specialised mountain detachment of the SS *Adolf Hitler Liebstandarte* and elements of what was to become the legendary SS Tibetan Legion that fought bravely defending the *Führer's bunker* in May 1945. Four German armies, reinforced with the entirety of the reserves assembled for planned operations along the entire Russian front during 1942, marched towards *Grozny* in the Caucasus, fighting huge battles with the also reinforced 20 Soviet armies. On 21 August 1942 Operation *Edelweiss* was completed. Pictures

Initiates of the *Thule* trained in the *Liebstandarte* allegedly opened the door with the help of esoteric operations, connecting it with the *Wolfschanze* "Wolf's Lair", *Hitler's* headquarters in East Prussia; Later, the bombing of *Hitler* by a group of renegade and disgruntled *Werthmacht* officers on July 20, 1944, in the "Wolf's Lair" would fail under unexplained circumstances, if one does not take into account this esoteric factor, the Dimensional Door operating there.

As for the German Antarctic base, new information that has come to our attention confirms the actual evacuation of around two million Germans and not just half a million, which were the estimates of several knowledgeable sources, and which we included in the first instalment of this report. Yes, that would have been an understatement. Moreover, the strange permanence of the base in the vicinity of the abyss produced by the effect of the great space-time anomaly that characterises the huge and monstrous Antarctic dimensional opening poses serious problems in glimpsing this mind-boggling place in the middle of the ice.



"I would like to point out something that left me intrigued to this day, it was the first time they took me across the Antarctic, I was distracted from the ship, contemplating that subjugating, spectacular landscape, with my gaze I was sipping every little thing that aroused my curiosity, as I didn't know if they would take me again, I was so engrossed that I lost track of what I was doing, I was so engrossed, that I lost track, of what was around me, or else, that they did it to me expofeso, since, I noticed that the ship, was moving, towards a slope, immense, since it had plenty of space, to slide down that slope, that was, covered, compact, the sides, as who, is introduced, between 2 mountains, either that I was distracted, either I was distracted, or I was tricked, or distracted, induced, because I saw the slide, steep and then, I don't know if it went into a cliff, nor do I know how deep it would be, because the slide, is imperceptible, what I know, is that I find myself suddenly, before what I, called, "The Paradise", this is remarkable, there was no sun, there was no artificial light, however, the illumination, was total, it was a divine light, like that of the "Aura", but everything, radiated a halo, spiritual, that did not damage the sight, like being, the whiteness, of the ice of the Antarctica, that rather is reaper, I say that it is a celestial illumination."*¹²

3. A Battle Never Told.

The terrible pressure that the Allies brought to bear through the largest systematic bombing campaign of residential areas without military targets in history, a crime without a name, let us only remember that over 10,000,000 tons of explosives were dropped on Germany, left its cities razed to the ground, making it impossible to carry out an effective and efficient military operation.

record of material and human losses. This cloak was the perfect cover to evade hundreds of thousands of people, from selected SS echelons, unborn children of the *lebensborn* project, and specialised military and civilian personnel; all were evacuated to a new base consolidated by the *Kriegsmarine* on the Antarctic continent. Hundreds of classified documents later leaked by the now defunct Soviet KGB confirm the existence of this German Antarctic base. Once Germany was occupied, it would take the Allies two years to prepare an expedition to neutralise it.



The operation was christened *Highjump*. Public opinion, which was not unaware of the mobilisation of such an armed force, was told that it was only a scientific mission. People began to wonder whether the penguins were really meant to be fought. Up to 30 warships and three *taskforces* were involved, including aircraft carriers, submarines, destroyers, tankers and troop carriers; *Task Force 68* alone had 9,000 men.

Task Force 68 made contact with hostile forces on 25 December 1946 when a *Sikorsky* helicopter was shot down by ground-to-air missiles fired from a cylindrical structure that emerged from the ice. At 5:41 a.m. on 26 December, while trying to pull the trapped *Fine Island* out of the ice, a large-scale attack was launched from several points and by weapons and devices unknown to the crews as they were being flown over by three burnished aluminium-coloured flying discs. Meanwhile a task force had

managed to land several armoured vehicles with ground troop cover, which were completely decimated and then destroyed. The USS *Caniesteo* exploded in a thunderous deflagration as the armoured vehicles and the *Little America IV* base came under fierce attack. By the end of December the base could finally be evacuated.

Admiral *Richar Byrd*, commander of the failed expedition declared to a confused public opinion at the end of March 1947 that: "*The United States must immediately initiate defence measures against hostile polar regions. I do not wish to frighten anyone but I must declare the bitter truth that, in the event of a new war, the American continent would be attacked by flying objects which can fly from one pole to the other at incredible speeds.* Believe it or not. After this confession, Admiral *Byrd* was forbidden to make any further statements until his strange death in 1957. Then came his totally misrepresented log of very dubious provenance.

In a sign of the unimaginable power the Nazis now had, UFO sightings began throughout the United States. To cover up this reality, the alleged crash of one of these unidentified flying objects at *Roswell* was fabricated to confuse public opinion and to disguise the existence of German forces still intact in Antarctica, as well as to disguise the fact that their UFOs were flying over US airspace with impunity.

But that was not the last time the US carried out a major operation against the Antarctic base. Little known, even among researchers, is the attempt to atomise *Neuschwabenland*. As it was impossible to get close, a tactical medium-range ballistic missile task force "*Polaris RTV3*" consisting of two destroyers, two frigates, two tankers, two aircraft carriers and two submarines was prepared; operation "*Project Argus*"¹³ was planned for the end of August and mid-September 1958. The cover was to be a geographic and geological testing expedition in the area to coincide with the so-called "Geophysical Year". At least three staggered attacks were carried out, two on 27 and 30 August and the last on 9 September; although the operation was top secret, the electromagnetic measurement base at *Cape Town*, South Africa, recorded the unusual discharges of electromagnetism, pinpointing the Antarctic area as the source of the electromagnetic deflagrations. The measuring equipment suggested that the detonations would have occurred 480 kilometres above the Antarctic Arctic Circle, i.e., mysteriously, they detonated in the stratosphere, off target.

4. UFO witnesses.

Since then a large part of the scientific expeditions to the Antarctic have been monitored by UFOs; in 1958 in the *Bedelt* Sea one of these Chilean expeditions was followed for days by huge cigar-shaped craft. We have already said that this German UFO model, built entirely at the base

NauSchwabenland was and is the object of the largest number of UFO sightings in the world. In Bolivia it was seen along the northern highway of the Department of Santa Cruz for several hours in 1980, in the book "*Proyecto Ovnis*" we include the account of a reliable witness of that incredible sighting, Mr. *Rodrigo Guerra Grundy*. But recently, in August 2012, it was seen by Don *Sergio Gaméz*, another Bolivian, very close to the snow-capped *Illimani* in the Andes Mountains.



On the other hand, the declassification of UFO reports in Argentina has revealed the existence of hundreds of people, Chilean and Argentinean military personnel, who have been the protagonists of strange sightings in the scientific bases that these countries have in Antarctica.

But sightings also occur frequently in areas that are

In coincident circumstances, Don *Victor Telléz*, a member of the "*Proyecto Ovnis*" team photographed one in the centre of La Paz, when it was late at night.

How can we explain these and similar sightings? *Lupus Felis*, the codename we give to a hyperborean gnostic who advises our entire team, had the opportunity to observe a gigantic UFO for 15 minutes, hovering static above the *Tiquipaya* area in the middle of the city of Cochabamba. According to *Lupus Felis*, it could have been a *Chang Shamballa* vimana, although we have not yet made comparisons with the types of craft in the Soviet dossier, the shape of a spinning top does not fit with any Nazi-UFO typology.

To conclude this chapter, we will give the pending answer to the question we posed above. The "UFOs", by transiting outside of time, as they would properly be time machines, would always be out of sync with the present time of the hypothetical observer, whether it be a small step behind in the past, or one ahead, in the future. However one looks at it, this poses a fascinating reality, that the "UFOs" would always be operational, right under our noses, but invisible because of the temporal desynchronisation. This operational anachronism would turn them into a formidable, undetectable espionage tool, making them almost invulnerable.





CHAPTER SIX

The Traitor Aliens.

1. Abductions and Close Encounters.

So far, five presiding chapters, we have set out the minimum argumentative development to put into context the subject matter of this report, which will shed much light on that other face of aliens, especially those who represent the powers of matter. Clearly, just as there have been millions of cases of UFO sightings around the world, there are also hundreds of cases of abduction and contact of the third kind, close and face-to-face encounters with extraterrestrials. However, there has also recently begun to be talk of close encounters of the fourth kind, which we could assimilate to the phenomenon of satanic possession, that is, strictly speaking, and removing any polarity induced by questions of religious faith, *alien possession*. In this sense, the film "*The Fourth Phase*", the Spanish title for the film supposedly based on real events starring *Milla Jovovich "The Fourth Kind"*, has caused a sensation among fans of the "UFO" phenomenon. We highly recommend it to the reader as it contains very interesting and little known aspects of alien nature that relate to our report.

Regarding abduction, we will say that it is apparently always induced by altered states of consciousness. Although we will go into more detail on the subject of "hypnagogic" states later, it is useful to advance some aspects in order to explain the subject in question.

According to the Hyperborean Wisdom, and as we have already analysed in several chapters of this report, the *virya* or man with an alien legacy is a double agent: a conscious subject of telluric or created essence marching towards perfection, and an *egoic* alien self or substratum that drives him from a subconscious sphere towards that entelechy; hence spirit is chained to matter and both agents are intrinsically confused, it being very problematic for the individual to determine in an act of reflection, where one begins and the other ends, or vice versa. The soul subject is immanent, i.e. our common waking state, which is temporalised, and therefore it is there where the Self is situated. In perceiving time we exist, in time. However, when we enter the state of latency or sleep, the physiological rest, the self transits through the subconscious region by the hand of the I. As immanence remains in this latency, time is disrupted in the state of sleep. We have thus described the waking state, the conscious transit through the



The dream state, a semi-conscious transit in the shadow or subconscious sphere, is the state of immanence itself, and the dream state, a semi-conscious transit in the shadow or subconscious sphere. Well, we have given a long explanation in order to affirm, almost with complete certainty, that spiritual raptures, abductions, paranormal phenomena, etc., are perceived outside of both states, a third posture of the "I" confused with the self, which is called **hypnagogia**. Let us explain it.

Both the waking and sleeping states are imbued with immanence, thus adjusted to the biorhythms of the physical body. There is physical activity in both states. Well, in *hypnagogia* there is NOT. For an indeterminate moment the self reaches the point where the lost self is located and is disincrowned from all biorhythms, disconnected, so to speak, from the body. This is the reason why abductees, astral wanderers, and paranormal experiencers suffer from a kind of bodily motor paralysis. The self, when placed in the "I", becomes timeless; in hyperborean gnosis it would be interpreted as the conscious glimpse of the **fenestra infernalis**. We will come back to this later, for now suffice it to say that close encounters, abductions and other states of latency induced by the use of psychotropic drugs, can tear us out of time and that is why paranormal phenomena, levitation, telekinesis, telepathy, mind control, extrasensory perception, are produced in this third posture or altered state of consciousness.

The testimonies of abductees are conclusive, there is space-time distortion accompanied by extremely traumatic experiences; introduction of probes into the body, manipulation of the human "aura", or else of the subtle bodies or the functional matrices of the design, meticulous recording of ontic memories, insertion of substances and even prostheses, etc. A few years ago, in 1994, a very explicit film appeared on this subject: *"Fire in the Sky"* by Robert Lieberman, which revolved around one of these cases of abduction and contact of the third kind. We recommend watching and analysing this film, and another more recent one: *"The Sign"* with Mel Gibson and Joaquin Phoenix, which we will go deeper into when we look at the subject of the *Crope Cicles* and the alien type called *"humus"*.

2. Alien Biotypes.

Outside the realm of science fiction, many of you will be familiar with the image of the small "little man" with a bulbous head, large pupil-less eyes, no ears and lips, a long neck, equally elongated arms and legs, and an earthy colour, commonly referred to by abduction and close encounter scholars as "the greys"; these *"aliens"* have practically become a cultural icon on a planetary scale and one finds them in the soup. However, although "pop" culture has stylised them abusively and they are as prevalent in the collective imagination as "Smurfs", "Ninja Turtles" and "Elves", the information we shuffle through suggests rather, that they really exist, and are more than collective myths rooted in the psychotic fantasies of an "alienated" society, and now the term fits correctly.

From what we have seen so far, it gets pretty complicated. On a hierarchical scale, we have the *Seraphim Nephilim* on the biotopological cusp, protagonists of the

gigantic and buenoid, because according to the acolytes of these "*aliens*" their proximity would raise the vibrational level of the environment, purifying the denser matter and the physical, mental and emotional bodies of the contactees. But where do green or earthy dwarfs fit into all this? Faced with such a framework where a whole series of speculations and theories have been woven, each one more far-fetched and absurd, we have no choice but to try to clarify the picture, establishing serious biotypologies, that is, possible in the field of the alien phenomenon and that, in addition, provide us with valid guidelines to explain the hundreds of cases that corroborate, at least in part, the cultural crusts about the form, colour and purpose of these "beings", which would be partly true, as in the case of the famous "greys".

3. The Greys.

There has been no end of speculation about their origin. They are said to have come from a planet in the *Zeta Reticulis* system, so they would also be called "*Reticulians*". Interestingly, British occultist *Aliester Crowley* claimed to have had contact in corporeal form with an entity he called LAM in New York, 1918, as part of the so-called *Amalantrah Works*. His description and drawing of this entity is very similar to the Grey biotype. *Kenet Grant*, one of his disciples, founded the "*Typhonian Order*" in late 1944 to invoke extraterrestrial entities through the "Cult of Lam"; this was undoubtedly the benchmark that gradually turned the grey biotype

They would be native to the planet as gene-products, a species of intelligent biorobots that the aliens who claim the created world and the powers of matter would use as crews of ships to perform surveillance and data collection on the hellworlds, from abduction and mutilation of animals, the famous "*chupacabras*", to monitoring paranormal activity. The real name of this hybrid species would be "*Sheidim*", the earthy-skinned dwarves who dwell in *Chang Shamballa*, a gigantic extraterrestrial base from which the aforementioned aliens of the cultural pact manage all macrocosmic variables.

Nimrod from Rosario describes them as dangerous, only when they are in a large group, they would carry some kind of stun gun, and according to *Rosalía Tagliavore*, who caught them snooping around *Felipe's* workshop, they would be wearing some kind of overalls. In this sense, everything coincides.

As for the monitoring of paranormal activity, it is logical that this kind of planetary police exists, since people who experience altered states of consciousness can be **fenestrated, which** would mean that the subject in question is suitable for contact with the aliens of the liberationist side, and this can only cause headaches for the agents of the system, from MIB (*Men in Black*), to services specialised in tracking down reactionaries dangerous to the synarchy.

4. The "Humus" type and the "Croupe Circles".

This alien biotype is very interesting and mysterious. Some claim that they are called "*humus*" because they come from "*Humus*", planet, moon, star system? Others argue that they are intraterrestrial and that the name is symbolic; as above, so below: under the *tree of life* there are earthworms, which are producers of "*humus*", the fertiliser produced by the "*humus*".


The particular feature of the phenomenon is that they are colossal diagrams that appear overnight, up to ten hectares in extent; the skew shows no trace of mechanical shearing and residual microwave magnitudes and electromagnetic disturbances have been measured in the surrounding areas. Some suggest that the

The *crop circles* have notoriously Mayan characters; but the symbols they display could also be framed as Tartessian, Egyptian, runic and even Hebrew, culturally speaking of course. So what is the purpose of these signs; simply to remind us of their presence? Would the aliens involved in the *crop circle* phenomenon fit into another manifestation of the grey biotype? Because they are very different, it has to be said. From the traits of the alien character in the film "The Signs", he would fit more into the form of the liberator alien or "loyal *siddha*", reptiloid, hostile, unfriendly.

Given the lack of information, and considering that in this report we are trying to establish an "alien" biotypology, ordered and differential, we will frame this biotype as "Humus", both for the semantic meaning of its name, as well as for the "signs" that would clearly indicate this framing.

5. The Humanoid Type.


Other "extraterrestrials" who have been the protagonists of close encounters, according to many contactees, would be of humanoid type, very good-looking, of enormous stature, with at first glance, "Nordic" features, and would sometimes be seen alongside the earthy-skinned "*sheidim*". Sixto Paz of the *Rama Mission*, and many *New Age* theorists, claim that these beings come from the constellation of *Taurus*, in the *Pleiades*, and that they have various



colonies on the moons of *Jupiter*. The truth is that these "*Pleiadians*", according to the information we possess, are not such, their real name would be *Hiwa Anakim*, a species of superhumans born of carnal copulation between aliens of the cultural pact and women specially selected from among the human races in ancient times. In this anachronistic context, it is time to clarify again that the aliens' abodes are situated in dimensional folds of space-time where time does not pass, or passes very slowly. They are, properly speaking, time travellers, as they can transit outside of time. While witnesses claim that these giants would be benevolent, ancient traditions describe them as fierce-looking and extremely dangerous, as they are the spoiled children of the *Nephilim Seraphim*, as Hebrew tradition calls the extraterrestrial beings who made a pact with the creator.

Note the persistent presence of the *anunaki*; in this case, hyperborean wisdom warns that these beings would be the guardians of the threshold; and it is possible that this is constant when analysing the cases of contactees, who coincide in having experienced states of hypnagogia, motor paralysis, thought transmission, possession, hypnosis and even *samadhis* or *nirvanas*.¹⁴ It is quite clear, when the subject comes to experience this confrontation with the actual infinite, either his consciousness is irreversibly phagocytised, merging with the demiurge, or he is able to resist the symbols that emerge in the *fenestra*, and in an act of heroism, free himself, back to the ORIGIN.

For some time now, theosophism and related branches, for numerous esoteric groups make use of the same study materials, have converged in the complete Hebraisation of their rungs or upper chambers; mandalic symbols, yantras, mantras, and postures, are impregnated with esoteric Judaism: the keys of *metatron*, the book of splendour, grimoires, course of miracles, tantrism, rituals of high magic, are saturated with this Judaic cosmogony, and, unsurprisingly, even the aliens, represented as beings of light of YHVH.

From the first alleged "*Pleiadian*" contactee, the Swiss *Billy Mier* in 1942, to the most famous case of alien-human copulation starring, of course, parents of *Cynthia Appleton's* half-human, half-alien son *Mathew*, these aliens present themselves, or at least in eyewitness descriptions before them, as real Israelites, wearing uniforms with Israel's patriotic insignia, the six-pointed star, and to top it all off, saluting "*Shalom*".

6. The importance of Exopolitics.

Exopolitics is an unofficial branch of foreign relations made up of specialised agents belonging to the secret services and intelligence agencies of the leading countries of the new world order, i.e. those that were allies in the second world war. These states, in addition to conventional intelligence and "dirty work" organisations, have top echelons that are well educated in the true alien nature, equipped, subsidised and trained in the knowledge of all kinds of esoteric science and areas of paranormal phenomena. Above the CIA and the FBI, there are the MIB (*men in black*), the MI-5 and MI-6, the




Undoubtedly the most representative agents are the MIB that are always described with a peculiar appearance and modus operandi: *"Creatures that have all the appearance of a human being, but are of a non-terrestrial nature, as we mentioned, they have a human appearance, but transmit a strange sensation. They may come alone, but usually in pairs, and sometimes in groups of three. Continuing with the description, their usual form of dress is: black suits, although they have also appeared in military uniform, they move around in a car of a very old model, although of a new appearance, in the United States it is usually a prestigious Cadillac, but rarely a recent model. At the same time, although it is a*

*perfect condition, scrupulously clean inside and shiny on the outside, and even has the unmistakable "new car" smell. If the subject writes down the registration number and investigates it, he always discovers that it is a non-existent number. The Druids, agents of exopolitics in contact with the treacherous aliens, as we shall see later in another section, subjected *Hess* to psychoactive drug treatments.

unknown in order to break his mind. What they did not know is that *Hess* was a kind of antenna that would radiate from *Spandau* the guidelines for post-World War II Nazi operations. *Hess* would be killed by ritual sacrifice, and it is quite possible that *Shin Beth* agents perpetrated this crime, which means that these agents would have been privy to complicated esoteric and ritualistic techniques unimaginable to mere lay agents of conventional intelligence services.

This is why an exopolitical centre must be mainly composed of esotericists or priests belonging to the highest initiation chambers, since they must handle ultra-confidential classified information, loaded with insane elements for those who do not participate in these instances.

However, almost all countries have experts in this field, albeit unofficially and in a veiled manner. For some time now, the Masonic lodges have served as a cover for promoting both politicians and agents to these spheres, who ultimately, given the net Judaic character of that organisation, directly or indirectly channel the designs emanating from the treacherous aliens. But the present report has been spun to provide an extraordinary message. CHAPTER SEVEN

The True Contactees.

1. The most important abduction and parthenogenesis case of all time.



Rosalia Tagliavore was born on 30 May 1930 in Rosario, Santa Fe province, Argentina. At the age of 16 she had her first and only son Felipe; in 1964, when Felipe was 16, note the coincidence, she began to be contacted by aliens. Since then she was abducted several times and taken to an alien base in Antarctica. The "extras" as Rosalia called them made a revelation to her, that her son was half human and half alien. Evidently, according to Rosalia's account on the web, the child's premature birth aroused the sensitivities of the paternal family, in the manner of the biblical account of Joseph and Mary's pregnancy without having met her. (This is not to say that this child is a new Krishna or Jesus or anything of the sort.

The "extras", Rosalia claims, fathered a child for her through a process of parthenogenesis. The abductions continued to occur irregularly until on one occasion the "extras" ordered her to send Felipe, who was twenty-five years old at the time, in 1972, on a trip to Antarctica. In 1996, after her son had completed the mission for which he was sent to the world, he disappeared without a trace. Then Rosalia, after four years of waiting, received a new instruction from the "extras" to publish his entire personal history on a website and that they had taken Felipe with them, who, by the way, according to Rosalia's website, always knew that once he had finished his mission, writing the book he had been sent to write, he would be evacuated to the alien base in Antarctica.

How Rosalia survived and endured so many vicissitudes is a mystery, as is how she spun and emerged such a wealth of information with such strategically targeted data. Anyone interested can corroborate the incredible event on the web. Although Rosalia was a humble and uneducated woman, she became, during the time she was activating the whole movement from Rosario, a powerful charismatic centre. Her departure a little over a year and a half ago left her work group and the circles of people who revolved around her presence in desolation. Always reserved and very cautious, she said and did only what was necessary, without an extra note. Aware of the mission that her son had to accomplish, she was always in control of this variable, preventing those who formed part of Felipe's group of closest collaborators from diverting or giving priority to other alternatives outside the realisation of the prodigious book that was being written.

Important essays and messages were poured out in her own handwriting which she could never have put together as "simple Rosalía", she herself said that she did not understand a single word of what was said or dictated to her... that the messages were for "others" and not for her, although she channelled them and then disseminated them through a specific group of people, who were completely trusted by her and who maintained the page, updated it, ran the forums, and operated with her on certain well-defined missions. This operative group of close associates always participated in Felipe Moyano's deployments, and after his departure, in Rosalía's; we will talk about this group or groups of people called OCTRA later on, within the framework of what is strictly pertinent. As far as Rosalía is concerned, and to conclude this brief review, we can say that she left the guidelines so well defined that she still operates as an indisputable charismatic centre, without the need for her physical presence in this world context, that is to say, those who had to be summoned have already been summoned, now it only remains to act as she did, without other considerations than the objectives set out in time and form.

2. The Mission of Luis Felipe Moyano.

Felipe Moyano came into the world on 28 October 1946. Outstanding in all his applications, Rosalía was advised to foster his innate genius through a specialised education. specialised education advanced y unconventional specialised education. But it was with the trip to Antarctica in 1973, accompanying an Argentinean scientific mission for three years, that Felipe became aware of the mission he was to fulfil for the "superiors": to write the most important book for mankind. Since his return from the "Belgrano" base in 1976, he compiled and studied 5000 books, threading together in his head all the hows and whys of history from the very source of its language.

original: Spanish, Basque, Latin, Sanskrit, German, English and Hebrew. Endowed with an acute comprehensive vision, he developed a system for reviewing the cultural records contained in multidimensional spaces of time-space, gaining access to the living history of cultural events and their protagonists. He rediscovered the lithic wisdom that allows us to know the properties of stones and their manipulation to operate complicated techniques of spatio-temporal isolation. Endowed with this extraordinary erudition, it took him 20 years to write the book that his superiors, the "extras", had entrusted to him: *"The Mystery of Belicena Villca"*. Persecuted by the intelligence services, hindered and harassed, he changed residence dozens of times, until he was finally able to form several circles in Cordoba that managed to disseminate the prodigious book to a select group of chosen ones.


At a certain moment, and in the face of the powerful siege that the intelligence services and the masonic power that directs the destinies of the Argentine Republic exerted to

neutralise the movement for the dissemination of "*hyperborean wisdom*" in

Córdoba and other Argentinean provinces, and on instructions from the "Superiors" to Rosalía, it was decided to publish *"The Mystery of Belicena Villca"* on the web. This is how it came into our hands at the end of 2005; to date we have been working for six years to disseminate it, forming reading groups, philosophical and esoteric circles, civil associations, clubs of friends, etc.; until in 2011, a year ago now, we managed to publish the first physical edition here in Bolivia, and a couple of months ago, in June, a second, somewhat larger edition, which is being disseminated through various socialisation strategies.

We can now say with certainty that the "Magical Novel" is the substantive, heroic part, for it narrates the acts of valour that are required to actualise the Hyperborean Wisdom. Without acts of valour to express it, all that unheard-of knowledge so

would only remain a dead letter, which is why we all agree that the novel is ALIVE.

That is why Felipe formed the Order at the behest of *Ricardo Centeno*, who provided logistical support. It was necessary to free a place from which to operate without being affected by the designs that would inevitably and unexpectedly fall on the operator. The Order was a Circle where each member acted as part of that containment, drawing upon himself to reduce contingencies, arguments and situations that would otherwise have had to fall to Philip. It was not an easy task and there were betrayals that left certain flanks exposed, so Rosalía had to bear the brunt of closing those gaps. The campaign was very costly.

In this sense it is necessary, very necessary at this point, to make some considerations about the *Order of Tyrodal Knights of the Argentine Republic*, in order to show the readers our particular way of seeing the matter and which has taken us years to reduce, rightly or wrongly, in order to understand the importance of giving to each thing the place and the function that corresponds to it.

Different is the case of the *Veganist Movement*, WHICH IS NOT AN ESOTHERICAL INSTANCE, BUT A POLITICAL ONE, although some of its members participate in the esoteric, and where the ODAL rune occupies the centrality of its symbolic ensemble. In spite of this, they are not "TIRODALS" nor do they call themselves as such, since it is not up to them but to abide by the directives emanating from higher instances through the strategic materials PONTIFIED by *Nimrod of Rosario*, framing

themselves strictly in the "O" strategy of the "O" of the "ODALs".

Loyal Siddhas, although their psychosocial political strategy is called the "V" strategy. So far, the Veganist Movement is the only political and social action group operating in the region, justifying its action on the following principles of the "O" strategy: *"But it should not be believed that the Odal Strategy is only successful when there is a real transmutation of the sleeping man into the Stone Man; that is undoubtedly the most important success, but it is not very frequent, especially in the case of Leaders or Conductors of peoples. Not being fully awake and ignorant of the origin of the "message", they proceed to apply the strategic principles in the governance of their peoples, taking them for their own invention. I could give many examples, but it will be of particular interest to you, Dr., to consider the case of those who have unwittingly "discovered" the principle of encirclement.*

When the "principle of the hedge" has been incorporated into the mental structure of a Leader, his Pure Blood, and with it the Song of the Gods, impels him to apply the "law of the Hedge" in all his concrete acts. Thus arise from particular societies to political, philosophical, moral theories, etc., conceived and executed according to the law of the hedge, within the framework of the Odal Strategy".¹⁶ That is exactly what the Emerging Vegan Movement, also called Vegan Legion, Vegan Phalanx, etc., is all about.

Having made this clarification, we can now conclude that OCTRA has made possible the dissemination of the *"Fundamentals of the Hyperborean Wisdom"*, according to the directive set forth by the "superiors", that is, ONLY TO THE ELECTED, meaning those who WILL ACT, PARTICIPATING BY THAT ACT, IN A STRATEGY OF LIBERATION. That is to say, all the meaning given to a CHOSEN person is completely turned towards the strategy in which he or she participates, and this ODALISATION is evident. This is the TIRODAL instance, a meaning-making exclusively focused on fulfilling the directives emanating at the time from the "superiors" through *Rosalía Tagliavore* and, when he was active in the sphere of meaning of the world, from *Nimrod de Rosario*.

And, in the same way, a true veganist, who can only ODALISED, can put meaning into the realisation of the veganist strategy inspired by the "O" strategy.

To conclude, let us speak of *fenestration*. *Fenestration* always requires an external will in addition to the will of the Self - which we call "alien" by virtue of the fact that the egoic agent is precisely alien to the soul subject which carries it along in its immanence - to manifest at a given strategic moment; if it did not, the interdimensional control system would detect the energetic movement, neutralising it, with grave risk to the *Viryá*. In other words, the instance of

fenestration is always brought about by an external agent with the help of the egoic agent. In the case of OCTRA, we can assume that its *fenestration* was propitiated by the Pontiff as an external will. In the case of the vegans, who evidenced their *fenestration* through the strategic acts that were concretised, we can only assume that it was a powerful external will that brought about the revelation of the unimaginable: the I-situation. The precondition for the manifestation of the *fenestra*, as readers will have already sensed, is ODALISATION, brought about by the egoic agent; there is *odalisation* when the whole of the sense-making participates in a strategy of liberation and an external will isolates the I; this alone guarantees the continuity of the Strategy, making possible the participation at the right moment of that external will, in order to *fenestrate* the aspirant. *Odalisation* is realised when there is this double coincidence.

4. Paranormal Activity, Altered States of Consciousness and the Astral World.

We have already said that paranormal activity refers to the voluntary or involuntary capacity of a subject to fracture or cleave, in some circumstances, the veil of maya, the illusion of the surrounding world, altering the eminent laws that govern it. Telekinesis, telepathy, levitation, distance vision, transit through parallel worlds, accompanied by altered states of consciousness provoked by the extra push of an alien will, the Ego, which at times reveals itself to the conscious subject who engulfs it in its temporal immanence, or perhaps the intervention of an external will, the alien contact. We also said that if that alien contact comes from those who do not participate in the synarchic strategy, i.e. the liberating aliens, it could be detected by a kind of control system or police, let's call it, interdimensional, where the "greys" or *Sheidim* play a leading role.

The Sheidim, a system of police control.



Then, if the initiate or psychonaut, by the thrust of his Self, or by the particular circumstance that his psychic evolution is going through, approaches the ORIGINS, he will be intercepted by those alien police, or else he will confront the threshold guardians, and without strategic posture he will unfailingly succumb, or worse still, die in the daring attempt.

Now, to understand what the astral world is, we must refer to the Hyperborean Wisdom, and try to glimpse the morphology of the Demiurge himself, since the astral world is one of his psychological spheres. 

2. The Vimanas of YHVH and the treacherous aliens.



Recall that in the mission "*Key One*", "*Operation Altwesten*" where a squadron of the Black Order SS under the command of *Karl Von Grosen* and *Kurt Von Süberman* was sent to intercept *Ernst Shaeffer*, leader of a renegade group of the *Abwher*, Army Intelligence Service under the command of *Wilhelm Canaris*, Germany's greatest traitor, where a dangerous clique of *anti-Hitler* infiltrators and communist acolytes operated, to open the *Chang Shamballa* canyon in "La Brea", in the *Kuen Lun* mountain range between Tibet and China. On that occasion *Bera* manifested himself in an energy armour and attacked the SS detachment.


3. False neo-paganism and neo-Nazism.

The synarchic strategy has always been the same: imitation in order to co-opt symbols, groupings, strategies and purposes, and divert them towards their own hegemonic goals. important to reduce this framework.


Leon Degrelle, a charismatic leader

It is here that the neo-pagan and neo-Nazi movements influenced by the aberrated mysticism of *Crowly* and *Anton Lavey* would play an important role, one side of the coin, which would radiate to that gentile youth - indifferent and empty, potential remnant that together with that new national socialist leadership, could jeopardise the realisation by the synarchy of the long-sought World Government of *Jehovah Satan's Chosen People* - through a new, updated vehicle for hypostasising gentile charisma through forms of artistic expression revolving around a revolutionary social movement influenced by the

In 1951, *LaVey* evidently had relations with *Jack Parsons*, the leading American disciple of the English magician and Satanist *Aleister Crowley*. *Parsons* had set up the "Agape" lodge in Berkeley, which brought together the Crowlyan faithful in California. *Parsons* rented a building for his lodge and opened an occult bookstore across the street from the *Berkeley campus* that was frequented by many of the leaders of the radical counterculture of the 1960s. This, coupled with the MK Ultra programme that would promote psychotropic psychedelia in order to prevent hypostasis from being reoriented towards a true spiritual revolution, generated the largest social movement of modern times, and millions of barefoot *zombies with flowers* in their hair flooded the streets and squares of the world's major capitals.

Yes, the synarchy had managed to capitalise on all that sense-making in its favour. The new leadership would be reduced by conspiracy and assassination, while the militant youth who were to sustain it sank into the swamp of a worthless life chasing scraps of something much greater reduced to the pompous paraphernalia of pop icons, clinging to bizarre fashions of decadent art to fill their emptiness under the sway of new forms of drug addiction, pseudo sexual liberality and uncompromising love.

The white, Caucasian, sinecure, Zionist Jew, thank goodness, there was no longer anyone to stand between him and absolute control of the wealth of nations.

4. The End of History.

This is the context of the end of history. As we have seen, the synarchy has turned everything upside down, to such a degree that even it does not control the variable of when.

That's life.

But if you have glimpsed even something that coincides with your own truth, we recommend you to take the bull by the horns, that is, to realise your strategic situation, to recognise that you do not belong to this world, to begin to renounce all ties that bind you to the illusion of life, and to abandon everything, in pursuit of a single ideal: TO FACE THE NEXT END OF HISTORY WITH HONOUR. Do it with responsibility and maturity, if you have pending commitments, fulfil them, that does not prevent or disqualify you from realising the lie and acting accordingly; we guarantee you that your Spirit and the liberating aliens will be there to assist you and give you the necessary push to help you realise your reckless challenge.
