

## **Brian Ruhe show December 2018**

Welcome to Revolution Radio on Tuesday nights from 6 to 8, this is October the 23rd, 2018. My guest is Loki Holgard, he's in Medicine Hat, Alberta, he's recently been arrested for a hate crime of some crime. This is Loki's second time on my show, so Loki, tell us a bit about your story and we can go from there.

Well, basically, I don't know where you want to begin in terms of my biography or in terms of the specific issue related to the hate speech or the public incitement of hatred crime that I was alleged to have committed by disseminating flyers and stickers around the town. If you could start with how you're running with the law came, what they charged you with, start with that. I can do that.

So basically, I've been charged with public incitement of hatred for distributing leaflets and stickers that proclaim Jewish white genocide or immigration equals white genocide and Jewish supremacism. There are also other messages that I had stamped with permanent marker ink on money bills, like Jewish white genocide, referring to various websites, statistical websites that verify that these claims that are implicitly made in these messages are actually verifiable facts and they're not just opinions, beliefs or, you know, irrational hatred, but they're verifiable claims on the basis of statistics, on the basis of the power that Jews hold in society, on the basis of their control, the major functions of power, the media, this and that and the other. And so basically, I've been charged with so-called public incitement of hatred under, I guess it is section 319 of the so-called hate speech laws.

And I've been basically sort of in a limbo state in terms of my legal case. I've been attempting to engage a lawyer from outer province recommended to me by, I guess I should, I don't know if I should reference Paul Fromm, who is assisting me, I may as well since we are here. Paul is a friend of us both, a friend and mentor to us both, we're the Canadian aid team here.

Paul Fromm is in Ontario, Loki is in Alberta and I'm in British Columbia, this is real Canadian effort. So basically, I was trying to engage a lawyer from outer province and Mr. Fromm curiously said that he would be willing to pay for the travel expenses of the lawyer and all that was required was the same cost of having a lawyer, the same as a lawyer locally, fees and disbursements for the lawyer, and the legal aid were giving me huge amounts of hassle and not giving me prompt answers as to whether this is something that they would actually do and I had to go through all sorts of incompetent minority workers at lower levels who would just sort of rudely try to brush me off and try to talk over me and prevent me from speaking. But did they tell you that you have to have a lawyer in your province of Alberta, you can't have some outside of Alberta, was that the problem? That was basically the conclusion that had been reached after probably well over a month of attempting to go through legal aid and also, so basically

that's the situation at the present moment that it's all up in limbo and I spoke to quite a few lawyers in the province and so forth trying to get them to have a willingness to take on the case with a reduced fee which is what they call a legal aid certificate, which is where legal aid pays their fees and disbursements, but most of the lawyers are such a bunch of greedy pieces of garbage that they basically refuse to even take on the case even though they were receiving money for it and of course they would never take on the case pro bono, which is to say gratuitously without receiving exorbitant fees because I suppose that they're too interested in their selfish greed and mammoned and they are the cause of the survival of their own people and ability for people to actually be able to speak their mind and have some freedom of conscience in this society and so basically at the present moment that's one of the major things that I would like anybody out there who knows anybody within Alberta, preferably within southern Alberta or in Medicine Hat, which is where I'm located, or Lethbridge, who knows a lawyer or who is a lawyer who actually wants to take this case on either through a legal aid certificate or if they're anywhere, if they're licensed to practice law anywhere in the whole country, if they want to take this on pro bono, gratuitously, which I encourage the viewers if they know anyone and this message gets out on YouTube, Bitchute, Revolution Radio, but I think it's an important cause you need the legal support at this time, like the International Jewish Power, they can print unlimited money, they have all the legal resources and one thing they do is abuse by process, they put people through the mill legally just to run them down and wear them down, so now is the time when we have to rally support around Loki because these cases happen in Canada, this is a case where we have to defend you and do what we can.

Yeah, in this case I guess you could say might very well be precedent setting because I specifically referred to Jews as such in the propaganda, it's not just propaganda, that's about like it's okay to be white or something, which is a more soft core variety of propaganda, which is still pro-white but not explicitly implicating Jews, so in other words this case basically will probably, if they get their way, will justify setting a precedent to basically censor people from speaking about Jews and that's exactly what they want. I guess I'm comparing it to my own approach, like we're kindred spirits, I often use the preface of the elite Jews, Jewish supremacists, or technically I would call it the Rothschild Zionist Talmudist, because a lot of average Jews don't know too much of what's going on or they don't have any money, do you in yourself, in your own mind, you differentiate between 60 million Jews in the world or the particular Rothschild Zionist Talmudist elite Jews, do you differentiate that way? I think there is some degree of differentiation, but at the same time the Jews do function as a collective group and derive profit and benefit and power through their affiliation with their collective and so even though they may not necessarily be hardcore Talmudic Jews, at the same time they are still, they still function as a group and so they have a biological basis for their praxis, their political activism or their business activism, it's all nepotistic, they all work together to some degree or other and so it's very difficult for me, given my vast experience with lots and lots of Jews in my

life, to be able to claim that the Jews are not collectively responsible for what's going on in the world, white genocide, because they function as a collective and again like Alfred Schaefer and various other people have said, there aren't very many Jews speaking out against this, these issues and you know the clergy plan, mass non-white immigration into... Yeah, yeah, I see what you're saying and for me my policy is every guest on the show, you know, they're the guests, you can express your views, so that's fine and you're right about the clergy plan and yeah, Alfred, he's a straight shooter as well, like you, you know. And of course, that's the unfortunate thing, because in this society, if you shoot from the hip, then you've got all sorts of guns pointed at you in the form of the police state and so they can basically break and enter into your property, steal all your property and then throw you into a cell and make you disappear, especially if you're not a well-connected person who understands or who has good connections and thereby has a sort of safety net surrounding you, whereas myself, I'm a complete lone isolate.

Wait a minute, Loki, you're connected to the Brian Roo show, you're seen by thousands and Paul Fromm knows you, so you're, you know, honestly, you know, when I started in 2015 with my show, I met Paul Fromm that year and I actually thought of him as he's my connection to Canada, because he's the old generation, he's been at this for 50 years, he's 69 years old, so I thought if I associate with myself and Paul Fromm, I'm less of a lone isolated target. That's actually my strategy, so I've done over 100 videos with him, so now you can hook up with me, you're the younger generation, I'm 58. How old are you, Loki? I'm 35.

Okay, so yeah, I think we're spreading our wing here, you're under our wing now. At least that's some hope for the future, that there's some people in Canada, some whites at the higher levels of, you know, status that actually have regard for their own people and their identity, such as a Doug Christie or something, that would be nice if there was another person of that sort who would come to the fore, who actually has a legal background or something. Maybe we should define who Doug Christie was, he's a lawyer who died on Vancouver Island a few years ago, but he defended Ernst Zundel on the Great Holocaust Trial of 1988, just a legendary Canadian free speech lawyer, you know.

Do you want to comment a bit on Doug Christie? Well, I personally don't really even pay very much attention to the particularity of politics or anything of that sort of legal issues, and I'd only heard of Doug Christie within the last few years, but so far as I understand, he was very willing to put it on the line, his reputation, etc., to defend people who are of pro-white cause and who actually have a willingness to speak out in favour of their own survival and continuance and advancement, instead of just cowardly tucking their tails between their legs and allowing themselves to be genocided by non-white immigration, which is obviously a deliberate plan on the part of the Jewish supremacists or the Jews as a collective to flood the country with non-white immigrants, specifically to try to, quote-unquote, mongrelize the races to make their hybrid product, their mongrel, as Kalergi called it, the man of the future will be a mongrel, a mixed race, Eurasian. Yeah, maybe

for the audience we can define, he was Count Koganoff-Kalergi around 1923, wrote the Koganoff-Kalergi plan. He was half Austrian, half Japanese.

He, in a sense, was the father of the European Union. He devised this vision of turning Europe from a white continent to a mud mixture of races. He's one of the biggest disasters that ever happened to the white race.

And he was funded, I believe, by Bernard Baruch. He was not Jewish himself, Koganoff-Kalergi, but he was funded by the Jews. Yeah, he was funded by Jewish bankers.

I have an audiobook of his book, Practical Idealism, that I made on my BitChute channel. I have two BitChute channels. One is called Aryan H8, Aryan Hate, and then the other one is my name in all lowercase letters with no spaces.

And those two videos basically are presentations of very core and key fundamental pro-white books. I saw your websites as well, it's really cool, you did some real good production, impressive look on your websites. Why don't you give everyone all of your website information right now instead of at the end, and we can paste it below this video as well.

Sure, yeah. I actually am on the websites right now, and of course at some point in this show I could always turn the camera around and just display them if you want, but one of the websites, this is about... Yeah, feel free, feel free to move the camera around. Your generation is better than the computers of mine, so anytime, it's up to you.

I'm not too sure because I can't see my camera. I'm not too sure. That's fine.

Hey, I can see myself. How's my hair? Okay. Yeah, that looks hilarious.

Okay, so here basically is just a provisional website of a larger website, so it's very poor quality so far, and I need to get some donations. Loki, you should center it because this is a split-screen Skype, so put it right in the center because the sides will be cut off. Yeah, that's centered.

That's good. Okay, so this website is basically just a scaled-down, very basic bare-bones version because I have no money to set up a better domain or to actually get all my content on there. I had well over, I would say, 2,000 PDFs from various, more or less, every source on the entire internet for white nationalist information.

I had huge amounts of MP3 files and very useful homesteading information, practical survivalist information, as well as my own personal content, and this is basically one of my handbooks, so if people want to donate to me and give me \$200 and I can get a better domain. Yeah, how do they donate? Do you have a PayPal? No, actually, how you can donate to me is through going to this other website that I have, which is related to this case specifically, but the donations for this case are not for legal funding. It's just for

basically getting some money to get a better website to put out content for people, and then on the other hand for... How can they send you money? Like, PayPal is very convenient.

Can you open a PayPal account? Here's the... I don't know if I should click you off. I shouldn't do that, should I? Your panel here in the upper corner because it's sort of... I think you can. Yeah, I think it's not necessary.

Try it. I can always call you back. There you go.

That's fine. Yeah, but you should try PayPal. Have you ever tried it? Well, I think you just let me explain.

This website, I think I've been having some problems with it too because it's only like a \$25 website that I put up, and the domain name is different from the one that I had actually paid for. So, for some reason, it's freespeechcanada.nfshost.com, and basically, it just presents the case files by manifesto, which is a manifesto I wrote prior to attempting suicide after this case because I got very tired of living in this horrible world, and so I was going to commit suicide. And so basically, it shows the manifesto right there.

I have a disclosure of all the police reports and everything that the police... And they're all redacted, which means that they've been edited and so forth. So I don't know what sort of chicanery is going on with this case specifically. But see, the website's sort of slow to even upload and so forth.

But basically, it's got general occurrence, all the police files and so forth I have here. And I also have evidence, just some of the stuff, some of the propaganda that I disseminated, such as stickers, putting this up on immigration centers and churches, because they're obviously very instrumental in facilitating the influx of non-white immigrants in here. And so obviously, that equation is pretty much legitimate.

I've been just leafleting, putting them in people's windshield wipers, stamping on money bills, doing this and this. And so that's just some examples. And so... Can you show us a picture of one of the bills that you've stamped? Can we see a bill that you've stamped? Because I saw a \$50 bill there.

Go up a bit, or the \$50 bill. Well, that's your stamp there, right? Yeah, what does it say? Yeah, it says Jewish white genocide. Jewish white genocide.

So you stamped this with a black ink stamp right on a \$50 bill. Yeah. Well, you've got balls, Loki.

You do a lot of things that I would never do. Well, I mainly put this on \$5 bills, because obviously, it's a smaller denomination, and I can get more of a message out that way. So

there's that.

And so if you want to give me a little bit of money, that'd be greatly appreciated. Since I have maybe \$200 to my name, I have to live off welfare. My reputation is damaged in the town because of the media defamation against me.

So I have basically maybe like \$580 a month that I'm given. Where's the donation button? How do they do it? You can email me. There's an email option here on the lower screen.

How do people email money? Well, I think it goes through PayPal. I had somebody help me set it up. It goes to a PayPal account.

Yeah. So do you have PayPal set up? Yeah, it's set up through this email. Also in Canada, we have internet banking, but I've discovered it doesn't work for the United States.

It's only within Canada. It's such a hassle. Like there's some real hassle trying to just send money from Canada to the United States without paying a \$25 wire fee.

But PayPal is good. PayPal, it's like just a 3% administrative charge. So if it's hooked up to PayPal, that's good, because I found myself it's got to be convenient for people.

Yeah. So basically, that's the website, [freespeechcanada.nfshost.com](http://freespeechcanada.nfshost.com). And it basically just shows all the police files and everything that I've been charging. I just mentioned NFS means nearly free speech.

[Mythoolsociety.com](http://Mythoolsociety.com) is on nearly free speech as well. So it's a good free speech website holder provider. So it's probably going to withstand.

It's protected by the First Amendment of the United States. That's the meaning of .nfshost. Right. So this website is the other one, which is just provisional website just to get some basic of my content up there.

But it's only a small, small portion of my content. So people give me a tiny bit of cash and I can set up a better website. It's [race.co.nf](http://race.co.nf) is the current one.

And so it basically just shows a little handbook that I wrote for the white nationalist movement called white law. And it's basically PDF, sort of a slow website right now, but hopefully that can be improved if I get more bandwidth that I have to pay for it, probably have to pay more money for it. So these are some of the works that I did.

Basically, a handbook, I wrote a basically like about a 900 page book of philosophical writings, which entail short stories and philosophical writings and treaties, so to speak, comprised of philosophy books. I've got, yeah, basically philosophy books and short stories here. And more of the same here.

I have also a 660 page meme book of cartoons that I did. But I cannot get that up there yet until I have the money to pay for it. And then I made games and so forth.

I guess I may as well just show the bit shoot channel while I'm out here while I have the camera. Yeah, I mean, while you're talking visual aids are always cool, you know, I'm sorry for the revolution radio audience, but you can always watch it on Brian or on bit shoot or Brian or on YouTube or on Loki. We can put this on your Loki bit shoot as well, right? Yeah, sure.

Yeah, the file, then I'll put it up there. Oh, yeah, you can take anything of mine and go ahead and load it up. So basically, this is my channel for things that are more meta philosophical or meta political discourses that I put forth, which also entails a lot of my commentary on the case and charges, just from a jurisprudential standpoint, I guess, from a natural law, or a divine law standpoint, if you have a degree in philosophy in Alberta, because you sound very more articulate than me, is that right? Well, I have a degree from the U of Winnipeg, which is actually where I had been living for quite a long time.

I've only been living in this town for about a year. Manitoba. So what's your degree in? It's in philosophy.

Okay, so I just want the audience to know that you're a learned man, you know, you're not just some, you're not a, what's the term, a knuckle dragging Nazi skinhead. You've really given a lot of thought to this. That's why you're on the Brian Roo show.

Well, that's basically what they're trying to portray me as in the media as a terrorist. And I guess I should show. Yeah, I don't know if people want to see I could just pop it up right now.

Basically, the media slander and defamation of my name in the all I have to do is just enter in my name. And then you can get a bunch of media slander about me, how they how they displayed on the front. I know the feeling you type in Brian Roo, you get at least a dozen pages on Google.

And Sinead McCarthy made a wonderful video about me too, or two. But I kind of laugh at the criticism. How are you taking it the criticism? I've been at this for, you know, five and a half, six years, I'm just used to it.

Well, basically, criticism about me. It's, you know, I'm not, I'm sort of accustomed to abuse myself, because my liberal father was a very psychologically abusive person. And so I had spent much of my life being demoralized, I guess you could say by him.

And I guess I'm influenced by, by Buddhism. We still have to appreciate our parents, even if they're like that, because they've given us life. And there were some times, you know, when they they nourished us, they taught us how to walk.

So we, you know, it's good to try to avoid criticism of our parents. Probably, you know, I think we've got to give our parents a break. We haven't heard their side of the story.

I guess that's somewhat true. But once again, it's still a reality. So this is an image that they displayed on the front page of most newspapers, you know, how they replicate their stories through right Reuters, and so forth.

And in Canada, so this one, they display all these guns that they took from me. And the reason why they took them was because I had been very paranoid and concerned about potential gun confiscation in the coming future. That picture, those are your guns? Yeah.

So tell us about your guns, how many guns you have and tell us about them. Okay, I'll go into the firearms issue now. So basically, right here, I had stockpiled firearms for the purpose of, you know, safety, security and survival because of all the violent criminals that they're bringing in from the third world at this time, the jihadists, and whatever else it may be, who knows, Chinese communists, or God knows what they're attempting to do to bring against us at some future point.

So I wanted a means of self defense. So I acquired these weapons as a means of defending myself in the event of extreme emergencies. And so they're trying to put them forth here, as if I were sort of terrorist.

And of course, benign breath has slandered me a lot and anti racist action. So I have a couple SKSs here, I scratched off the serial numbers, because I was going to bury them in the ground, I was going to cash the weapons. And of course, that's apparently illegal in this country to do that.

It's illegal in Canada to bury guns in the ground? To erase serial numbers, even though the thing is, they tell us a bit about that. I'm not familiar with the laws, like just to think of the audience, right? The audience said don't know nothing, did do nothing. Think of them.

Yeah. So in this society, they claim that there's no such thing as a long gun registry, a long gun being a rifle or a shotgun. And yet at the same time, they make it illegal to erase serial numbers from a firearm.

But the thing is, a serial number is a means of tracking and tracing weapons, which is a means of basically unofficially registering it, because then they can say, this person purchased this gun, they live here, because the firearms license says so that they have to show in order to purchase guns. And so in other words, they can basically pin you down with having these are those guns on the basis of the serial number if they ever detected. So my intention was to erase the serial numbers and cash the guns in the ground, in the event that they were going to confiscate guns.

And that way, I could have a cache of guns somewhere buried way away from whatever

property I was living on. And that way, I could use that as a means of self-defense in the event of, again, extreme emergencies or societal collapse or some sort of revolutionary violence brought against the white population in this society, like they had done in the Bolshevik Revolution with the against the white Russians. They had brought in Mongolians, I believe, also to basically attack the population there.

So basically, I guess I think of, I think of the Kokonak Kalergi plan is a gradual, incremental thing, like, we're all frogs in a warm pot of water, they're slowly heating it up, because they don't want the goy, the cattle to stampede. So they're slowly starving us. So that's how I interpret it that way.

Oh, yeah, basically, it's called the Steinleit plan, too. Also, that's another thing that they're implementing, I guess you could say, unofficially, Stephen Steinleit, I did an audio book on his, some of his writings about how the they're trying to reduce immigration a little bit so that it won't wake up white people, and then white people will not be able to rebel against what they're doing as quickly. So they're basically trying to gradually do that.

That seems gradual, but I mean, I guess you want to be prepared for all possibilities, because the future is uncertain. Well, that's exactly right. Because given that that's the sort of Levin of the Pharisees or the gradualism that they employ as a means of basically effecting their changes, you know, like with feminism, their first wave, second wave, etc, of feminism and so forth.

So too, in this case, they start first registering firearms, when there was no registration for firearms before. And then from there, they start restricting firearm ownership and making more laws saying that, oh, this, you're not allowed to have a magazine of this capacity. And then five years later, if I didn't come up, I just want to tell the story that I heard about.

John Dhanujan told me that in Canada, two of our white nationalist compages were shot and killed by police. I forget what year one was in Edmonton, one was in Nanaimo, British Columbia, but the police knew that they had guns. And I think in one of them, they came shooting their way in.

And I think the guy bled to death. The other guy in Nanaimo, the police were in his apartment, they claimed that he attacked them, the police officer, I think a woman shot him to death. That's why I made public announcements that I have no guns in my possession, which is true.

I'll never own a gun because in my case, if I had a gun in my apartment, in Canada, you have to properly register the gun. Well, I could say, well, Brian Ruse, manic depressive, he went crazy, he's got a gun. So just for our safety, please be shot away.

And oh, sorry, Brian Ruse is dead. So I clearly don't have a gun. I'm just wondering if you, I just want you to know about those two cases.

John Dhanujan told me this back in the early days in 2015. He's one of our great white nationalist elders. I was just in touch with him yesterday.

He's been at this since 1978. I'm just wondering, were you aware of these two cases? And are you careful that the police don't use this as an excuse to come shooting in after you? Well, I actually never heard of that before, but I could definitely see how it would be something that they would do, such as the Weavers of Ruby Ridge and so forth, Randy Weaver and so forth, and how they basically pretty much just make up excuses to go after those who are so-called dissidents or a threat to their system, such as Gordon Call, who didn't pay property tax or an income tax. And then so they just went and shot him, basically.

And so especially we know of international Jewish control over the Masons. Masons control the police. Many Masons are police members.

If they want to take me out, well, they can do it. They control the judiciary. It'd be so easy.

Well, Brian Ruse, he's crazy, he's manic, you know, and we found him in a pool of blood or whatever. I know that, I know that, and you know that. Yeah, so I guess now they know definitively that I don't have any firearms, although they could always say that I have illegal firearms now.

So obviously that's a problem and it can be twisted and turned however they want semantically or, you know, through graphic visual arguments in their media. They can brainwash the stupid masses, I guess you could say, to believe whatever fear-mongering thing they want them to believe. So I can see that now just walking around the town that a lot of the people, especially Jews, that I had previously dealt with when I was purchasing such as, for example, groceries or whatever, that before they had, you know, treated me somewhat more decently.

But I guess now they managed to get a hold of a photograph of me and so they could identify me for who I am. And so when I go around in public, I always get a lot of sort of hostility. Yeah, so you're in a small town, we should put like Monica Shaper in Jasper, you know, she was shunned.

But in the city of Vancouver, I guess I've got it pretty good, two million people lower mainland, even the immediate neighbor to where I live, people don't know me. I don't get shunned at all. I walk down the street, I talk to families, other kids, I have no problem.

So it's tougher for you in a small town. Yeah, basically the smaller the town, the more

petty the mind of person in many cases, as well. So it becomes hyper focused, like the person who does the slightest thing, it will be blown up into the greatest, you know, magnifying glass.

People talk in small towns and big cities, it's anonymity, people talk in small towns, I really feel for I haven't lived in a small town since 1980. And even that it was a pretty big suburb. And we didn't know each other even there.

Yeah, I guess small towns have their virtues and their vices, you can have anonymity in a big city. But at the same time, very often, you have a sort of isolation, even though you're in the midst of a large population group, some so many people in cities don't really have anybody that they can actually involve themselves with. Well, it's so true.

I mean, I have my little group of it's statistically today, there's more loneliness than ever, I think about 40 or 50 years ago, people said they had like three or four close friends. And now many people are saying none. Right, that's unfortunately the case with myself, given my beliefs and so forth.

And my not really being involved in anything and having had a sort of a fairly traumatic lifestyle or whatever upbringing in some ways. Hey, Loki, I invite you to be a guest speaker at the Thursday night, Brian Ruscio group here in Kitsilano, Vancouver. Come, you can stay at my place.

I mean, I can't pay for your bus fare or plane fare. But this is a little group here, you're more than welcome. I think even if I were to hop on a bus now, it would be too late for me to be able to transport myself and get there in time.

If it's Thursday night, but yeah. Well, I mean, it's every other Thursday night. I'm just saying it's an open invitation.

You have a group here that you can talk to. I know I'm happy I've cultivated a group of real people in person. In fact, we were just interviewed last Thursday by a pretty big YouTube channel called Pangburn Philosophy with Travis and Armin.

They did a story on us. We recorded for three and a half hours. The video hasn't been released yet, so we'll see.

Yeah, right now, I obviously have no money to even travel anywhere. And at the same time, I'm confined to this town according to my recognizance conditions or so-called bail conditions. I have to check in with the police every single Friday during the course of the police station's business hours of the day.

I have to sign a book and so forth. Also, the police, when they came into my place, they basically took every single one of my so-called weapons, even kitchen knives. When I had attempted suicide and cut my wrists, I could not even cut up vegetables to eat.

So I had to use a razor blade to cut up vegetables. Luckily for me, I'd actually stockpiled food such as sardine cans and various other forms of food here because I'm a prepper. So I prepped all sorts of emergency food supplies and water.

Otherwise, I wouldn't have been able to even have any food. And I would be basically in a state of malnutrition at this time. So luckily for me, I'm always thinking that the worst might occur.

And so that has saved me on a couple of different occasions in the past. It probably might be best not to repeat that you attempted suicide. I don't know, that might put the audience off.

And I'm sure you went through a bad time though. Well, basically, it was just a sense of hopelessness that here I am in this world and I do so much effort trying to help other people and I get no means of really involving myself with people. There's nowhere to go.

There's nothing for me to do. I don't drink liquor in bars or hang around in churches because of their skewed theology of invading their own countries with non-white invaders and worshipping Jews as the chosen people of God. So for that reason, I don't really have much of a willingness to involve myself with them.

So it's very hard for me to find a place in the world. And for that reason, I basically said, well, I'm not just I'm not going to continue anymore. But obviously, that was a sort of a pathetic cop out on my part.

I mean, all of us go through this stage of isolation. I think the process of waking up with everyone is slow and people find out, you know, they get isolated because you realize, my God, 95% of people around me, including my friends, don't know this. And if I talk about it, they'll shun me.

So I guess it's good to realize it's a shared suffering, that you're not alone. And I've managed, other have managed, so it's best to stay alive. From a Buddhist view, there's really no excuse for suicide.

It's a negative action in itself. So it's bad karma because you're killing human beings. So it's it's best not advised.

Yeah, I've come to that conclusion myself and actually made a video about it called suicide attempt on my other bit shoe channel, the Loki Holgaard one. Oh, I see, which explains my rationale for having done it at the time. And also my recognition of the fact that it was an error of judgment, and that I shouldn't have invested any of my time in that because obviously, it's good.

We're saying that, yeah, we're saying that today that you renounce the idea of suicide. It's good that you're clear with the audience about that. I definitely have come to that

conclusion because from a metaphysical or spiritual standpoint, you kill yourself in the physical, but you still continue on beyond that, whatever other sort of form of energy body or higher subtle body of yours.

And so you're just, as you said, generating karma because you're not enabling yourself to go through the natural processes. And you're sort of you know, against yourself, you're acting against your so you can come back on camera. This is more you want to show us on your bit shoot.

There's more you want to show us before you come back on camera. Um, well, no, I was just scrolling through trying to, you know, we might as well see you. You're the guest, we might as well see you instead of your computer screen.

This is, this is good. Good, some visual variety, because I know I'm a low production video show. So at least we have some and be centered for the picture as well, because there's a split screen.

I can't see myself. That's good. So yeah, there we go then.

So in other words, basically, suicide is definitely something that I will never do again. And at the same time, I should discuss briefly about that. Do it again.

I won't do it again. When I did do that, and I called the paramedics, the, the police who attended one of them, a Filipino guy, he actually said, Oh, you don't commit suicide like that. And he showed me where to cut my veins so that I would get it.

No way. No way. Basically, and at that time, I was still in the mental state where I said, Oh, well, I probably will just repeat the attempt once I get out, maybe because it was sort of like, not entirely certain or decided to give you instructions to do it next time.

And so too, when I went into the hospital and had my South African doctor stitched me up very well in his competent way, South African doctor here, and I spoke to a Jewish psychiatric nurse, and she basically was supposed to keep me on suicide watch overnight or something like that in the event that I might repeat the attempt, which I was contemplating, but then she just released me. And when I was released, which of course was obviously something, you know, my suspicion was that she deliberately did that because she wanted me to repeat the attempt and to commit suicide, because she is part of their so called cabal, I guess you could say. And so when I was released, or in the process of being released, there was another nurse there, who is another Jew.

And she basically said, Oh, well, you know, do you know how to get home, go this way, that way, but I didn't even know where I was at the time, because I was quite disoriented. And so I asked, Well, how can I get home? Do I can I can I get some dressings? And then she says, Oh, you have to pay for that, and so forth. So in other words, basically, you're just leaving me with no money, no nothing.

And I'm supposed to just crawl back home with my wrist slashed, and not even getting any dressings and so forth. But luckily, I had another South African doctor who is my South African doctor here that I had deliberately gotten because I knew that he was South African, and I could tell that he was potentially somebody more trustworthy than for example, a jihadist or Muslim doctor or Jewish supremacist doctor or something of that sort. And so he again, stitched up my, my wounds quite well.

And also gave me some valuable advice and so forth. So he was a big help morally as well, because he was a Christian from South Africa and so forth. So that was a benefit for me to have somebody at least, you know, that I could see that they were not, you know, not entirely against me and so forth.

So basically, that was a suicide attempt episode. And then right around that time, the social worker that I had, because I had been on welfare here, because I couldn't obtain employment, given that I didn't have a driver's license, and I wanted to get oil field work to get some quick money together. But I didn't have the driver's license, couldn't obtain work there.

So I was living on welfare, and I'm still on welfare for about 586 bucks a month is what I get. She reduced my income by \$100 per month deliberately, probably, that's my suspicion, because her grounds for doing so was that I lived in my father's house here, because this is my father's house, he owns it. But I was living... You mean, where are you living now? I was living in that same house before that event.

And are you living in your father's house now? Yeah. Okay, and you're a medicine hat, right? That's correct. Yes.

Yeah. So in other words, what I'm trying to say is that, as soon as she heard about this, she deliberately used that as a pretext to reduce the amount of money that I received per month. In other words, to try to cause harm to me, which of course it did, because taking \$100 away from me, given my extremely minimal income is obviously, you know, a way of creating greater hardship for myself, because I'm supposed to pay about \$300 a month here for rent, on top of having, you know, only \$280 for like, phone and internet and so forth, on top of that.

So it's not exactly enabling me to... You're paying rent to your dad, you mean? Yeah, that's correct. Yeah, I guess that's fair enough. Well, the thing is, when I came here, I was supposed to have part ownership of this house.

And then the only reason why I'm in these circumstances is because I was involved with my father in a business project that took like seven years of my life away, where we had land out in Surrey, BC, right around the Serpentine River. That's my neighborhood, it's just like 50 miles from here. Yeah, and we were going to set up a farm there, but then he basically ended up screwing me over and selling it off to East Indians and so forth.

And I was supposed to be able to live there for the rest of my life forever, and then inherit. So I guess I have to be sympathetic to your dad, if he's provided a lot of wealth and provided for you, you know, I'm kind of sympathetic, I don't want to criticize your dad too much. I've never heard his side of the story, you know? Right, true enough.

But at the same time, I'm just illustrating the point that that's the reason why I'm in these circumstances, because I became involved in these so-called business with him. It just led to my total destruction of my career plans and my life and future. But I couldn't even possibly begin to discuss all the psychological abuse that I've been subjected to during the course of that so-called business project.

But it would take us too far astray from the point here, of course, which is basically right now that I'm sort of in limbo and not really having any place in the world, not really being able to do much, even from a legal standpoint, I don't know. Obviously, Mr. Fromm has been involved in his case, or his mayoral campaign. He's the one that introduced me to you months ago, because of your case, of course, of hate crime in Canada, we always jump on those to help out.

Yeah, so that was nice of him. But so far, I don't know what's happening in terms of what recourse I should have. So I guess basically, the only recourse is either seek a lawyer.

But then again, if some lawyer out there has a willingness to take on the case, then that would be great if they're actually on my side. So basically, that's the situation in terms of this exactly specific situation, legally, from a legal standpoint. So today, I had a firearms hearing, they gave me the option of having a hearing for the- That was today, October 20th.

What happened with that? Trying to reverse the decision, but basically nothing happened because I was so unprepared. First, when I spoke to the chief firearms officer on the phone, they basically had made the decision on the basis of the fact that they claim that I had been diagnosed with paranoia and so forth. Because I've been seeing a counselor.

The reason why I've been seeing a counselor is because the social services people who are Jews had basically given me a sort of implicit ultimatum saying that if I didn't seek the counseling, that I would be basically be cut off from welfare. And so then I would have no source of income. So that reminds me, just interject, little kids have to have vaccinations.

If they don't do it, well, they can't go to school. Once you get all these vaccinations, which could cause cancer or autism, whatever. So it's kind of like they pull the gun to your head.

Pretty much. That's the sort of shotgun clause. Either you get one barrel or you get the

other.

The lesser of the two evils. So in other words, I was sort of pressured into counseling and looked upon that as a means of sustaining myself from an economic standpoint. Because throughout all this time, too, I've been writing.

I've been writing like a thousand page book and so forth over the course of a couple of years. And then about a 660 page cartoon meme book. I've also done... Wow.

Do you make cartoons yourself? Yep. Do you got anything you can show us? Hold up to the camera. Well, basically all those cartoons are not on the website now because they were on a blog, but I took the blog down.

And so I can put them back up. But I have to have more bandwidth for the website because... What a creative young man. Well, I try to be.

Basically, I wake up at five in the morning every day. I go to sleep at nine at night every day. And every single day I write for a couple hours.

I do meme illustrations and then I do propaganda and so forth. What do you mean by meme illustrations? Can you go in a bit more detail? Well, basically, they're just cartoons and also graphic illustrations. You know, sort of like, I guess, your word news type stuff to some extent, but only a very more minimalistic type.

So in other words, it's trying to create memes, trying to generate general meme ideas to facilitate the purposes of white nationalism, the 14 words, if you will. We must secure the existence of our people in a future for white children and so forth. So in other words, that's what I've been doing.

And so I was pressured into counseling as a means of continuing to subsist on welfare for like 600 bucks a month or so. And so I was seeing a counselor over the course of the last six months and so forth. So I have a mental health record.

So the firearms people or the claim on their part to take my firearms away was mainly because that I would be a threat to public safety on the grounds that I was diagnosed with paranoia, but I have not been diagnosed with paranoia. And that's proven. Just for the record, you've never shot at anyone in your life, right? No.

You never pointed a gun at anyone in your life? No, I basically never even had a gun or I never even shot a gun more than maybe two times. So I just had these guns for extreme emergencies. And I had actually been so unconcerned about them that I just left them in the basement.

Basically, I lost them in a corner because I was so busy with other little prep projects for my survivalist preparations, gathering libraries of information. Do you want to share with

the audience how you got the guns? It's up to you. You don't have to tell everything.

Well, I basically just bought them from the store. So I had a firearms license. I've never bought a gun before.

You just go to the store. But don't you need in Canada a license to buy a gun? Yeah, I had a firearms license from 2012 onwards. And that was right around the time when I first began discovering more specifically in detail what I had previously understood to be the Jewish conspiracy.

In other words, I was falling into the Alex Jones in terms of the details, like what they're specifically doing and how extreme that is with chemtrails and whatever it may be, the specific minutiae, fluoride in the water and so forth, and vaccinations and all this. And I didn't really know very much about that prior to 2012 because I never had much contact with the internet. I usually just avoided the internet.

It's sort of like a mind control machine, I guess you could say. So once I became very aware of Freemasonry through TexMars and through Alex Jones, then I said, well, it's pretty depressing. I thought that there was going to be much more hope for white people.

I thought that the elites were sort of battling against the Jews, and I didn't know anything about Freemasonry and so forth. But now my conception is that basically Freemasonry, so far as I understand or know, is basically a Jewish sort of psyop, a means of hooking in the Gentiles to be corrupted by black magic or whatever you want to call it, occultism. So yeah, I think Masonry is Judaism for the Gentiles.

It's definitely controlled by the Jews. Yeah, there's also a book by General Eric Ludendorff called Destruction of Freemasonry Through Revelation of Its Secrets, which was written in 1928. He basically proves that Freemasonry is basically just a Jewish psyop, I guess you could say, and that they become de facto Jews only at a lower level, sort of like the puppets of the Jews.

Like that image from, I think it was Soviet Russia or something, with the puppet master Jew, and he's got on one side the Bolshevik, and on the other side he's got the Freemason, and he's puppeting them both. So basically, I came into this understanding of the specific details of the conspiracy, vaccines, fluoride, pharmacological poisons, allopathic genocide, and so forth. And so I became very paranoid, I guess you could say legitimately, not in a sort of crazy sense or, you know, diagnostic and statistical manual psychiatry sense, but in a sense of being very aware of what's going on and trying to take the necessary precautions.

So I became involved in prepping and then I got my firearms license. And so from there, I just got some firearms and basically just stowed them away and stockpiled food and so

forth, and got my emergency candles and bags and survival kits and whatever the case, all of which is basically outlined in that handbook, White Law, that I wrote, which is basically an 88-page handbook that explains various guide on my part, from my perspective of how to survive in this world in general, a sort of synopsis or overview. Oh, Loki, sorry to interrupt.

The music is just coming on now, we have a five-minute break. Revolution Radio is totally missing this. Welcome back to Revolution Radio for the second hour.

It's Tuesday, October 23rd, 2018. We're here every Tuesday night from 6-8 to spread the hate. So my guest today, my fellow Canadian, Loki Holgaard.

Welcome back, Loki. Hello again, Ryan. How are you? Very good.

So where do we leave off? Hey, I must admit, you're a great, easy guest to have. You're a good speaker. You know what you want to talk about.

I just have to sit back. So where do we leave off? Well, basically, I was not too sure exactly where we were, but I guess I was discussing more of the particulars of the case. What's that? And so basically, I was going to just briefly read off some of the notes, if I could, that I made in terms of personal reputations of charges.

Some of our notes. Okay. Yeah, and basically, these are notes that I had personally done right around the time that the case had ended, when I felt very keyed up with adrenaline, always in a sort of extreme stress mode, where I was thinking that I have to do everything I possibly can at this very moment to get all my case, I guess you could say, formulated from my perspective.

And whether I give this to a lawyer or whatever, or I even had to represent myself potentially, then I will be able to at least have some inkling of how to present my case so that it looks in the most honest and open fashion. So basically, I just wrote a bunch of notes and so forth. And I also made videos of them on the Loki Holgaard Bitchute channel, basically just reading off my notes so that people can gain access to that information if they want.

And so basically, my rebuttal of charges, I just draw upon the criminal code references from sections 317 to 321 of the Canadian Criminal Code, that basically I'm affirming that what I've done is neither hate nor a crime, because hatred connotes an emotion. How can this specific emotion be proven to strictly follow as a consequence of viewing the specific material that I disseminated or distributed? And you're also acting out of love for your people, you're acting out of love. That was actually one of the things that I had emphasized in this, in my case or brief, I guess you could say that that is what is the motivator.

Obviously, if I were just doing this out of hate, why would I not put something more

derogatory towards Jews? And why would I care about specifically referring to how white people are being genocided by them? If I were just acting out of a hatred for Jews, then why not just target Jews and leave white people out of it altogether or something like that? So that wouldn't make too much sense to a rational person. So in other words, further of this refutation of the charges, hatred is not necessarily incited by the communication. It's not certain or morally certain as a consequence of viewing a specific material.

And according to the law, so far as I know from the Criminal Code of Canada that I have here, I have a Martin's Annual Criminal Code, which is like a larger compendium that's used in law schools in Canada. So it's basically the standard textbook version of the Criminal Code. And it says you must prove beyond a reasonable doubt that hatred is necessarily incited or likely to be incited.

That it's got to be certain or morally certain to follow as a consequence of viewing it. And that's not really the case in this case, because how does that imply hatred by putting something up like 99% of the 1% is Jewish, which is another sticker that I had put around. How does that imply any hatred of anyone at all? That's obviously not followed, doesn't follow from the premises.

And so it says you must prove it beyond reasonable doubt. But obviously, there is reasonable doubt there. Therefore, those charges shouldn't apply.

And so they should just be thrown out altogether. But then again, they can twist semantics however they please and use their court system in their favor, because they're the ones who control it for the most part. So if the statements are true, then according to what I've read in this Criminal Code of Canada, it's non-conviction.

So in other words, if what you can say is true, then it's not a conviction. But that might not be the case so far, as I know. I'm not a lawyer, so I don't know or too well versed in it.

So if I can prove that the statements that I've made are true, then it can't be a conviction. So in other words, it does immigration equal white genocide. Well, yes, because you're displacing people from a specific territory, you're denying them exclusive territory in which to live.

And in so doing, that prevents them from preserving their own ethnic group, which is basically an implicit form of ethnic cleansing, which is basically genocide. So in other words, the people who support the legislation behind non-white immigration, even of any sort at all, even in numbers like one or two people, then that implies that they're complicit with genocide and that they themselves should be charged with crimes against humanity for advocacy of genocide against an ethnic group called white people. So also a defense is that if it's an opinion based on a religious subject, then that can somehow

be a defense.

So my opinion is based on a religious subject because Jews are a religious group adhering to the Babylonian Talmud, which entails advocacy of genocide and hatred towards non-Jews. And I wrote up a section of Babylonian Talmud quotes, which I derived mainly from Michael A. Hoffman's Judaism's Strange Gods, which is just... I'd just like to interject and give a lot of big support for both Michael A. Hoffman. Also, the Babylonian Talmud is the highest authority in Judaism.

So that's the source of a lot of evil. So good to highlight that. Thanks.

Carry on, Loki. And I basically wrote up just a brief document of citations of specific passages. You know how in the Talmud they refer to passages like Shimeon Hadarshim, Folio 58d and so forth.

Basically, the references from the Talmud. I basically just said, okay, this reference refers to how they advocate genocide. This reference refers to how they advocate pedophilia.

This reference refers to this and that. So I made another video reading another document that I had done in proof or proof that this is actually the reality. And therefore, not only is my statement based upon religious subject and is true, but it's also actually implies that their religion, their texts is itself hate literature.

And so therefore, if anything is to be charged with anyone charged with hate, it's those who are advocates of the Babylonian Talmud. So, but of course, that will never be upheld in court anyway. But you're right.

I mean, they turn the law upside down, turn the truth upside down. The courts are not in the favor of truth. Imagine that the court of law is not about truth.

It's about Judaic law. Pretty much. It's the Noahide laws and the laws of the Talmud that apply only in a sort of like double standard law where the Jews can do whatever they want and anybody who's not a Jew is subject to their will.

And whatever truth, wherever truth lies, doesn't matter. It's just an irrelevancy to them. I just want to interject you.

I'm glad you mentioned the Noahide laws. For the viewer, I did a whole episode with the guest, Jerry Westfall on the Noahide laws. So if YouTube, you type in Brian Rue, Noahide laws.

There's a lot to understand there. Basically, United States and Canada is being run by Noahide laws and is gradually getting worse. I also did a couple of videos on the Talmud and the Noahide laws on the BitChute channel, AryanH8, the AryanH8 channel, where I

basically just make audiobooks of other people's writings for the most part.

So I'm basically presenting core texts there so people can have those as an easy reference when you're doing dishes. You've done a lot of work. Holy smokes.

This is very good. Dedication. I try to do whatever I can do to try to facilitate this purpose because I, obviously, we are who we are.

We're white people. We don't really have much of a choice to just sit around and fiddle while Rome burns around us or twiddle our thumbs and amuse ourselves with bottles of champagne and driving around in luxury automobiles because that could just as easily be taken from you through force by communist revolutions like in South Africa and so forth. So it doesn't really matter how much money you have or what your status is.

You either you're on the side of your own people or you don't have a future. So you're backed into a corner and you don't really have any options, even if you wanted any other options. Because for me, if I had any other options, what would I do? I would just basically spend my time studying esoteric sciences or philosophy and just live a healthy lifestyle, maybe study alternative health or something like that and try to assist other people in that way.

But now, obviously, this is a far more serious concern. So we have to put our own personal desires on the back burner or at least merge our desires with the desires of the collective or whatever serves this purpose. So that sounds a lot like the great one.

Otto Fittler said the needs of the community must be above the needs of the individual. The needs of the individual must merge with the needs of the community. So Otto Fittler is quite clear about that.

The Führer. And one of the cartoons that I had mentioned to you before in our last video that I had done is basically using a quotation of Hitler saying that what I am, I am through you and what you are, you are through me. So in other words, that's authenticity, according to Heidegger.

And basically, you have to exist your essence to be who you are. And that is a person who is bound up with a collective consciousness or a group. And you can't just be a so-called individual as Kalergi would have you be that, you know, we would replace a society or a nation of peoples with a nation of individuals in his practical idealism.

And you can't do that because then that just leads to your total enslavement to Jews or the Jewish supremacists. And even then it would just fail because without white people sustaining society, there is really not going to be any civilization on Earth, basically. So it's a utopian, satanic, utopian dream on their part to think that they can magically create this Jewish utopia, as Rabbi Michael Heger said in his book of the same name, the Jewish Utopia, which I have an audio book also of that.

Basically, thinking that they're going to rule it all and everybody will just happily put slave chains around their necks and so forth. And, you know, I have an idea of mine. Of course, I'm a Theravada Buddhist and teachers, so from our worldview, the evil one is Mara and Mara's dominance of the world comes and goes.

I'm just asking you, do you have a spiritual worldview or your combination of ideas like this, this evil that the Jews follow? Do you think it's Satan? Is it Mara? What's your own feeling? I don't expect you to be a Theravada Buddhist. I know you're not. I'm just interested in your spiritual interpretation or your worldview.

Well, actually, through watching your videos, I had investigated Theravada Buddhism when I was living in Winnipeg because there was an organization in Winnipeg about it, but it was so far away on the other side of the city, I couldn't do it. So basically, my spiritual or philosophical orientation is sort of a syncretist, I guess, generalized conception based on more areosophical, even maybe esoteric Hitlerist values or views of Miguel Serrano and the Adolf Hitler and the ultimate avatar. I actually made in the last couple of days, quite a few videos on the Aryan Hate Bitchu channel of Miguel Serrano's writings and another philosopher that I discovered called Jason Tompkins, who is the person who translated Miguel Serrano's *The Golden Cord*.

And it basically presents quite a lot of interesting perspectives and sort of Gnostic, syncretist understanding of things where Jehovah is the demiurge and the Jews are a creation of the demiurge, and we are basically the children of light. But then, of course, you have someone like Jörg Landsvang-Liebenfels in his book *Theozoology*. I don't know if you've ever read that book, but it's about 88 pages.

I read some of Miguel Serrano, like, I guess, have you read my [ThuleSociety.com](http://ThuleSociety.com) website? We have five leaders from 1945 today and David Myatt is the only one still alive. Miguel Serrano is one of them, you know, have you seen my [ThuleSociety](http://ThuleSociety.com) site? I had been on it a couple of times, but I forget the actual content of it. Yeah, sure.

I mean, it's so much to read. Yeah, I could always revisit it, of course. But basically, in terms of my values, I guess you could say somewhat Areosophical, somewhat even natural law philosophy, like a David Lane, 1488 type thing, but more even Christian Identist to some extent with Wesley Swift.

His podcast or sermons, I guess, they would be called, were quite esoteric and quite spiritually enlightening, I find. So I subscribe to that sort of dualistic world view where the Jews basically are the children of darkness, in a bio-spiritual sense. And actually, I'll just read, if I can find it, because I have a whole bunch of notes here that I've gathered together.

Yeah, sure. Go ahead. I can always edit bits out.

Take your time. If you don't want me to move around too much, basically. So here, my conception of race.

Race doesn't exist in my understanding of things, only different quote, unquote, kinds. The term species could equally well be applied. I support the ethical precept of kind after kind, meaning physical separation of kinds geographically.

I have regard and respect for the diversity that exists in a world that don't advocate a global monoculture under the United Nations totalitarian government. Hence, I do not subscribe to the secular humanist evolutionist bias wherein all kinds are labeled humanity as a way of forcing them together under the United Nations, which is the end goal of those who control society, wherein all kinds are to be genetically hybridized and have their identity destroyed. So basically, in terms of worldview, I subscribe to a so-called biocentric worldview as Ludwig Clages.

I don't know if you've heard of him. He basically wrote, I think it's, I forget exactly what the title of his works were, but he subscribed to a more naturalistic biocentric value system. But I would take that to a slightly higher level of metaphysics, aerosophically, I guess you could say, in terms of Jörg Landsvang-Liebenfels.

And I have an audio book of his called Theozology that I made. When did he live and what decade? Jörg Landsvang-Liebenfels was around late 1800s up until probably 1920, maybe. This is in Germany? It's in Austria and Germany.

And he wasn't part of the Thule Society then at that time? I think he was, he formed an organization called, or had a magazine called Astra Magazine. And I have every single issue of that magazine, but it's in Fractorscript, the previous to the change of character. So in other words, it's not really readable to most people, because I guess you know what Fette Fractor is, or the Fractorscript.

It's basically sort of like a character typeset from prior to 1938 that was changed by Martin Borman. And so it's like the old medieval looking script in German. So if I could get somebody to help me translate that, then we could get 96 issues of Astra Magazine, and Arthur Kemp of Astra Publications.

He said to me by email that he would have a willingness to sell it on his website. So if we can get a translator, that'd be great. If people could just contact me through email about that, then I'd appreciate that.

I noticed, like asking for volunteers, it seems a lot of organizations are asking for volunteers, probably are hard to get that. Yeah, I've actually communicated when I was at the farmers market here with some Hutterites. Some of them actually knew people who could read the Fractorscript.

And they said that they would get in contact people about it and so forth. But it's still

sort of up in limbo now. And it would probably cost quite a lot of money, at least 5000 bucks, but I don't have any money.

So obviously, that's not within my financial means to be able to reify that project. But I definitely like to get that as well. I have lots of Third Reich anthropology works by Alfred Plotz, Fritz Lenz, Eugen Fischer, and so forth, the old Rasen hygiene works in Fractor.

And so if somebody would have a contact with me, then we can potentially actually sell that, you know, I don't want the money, I just want the documents. And I want to help other people get them. But somebody else who wants to help can just take the money.

You know, if they can sell it wherever, however, then that would be something definitely that would help people become more aware of the what the actual Third Reich was about. Because obviously, there are lots of documents like on [thirdreichbooks.com](http://thirdreichbooks.com), [third-reichs.com](http://third-reichs.com). You know, that's with Gerhard Luck, right? I've had, I want to mention Gerhard Luxman on my show, many times, he said something like 96% of the documents of the Third Reich have not been translated into English. A lot of precious jewels are sitting out there.

So much of it has never been translated. And that's all that's needed, basically, is not just German speakers, but those who can read the old Fractor script. If you can read that, then it can be translated into German or whatever modern language.

And then from there to English, ideally, that would be nice if people would facilitate that. But of course, it's up in the air and whatever. And then we saw the National Socialist philosophy, even as a kid, I thought it was kind of like a treasure map to this secret treasure that's being kept away from us.

I guess maybe I had this psychic interpretation from a past life that this is the greatest civilization known to civilization. So that's my view now, that there's this great wisdom of National Socialism, National Order, of how to have a just and true civilization. And that information has not been destroyed.

It's still there in German. And we have plenty of information to recreate the National Socialist world. And what's interesting too, if people are familiar with Miguel Serrano and his conception about the hollow earth and how the, in Neuschwabenland in the South Pole, how the Hannebukraft and so forth traveled to the hollow earth and the flight of Habsburg in 1946, how basically the German or National Socialist elite escaped their destruction through going into the hollow earth.

And that may very well be maybe some sort of second coming or the second advent, maybe they'll meet up with aliens from Aldebaran or something of that sort, so far as we know, because there's somebody like Wilhelm Landig and so forth, who basically wrote fictional books about that sort of thing as well. Yeah, I'd like to just support that for the

audience. I think the aliens of Aldebaran, this is for real, because the Thule Society's golden girl channeler, Maria Orsek, she claimed she was channeling through the Aldebaran star system, 65 light years away from here, she was channeling down flying saucer design.

Beyond that, I don't know, but I think this is for real. The Aldebaran aliens could today have a relationship with the Germans, the white race, and also they could be fighting against the reptilians and the greys. So there is a cosmic battle going on with maybe 57 different types of aliens, but they probably have some sort of order works out amongst themselves.

So I believe that the Aldebaran aliens are bonafide. So just to support what Loki said. I mean, who knows about the Hall of Worth? I don't know.

Obviously, it sounds very ultra or very, you know, extremist or eccentric, but obviously, there are more stranger things under the sun than what you can see with your eyes. So I just hope you can center your screen a little bit more on your computer. Yeah, I was just going to show you that I had also just today made audiobooks of Wilhelm Landig, the SS esotericist, who wrote Gotzengenthülle and various other in German.

And I know where I can get these in German, but not in English translation. So also, there's Miguel Serrano interviews. And this guy here, I just discovered recently called Jason Tompkins, esoteric Hitlerism, I gave his website there, people can get his books and stuff, his translations.

And so too, in here, there's other Miguel Serrano books. I don't know if you want me to turn the camera back to myself or... No, this is cool. Whatever you like.

You don't have to zoom in. If you want to click on any of your videos and pop them up, it's up to you. Sure.

Well, basically, right here, I'll show you a little game that I made. I'll turn the volume off, though, so that... Yeah, that's cool. Show us your little creations here.

It's basically a game based upon Monopoly, that I created just within the last week. There's got a little board game square... Oh, when I was young and so creative, you know, now I'm so 58. I'm so calcified.

I guess you gotta have maybe do some ayahuasca or something like that to break the calcium around your brain or something. Who knows? So I got my five footest precepts. That's a tough one.

Yeah. Well, basically, I've made a bunch of different games too, for the movement, so people can play like chess variants and so forth. And Monopoly variants, just, you know, to while away the cold winter nights down by the fireplace.

If you want to entertain yourself in some way, there's a money bill that I'd be using for the Monopoly type game, six million shekels and so forth. Look at that. This is great.

Good visual aids. Yeah. And there's one of the squares.

Basically, these squares are to try to represent what's going on in the world, like fifth column. You know, you got Christianity, Freemasonry, allowing the foreign invader in. You've got the barrio section, you know, how in Monopoly, they've got the sort of ghetto-y section with Baltic Avenue and Mediterranean Avenue.

I remember that well in Monopoly. I was a big fan of it as a kid. In that case, they've got the barrio, they've got Blue Collar Boulevard, stuff like that.

Just cheesy. Where do you find the time? Where do you find the time to create all this stuff? Well, basically, that's all I do. It's just, you know, because I try to create and try to develop my creative faculties, mainly through writings, but sometimes this is a good escape.

Bohemian Boardwalk, instead of Boardwalk, where all the trendies live. Coontown, which is, you know, they've got your needles and your drugs and your gangbangers shooting through a watermelon and so forth. Sort of, you know, extreme racist or racialist game here.

Cop Land, the five point of stars inverted for the pentagram, you know, it's got stealing, theft, and so forth. So what's the meaning of the five-star pentagram versus the six-star star of David? What's the difference? So far as I understand, five-star represents man. And so if the point is upwards, then that means man perfected, maybe.

Again, I don't really know that much about occultism, but when it's inverted, that means that basically the matter supersedes spirit, that basically, it's sort of Satanism, that, you know, you're utilizing the material plane, and you're trying to maybe use that to gain occult power or something like that. So that's... Reminds me, I was in Orillia, Ontario once, and I was driving around. It's a pretty small town.

There's all these houses with this huge big pentagram. It must have been like a foot and a half across on about six houses in the immediate neighborhood. So what, are these masons just letting everyone know, okay, we're all here? Like, it was so obvious.

I've never seen this before. So in a small town, I think Orillia, I've read, is a bit somewhat Satanic. Actually, my mother lived in Orillia, because she's from Denmark, but they moved there to set up a greenhouse.

And interestingly enough, when I was in a small town in Manitoba, in a farm town, right across the road from me, the mayor lived and he was a Freemason. And he had, you know, how they have Christmas decorations, like those big five pointed stars, he had an

inverted five pointed star on the corner on the pole. He and his son would shoot off fireworks every Saturday, because it was a very small town, there was no police or anything.

And they just do whatever they want. It was like the boss hog of rural Manitoba. So it's pretty amusing.

But you can see the occultism basically everywhere. Obviously, the Freemasons and the Jews are in bed together. And they're basically just having their humor at the expense of the goyim, or the profane, as they call them.

So yeah, it's basically just, there are so many examples, especially in Winnipeg. I think you might have heard of Frank, I think his name is Frank Albo, who... I don't know him. He said the ability to say, I don't know.

Yeah, he was, he was interviewed on Red Ice Radio about the Winnipeg legislature building, which is basically like a Freemasonic temple. Yeah, and I had been there many times around that place in Winnipeg. And it always gave off some sort of creepy vibes.

Around the downtown there, there's just so many old Masonic lodges, with all sorts of hauntings and so forth. And when I work in security in the middle of the night, I would work in like, haunted hotels and stuff there. And you got these extremely weird, energetic vibrations and so forth, in all the haunted hotels.

Yeah, there's definitely haunted buildings, that's for sure. Yeah, especially in Winnipeg, but I'm sure every city has it. Yeah, Winnipeg's a really old, very Masonic city, right? They planned it from day one.

There's a real Masonic center of Canada, a lot of, a lot of Jews there, Big Bronfman Center. Yeah, actually, it's the exact geographical center of North America, Winnipeg. So that itself plays into it.

I didn't know that. North America, I didn't know that. Yeah, you can basically, you can basically look that up on the internet, that it'll show a map of Winnipeg in the center and lines radiating out equidistantly over the whole of North America.

And that's where the NAFTA superhighway terminates in Winnipeg from Mexico. So what are they going to be doing? I've been to Winnipeg, it's been a week there. Yeah, it's become a total criminal den in the last, I don't know how long, probably at least from 2004, when they started really jamming in the foreign invaders.

At that time, before that, it was a fairly white city still, and it was a fairly decent place to live. But then it became extremely violent. The last place I lived, I lived in a small apartment in a so called trendy area right next to the University of Winnipeg.

And just before I moved in, somebody had been hacked to death by a machete. I was living in a room with two native drug dealers on either side, a mental patient above me, right outside my window, there was a house, there were race mixers above, homosexual, Native American race mixers, and below them, there was some so called Judeo Christian race mixing couple. My gosh, being hacked to death is one of the worst ways to spend your morning.

I can understand that. And basically, it went from when I was working in security in Winnipeg, in 2007 or so, in the ghetto, you could hear gunshots going off every night. And there are basically blacks prostituting white women and natives out of their convenience stores that they got free money from the so called government to set up.

And then from then, when I went back to Winnipeg five years later, there are gunshots in the day in the trendy area going on. There's gunfights. You know, I'm glad I lived in a trendy area of Vancouver.

I've actually just last month, seen blacks move in down the street here. But so far, it's pretty peaceful area, Kitsilano near Kitsilano Beach. I guess I'm just lucky.

Yeah, because all you have to do is look at Surrey and all the crime and violence going on there. And then you get Surrey. We know that's the more violent area.

It's outside of the city of Vancouver, about 15 miles. And we make jokes about Surrey in Vancouver. They call it Curry because there's so many East Indians there.

Yep. Big East Indian population. Curry and Hongkoover, Vancouver.

All the triad gangs and so forth there. But I guess, do you want me to get back to the rebuttal of charges? Yeah, yeah, we should talk more about your case because we only have half hour left. Okay, I guess I'll bring the camera back to myself over here.

Is that good? Yeah, yeah, that's good. So basically, what I was doing was trying to rebut charges. I had, you know, in that sort of extreme panic state or a state of extreme stress.

After having been released, I was kept in the prison, or whatever you want to call it, the holding tank. I guess it's technically a jail in the very small concrete room for 40 hours. When I first was arrested, I actually thought I would only be kept in there for about maybe an hour and a half.

I don't know why I thought that. But I guess because I didn't really think that the charges were very serious. I assumed it would just entail some community service hours or something.

Because I never actually really paid much attention to the media, you know, like the developments in so-called hate speech legislation and so forth. So I was like, oh, well,

about an hour and a half to go. And I was just working out and so forth in there on camera.

And then the time stretched further and further and further. And nobody was contacting me and so forth. I was like, well, when am I going to get out of here? And then when I was interviewed by the police officer, he says, all of a sudden, to try to get a reaction out of me, we found the guns.

And I'm thinking to myself, guns? What are you talking about? We found the guns. And then I was, well, I didn't answer him because I always said, I have nothing to say to the police the entire time. But when he brought up the guns, I was thinking to myself, well, why guns? And then I said, oh, right, I shaved the serial numbers off them.

And I drilled out the pins and magazines so I could have larger capacity magazines, which was one of the charges that I have too. What's the legal significance of shaving off the serial numbers? That's the whole thing, because I was not even entirely sure if that was illegal. But I guess the reason, like I said before, the reason why they want to have serial numbers on there is so that they can track you with guns.

Because it's an unofficial form of registration. Because they can say, okay, we sold this gun to this person. It's got this serial number.

So now this person has this serial number. And if we don't get it back, when we confiscate the guns, then we're going to know that this person has this gun. So that's my suspicion of why they make an illegal to erase serial numbers on guns.

And so I was going to cache the weapons in the ground, like I said, according to, for example, what William L. Pierce wrote about in the attack magazine that he used to have prior to his formation of the National Alliance. He wrote, had a magazine called Attack, and it explicitly detailed how to cache guns. And so do in the book, The Turner Diaries.

So my intention was to cache the guns so that I could have, you know, defense in the event of extreme chaos or whatever for self-defense and community defense. So in any case, I shaved off the serial numbers, and the police were interrogating me. And I said, oh, now there's obviously going to be serious problems with respect to the guns.

And yet he said, oh, it's not the guns I'm worried about. This is what I'm really worried about, the hate speech. Because he thought, allegedly, and allegedly, they still want to create that impression, or they might actually think that some of them, that I'm a terrorist who wants to harm people with these guns.

So they create a false association, like I showed in that media presentation. You know, look at all these guns in this image, right? What a hater. Do you see that hater? He's a hater who has guns.

He must want to hurt people. You haven't broken any laws. And this is Canada.

Yeah. And I actually spoke to, you know, who Gurchen Zwigular is, probably, right? Well, yeah, Gurchen's been on my show. He's close to you.

He's in Alberta. He's been on my show. I talked to him, and I read his, he gave me a free copy of his book, The Handbook for the Righteous.

And I talked to him. And it says in that book, if there's no harm, there's no crime. According to maybe substantive law or whatever, common law.

But apparently this is criminal. So, you know, the law is so ambiguous. You can never really understand what exactly is legal and not, and what the parameters are.

Because that's by design. They can, they can basically do whatever they want, right? With the vague law. Gosh, look at that.

Look at the whole Constitution of Canada. One clause gives you your rights. Another one takes them away.

This is all premeditated in 1982. Yeah, the Charter of Rights and Freedoms, or what I call it, the Charter of, what did I call it? The Charter of Rights and Fiefdoms, or Wrongs and Fiefdoms. Yeah, that's right.

So it's not worth anything, our Constitution of Canada. I mean, the American Constitution's got something to offer, but not the Canadian Constitution. Yeah, and basically the ambiguity of the law reminds me of the book by Thomas Shepard, The Tyranny of Ambiguity.

And I did a video about that related to the law. So it's sort of like a forensic version of that book, which is more related to sexual matters and sexual relations between men and women, Thomas Shepard. So I basically applied that tyranny of ambiguity notion to the law because that's how they tyrannize on people.

And I spoke to the chief firearms officer about my, about this, these issues. And I said, is it legal to have firearms for self-defense? And then the person said, I didn't say it was not legal. I hope that it was illegal to have firearms for self-defense.

But that doesn't specifically answer if it is legal to have it. You just said that it isn't illegal. So that's just idiocy.

In any case, basically, so I'm thinking, well, now that I'm being interrogated and these firearms offenses still don't amount to anything, according to my interrogator here, they're saying that the main issue is by just disseminating a bunch of material. So I told the guy, even though I said to him, the only thing I said to him was, I have nothing to say. But then at that point, I said, okay, I'll tell you.

I have no intention of harming anybody with these guns. And that's the truth. So that's on camera.

And that, I think, is in the disclosure. I'm not too sure if it's on the website, though. There's like a, my interrogation was in the disclosure that I received.

And the disclosure itself was very suspicious, the way they sort of procrastinated in giving it to me. And they also, I kept asking, according to the instructions of Paul Frong, he asked me to get the information to obtain. I'm not too sure what that is, but it's something related to how they procedurally get information from about the case or something.

And so they were not willing to give it to me. And I'll just quickly just shoot over here. Yeah, I like your bird.

What does the bird behind you mean? That, well, basically, that's the Viking Raven flag. Okay, I'm glad it's not Native Indian art, because Native Indian art is another international Jewish conspiracy to undermine the white race by emphasizing Native Indian art. So this is, you're saying it's Scandinavian.

That's good. The thing is, my father actually knew Norval Morisot, because he's from the town where I grew up. You should go a bit more to the center, to your right.

Yeah, there you go. Okay, and just a little anecdote that Norval Morisot almost died, and my aunt saved his life from the snowstorm. And my dad actually had a bunch of Norval Morisot paintings.

And he basically gave Norval Morisot a bunch of bottles of liquor for his paintings. So it's just an amusing anecdote there, while we're discussing that obvious cultural hegemony, where they try to give all sorts of culture in the media, except white culture, to try as a mechanism of displacement of white people, saying that, you know, African drumming is just so intellectually sophisticated. And all those harpsichord music and piano music and Baroque music and so forth, that's all just garbage.

You know, you need to listen to gangster rap. And that's where it's at, man. I actually used to listen to gangster rap as a teenager, because I'm sure to hear that.

Yeah, because having no guidance in life, I had, you know, need of a masculine figure in my life as a sort of father figure. So I guess I must have... Oh, thank you, Loki. I must have gravitated towards the Negro figure, you know, how it's portrayed in the media as some sort of hyper masculine... Yeah, the media will do that.

Yeah, so you got that. And so basically, Uncle Phil from Fresh Prince of Bel-Air and Carl Winslow from Family Matters became my substitute fathers during my teenage year. And I listened to rap music and so forth.

So obviously, that's an unfortunate, degenerate, cultural sigh off on white males. I mean, trying to make... Yeah, I'll just share. When I was the same age in the 1970s, one of my father figures as a teenager was Archie Bunker from All in the Family.

He was my anti-hero, man. I loved Archie. Yeah, actually, I think that was another sigh off on their part to discredit white males, like Homer Simpson and so forth.

And I actually wrote about that, the allegories in one of my writings in the White Shrapnel philosophical book that I wrote. I wrote about how all these different cartoons are just, you know, sigh offs as a means of trying to, you know, distort people's consciousness. And so forth, demoralize and so on, psychological ops.

But anyway, getting back to the legal case, the information to obtain, let's see here. The prosecutor office said that the information to obtain was sealed by the court. And according to what I've heard, they must unseal and review, then send it in the disclosure.

But I never received that in the disclosure yet. And according to the law, so far as I know, you can't seal, you can only seal a search warrant, not a 487 warrant, which is the ITO. And it's sealed to protect confidential informants only.

So in other words, they're covering something up in this case, and there's all sorts of procedural anomalies or discrepancies, whatever you want to call it. So basically, they're deliberately covering something up where they made errors. And I don't know how to obtain that information or what to do specifically about it.

So at the present moment, it's sort of in limbo again, not really sure exactly what is going on or what recourse I should have at this present time. Hopefully, now that the mayoral campaign is over, maybe Paul Fromm will be able to give me some more practical advice. If I didn't check, did Paul Fromm win as mayor of Hamilton, have you heard? No, I actually just heard his interview on Andrew Carrington Hitchcock's show today.

What happened? Well, he wasn't discussing that. He was discussing the immigration issue. But that was today's show with Andrew Carrington Hitchcock.

I was on Andrew's show on Monday. Today is Tuesday, right? I had to get up. I was on the show at 5.20 a.m. in Canada because he's in England, but I made it.

Yeah, same with me. When he interviewed me, I don't know what it was, a couple of weeks ago or something like that, maybe even a month ago. It's got a good show.

It reaches lots of people. Yeah, the unfortunate thing is when I was on his show, I had set up the website [freespeechcanada.net](http://freespeechcanada.net) so that I could spread this information to people and put my email up on there for them to contact me. But I only got like three emails

back.

So that was dismal feedback. That reminds me, Revolution Radio is only audio, right? There is no text. So you actually have to spell out.

If someone is going to donate you money, we could do that now because on the video, we can write whatever you want. You can send me that. But right now for the audience, maybe slowly tell how can people donate money exactly where to go? Because it's only audio on Revolution Radio.

Oh, I didn't really realize that. Otherwise, I wouldn't have done so much visual. Well, like this is visual, right? But for Revolution Radio itself, it's only audio.

Yeah, I didn't realize that. But in any case, I'll just go to my website to be able to get the... I have to get onto the website first. And then from there.

Yeah, so we've got about 12 minutes left. So we can do that and anything else. But yeah, we're covering a lot.

That's my intention to try to present to people as much of this information as I possibly can. So, okay, I will spell out. My email is loki.is at innocent.com. That's one specifically for this purpose that I have that email.

Maybe repeat that if people are listening. Maybe repeat the same thing. loki.is at innocent.com. Very good.

And then I should also mention my more regular conventional email, which I used with you last time. I don't know if you want to put it down visually on your show if you can. Oh, yeah, yeah.

But yeah, but to tell the audience, you want people to email you directly, right? That's fine. That's correct. That's canadianrenaissance at tuta.io is my other email.

But the donation one is loki.is at innocent.com. Okay, and then there's a button on there that links to PayPal. Is that right? So far as I can understand. Okay.

Somebody helped me to set it up. So if it works, it works. That's good.

Their issue there. But I'm not really too sure because I haven't actually donated to myself since I have no money to donate. But I guess that's self-love, meant to donate to yourself and donate to the world.

In a way, the way I donate to myself is just writing all this stuff and throwing it out to other people. And then if they give me feedback, you know, it gives me somewhat of an ego boost, maybe or, you know, it makes me feel like I'm part of things or making a contribution to things in some way. So I look upon that obviously as a, you know, good

thing, benefit.

I don't know if I should continue since we only have about 10 minutes left for my rebuttal of charges. What do you think is best? What everyone do last 10 minutes, you know? Some guests have nothing to say after an hour. You're an easy guest to have Loki.

It all depends on how much I want to ramble. But I guess I'll just continue just do some brief things. Maybe you can cut me off in five minutes or so and we'll just do something else for the remaining five minutes.

Okay. Okay, so basically another refutation. This is according to the criminal code references section 317 to section 321 for refuting hate speech charges.

Basically, it has to be proven. It has to be proven beyond a reasonable doubt that there was an intent to incite hatred. If statements are true, then it's not convictable apparently.

The opinion must, it can be based on a religious subject. If it's true, then it can be refuted. It has to be relevant to the public interest in order for it to be true for public benefit believed to be true intent to curtail.

Let's see here. So in other words, was it for the public benefit that I did this? Well, yes. My intention was basically to raise awareness with white people to make them aware that you're basically living in a matrix of illusion, a Zog matrix, and that they're the ones who are controlling it behind the scenes and that all this right-wing, left-wing, political shell game is basically illegitimate.

It's not going to be the solution to your problems. It's not the liberals. It's not the conservatives.

It's not the Muslims. It's Jewish supremacy at the highest levels. The so-called capstone in the pyramid, or I guess you could say the trapezoid or the upper layer of the trapezoid because I won't call it a pyramid because they're basically satanic and that's what the trapezoid is all about, right? It's invocation of evil forces or demonic forces.

What is a trapezoid compared to a pyramid? Pyramids have four sides. Yeah. Trapezoid is basically a pyramid with the top cut off.

So in other words... Oh, like on the dollar bill with the all-seeing eye in there. That's right. And so far as I know, the all-seeing eye, although I may very well be wrong, is basically Lucifer and or the planet Saturn maybe.

It may be Saturn. Let's talk about David Icke's views on Saturn and the moon. Maybe save that for another video.

Basically, I had written up a little paper today and did a video on it called Are the Jews

Reptilians? You know how David Icke's conceptions... Yeah, we can talk about that last five minutes because I think even from perspective of ufologists like Richard Dolan, he told me here in this very room, he's not saying this so much now, four years later, that he felt that the Rothschilds, Jews, he didn't say Jews, the Rothschilds are answering to the reptilians and that the relationship was the reptilians had an agenda on planet Earth and they're working through the Rothschilds. Of course, I'm saying through the Jews. Right.

Basically, I agree that my conception is that, and this is also a Christian identist or dual seedline Christian identist perspective, such as Wesley Swift. I have all of his information and sermons. I can give to people for free, links.

Basically, that the fallen angels are the ancestors of the Jews, and this is also Jörg Landvand Liebenfeld's interpretation in theozoology. That they interbred with the beasts of the creation, whether it be through genetic engineering or through physical fornication, and thereby they created the non-whites who are basically the creations of the fallen angels. And the Jews themselves are derived heavily from the fallen angels.

They have the so-called serpent seedline or the seedline of Cain that comes from the fallen angels to the Cainites, to the Canaanites, to the Edomites, and then they're mixed in with the Khazars, and that constitutes the Jewish biological stock of whatever you want to call them, those who claim to be Jews but are not, but are the synagogue of Satan and Revelations 2.9 and 3.9 of the scriptures or the ancient parchment. I just want to clarify, the Khazars who claim themselves to be Jews but are not, I don't want the other Jews, the Sephardic Jews, to get off the hook. They still wrote the Babylonian Talmud, they're still Jews, and to keep it simple, the Khazars were accepted and converted to Judaism.

So I'd say they're all guilty, basically. Basically, they're so-called reptilian hybrids, I guess, David Icke's conception of, you know, reptilian shapeshifters and so forth. And basically in the video or paper that I did today, proves from my perspective, on the basis of physiological evidence, on the basis of somatotypes and behavioral psychology and general behavior, that Jews have a sort of reptilian consciousness or reptilian behavior and appearance.

Their eyes are sort of slanty, they have a wide cut mouth, they have a hooked nose, receding forehead, they have a sort of elongated torso relative to limb length, they have a sort of slinking, sneaky type of personality, a sort of psychopathic personality, they have a very heightened level of reptilian brain consciousness, the so-called arc complex, ARC complex, pons, medulla and brainstem, which governs the lower states of consciousness, the fornication, fight, flight, and so forth, because they're always going to this sort of reactive minded feral mode. They also have a sort of psychopathic, like hyper rationality, where they're always trying to control everything like a matrix, right? They're

basically like the Borg, they're always trying to micromanage every facet of existence. And so also in media, you see the movie Aliens, the movie Species, you see the movie They Live, that refers to the constellation of Orion in They Live.

And Orion is apparently where they come from. They've got the Egyptian pyramids, the burial chamber pointed right at Sirius B in the constellation of Orion. And the Mormon faith is basically Freemasonic.

And they look upon themselves as ascending to a place called Kolob once they're done on this earth. And that is basically Sirius B, which is in the Orion constellation. So in other words, it all sort of dovetails to prove that there's an Orion connection with the reptilians, that that might very well be their home base.

I just want to interject, my viewers are tired of me saying this, but Lord Buddha, who is my favorite person in history, he stated there are reptilians in the first of six heavens of the central spheres. We call them Nagas, N-A-G-A. And he stated specifically, they have the ability to shape shift into human form.

And this happened in the Buddha's lifetime. And this was common knowledge. And it's common knowledge today in Thailand.

I mean, it's not that we see it every day, but these are Nagas in Buddhist cosmology. They are reptilians, same thing. This is part of Orthodox Buddhism 101.

Thanks. Yeah, it definitely seems to be the case, because even in the Bible, or the so-called Bible or scriptures, you have the word Nakash for the serpent. So it's a linguistic cognate of Naga.

And this basically seems to suggest that there's some sort of like serpent civilization, even, you know, antediluvially before the deluge, you know, like, when was it? 5,000 years ago or something to that effect. That occurred either over the whole earth or within the Tarim Basin in Western China, that the fallen angels, they interbred with the beasts of the field, created the non-white races, and or maybe brought some of them from a foreign planet, like Wesley Swift contends. He contends that they brought the Negroes from planet Venus to this earth, apparently.

And so then there's the whites. They're not genetically related to anyone, but according to Christian identity, they're the children of God or are brought upon this earth. So maybe when they say God or Elohim, maybe they're referring to aliens from El Beberon or something of that sort.

That may very well be the case. Of course, people could say this is just wild speculation or woo woo, whatever. But at the same time, what conforms to the historical record, the ancient Sumerian cuneiform tablets, the Babylonian portrayal of sort of winged figures on their cuneiform tablets and so forth.

And if people listen to that brief write-up that I had of the Jews' reptilians, it shows a picture of, on one side, a Jew with very reptilian-looking features. And on the other side, pictures of Sumerian reptilian statuary, I guess you could say. You'll be able to know what it is once you see it because they're fairly well-known images of the statues from Sumeria.

So that is basically my conception that the Jews are basically a distinct species of being, even if they're hybridized with more or less all the other types. And that's the way they have it, trying to spread their kind, is through hybridization and interbreeding with different species of being. And that's how they sort of hegemonically take over the world for themselves, for the most part, is through that process of interbreeding through the matrilineal line, basically.
