

roper report interview

This is for all you new people, I only have one rule, everyone fights, no one quits, don't do your job, I'll kill you myself. Hello and welcome once again ladies and gentlemen, boys and girls and children of all ages to The Roper Report, Billy's balkanization broadcast, brought to you sporadically by the numbers 14 and 88 and the letter H, home of AryanWarrior.com, the show all network, and coming to you recorded in Technicolor. You know, we like to push the envelope, we like to kind of go to the extreme, really we're accelerations and we're balkanizers and when we do a show, we don't just, you know, halfway do a show, we support political prisoners all over the country from sea to shining sea, Mad Hill to Colton Fierce and Dylan Roof to, you know, people that we won't even name because they haven't been brought to trial yet.

We're going to talk about that, we're going to talk about the child defenders and we're going to talk to a Canadian free speech activist in the last half of the show who has been arrested on these hate speech charges and some firearm charges, he's coming to trial soon and he wants to give you his side of the story before he does, but first we have as our special guest to start out the hour for the Rope Report this evening, Julian Calfee. Now, Julian Calfee probably needs no introduction to those of you in the white nationalist circles, but I will tell you that he's a good friend of mine and an officer of the Show All Network and he's one of the child defenders that back in June were actually allegedly involved in stopping an attempted child predator who wanted to have illicit sexual relations with a 15-year-old boy. That did not happen and Julian is here tonight to give people an update on the child defenders case and the story, so Julian, how are you doing, man? Not too bad, how are you doing? Doing good.

I wanted to give you a chance to come back on the show and give people an update about the case to tell them what's happened so far since the last time you were on the program and then we can talk about what's going to happen next. So catch people up, please, what's happening? Well, at the moment we have been assigned public defenders. I guess since Hate Trackers has already put it out there, I'll just go ahead and say that our other fall partner, our co-defendant, Nick, he decided to write a statement in state's evidence, so they're using him against us.

But as it stands right now, we have a pre-trial and a trial date in December that will more than likely get set back again and we're just kind of going from there. I think I'm real hopeful with the situation given the fact that he was there to have sex with a minor. Even if it goes to trial, I'm not expecting too bad of an outcome, but that's pretty much where we're standing right now.

We're just playing the waiting game with the state. Now, December 21st, we're going to have our Show All Network Christmas meeting and it's going to be a festive party, a wonderful occasion where we're going to give gifts to several families in the Show All

Network White Family Christmas Drive. And if people would like to find out more about that, they can do so through IronWarrior.com. And if they'd like to send a gift for one of their kids, we have kids on our wish list from infancy all the way up to their teens and both sexes, there's only two.

And so they can send a gift to us through PO Box 1937, Mountain View, Arkansas, 72560. That address is available on the website as well. Or if they'd like to find out more, they can certainly email me.

But at this meeting coming up on the 21st, I don't know if you've seen it or not, but we have a Show All Network lady supporter who has painted two really nice, professional quality paintings, acrylic on canvas. One incorporates a Show All Network symbol and the other is actually a Third Reich related insignia from World War II, historical item. They are both going to be auctioned off at that December 21st Show All Network Christmas meeting and the proceeds of that auction will go to help you guys' legal defense fund.

We certainly hope for the best possible outcome, but it's always better to be prepared. I used to be a Boy Scout, so I always want to try to be prepared. And so tell people, before we get started and forget about it, if they want to make a contribution to your legal defense fund, what is the best way for people to do that? Currently, I don't know if it's the best way, but it's the only, it's the way that would work best for me is PayPal.

I know we're coming up on the holidays. A lot of people got money that they need to buy their own family's things with. So of course it's donated at your own discretion.

And just to rehash a little bit, I don't want to, you know, step over my bounds and say more than I should, but what is alleged to have happened, as far as I understand, is that this guy who, I guess his husband is currently incarcerated for sex crime, he's an adult male homosexual, thought that he was going to be meeting a 15-year-old boy for sexual relations, and actually showed up late at night after sending messages through Grindr, which is a homosexual dating app, and in these messages, which I've had the opportunity to see, he specified that he was meeting a 15-year-old boy, and that he was also saying that he did not want the police to be involved because the boy was 15, and

that the boy could not tell his family. Am I pretty correct there in what happened? Yeah, that's pretty spot on. So he was an attempted child predator, thought that he was going to be having sex with a 15-year-old boy.

He got surprised. Things did not happen as he intended. There was an altercation, and so the child offenders are facing charges for that.

And since you mentioned it, as you said, one of the persons who were involved has gotten very creative, wants to be a fiction writer when he grows up, and has, I guess, given statements to law enforcement, which are not only in conflict with reality, as I understand it happened, but also actually in conflict with the statement of the alleged victim. Is that the case? Yeah, that is correct. So it's going to be funny, you know, if it ever went to trial.

These two witnesses, I understand, publicly contradicting one another through their sworn statements they've already given. So it's too late for them to even fix that up. But anyway, we'll see what happens in the future with that.

It's sad to see that that has happened. Did you have any comment about how that has happened, or what is going on with that, or any comment about the person or persons who may have offered that different statement? You know, I've had plenty of time since we received the motion of discovery and gotten to read the full statement, all four pages, and he definitely took some creative liberties and added quite a bit to what was already pretty bland. But I've had plenty of time to sit here and think about it and brew on it.

And realistically, I understand. I'm not mad at him. I don't hate him.

I don't wish any ill will for him. But I wish he would understand how freaking stupid that was, and that he didn't do anything but dig his own grave when he did that. In a legal sense, not as a... Yeah, rhetorically speaking, because, you know, this is the kind of thing that could really ruin his ability to get a job or to have a career.

I mean, unless he wants to move to, say, the Philippines or something. I mean, really, I don't know what he's going to do. I hear the wife is over there already annoying.

Exactly, yeah. Yellow fever, right? But unless he wants to do something like that, you know, family tradition, right? Like old Hank said. But yeah, so December the 6th is the next trial date for you guys, is that right? I believe the pre-trial date or the preliminary hearing is set for the 2nd.

And then the 6th or the 10th is the trial date. And that's, you know, we do anticipate that there could be continuances that they could get forward even, you know, past the new year. There's always that opportunity, especially with changes of representation, legal representation in lawyers and continuances from both the defense and the prosecution.

The prosecution, you know, once they see that there's a contradiction between the alleged victim's testimony and statement and the other alleged perpetrator's statement, they may very well be desperate, pleading for a bargain of some kind. But we'll have to see how that plays out. Also, so you guys, if that's not continued, we'll be going to trial about the same time as Jessica Rivas over there in North Carolina.

We'll be going to Pittsburgh on the 18th of December. We had Jessica as a guest on the Roper Board a couple of weeks ago, and she was talking about her arrest for that concealed carry infraction there at the demonstration there defending the Confederate monument in Pittsburgh. And we also had on that same program as a guest Russell James, who runs the Colchester Collection of White Nationalist Books.

And I wanted to let you know, Julian, that Russell has told me that from November the 1st until the end of the year, all of the profits that he makes in the Colchester Collection from book sales, he is going to contribute to your legal defense fund. That's fantastic. If you speak to him before now and then, tell him I greatly appreciate it, and so does John.

He's a great guy and dedicated to the movement as we are, and so we'll see how much that works out to be. So people, listen, if you want to get a good book and you also want to help a good cause, you can go to the Colchester Collection and all the proceeds, all the profits from the Colchester Collection from now until the end of 2019, he's going to contribute to the Child Defenders Legal Defense Fund to help our guys. Now, I want to talk about another issue since we've got some time, if you don't mind.

And once again, we always have to be careful about what we say about upcoming trials, but we can, you and I can speak about another couple of arrests that have happened in different states, one in Texas, the other in Colorado recently. And these are related incidents, you know, where in both cases, people whom we knew, at least indirectly, you know, got caught up with an e-thought, really with some e-girl that wasn't even a real person, owned VK, this profile was going under the name Nikki Mason, and I believe owned Facebook as well. And so Mr. Holzer out there in Pueblo, Colorado, and a gentleman who is known, you know, as Sam Dimas to us in Texas, an 18-year-old guy.

I like to think that his name there was dumbass. I feel like it fits better, but perhaps. Yeah, if you had a vowel in there.

That's the French pronunciation of D-E-M-A-S-S, right? Yeah, well, I guess so. So he's an 18-year-old kid, and he was also caught up by this same female persona, not even a real girl. And, you know, without saying anything more than what's already been published in the controlled media, Mr. Holzer was caught up in meeting with and discussing with literal FBI agents pipe bombs and Molotov cocktails in relation to a Jewish synagogue in Pueblo.

And apparently, Mr. Dumbass in Texas was caught up by this same operation, the

Sunnypot. And my understanding is just giving information on how to make a pipe bomb, which literally, you know, you can go to a thousand places on interwebs or there's books in your library that will give that same information. So not only is this, in my view, entrapment in both cases, but it's also, at least in Dumbass's case, there's no intent to do anything illegal.

So anyway, that's my understanding of it. And I am not, of course, involved in the investigation or the case. But I wanted to give you an opportunity, because you did know a little bit about both these cases as well, to comment on that.

And obviously, I think we both agree that this is why people do not need to even joke about illegal stuff. And they also need to. I don't care how how incel you are, how thirsty you are.

This is why you do not say stupid stuff to try to impress girls. Really, whether it's real girls or not. But what are your comments about that, Julian? Man, I'd like to say that both of them, personally, we're friends, if not only acquaintances.

So it kind of sucks, you know, there's two people that I did know that I had spoken with on multiple occasions prior to this. I was on 90 Day PB and had spoken to the one in Colorado for years. And man, I understand the mindset.

But like you said, you know, it's not worth your whole freaking life just to talk about some illegal shit to impress somebody in Mr. DeMas' case. And in the case of the Colorado guy, you know, I can't sit here and counter signal anyone that wants to do the boogaloo. But have some common sense about yourself.

You don't talk about it to some random chick on the Internet you've never even met in person. And you sure as hell don't talk about it to people that you've only met one time. Just on that general basis.

But still, you know, it's counterproductive to even really talk about it. Like we've spoken about many times, accelerationism isn't full blown revolution against a federal state. It's more reactionary than that.

It's going to happen. We don't have to spark it. The leftists don't have to spark it.

It's going to collapse organically. We just have to be ready for it. And if we can do the legal means to spur it further, then by all means.

But you're just wasting your life and throwing away precious years when you could be contributing by doing this shit to showboat and to try and impress somebody, somebody you've never met at that point. You know, exactly. And, you know, I can't help but just sit here and shake my head at both instances.

On the interwebs. And how many times has this happened? Dozens of times. Yeah, exactly.

And people never learn. And I understand. So it's the oldest thing in the book, you know, some thirsty guy and some female avatar.

And that's all it takes, you know. So, yeah, I hate it that this happened to these guys. I'm sure they both had good intentions.

They're probably both good guys. Um, one of them is really, really young. Barely 18.

So his life is pretty much screwed now. I mean, really, I don't know what's gonna happen to him, but it's not gonna be good. And, you know, you and I have in our positions as officers of the Shitwall Network and as people who influence, you know, younger guys and new guys, we both consistently tell people, you know, look, if you're going to be serious about this, then you need to get your stuff together.

You don't need to be breaking petty laws. You don't need to be getting attention under yourself and put yourself under a microscope because I have no idea what's going to happen in the near future. But I certainly hope that what happens, you know, does not find me locked up in a prison cell where I miss it all.

And, you know, not gonna be a good place to be when things when the lights go out. You don't want to be in there. So, you know, it is sad for Sam.

It's sad for Mr. Holzer. But I think that I hope, man, I pray that this can be a lesson to some others. Don't talk about illegal stuff.

Don't joke about illegal stuff. And honestly, I've never really met real life women who were impressed by that kind of thing. I mean, there might be some things that a guy could say that could impress a girl.

But I've never really found that that is one of them that really scored many points when I was, you know, trying to get female attention. I don't know. Maybe I was doing wrong.

Something about my life as a fugitive in jail or dead. Yeah, because, you know, obviously, you know, we both understand that women are attracted to security, their nest builders, their nurturers, and they want to think that you're doing something for their children's future. You're doing something for our people's future.

And that's good. If you're heroic, that's great. You know, but obviously, you know, stability is the kind of thing that attracts a lady more than at least a quality lady, you know, unless she's just really psycho, in which case run away fast as hard as you can, you know.

But I guess to a young guy, you know, this kind of impress a girl like he's puffed up his

chest and acting real alpha, like he's showing up how much tea he has, how much testosterone. But I think that was the wrong way to do it. And I wish, you know, some of our friends, some of our mutual friends had met him and vetted Sam.

And, you know, I wish that he had enough time to get better guidance and better direction before he made an error like this. I think that if he'd spent more time around us, you know, he probably would not have made that kind of silly mistake and end up in federal custody right now. So we hope the best for Sam and we hope the best for Mr. Holzer.

But we hope that everyone listening to this show will learn from their errors and, you know, profit from their mistakes, not repeat them and not have to make their own in this regard. At least, you know, make your own mistakes. Don't repeat somebody else's.

Don't talk about illegal stuff. Don't joke about illegal stuff. And don't think that just because you have some kind of conversation or chat online that you know who you're talking to because you probably don't.

There's no secure social media platform. There's no secure form of communication online. And people are often not what they purport themselves to be on social media, obviously.

But let me ask you this, Dallas. Shift gears just a little bit. I want to ask you, think about the time that you have spent in the Shield Wall network, you know, over the last couple of years and share with our listeners, because, you know, we can talk about arrest.

We can talk about convictions. We can talk about cases and trials. That's kind of all black pill.

That's, you know, not very enticing or inviting, right? But share with our listeners some of the more fun memories, some of the fun times that you remember having with Shield Wall. So they won't think that it's all about, you know, trying to beat a case. What are some of the most fun memories you have in relation to, you know, our our time together in the Shield Wall network? Oh, yeah.

You might people people can look at it right this very second and say, oh, man, they got three Shield Wall members facing charges. They got another one. It's in Virginia, right? Virginia, West Virginia, whatever.

Anyway, one that's already in prison. They can look at all that and it kind of may be taken out of context and like, but it's not that that is a it's an anomaly compared to everything else. I mean, I have I have seen the best in some of these folks.

I've been to their houses. I have been to so many meetings, get togethers, events, protests, rallies, conferences. And I mean, all this all this kind of legal stuff with us is

completely if we're being realistic, this is completely unrelated to Shield Wall at all.

It wasn't like sanctioned or anything. You pull all that together and my best memories really are just are the meetings, getting to meet people, getting to learn some some skills that are applicable to everyday life and post shit hits the fan life. Uh, the camaraderie of getting a march in somewhere with your brothers and, you know, you may not know exactly what's going to happen, but you know that the dude beside you and the dude to your other side has got your back.

You know, that's the most fun thing. Not knowing, right? Yeah. Yeah.

I mean, like there's a it's an adrenaline rush, you know, but aside from that, if you take all the all the rallies and protests out of it and you just bring together the wholesomeness of it, man, I have met some good families. Some solid families that are amazing people. And even if even if Shield Wall were to collapse or if we were to to lose them as as members, they are genuinely good people that I would still consider strong friends.

And you take into account some of the the skills and things that I've picked up over the couple of years I've been with us. You know, it's. They're really they're really beneficial things to know.

I mean, that and that's that's the main thing is just knowing that you got people there that you can consider your friends. And that's kind of hard to find nowadays. If you're a white nationalist and you're involved in this, you don't find very many people that you can consider a friend, you know, every day, you know, nine to five.

And that's really our focus, you know, to get people off the Internet so they're not so thirsty. They end up signing their life away for some thought, you know, to make friends in real life, people you trust and, you know, face to face. And, you know, that way people don't end up making these kind of mistakes.

I guess it's kind of all full circle and and interrelated. I appreciate you sharing your time with us, Julian, this evening. I know you got a lot going on, man.

But before I let you go, tell people one more time that PayPal email hookup. So, Julian, thank you for your time, man. I look forward to seeing you again soon. Tell Johan that he missed a conversation, but I know that he had a hard day and he's sleeping it off.

But thank you for coming on The Roper Report and I look forward to hearing from you soon, man. Absolutely. I look forward to talking to you again.

Okay, 88. 88, brother. I want to thank Julian Calfee for being on The Roper Report for the first half of the show telling us about the Child Defenders case and how people can help out with their legal defense fund.

Our next guest for the second half of the program this evening is from Canada. You know, I guess supporting political prisoners and activists for our cause across the nation is not enough for The Roper Report. We're going international now.

So we have on the phone through international call an activist, a patriot from Canada who's going to tell us about the situation he's facing there in our neighboring state to the north. Loki, how are you doing this evening? Pretty good, Mr. Roper. I appreciate being on your show to enable me to spread the message some more.

No problem. We're glad to have you. And, you know, you and I have been talking, I guess, through social media for a little bit about your case.

I understand that it has not gone to trial yet. So this is an ongoing situation, but that you have been involved in charges based on what they consider to be hate speech and also

through some minor firearms infraction. And, you know, we we don't want to, you know, make an international incident by talking bad about Canada.

But it is the case that, you know, Canadians such as yourself don't have even as much of a First Amendment protection, freedom of speech as we have here, you know, in the United States. So tell people what happened with your situation, with the charges. And what's coming up next? What's going forward? Well, basically, most of the information can be gotten on the website that was set up for the case.

It is free-speech.is-great.net and that basically gives an overview of the chronology of events that happened in the last year for the case. Happened to me personally, all the persecution by the Jewish community in this town and their police operatives. I've been spied on and basically harassed and bothered by Antifa people that they have working for them, have death threats made against me and things of that sort.

So basically, it's all on that website again, free-speech.is-great.net. So basically, what they're charging me with is public incitement of hatred. We don't really have apparently much in the way of the capacity to even speak at all in this country. I'm not even too sure really what the law is.

It's all so ambiguous and a lot of gray area. You can't really tell what constitutes hatred, what doesn't. That's the whole jurisprudential issue.

You can't really know what the definition of hatred is according to these people. So they're basically charging me with willful promotion of hatred for spreading messages, distributing stickers and leaflets and pamphlets saying 99% of the 1% is Jewish, immigration equals white genocide, Jewish supremacy, stamping money bills with permanent marker ink, Jewish white genocide. And then from there, on that basis, they raided my property with a sort of flimsy excuse, not really too sure if they legally even got the search warrant through proper legal channels.

It seemed to sort of have rushed it. They raided my place, found a bunch of firearms that I had that I was intending to cash so that in the event that almost inevitably the government here will start trying to confiscate firearms, which the Prime Minister has already furthered that procedure or that, I don't know what you call it, that totalitarian tiptoe of the left wing where they push for more and more gun grabbing. Right, incrementalism.

Yeah, gradualism or incrementalism, that materialistic dialectic of left wing versus right wing, they keep moving the goalposts forward every election term or even within the midst of that. He was holding up one of the firearms that I personally had. I had two SKS rifles, not being a very affluent person, I had to scrape the bottom of the barrel for the most useful firearm.

So I had two SKSs, I had a Ruger 10-22 and a bunch of ammunition for that. All that was taken because I had foolishly scratched off serial numbers for a couple of the firearms, allegedly, that they had found here. I was going to cash them in the ground and relocate to the countryside for survivalist purposes.

But I was obviously far too hasty and imprudent, but I had no idea that the police had the just to intrude into one's house on the basis of one's spreading around a money bill which proclaims Jewish white genocide. Not to say that I'm acknowledging that I've done that. I'm just stating in general that that's sort of a tenuous link or not the greatest justification for police to be able to raid your property.

At least I didn't think so until I was the victim of this more or less home invasion and theft of my property. They stole about eight and a half thousand dollars of my stuff. I had a couple thousand dollars of money bills with these stamps on them here.

I had a bunch of books and USBs, computers, a whole grocery list of stuff. They strew my stuff all over the place here, slept the house in a shambles. So basically that was what I returned to after being in the holding cell for about 42 hours or so where they sort of kept me in there, you know, just allegedly trying to get a bail package together which eventually amounted to a \$4,000 bail.

I couldn't leave my property in the middle of night after 10 o'clock or before six in the morning. Otherwise, I'd be jailed or have to pay the fine or both. I have to check in to the police every Friday between business hours.

So basically I've been more or less put under house arrest for the entire time since I believe around early August of last year and my chronology of events document on that website reveals all the very minute particulars of all the situation that occurred from that time of arrest to the present time. Now, you said that that was August of last year. Loki, I know that this is Canada, so I'm not as familiar with Canadian law as I am with, you know, American federal law, but is there no limitation as far as time limit on how long they have to press charges if they're going to or move forward with trial or what is their intent now? What is the situation going on right now? At this very moment, throughout the entire case from the beginning, they were doing their utmost to try to railroad me through the legal system, and I was doing whatever I could to try to, you know, ensure that I got at least some type of fair representation or some type of, you know, didn't get the raw deal from the jog.

So they are trying to basically do everything they possibly could in their power to just force things through as quickly as possible because this case would represent, you know, a false association, as in my case, it is a false association between the possession of firearms and the possession of, you know, improperly stored firearms, firearms that look like big bad evil guns to the eyes of the average left wing city dweller or whatever, people who've never seen a firearm before in their lives. Right. That and criticizing Jews,

so in other words, they're trying to portray me in the media they control as a terrorist, basically, you know, and so I was having police detectives interrogate me about the Bowers shooting when that occurred last year.

So I just, I just stated to the police detective, just all you have to do is just Google, you know, Bowers false flag. In my opinion, it was just another false flag event. But whether that is or is not the case, it is my opinion that it is.

Still, they're trying to create that appearance in the media so that they can justify the red flag laws, which they did, and various other of these gun grab laws. I reached out to all sorts of firearms or the two firearms organizations in Canada that actually claimed that they're here to, you know, ensure people have firearms rights. But the only thing that they would do is just try to sell me insurance.

They didn't really seem to care almost about people actually having any firearms rights. It's just a little bit, a little bit too late for that, right? Yeah. And at the same time, though, they didn't really seem to care in the least about the actual rights of people to have firearms.

They're just working within the current laws. And, you know, typical conservator put the brake on the tyranny just a little bit so that the people can continue to live a life of comfortable decadence and, you know, watch as they continue to fall off a cliff, basically full steam ahead off the cliff. So none of them helped me and the lawyers, the only lawyers that I could potentially get at first, maybe were a couple of Jews.

So I was thinking to myself, well, that's a very stupid idea. So we'll just keep searching legal aid. The government provided lawyers for some better lawyers.

I reached out to some. Most of them wouldn't accept it. They didn't.

They wanted more money. They said, oh, I wouldn't accept that on a legal aid certificate. Most of them wouldn't take it because of the controversy of the case.

One of them said that he was interested if he could get, you know, full price, which would cost like over \$30,000. And then he tried to refer me to one of his Zionist Jew colleagues. Eventually, the case and all the police report, police disclosure was posted on the internet.

That was told to me by the Crown, which is the government here, that I was forced to take it down from the internet, even though I never claimed that I put it up there. But yeah, it was up there. Now it's down from there.

From there, I was getting Antifa harassing me, making death threats, referring to knives, you know, they're experts at knives, blah, blah, blah, getting quite a lot of sort of sinister comments about how I'll be committing suicide in jail. A lot of comments about particle

beam weapons and how they're going to use it to experiment on people there. So who knows? Because this is right next to a NATO base where they also have, I think it is a class four, class five biological laboratory for weapons, you know, bioweapons, basically, in effect.

That's very close to this small city of about 70,000 people. So I was getting a little bit paranoid, you know, well, maybe these people are going to try to do something to me or experiment on me. So I was doing what I could to try to get as much of my writings and content, philosophical writings out as I possibly could during that time.

While I waited for a lawyer, a proper lawyer, the only lawyer I could get eventually, which was right around the beginning of this year, was a young liberal lawyer who had defended a pedophile teacher in a nearby province and who had also overturned the, what is it, a fag conversion procedure that some Christian organization was offering in the nearby city. He had overturned that decision. So he was basically a complete leftist and then was trying to work, it seemed to me, with the Crown against me to try to railroad me through the system.

He never even really looked at the disclosure almost at all or on any of the actual facts. And he never even enabled me to see the disclosure, the police report, almost at all. And then from there, he was trying to persuade me to sign what is called an agreed statement of facts, which is basically just a euphemism or concealed jargon for a plea bargain.

So that basically entailed all sorts of subtle language, such as the accused willfully promoted hatred by spreading messages, blah, blah, blah, of hatred, blah, blah, blah. So they're basically trying to get me to acknowledge the fact that these are legitimate laws, these so-called hate laws, by agreeing to this statement of facts that I was to sign. But I looked it over and I said, no, I can't sign this because of the emotive language that obviously implies that I acknowledge that this is an actual crime.

So eventually, the lawyer said that he couldn't represent me anymore because he, you know, I told him things that were not very good or within my interests in terms of his representing me. So from there, I had to part ways with the lawyer. And then the Crown was mentioning the statute of limitations of the Jordan decision, which apparently by February, assuming that the Crown is the one that had wasted all the time, that they would be, that the case would be thrown out potentially.

So at that time, they were doing their utmost, sort of in a panic, trying to force it through, trying to get me to go to a pre-trial hearing where I would, they hoped, reveal all sorts of incriminating evidence and so forth so that they could just, you know, finish it off quickly and pack me away into jail. They want two years for the offences. So eventually, just within a month later, I managed to get a better lawyer, somebody who actually seems to care about, you know, people's ability to speak freely without

restriction.

He was telling me there's all sorts of corruption going on here. He could tell that. And he was stating to me anyway, although I wouldn't extend 100% trust to anybody involved in the legal system or the government, that he is only concerned with, you know, upholding his duties as a lawyer.

So that's at least something positive at this point. So still, I don't know exactly when the trial will be. It was supposed to be maybe as early or as late as the summertime of next year.

So once again, it's still, you know, like the wait time, whether this will be thrown out or not, or whether I'll be thrown into the cage or not is, I'm just living in limbo right now. So I don't really have any understanding of whether this is going to be the conclusion or not. So it's all basically up in the air.

So I'm just doing what I can to try to reach out to people and spread the message so that people can investigate that themselves and see the corruption at a sort of micro level, you know, the level of the peasant who's being persecuted by the prince, I guess you could say. Fascinating. Now, I want to revisit a couple of things that you mentioned, backtrack just a little bit.

You said that of the charges that you're facing, potentially the penalty could be two years in prison. Is that correct? That's right. They had wanted me to agree to one year in jail through this agreed statement of facts that they were trying to get me to sign.

But because I was willing and I'm willing to endure a greater legal penalty, so long as it doesn't create that legal precedent, so that this won't become case law, so that it will not, you know, harm other people, other white activists, or even just generally activists who care about free speech, that I'm willing to endure that if need be, because I don't see that this world's going to be going in any positive direction in the up and coming years, as you write up and hasten the day and various other books that you've written. Basically, it's going to be going to very more, you know, much more chaos soon enough, I can anticipate, I don't see it's becoming anything better. So I agree, man, for sure.

Now, let me ask you also about a statement you made. Now, I hope I didn't misunderstand you, but you said that at one point in time, there was information about this particular case available online, and that the government then requested or ordered that it be removed from the internet. Is that, did I understand correctly? And if so, I understand this is Canada, of course, but what legal power or authority did the government have to demand that that information about the case be removed? What they had done was sort of give me this shotgun clause, either or, either I take it down, or else they'll alter my bail conditions.

They didn't exactly state what, so maybe I might have had to forfeit \$4,000, or maybe I might have been jailed, or who knows, have my liberty restricted to a greater extent, or had other additional charges added to the case. So I'm not too sure. But in any case, the police report was taken from the website.

Not too sure if it's possible to find on the net. At this present time, maybe people can find it somewhere. But yes, also, what was I going to say? I forget what I was going to say there.

But yeah, there, they'd added additional charges to this package of charges, which consists of, I don't know, as much as 15 charges or something like that. Because I had accidentally not checked in one time to the police. I had skipped a day because I was, you know, busy and I'd forgotten.

And so when I went the next week on Friday during business hours, as per the usual, they said, oh, I'm gonna have to get you to speak to a police officer. So then I had to go into jail there again. I was in the holding cell for another 12 hours or so.

They never gave me any food or anything like that. Not to say I would eat it anyway. But when I was in there, they had planted another person there next to me in an adjacent cell.

And this person, they were shouting and screaming about Nazi, right-wing Christian racists and so forth, trying to get me to make some sort of, you know, incriminating statement or something because it's, of course, all recorded and everything and on video when you're in the cell. So basically, that was another one of their setups. They'd actually done that to me before, before this case occurred, in an attempt to try to find out if I was the one who was doing this, because I'm in now at this time in my life, I had undergone serious hardship because of my involvement with my liberal father in a business project that he screwed up selling off all his parents' property to East Indians and non-whites and screwing me over, wasting about six years of my life, and so on.

So now I'm basically having to subsist on welfare. And I had to go as a condition of my receiving the \$600 of welfare per month to this sort of session where you have to sit around and listen to them, you know, tell you how to get a job, blah, blah. And in that session, they were having somebody planted in there as well, trying to, you know, rattle the crowds, saying, how come there's nothing but white people here? Blah, blah, blah.

And this guy was tailing me afterwards, too, when I was walking around in the public space, trying to involve himself in conversation with me to find out if, you know, if I was the culprit or the perpetrator. So just all sorts of stuff like that in this town. It's sort of like a Hazard County, Dukes of Hazard place.

Big Zionist town. It's pretty much crawling with Jews. The Jews run all the franchises.

They infest the government. Lots of Zionist Christians. Some of the people persecuting me here are, you know, the Christians.

Allegedly, I was placing stickers saying immigration equals white genocide on church doors and windows and so forth around here, as well as immigration departments. And those are the parties who are charging me with offenses, as well as taking some Kingdom Identity Ministry flyers and putting them around on people's windshield wipers. One of these conservatards with their Support Our Troops ribbon on the back of their vehicle.

I put it on there, and then they're the ones who end up charging me. So I guess it goes to show that conservatards really don't have any interest in conserving anything really very worthwhile, certainly not the way it asserts identity. You're absolutely right, Loki.

Actually, you know, it's ironic that you mentioned that because the Kingdom Identity Ministries, I know the people involved with that, and they actually live down here in Ozarkia, not too far from me. I know them in person. But you're right that conservatives have given me a lot more grief than liberals, actually, because they're the ones most tied up in preserving the status quo.

And they fight the hardest against those of us who want to try to make things better. I also wanted to ask you for clarification about something that you said that basically they're pretty amorphous about what they define as hate when they talk about hate speech laws or inciting public hatred. Hate is a subjective term.

It's the opposite of love. But just as you cannot have a love crime, you probably couldn't have a hate crime. What is someone's motivation in committing a crime? Well, is an act of passion less or more of a crime than a cold-blooded act? I'm not sure.

Apparently, the government thinks that they know better than we do, and that an act against the people that are favored by the government, speech against those who are favored by the government, is considered a hate crime or hate speech. In your case, though, you have several different messages, some of them anti-immigration, some of them anti-Jewish, that are going out. So you're not just targeting any specific group solely.

You're being an equal opportunity hater, but it seems to me like there's a similarity between what you're facing there and what we have here in the United States, the red flag laws, because the point with red flag laws is not someone saying something politically incorrect or even, in your case, illegally so. Hate speech, which there are a lot of people here in the United States who would like to have federal hate speech laws for us, and some states already do. But in your case, it seems like the hate speech charges were really just an excuse to be able to try to invade your property and to confiscate your computers and your firearms and to get you on those firearm charges, which were

really the purpose behind it.

And red flag laws here are coming down the pike for a lot of places. We've been mentioning federal hate crimes laws or red flag laws, where people like me or people who stand up for the original values of our founding fathers could literally be disarmed in the face of Antifa threats because of our political views. And so the same people who report your post on Facebook could make a phone call to have you stripped of your firearms.

And so your situation kind of sounds similar to the red flag laws that we're facing here. And I heard you say that you may not have made allegedly the best possible decision in regard to all of the firearms related circumstances, but still, that would have never been incident, never would have come to public light. You weren't hurting anyone.

You weren't using those firearms to hurt anyone and had no intention to. So whether or not your firearms had scratches on them or not, or whether they were properly stored or not, would have never been in the public view, would never have concerned anyone except yourself, had not been for the fact that you were targeted for exercising what in many places are still considered free speech liberties. So you were targeted for your speech, not really for the condition of your firearms or how they were stored.

But I just want to clarify, you haven't gone to trial yet. At one point, they said that the charges might be dismissed and the trial not happen at all if you were not tried by February. But now you're saying that the trial could happen as late as next year, as late as this coming summer? Right.

It basically depends upon whether there's an opportunity based upon the schedule of the judge to be able to sit during that trial. So it's just logistical for the most part. But I think it is the sum total of the time that the government has taken that they add up to about a year and a half.

And if it exceeds that, then they throw out the case. And if it doesn't exceed that, then it continues. So it just depends that it would be the statute of limitation or the criterion through which it's discarded or not, that that comes into effect.

But so, yeah, basically, it's just a sort of numbers game at this time, for the most part, whether that will be the inevitable conclusion or not. But absolutely about your discussion about the sort of semantic games of hate speech and all these emotive, this emotive language, it doesn't really make any sense unless you're some type of communist or Zionist Christian who worships Jews, who has no willingness to enable people to have basic liberties to express themselves. That would be the only group of people who would look upon such restrictions as legitimate.

People who are basically ideologically biased and blinded by their dogma so that they

cannot think outside of that. Anyone who is racial or has any racist thinking or thoughts is immediately the new heretic of today's society, basically a criminal without having committed any crime, a thought criminal, George Orwell, 1984 type stuff. So basically, just like in the Soviet Union, with, I think Stalin had instituted that, or maybe it was Lenin or whomever, with these anti-Semitism laws, you can't speak about the Jews.

And if you do, you're shot on sight. That's pretty much the same sort of thing that they're working toward, whether that will actually work out for them in the end. It's definitely a question.

They might be able to establish that, such as in the case of the Turner Diaries with the Cohen Act, I think it was, where they— Right, I guess it was. And then, of course, from there, once you take away people's ability to speak, to communicate, to function in society, then it will have to be revolution. But as to ability to function in society, I've already had the Royal Bank of Canada, which is the largest bank in the country, terminate my bank account without any reason.

That was last year. I asked them on the phone, why is this? Oh, it's our policy, safety, blah, blah. So it's the standard excuses.

Why are you preventing me from transacting? On Amazon, I've tried to order books on occasion, so I've been prevented from ordering there. They didn't send the books I had ordered. Same with eBay, too, both of which are Jewish-controlled companies.

I've been banned off all sorts of sites as well, just as most people have who are racials. But yeah, basically, they're persecuting us, and they're beginning to prevent people from involving themselves in financial transactions, which is, of course, essential for life, which is basically, in effect, killing people softly in a sort of sneaky and cowardly fashion for the most part. We here in the United States and you guys there in Canada, we may be thousands of miles apart in terms of geography, but we're not that far apart in terms of our shared struggle.

And I am honored to have met you and consider you to be a new friend of mine. I will hope that you will stay in touch with us to keep us up to date and let us know what happens with your case. But before I let you go, would you share with us one more time that website where people could find out more information about this case, and if there's any way that they can get in touch with you that you'd like to share? If not, I understand, but give that website one more time and tell people how they can get involved, please.

Okay, the website is free-speech.is-great.net, and there's an email link there, so you can email me through the site. Also, my content website is the-struggle.net. The-struggle.net. That's pretty simple. It's about as simple as you can get.

Well, Loki, thank you so much for being on The Roper Report. It's been a pleasure to

speak with you, and I'd like to have you come back again when your case is determined. Give us some good news, hopefully.

Well, hopefully I won't be in jail because obviously from there I won't be coming out to speak to anybody for quite a while. But thanks for having me on your show, Mr. Roper. Thank you, sir.

Have a good day. You too. Well, that was Loki from Canada telling us about his situation and circumstances going to trial, potentially, for hate speech charges and firearms-related charges in the Grand Dominion of Canada, following Julian Calfee of the Child Defenders here in Arkansas, talking about their pending case.

And if you would like to help out those gentlemen, we certainly encourage you to do so, just as we encourage you to help out Jessica Rivas or any of the other many, unfortunately, many white nationalist political prisoners throughout the United States and now around the world who share our struggle.
