Who ever said it first, it really matters not. The words I am about to impart to you have been spoken of for many years and by many people. The words I am referring to are;

Ever more you learned and realized how much more there is to learn. The universe in an immense place. And as you look ever further outward, you can not help but be amazed. You live in a universe of billions of galaxies, each one of which is made up of billions of stars, many of which support solar systems, where all manner of life has evolved.

As you look outward at the stars, and ponder your place in this nigh on infinite, eternal universe, many of you forget to look inward, as well. You forget there is an inner, as well as an outer world in which you experience your existence. One must also look inward and focus to the center; to the Source of All your reality. By so doing, you will come to understand these words even better.

My words are to help you make more sense of things and help you come to an experience that what you think, surmise, intuit, and understand is true, sometimes it is a quick and easy achievement, other times it takes years and years to realize. To come to the truth, one must change one's mind from time to time, as new information comes in. Truth is sometimes a splendid thing. Other times it is damn depressing. First of all, before we begin, I must remind you, words are only words. It is what you do with them that matters. All that I am able to do is tell it as I see it, having spent years researching into a piece of the puzzle which is the creation we live in. The words I am going to share with you are readily searchable on the internet and in the libraries. Think upon the words and let them work in your minds and hearts.

Also remember, **truth is relative to time and space**. You live in a relative reality. There are absolutes, but being finite beings, you only see through a glass darkly. However to elucidate the concept of absolutes, I will give you some examples. The first absolute truth is that your Father in Heaven loves you unconditionally, when you live according to His Will to be perfect even as He is perfect. That is an absolute. When you stray from that path, the love may be tempered with justice.

Other absolutes are: a circle is not a square, black is not white, and so on.

The One Whom you call **God**, is real. He is your Father in Heaven, at the center of all reality; the very center of the universe of universes. His abode is the perfect centre, the Isle of Paradise. Your Father is, The Eternal I Am, the Alpha and the Omega, the First and the Last, the Beginning and the End.

He is not responsible for your misfortune on earth. God is not a puppetmaster. Free will is the rule. Alas, your planet is over run with the minions of Lucifer and Satan, who disguise themselves as your government and legitimate mega corporations with your best interests in mind. It is public record knowledge that many powerful figures are Satanists. One does not have to dig deep to find that out. There is evidence that some very powerful organizations require an oath to Lucifer.

Now, at this point you are probably thinking those names are Bible names and all of that is a lot of malarky. Priests made all of that up, thousands of years ago, to scare people, and none of it has anything to do with you. This booklet will throw some light, I hope, on the strange puzzle which this planet must seem to you. Human beings are complicated beings, many of whom are ruled by emotions and not good sense. I would have said, *common sense*, but that does not seem so common anymore. So we will say, *good sense*. Truth is not about an emotional attachment to an idea, such as a tradition. If the attachment or the tradition is counterproductive to your well being, then cast it aside and embrace what your heart and mind, your good sense tells you is true.

So, let us shine a light into the darkness which is the past. Let us look in the distant past when things were very much different than today. Let us go back to the times of Babylonia, when men became gods and ruled by divine right, for good or for evil. The times I am talking about begin ten thousand years ago, circa 8000 B.C.

When a man became a god, his hubris often times resulted in the deaths of hundreds and thousands of folks like you. Your ancestors watched as their brothers and sisters were enslaved; to labour till death, to support the voluptuous lifestyles of the rich

and famous.

Are these days much different? Do not many of you slave your lives away at jobs you hate, supporting the luxurious life styles of your owners?

Before the evil transition, when priests declared a man had become a god, people lived in small, tribal situations, with a headman, or woman, or both, overseeing affairs of the community. As people decided there was more strength in numbers, they began building towns and cities. Civilization developed as urban centres became more sophisticated and cosmopolitan. Eventually a strong man became king. In Babylon the man became a god.

Of course, the entire idea makes no sense. It is impossible for a man to be god.

What makes better sense are the words attributed to Jesus in the book of Matthew. In Chapter 23, verses 8 to 10, He clearly states that we are sovereign beings. We have no one over us but God. 'Call no man, Master. Not even the Messiah. And call no man Father because you have only one Father, who is your Father in Heaven.'

Human beings, since they became conscious of their existence on Earth in relation to their metaphysical world, have always been sovereign, with a direct link to God. Remember, 'call no man, Master.'

The idea of **the divine rights of kings and queens is a myth**. The myth is only given credence by the consent of those governed, who greatly outnumber the rulers and their minions, by the way. However, lest you think all rulers have been monsters, that is not so. Some are good, most are bad, some are deranged psychopaths. Some rulers did believe in law and order; justice and fair play. In the case of the often times maligned Roman Empire, emperors such as Antonines Pius, or Marcus Aurelius, were benevolent dictators. Their approach to governance was philosophical and humanitarian especially for the times they lived in, (A.P. circa 86 - 161 A.D., M.A. circa 121 - 180 A.D.). They did a lot of good to bring the *pax romana* to a large part of the world.

Other Roman dictators, such as Caligula and Nero, were murderous sociopaths. Their interpretations of the law was much different than those of others. They were diabolical god men.

The issue is the *interpretation* of law. Is the interpretation at the discretion of the monarch, or should there be a code for everyone to easily understand and judges hired to do the interpreting? Eventually a jury was added to further the cause of fairness in court. However, we all know how fallible humans are when diamonds and gold are dangled before their noses.

Some ancient monarchs thought it wise to make the law easily known to all subjects and eliminate or lessen the need for *interpretation*. The law was simple and easily understood. In ancient times, in the Near East, a number of law codes were scripted in stone, or on other materials such as clay tablets or papyrus by rulers who were wise. Stele were placed in prominent places, such as the market place, so the people could see the law clearly displayed and simple to understand. Some of these ancient law codes are: the Code of Ur-Nammu, the King of Ur, the Laws of Eshnunna, the codex of Lipit-Ishtar of Isin, plus the codes put together by the Assyrians, Hittites, and the Mosaic Law, of which we will speak later.

Hammurabi is one of the best known of the ancient rulers, whose laws are known as the Hammurabi Code. Hammurabi was a wise king of Babylon, who put up a seven foot, four inch diorite stele and had the law engraved on it in Akkadian, an ancient language found in cuneiform script. It was the lingua franca of the region at the time. Just like English is today, a language spoken all over the world by people whose first language is something else. Hammurabi felt called upon by the gods, Anu and Bel to bring righteousness to the land. This amazing code states that not even the king is above the law. This code dates from approximately 1790 B.C., That is almost four thousand years ago!

Following are samples from the code of Hammurabi:

If anyone ensnares another, putting a ban upon him, but he can not prove it, then he that ensnared him shall be but to death.

If anyone brings an accusation of any crime before the elders, and does not prove what he has charged, he shall, if a capital offense is charged, be put to death.

If anyone steals the minor son of another, he shall be but to death.

If a man buts out the eye of an equal, his eye shall be but out

If a man knocks the teeth out of another man, his own teeth will be knocked out.

If anyone commits a robbery and is caught, he shall be but to death.

There are 282 such laws in Hammurabi's code. To make things simple there are usually no more than a sentence or two, unlike the convoluted horror posing as the law in today's world. The 282 laws are bracketed by a Prologue in which Hammurabi introduces himself, and an Epiloque in which he affirms his authority as king and sets forth his hopes and prayers that his code of laws will serve a righteous purpose.

Eventually **Moses**, which is an Egyptian name, by the way, arrived at the Ten Commandments and put the authority for the laws with God Almighty. When exactly the Mosaic Law was derived is open to debate. Some say that Moses lived from 1526 or 7

B.C. until 1406, while others say he dates from circa 1250 B.C. Whatever his dates, the point is, a long time ago a very simple set of ten laws was given to the world, which anyone can read and understand. The Ten Commandments are a remarkable achievement because they are so simple and yet so comprehensive. In the history of law, the Ten Commandments are to law what $E=Mc^2$ is to physics. The Ten Commandments make a lot of sense to me and provide an excellent basis from which to begin discussions regarding the law. I will tell you more about this later on.

As civilization evolved and god men and their handlers, the priests, developed their power over others; sometimes utilizing grotesquely cruel displays to persuade people to accept the monarch's, or the priests' versions of the truth, people eventually evolved into beings who thought less for themselves and allowed themselves to be ruled, more and more.

The god men, (kings and queens), and the priests also became covetous of other people's situations. They began to desire other people's women, land, and their gold. And so, through clever manipulation of their subjects' minds, by playing with their world views and their dearly held versions of the truth, the monarchies and priesthoods manipulated people into armies and navies and waged war, in order to steal other people's stuff; gold, land, and women. All of these wars eventually resulted in the deaths of millions of people.

By the time of the **Phoenicians**, circa 1000 B.C., civilizations had developed more complex contractual relationships in exploration, commerce, trade, and warfare. People began to further develop the instruments of law courts and a new type of priest evolved called a, *lawyer*. Note, today's lawyers and judges dress in black robes, much like those of ancient Babylonian priests. Anyway, a class of people became learned in the interpretation of ever more complex codes of laws. These practitioners became practiced in decoding the esoteric language in which the legal codes came to be written.

The Phoenicians were a great seafaring people, who likely sailed across the Atlantic and developed enterprises in South and Central America, in addition to their exploits everywhere else their ships could reach. These incredible people developed law codes to include the commerce they conducted over the waters of the planet. These law codes came to be called, Admiralty Law, (AL).

Admiralty Law makes all human activity a commercial enterprise. Even human beings have commercial value and can be bought and sold. Hence, if the king is to have unwilling people row his boats and be able to appoint a man over them; a captain, who lawfully holds those boat rowers' lives in his hands, the king needs a law, or set of laws written in clever words to make it legal, because, precedent was set with the Code of Hammurabi, remember? The king is not above the law; so the law has to be written making what the king does, legal.

Remember that. **Admiralty Law**. We will talk more about A.L. later on.

The legalized enslavement of human beings caught on in some people's minds and they figured out an even more horrific set of ideas to further the dark agenda.

Somewhere around 540 B.C. or so, the beginnings of an oral, Rabbinical code began to sprout in Babylonia. Some of the ideas were written down in books of laws

collectively called, the **Talmud**. The Talmud became the supreme laws for those people who call themselves, Jews. This code of laws teaches that anyone who is not one of them is 'an animal in human skin.' The Talmud teaches that the Judaist is a superior being and that the children of gentiles are fair play for their sexual perversions. The Talmud also advocates sex with animals. You can check this all out for yourselves on, www.comeandhear.com where the Talmud is revealed in all of its Babylonian glory. More on that later.

Eventually, as time went on, the Romans developed a written history of their legal practice. They were really into the practice of law and record keeping. People came to the Roman courts to listen and learn from able orators who crafted skillful arguments in prosecutions or defense of clients. Some of these 'battles' were preserved and can be read today.

According to Wikipedia, "the term **Roman law** denotes the legal system of ancient Rome, and the legal developments which occurred before the seventh century AD — when the Roman–Byzantine state adopted Greek as the language of government. The development of Roman law comprises more than a thousand years of jurisprudence — from the Twelve Tables (ca. 449 BC) to the *Corpus Juris Civilis* (AD 529–34) ordered by Emperor Justinian I. This Roman law, the Justinian Code, was effective in the Eastern Roman (Byzantine) Empire (330–1453), and also served as a basis for legal practice in continental Europe, as well as in Ethiopia, Japan, and most former colonies of European nations, including Latin America.

Roman Law is not to be confused with Civil law (a legal system), which is descended from Roman law.

At some point in the history of their jurisprudence, the Romans got it into their legal minds to form **corporations**. Being skilled at legal arguments, Roman lawyers concocted the idea that a group of people, or even a single individual could hide behind a legal fiction and do business under that name; devoid of blame if the business goes under, or not. To wit, the present situation regarding massive bailouts for large corporations, whose minions received huge bonuses, while those funding them have been reduced to wage slaves. The international banking corporation is doing exceptionally well in these times of depression; where once again the common people are fleeced like sheep. I will discuss this at more length, later on. Let us continue to look at further developments in your history.

As empires grew and more and more power fell into fewer hands; eventually there came to be emperors who wreaked all manner of harm on scores of people. The god/man idea elevated men to the level of living deities; whose will was to be obeyed, lest one lose one's head. And, as you likely know, many heads have rolled ever since. Even into these, *enlightened* times.

Today we don't literally see heads rolling, but what we do see is the economic murder of many undeserving individuals caught in the many tentacles of the corporations called, the GOVERNMENT OF CANADA, THE UNITED STATES OF AMERICA, the CANADA REVENUE AGENCY, the I.R.S., MONSANTO, etc. More on that later.

You all know something about the Roman Empire because they influenced the beginnings of what eventually helped to establish one of the largest and longest lived empires; The Holy Roman Empire. However, you likely know little about other empires. The Byzantine Empire, for example. You probably know about the Persian Empire and

Egyptian one. It was a big one. Or that of the Chinese or the Mongols? What do you know about the Celts and their migrations? Have you heard about Ostrogoths or Visigoths? What do you know about the Khazars? Likely not too much because their history has been buried. Have you heard about the Ottoman Empire? All of these collections of human strivings figure into a total picture of things as they have evolved into the 21st century. Now we live in very interesting times. The old Chinese philosopher who said that, *interesting times* was a kind of curse, is laughing and said, he saw it coming.

Anyway, back to what is happening in Europe, back in the year 313 an emperor named Constantine declared Christianity to be a religion worthy of toleration by the empire he ruled, that being the Roman empire. By 325 the Council of Nicaea took place and the first Church of the Nativity was established in Jerusalem. Now, lest you think this matters not; let me assure you it also matters a whole lot in understanding how things have evolved into the 21st century and our present situation regarding the Law and Government. In 380, the Emperor Theodosius declared Christianity to be the state religion, 15 years before the Roman empire collapsed.

Christianity became the religion of the Roman empire, which was incorporated as the Holy Roman Empire, where popes ruled over kings and, in some cases, these popes were every bit as ruthless; sometimes more so, as the secular rulers. The Holy Roman Catholic Church was ruthless as they stamped out heresy; **thought crime**. During some of the very darkest ages, horrific public spectacles of diabolical madness were regularly meted out to unbelievers, easily convincing people to accept the teachings of the church.

Indeed, what became **organized**, **corporate religion** plays a major role in how things are today in this *enlightened* century. Every thing beautiful, special, advantageous, life enhancing, even the expression of sincere, heartfelt love, was suppressed for a long time as the Christian Church, which became the Holy Roman Catholic Apostolic Church, took control of people's lives; their hearts and their minds and suppressed a whole lot of knowledge as heresy.

To think that a Roman surgeon's kit of the First Century is almost identical to a modern surgeon's kit, it makes one wonder what medical practice could have evolved to by now. Delicate surgeries were already being performed in the first century. The ancient Egyptians were already performing cataract and successful brain surgeries. If that experience and knowledge had not been suppressed for all those centuries to present day, think of what a world we would be living in today. Human inventiveness is a natural propensity of human beings, unless it is suppressed for a long time and the conditioning becomes a factor of your DNA. It is my contention that there is an ongoing program in public schools to stamp out as much free thought and inventiveness, as possible. Certainly some escape, to a degree, however, if you think about it, a whole lot of you are damaged by your public schooling.

As human cultures advance, once again; the emphasis on those specific conditioned genes, tending people towards sheepification, become de-emphasized and more assertive factors gain precedence. Hence, even though there are still lots of people who subscribe to the Catholic Church, more and more are turning away. The unfortunate thing about it is, they are also turning away from God. They lose sight of the focus; the Center of All Reality. They lose contact with the Source and Center of the Universe of Universes. The First Uncaused Cause Who Set it all in motion. The Alpha and the Omega, The First and the Last, The Beginning and the End. Our Father Who is in Heaven. A personal Deity

with Whom we connect, deep inside our hearts and minds. When you lose connection with your source; you have no real spiritual focus. The Father is the focus point. More about this further on. Just keep reading.

You will read some more about earlier times.

The version of reality taught by Roman Catholic doctrines, did not make for an overly happy existence, much worse in the Dark and Middle Ages, the Renaissance, the Enlightenment period, and pretty much up to our present day. I can remember my catholic girlfriends and how afraid they were of living a full life. They couldn't do this and they couldn't do that. They had to eat fish on Fridays. A whole lot of their lives were directed by church doctrine; the legalese the Church uses to obfuscate and rule over the flock.

The incredible scientific and technical achievements of the Greeks and Romans, their achievements in the Arts and Sciences; all went for naught when the Holy Roman Catholic Church took control over the people. In 380 the Roman Empire became the Holy Roman Empire. God help you if you disagreed. Public piety became a madness which drove many into the flames of hell, most especially during the infamous days of the Spanish Inquisition, which you would expect to have occurred during the so called, Dark Ages, but that is not so. The first Inquisition was created in the Middle Ages in the year 1184 by Pope Lucius III to combat the Albigensian heresy. Thousands of Cathars were horribly murdered because they had a different way of worshipping God, than what the priest culture of the Catholic Church dictated. The Cathars had a more direct experience with the Source. They were peaceful and communal.

The infamous **Spanish Inquisition** evolved during the Renaissance and straight on through the Enlightenment period, the French Revolution, and the tumultuous years of Napoleon all the way to 1834!; less than 200 years ago. Mary Daly, in her amazing book, *Gyn/Ecology, the Meta Ethics of Radical Feminism,* states that between six and nine million women were burned at the stake during that period all over Europe. She places the dates between 1450 and 1750. In those days a man who dispensed herbs and medicines was called an *Apothecary*. If a woman dispensed those healing potions she was called a witch. Medical practice and the Church were in cahoots with each other; both being patriarchal, misogynistic organizations.

Just to refresh your memory. The Spanish Inquisition was an institution the Catholic Church and Spanish Crown evolved in Spain on November 1, 1478. This Diabolical institution was organized to stamp out thought crime, first in Castille, and eventually all over Spain and other Catholic countries. Anyone accused of a number of heresies could be horribly tortured and then burned alive. The torturing was done by monks of the Dominican persuasion. Judging from the records of their endeavors they went to some bizarre lengths to hurt people and extract confessions from them. These twisted Dominican monks enacted every horror you can see depicted in paintings of Hell from that period. It was a time of cutting, hanging, prodding, smashing, tongue extractions, you name it. I can bet you would be hard pressed to come up with some of the Diabolical methods used on living human beings; screaming at the tops of their lungs for mercy.

By the 16th Century protests against Church doctrines began in earnest and many more people were killed. Sometimes hundreds at a time; up in flames! Can you imagine the screaming, as living people were tied to stakes, smeared with fat, and then slowly burned to death. Other people came out in large numbers to watch and hear the spectacle.

People love spectacles. Even today, some of you derive great pleasure from watching people blown to bits in action movies, or burned alive by flame throwers in a second world war epic.

Such a burning death was meted out to the last Grand Master of the Knights Templar; Jacques de Molay, who was slowly roasted to death over a smokeless fire in Paris. It took about two and a half hours on March 18, 1314.

Why was he roasted?

He fell victim to a pope and a king. Burning Jacques de Molay was supposedly the end of the Knights Templar, however, they went underground. You can clearly see their influence in the Cross of St. George which is the English Flag, and the International Red Cross; which has been collecting blood samples for a long time. More on all of that later. Keep reading, it all gets ever more interesting and clear.

The Bible is a big compendium of many writers about various subjects. Some of its information is good, and some of it bad. To say that a book, which appears in many, many translations by many, many different Biblical scholars, is the *absolute* word of God, is philosophically not possible. There are no translations of absolutes. An absolute word is exactly that; absolute. There are no further translations. An absolute word means, 'this is it,' period. Hence, by definition it is not possible for the Bible to be the absolute word of God. Therefore the book is fallible; and it is. You have to understand this and accept it. I am not saying it is all wrong, just parts of it.

Wherever the Bible talks about a hateful, vengeance minded, jealous god; who enjoys the smell of burning flesh and tells the Judaists, 'if you want what belongs to the neighbours, take it. Kill everything that lives there and steal what you want. Then burn the whole thing to the ground. If you want their women, take them. If you want their goats, do what you want. Take it all.' These admonitions are in the Book of Dueteronomy.

What about the part where the Old Testament god demands human sacrifices? You are familiar with that story, I'm sure. If you actually think about that; a god demanding that a father sacrifice his son, you do not get the picture of a benevolent, loving father, but a diabolical monster. When you think about the Old Testament god, you are mostly thinking about the god of the Torah; the first five books of the Bible: Genesis, Exodus, Numbers, Leviticus, and Dueteronomy. The god who is presented there is, Yahweh, who is an ancient thunder god. The image one gets is that Yahweh, the god of the Judaists is a diabolical monster; a god of the underworld.

Yahweh is not the God about whom Jesus said; He is your Father in Heaven. Jesus talked about a loving father; one who forgives, who is kind and gentle. Yahweh is nothing of the kind. It is very important that you think about this and take these words to heart. It is all very important with regard to you and the law, about which we will speak, once you have learned these basics. So read on and learn more about your history.

Jesus also said, in Matthew 23, 'Call no man Master, not even the Messiah,' which, is a very profound statement. The Lord of the Christian Church says there is no one to be called Master, not even Him. In other words, you are not a slave. You are not to think of yourselves as slaves. 'Call no man, Master.' This is a fundamental truth you have to remember if you are to free yourself from the tyranny of the unrighteous.

As various empires grew and waned, an assortment of organized religions evolved alongside Christianity; Buddhism, Hinduism, Judaism, Islamism, Shintoism, and all the other, isms, such as, Behaviorism to Voyeurism. All isms are fabrications of human minds and attempts to make minions; to make members of a herd, willing to give up their souls to belong; either under duress or religious fervor, or some other enticement. Even belief in the rights of government over the individual, is a religion; a way of life believing in the almighty state. Communism is a religion which reveres Lenin and Marx. In Communism, all ownership is placed in the lap of the state and the people are cogs in a machine; only useful so long as they remain functioning cogs. Early retirement to the grave is common under Communism.

The Kingdom of Khazaria existed in the far east of Europe from 652 until 1016. Have you ever heard about Khazaria? Likely not. It is surprising because at one time, it was a major player in Europe. The area, at its maximum extent, included the geographic regions of southern Russia, northern Caucasus, eastern Ukraine, Crimea, western Kazakhstan, and northwestern Uzbekistan. This was a substantial area. The people of that region were forcibly converted to Talmudic Judaism in 740 A.D. These people became the Azkenazi Jews of Eastern Europe and became the 13th Tribe of Israel. These people are the ancestors of more than 95% of people who call themselves, Jews, or Judaists today. Read Arthur Koestler, *The Thirteenth Tribe* for more information about these remarkable people who figure so prominently in the world today.

Just as **there are actually 13 signs of the zodiac**, there are actually thirteen tribes of Israel which make up the Jewish people. And, just as that bit of historic information is suppressed, so is knowledge of Ophiuchus, also known as, Serpentarius, *the serpent holder*. The sun passes through this constellation for 19 days, from November 30 to December 17th. This serpent holder is known for healing powers. Note the presence of the serpentine in much of human thought. The modern medical practitioners have a symbol of two serpents coiled around a staff. Reptilian imagery is everywhere; gargoyles for eg.

Now, you are probably wondering what has Khazaria and the Azkenazi Jews have anything to do with any of this. During the times of the Kingdom of Khazaria, the king demanded such a level of respect, that when the emperors of the Roman Empire exchanged correspondence with the king of Khazaria, three gold seals were affixed to the document. Normally there were only two golden seals when correspondence travelled between emperors, from Ravenna to Constantinople. The Khazars were known for military prowess and a kick ass attitude.

As Christianity and Judaism evolved, eventually the idea of monasteries and convents developed amongst the Christians. All kinds of weirdness evolved, as well. Just as amongst the Hindus there are people who are fakirs; they sit on nails, or stand on one leg for thirty years, that sort of thing, in the Christian world, people started sitting alone in a cave for years on end, or on top of a pole, or whacked at each other with barbed whips and so on. People saw all kinds of evil and macabre things during those dark times. Why did such strange behaviors accrue during those times? I believe it is highly likely that people were salt deprived as well as eating ergot infested bread and porridge.

Ergot is a fungus which grows on rye and wheat. It is the fungus which contains lysergic acid diethylamide, LSD. Ergot was common in those dark times, when people were regularly broken on wheels, or nailed to crosses and left to writhe in agony.

Due to rising levels of sea water, salt farms on the coasts of Europe and the Mediterranean area were destroyed because the water travelled inland for a long distance in the low lying areas where the salt farms were located. During one such time; the high Middle Ages, salt became a rare commodity for about 500 years.

When a human being is salt deprived, which many of you are today, the body does not function at peak efficiency and robust health. In fact, salt deprivation can lead to madness. There is evidence that during those dark times, homicide was common and the drinking of the victim's blood a necessity for life, in order to get precious salt.

Natural, full spectrum sea salt contains 92 important micro nutrients; minerals which help to fine tune the brine which comprises our blood. Celtic and Himalayan sea salts are available and should be taken regularly. The white table salt most of you use only contains iodine. The rest is basically useless and some of it poisonous. The body can't use it.

The **iodine** was added to table salt in the Cold War era, when everyone was afraid atomic bombs were going to be dropped in greater numbers than merely insane test explosions in beautiful atolls, under and above ground by *benevolent*, *well meaning* governments.

Even those atomic bomb experiments, no matter how well controlled, poisoned the planet, not only the diabolical explosions over Hiroshima and Nagasaki. All of those dangerous tests and those evil acts in Japan put a lot of radioactive iodine into the atmosphere, When the pituitary gland, at the center of your brain is iodine deprived it grabs the radioactive iodine out of the atmosphere. Since the pituitary gland is the master gland, I am confident you can see the problem that would accrue if it is deprived of its most important nutrient. More people would die of brain cancer.

Today the entire world has become radioactive. The use of depleted uranium in Afghanistan, Bosnia, Gaza, Iraq, Lebanon, Libya, and Palestine plus the Chernobyl and Fukushima disasters has resulted in the total irradiation of the planet. Whoever gave those people the right to monkey with radioactive atoms, should be seen as traitors to the human race. It is just another one of those things which governments do in your name. However, I digress and will return to the history of salt deprivation in the Dark Ages.

When you add to salt deprivation, the eating of ergot, one is firstly devoid of important micro nutrients which can lead to madness and decrepitude, while also experiencing hallucinations. The eating of hallucination inducing, L.S.D. and the madness from a lack of salt produced some very unusual visions. Take a look at the Heaven and Hell painting by Heronimous Bosch, for example and you will clearly see what I mean. It makes sense that people were having all kinds of visions as they saw inside their genetic memories and other energy vibrations in the electromagnetic environment that is planet Earth. No wonder that things went weird in the Dark Ages. No wonder there were wizards and elves, pixies and leprechauns wandering about in the world. The things people saw in those days were of heaven and hell. They either saw rapturous visions of glory, or they saw people gloriously martyred for their faith, or heretical viewpoints, with axes, fire, saws, spears, or swords. Vampires could get you and suck your blood for real.

Because the Bible plays such an important role in what we are talking about, it is important we look at it a little more closely. The Bible presents two visions of God. In the Old Testament, especially in the Torah, the Books of Moses; Genesis, Exodus, Numbers,

Dueteronomy, and Leviticus, you read about a wrathful, vengeful, diabolical god who should be feared. In Dueteronomy you read about a god who tells a tribe of people in the Middle East that if they covet what a neighbour has, then for them to go take what they want, to kill everything that lives there, and then burn the entire thing to the ground. This god is called, Yahweh, the Thunder God. He is a god who condones horrific violence and oversees bloody sacrifices. That is the god of the Old Testament.

The New Testament tells of Jesus, Who came into the world to present a much better picture of He Whom we call, God. Jesus brought a vision of love, mercy, and generosity. A vision of God as a loving Father.

The New Testament presents Jesus acting the ideal of altruism. How one can lay down one's life for one's friends. How it is a good thing, to share and be kind to each other. How God is Our Father, the loving ideal we treasure in our hearts and minds. The very center of our being and creator of our miraculous reality. Jesus admonished us to, 'Do unto others as you would have others do unto you.' That is positive altruism. You do it because it feels good to do so. In law this commandment is written in the negative. 'Do not do unto others as you would not have others do to you.' That is simple enough, do you not think so? So, do you suppose the owners and agents of REVENUE CANADA would like to be fleeced as they are fleecing the rest of you?

The Bible also presents a simple set of rules; which we can all memorize very easily. These rules are the **TEN COMMANDMENTS** also known as the Mosaic Law.

The first commandment is: **no other God**. One God only, Whom Jesus called, The Father in Heaven, and Whom He portrayed as a loving father who knows us and loves us unconditionally. Not a vengeful or merciless god, but a loving Father. Remember that always.

For whom so ever sincerely repents their sins is forgiven, for the Father transcends the Judge. Given that in a cause and effect universe which is and has been forever; there has to be a First Uncaused Cause for the effect, which is the universe, to be. The First Uncaused Cause of All Reality is a personal deity Who is Our Father in Heaven. He is the core of your being at the very center of all things. This idea keeps one focused and seeing more clearly into the dark glass than further obfuscating things by introducing more gods. Hence, ONE GOD ONLY.

The second commandment has to do with the making of **craven images**. No golden calves, holy rocks, holy statues, relics, to which we can add, no *celebrity worship*. The second commandment is about directing attention to what is truly holy. Love, Peace, and Mercy, those are holy concepts. Be not a worshiper of things and persons. It is not about things and elevated people. Yes, of course you want to appreciate the magnificent work of your artists; the composers, the writers of the plays; the great books and movies. Of course you want to enjoy and celebrate the achievements of people. However, remember, all things will come to pass, with time. Enjoy the miracle you are and how incredible it is that a tiny seed will grow a Douglas Fir or a California Redwood tree. Look out at the stars and study the universe you live in. You will find the miracles you are looking for and the holy things you seek. Everything is designed. Nothing is that has not been thought. The idea precedes the action which results in a thing. Ideas occur in your mind. The first idea occurred to the First Mind.

The third commandment regards using God's name in vain. Swearing and cussing using holy names is not healthy for you from a spiritual and psychological point of view. It is important for harmonic being, that one should keep holy that which is holy. One should never defame one's Father, or Mother. Certainly one should not use the name of your Creator in a derogatory fashion. By defaming the Father you defame yourself. It is very simple, really. As for using the name of our dear elder brother and sovereign, Jesus in vain, well, that is certainly not such a good thing either, psychologically and spiritually because He did you no wrong. He went about doing good works for people and spread a positive word about Our Father in Heaven being a God of Love. Why would anyone want to defame such an exemplary being?

The fourth commandment is about keeping a holy day. Traditionally it has been Sunday in Christian countries. The day of the Sun, the Son, the Day of Reflection and Rest. It is important that you have a day where you can be with your families, your thoughts, your hobbies, and reflect upon the holiness of life and how precious your moments are. The holy day extends into holidays; of which you all should have an abundance. However, the abundance is denied to you by they who control your purse. Holy day and holidays. Keep a day holy and think upon how you, a child of God, can be in such dire straits with the governments and their nefarious webs of laws in which they ensnare you and your family and friends. **Remember, Sunday**. Perhaps you should return to keeping one day per week as a holy day. Nothing is open one day per week. Everyone is home, or at the park, or whatever, on that day. Keeping Sunday holy will give everyone a break one day per week. You would all save on a lot of gasoline money, that's for certain.

Commandment number five is to **respect your father and mother**. Of course you should. They gave you life and an opportunity to experience life on Earth. Respect is not love. Respect is being thankful they are in your life. Remembering that your life is a miracle, and life is an interesting experience, respect those who brought you into the world. Remember that your mother went to great pains to birth you. Life does not come easily into this world. For those who toiled to bring you here, your father and your mother, respect them and listen to their words. Treat them with kindness and you will feel a whole lot of good. If you also love your parents, then everything is great! I love my parents. If it was not for them, I would not be here. I am happy to be here. Hence, respecting my mom and dad comes easy and we all feel good about that. The more good we feel, the better everything is.

Number six is about **not killing**. Of course we must not kill each other. That is not a good way to solve problems. It makes for very bad Karma. Killing living beings, especially sentient ones, sends a very negative energy into the electromagnetic pool and brings everyone down. So, what do you do with those who kill? That is a touchy question is it not? What indeed does one do with the likes of Joseph Stalin, or Mao Zedong? Or Ted Bundy and Clifford Olson? It is a question which must find an answer.

Commandment number seven is about **adultery and how one should not do that**. Messing around creates all kinds of problems. You know all about that. Many of you have gone through some kind of romance trauma. When one is in a committed relationship, that is what commitment means; to be loyal and sexually faithful. If you don't like living with your husband or wife, then first divorce and then go with an other. When one is married, that means, monogamously. And, of course, when you think about it, monogamy makes the best sense in these STD times, most especially.

The eighth commandment is **to not steal**. Stealing is not a good thing to do. People have acquired things through the sweat of their brows. Instead of stealing, make work for yourself. Yes, of course it is easy to say that. In these days of economic depression, jobs are just not out there for some of you. However, you will begin to see why some of your financial burdens are not of your making and result from legalized theft of your income. You are admonished not to steal, yet the GOVERNMENT OF CANADA and CANADA REVENUE AGENCY steal you blind every day and most especially in April.

The ninth commandment is about bearing false witness. You should **never bear false witness** against anyone because it is lying and lying is a terrible behaviour which tends to bite you in the butt eventually. Bearing false witness against your neighbour can cost your neighbour his life. In Roman times, someone who bore false witness and was found out suffered a terrible fate, even unto death in some cases. If you bear false witness in a court of law, perjury being the charge, can actually land you in serious consequences. Therefore, it is best to always tell the truth. Lying is just a bad idea and does nobody any good.

And, last of all, the tenth commandment. This one is **about fundamental property rights**. You must not be envious of your neighbour's property; not his house, not his wife, or anything which belongs to your neighbour. Leave his stuff and family alone. Don't touch them. Don't be jealous of them. Your neighbours are your allies, not your enemies. If you covet what is theirs it will only make you unhappy and put up a barrier to good relations. Living in harmony is far better for your electrochemical balance. In the case of REVENUE CANADA, it covets everything you own. How do you feel about that now?

The Ten Commandments were written a long time ago. They still make great sense today. It is **a simple law**, not something complicated. There is not much need for lawyers with such a simple set of laws. By the way, did you know that lawyers call you an *imbecile* when they refer to you as a, *client*. You give up all your rights to your lawyer; who is very skilled at emptying your bank account.

A lawyer's first allegiance is to the court, not you, the client; the imbecile who is paying through the nose for the privilege of appearances in court. By the way, you know that a judge sits on the *bench*. Do you realize that *bench* is Latin for, *bank*. What is the first thing you see when you enter a court of law? Cash registers! Anyway, I digressed and wish to return your attention to developments in Europe in earlier times. Remember, it is important to know some history, at least. The more you know, the better is the foundation upon which you build your new castle.

In the 12th century; during a period historians have called the **Middle Ages** men and women, who did not want to live in the tumultuous and insecure real world escaped into monasteries and convents. Some were brought there against their will. The monastic life is not for everybody. Some people went quite nuts there. Monastic orders eventually proliferated in Europe. Each of them imposing some sort of torment on the man or woman who enrolled or was forced to enroll in a life of poverty, hard work, and in some cases, horrendous punishments for straying from the narrow path.

The 12th century was also a time when the Christian world was ticked off with the Turks for taking Jerusalem, the home of the Church of the Holy Sepulchre.

During the 12th century very large monastic orders had developed; some of these were militant, warrior monks. The militancy became a necessity against the evils of the world, *outside* One of these militant monastic orders were the Poor Knights of the Temple of Solomon; founded by Hugh de Payens and friends sometime between 1118 and 1120 and taken under the protection of King Baldwin II of Jerusalem. Remember, I mentioned the Knights Templar earlier. They show up regularly in this story.

In the year 1215 Knights of the Temple in England were instrumental in the development and adoption of another major achievement in what became Anglo-Saxon Common Law, namely the Great Charter known as the Magna Charta, also known as **Magna Carta**. This important document was signed at Runnymede on June 15th. The King of England pledged allegiance to the Great Charter, '...by our heirs in perpetuity.'.. and later on, '...our heirs for ever, all the liberties written out below, to have and to keep for them and their heirs, of us and our heirs:'

In other words, the Magna Carta is to be obeyed by all kings and queens of England henceforth. The Magna Carta became a major achievement in establishing fundamental human rights. In this document, articles 38 and 39 read as follows:

- 38. In future no official shall place a man on trial upon his own unsupported statement, without producing credible witnesses to the truth of it.
- 39. No free man shall be seized or imprisoned, or stripped of his rights or possessions, or outlawed or exiled, or deprived of his standing in any other way, nor will we proceed with force against him, or send others to do so, except by the lawful judgment of his equals or by the law of the land.

These fundamental human rights were the law of the land in England until King James the First invoked the concept of a divinely appointed king who could mete out justice at his whim. According to James, he was God's direct contact on earth. He commissioned many scholars to interpret ancient documents written in, Aramaic, Greek, Latin, and other more obscure languages. Those documents were thousands of years old and contained snippets of information passed on in myths and stories; tales of heroes and heroines, bad guys and good ones. And, of course, the information about Jesus, and the teaching of the Apostle Paul. All of these ancient documents were translated by the commissioned scholars to come up with the King James Bible. The King James version of the venerable old papers is only one of many bibles. A lot of battles have been fought over interpretations of the book. Many millions of people have been killed through the ages because of the interpretations. If the Bible was the Absolute Word of God, there would be no interpretations and no misunderstanding about meanings.

One group, which did a fair amount of killing were the Knights Templar, as **the Poor Knights of the Temple of Solomon** came to be called. They did the killing in the Name of God. Their mandate was to protect pilgrims coming to the Holy Land. Of course this was not done for free. The Templars made a lot of money off the pilgrim trade. Many pilgrims were people of substantial means. It was not cheap or easy to go on a pilgrimage to the Holy Land.

The Templars enjoyed the hospitality of the King of Jerusalem and were allowed to do extensive excavations of the temple mount there. The knights were obsessed with the temple. So are the Freemasons and the Jews, today. There is something about that

Temple Mount which still stirs people to obsession and wonder. Jerusalem is a very important place.

The Knights Templar also became a huge banking enterprise; the largest in Europe in the Middle Ages. They actually enabled clients to write cheques or carry paper bank notes which could be carried from place to place much easier than piles of gold and silver. Of course, if these paper note carriers were killed, not all of the gold and silver was returned to the estate of the deceased.

Eventually **the Knights Templar became exceedingly rich**. They became so rich that kings and popes cast covetous eyes in their direction. On Friday the 13th of October in 1307, King Phillip IV of France, who was deeply in debt to the Templars, attempted to round them all up and charged them with heresy. Ever since, Friday the 13th has been considered an unlucky day. Hundreds of knights were horribly tortured to confess to crimes of heresy. It was said they worshipped a severed head and called it Baphomet.

Not all of the knights were captured. Some of the knights had been tipped off because the treasure fleet escaped to Scotland two days before that fateful Friday. The poor Templars, who lived, went underground and morphed into the global fraternal organization now known as the Freemasons. Hence their obsession with the Temple of Solomon, as well.

It is believed there may be a possibility that some of the Templar treasure ended up in Nova Scotia, but that is another story. Where the treasure is, exactly; only a few know and likely have had access to it for a long time. Gold and silver have held their value through the ages.

For example, in the Middle Ages an ounce of gold could buy you a suit of nice clothes. Today, for an ounce of gold you can still buy a nice suit of clothes. Consider that in relation to what we are forced to use; pieces of paper and coins made of base metals, gold holds value. Compare a fifty dollar piece of gold from 1900 or a crumpled, torn old fifty dollar bill; the gold is worth over a thousand dollars but the piece of paper is worthless. The same goes for silver and base metal coins. Silver is actually worth something. Gold and silver are money. Paper is worthless. The Knights Templar were some of the first bankers to use paper money. Masons are heavily involved in banking today, and many other influential organizations.

As are the **Rothchilds**, about whom a great deal has been written. These Ashkenazi Jews have been involved in banking since the eighteenth century. Meyer Amschel Bauer Rothchild, a founding member of the Illuminati; an organization which figures heavily in all of what we are talking about, said, in about 1776, 'Give me control over a people's money, I care not their government, I will control those people.' Rothchilds own just about every central bank in the world. They control the World Bank and the International Monetary Fund. They and their minions control a good part of the world today. Banks control governments and most corporations. Banks fund it all with make believe money and live high off your backs. After all, you are just animals in human skin, as far as they are concerned. Hence, just like sheep, you are shorn.

More on all of that will come later, let us return for another moment to the times of King James the First of England. He was the sixth King James of Scotland before becoming King of England. Anyway, he tried to do away with the Magna Carta. Therefore,

two other important acts were forced on the Crown. **Habeas Corpus Act of 1640** and a second Habeas Corpus Act of 1679. These Acts make it illegal to imprison people for administrative convenience. A person being detained must have access to the court in order for a judge to determine whether the detention is lawful. Habeas means to hand over. Corpus means the body.

In 1677 another important piece of the Common Law was enacted. It was called the **Statue of Frauds Act**. This marvelous piece of legislation establishes what constitutes a legal contract. This is very important because in most justice systems there are two types of court, Civil and Criminal. Civil courts have everything to do with contracts. Contracts are agreements between human beings, either oral or written. Written is the best type of contract. All parties subject to the contract must affix their signature. The summation of a lot of legal jargon, regarding contracts, is that the contract must be entered into with benefit to all parties. The contract must be entered into under considerations; which include such terms as: (The following comes directly out of the FreeDictionary.com.). As you read the words think about REVENUE CANADA and its relationship with you. Then ask yourself, since the CANADA REVENUE AGENCY is a corporation; therefore a person in law, where is the contract between you and them?

consideration n. 1) payment or money. 2) a vital element in the law of contracts, consideration is a benefit which must be bargained for between the parties, and is the essential reason for a party entering into a contract. Consideration must be of value (at least to the parties), and is exchanged for the performance or promise of performance by the other party (such performance itself is consideration). In a contract, one consideration (thing given) is exchanged for another consideration. Not doing an act (forbearance) can be consideration, such as "I will pay you \$1,000 not to build a road next to my fence." Sometimes consideration is "nominal," meaning it is stated for form only, such as "\$10 as consideration for conveyance of title," which is used to hide the true amount being paid. Contracts may become unenforceable or rescindable (undone by rescission) for "failure of consideration" when the intended consideration is found to be worth less than expected, is damaged or destroyed, or performance is not made properly (as when the mechanic does not make the car run properly). Acts which are illegal or so immoral that they are against established public policy cannot serve as consideration for enforceable contracts. Examples: prostitution. gambling where outlawed, hiring someone to break a skater's knee or inducing someone to breach an agreement (talk someone into backing out of a promise.)

Something of value given by both parties to a contract that induces them to enter into the agreement to exchange mutual performances.

Consideration is an essential element for the formation of a contract. It may consist of a promise to perform a desired act or a promise to refrain from doing an act that one is legally entitled to do. In a bilateral contract—an agreement by which both parties exchange mutual promises—each promise is regarded as sufficient consideration for the other. In a unilateral contract, an agreement by which one party makes a promise in exchange for the other's performance, the performance is

consideration for the promise, while the promise is consideration for the performance.

Consideration must have a value that can be objectively determined. A promise, for example, to make a gift or a promise of love or affection is not enforceable because of the subjective nature of the promise.

Traditionally, courts have distinguished between unilateral and bilateral contracts by determining whether one or both parties provided consideration and at what point they provided the consideration. Bilateral contracts were said to bind both parties the minute the parties exchanged promises, as each promise was deemed sufficient consideration in itself. Unilateral contracts were said to bind only the promisor and did not bind the promisee unless the promisee accepted by performing the obligations specified in the promisor's offer. Until the promisee performed, he or she had provided no consideration under the law.

For example, if someone offered to drive you to work on Mondays and Tuesdays in exchange for your promise to return the favor on Wednesdays and Thursdays, a Bilateral Contract would be formed binding both of you once you provided consideration by accepting those terms. But if that same person offered to pay you \$10 each day you drove him to work, a unilateral contract would be formed, binding only upon the promisor until you provided consideration by driving him to work on a particular day.

Modern courts have de-emphasized the distinction between unilateral and bilateral contracts. These courts have found that an offer may be accepted either by a promise to perform or by actual performance. An increasing number of courts have concluded that the traditional distinction between unilateral and bilateral contracts fails to significantly advance legal analysis in a growing number of cases where performance is provided over an extended period of time.

Suppose you promise to pay someone \$500.00 to paint your house. The promise sounds like an offer to enter a unilateral contract that binds only you until the promisee accepts by painting your house. But what constitutes lawful *performance* under these circumstances? The act of beginning to paint your house or completely finishing the job to your satisfaction?

Most courts would rule that the act of beginning performance under these circumstances converts a unilateral contract into a bilateral contract, requiring both parties to fulfill the obligations contemplated by the contract. However, other courts would analyze the facts of each case so as not to frustrate the reasonable expectations of the parties. In neither of these cases are the legal rights of the parties ultimately determined by courts by applying the concepts of *unilateral* and *bilateral* contracts.

In still other jurisdictions, courts have simply expressed a preference for interpreting contracts as creating bilateral obligations in all cases where no clear evidence suggests that a unilateral contract was intended. The rule has been stated that in case of doubt an offer will be presumed to invite the formation of a bilateral contract by a promise to perform what the offer requests, rather than the formation of a unilateral contract commencing at the time of actual performance. The bottom line across most jurisdictions is that as courts have been confronted by a growing variety of fact patterns involving complicated contract disputes, courts have turned away from rigidly applying the concepts of unilateral and bilateral contracts and moved towards a more ad hoc approach.

In all contracts, whether nominate or innominate, there is implied an exchange. L'obligation sans cause, ou sur une fausse cause, ou sur cause illicite, ne peut avoir aucun effet. An obligation without consideration, or with a false one, or with an unlawful one, cannot have any effect. Nuda pactio obligationem non parit. A naked promise does not create a binding obligation. Nudum pactum est ubi nulla subest causa praeter conventionem; sed ubi subest causa, fit obligatio, et parit actionem. A naked contract is where there is no consideration for the undertaking or agreement; but where there is a consideration, an obligation is created, and an action arises. Two other foreign legal phrases, and very important as you can well understand when you read them, follow below. The phrases are kind of buried. However, in order to show proof, I have taken a snippet from records of the Supreme Court of the United States. The phrases are in Latin, as most legal phrases are.

Actus legis nemine facit injuriam; no act of law can harm a man.

I say there is not one word to that effect, and twere most atrange if there were; for I ask again, if the Act of 1839 be not made for that very case, for what case was it made? or what is it good for?

The result of the whole now is exactly to the consequentially and by contract parties to it; a multo fortiori where they are only so consequentially and by contract parties to it.

NO ACT OF LAW CAN HARM A MAN.

Always remember that.

Legis constructio non facit injuriam.

The construction of law does no wrong.

Following is the Common Law, essentially in a nutshell:

- 1. **The Golden Rule**, Do unto others as you would have others do unto you. Also written as: Do not do unto others as you would not have others do unto you.
- 2. **The Ten Commandments**. One God, No Idols, No Blasphemy, Keep Sunday holy, Honour your mom and dad. No killing. No adultery. No stealing. No bearing false witness. And no coveting of your neighbour's stuff.
- 3. **The Book of Matthew 23** in the New Testament of the Christian Bible. Verses 8-10. Call no man Master and no man Father.
- 4 **The Magna Charta**, especially clauses; 38 and 39. Remember, the King of England signed the Magna Charta in perpetuity; meaning all kings and queens of England henceforth.
- 38. In future no official shall place a man on trial upon his own unsupported statement, without producing credible witnesses to the truth of it.
- 39. No free man shall be seized or imprisoned, or stripped of his rights or possessions, or outlawed or exiled, or deprived of his standing in any other way, nor will we proceed with force against him, or send others to do so, except by the lawful judgment of his equals or by the law of the land.

- 5. **The two Habeas Corpus Acts** of 1640 and 1679. You can not be locked away without access to a public court and an impartial judge to see into the legality of matters pertaining to your arrest. Hence, you can not be disappeared by the government.
- 6. **The Statute of Frauds Act** of 1677. Basically, a contract is an amiable agreement from which both parties benefit. Coercion, intimidation, threats, forcing a contract on somebody and they enter into it under duress, does not describe what contracts are about. Contracts are mutually beneficial, period.

Those six wonderful sets of words basically form the foundation of the Law of the Land. It is a fair set of laws which make for orderly, civilized society. A society where acts of law do not hurt people. They are not fleeced and torn from their property by ruthless agents representing the Crown and the Bank. Remember, the word bench; on which a judge sits in court; albeit not really a bench, but figuratively; that word is Latin for bank. Hence, the Court of Queen's Bench is interpreted as, The Court of Queen's Bank. Cash registers are very present in modern law courts. You can even use your Visa or Mastercard for some transactions. You can negotiate your way to lesser consequences or even buy your way out of a murder charge, if you are rich enough or some sort of politician.

Anyway, you can see that **the Common Law is pretty easy to understand**. It is based on precedence. Decisions of courts; they being the Crown's courts, are to be based on earlier rulings. The list of six earlier rulings are the precedents. There is not a lot to it. They, who control the legal industry try to make it appear that the law is very complex. They feed on that. But, when you think the preceding through, what more do you need for a code which forms the foundation of a civilized society?

We do need courts. However, I am sure we can all agree, modern courts are not about justice in a lot of cases. People who are very dangerous to the well being of others; psychopaths and sociopaths, those sorts of people need to be put away for the safety of the community. There are times when such creatures are released, contrary to the common weal.

In my opinion, the community affected by the miscreant should determine what happens to such a monster. Knowing something about the mind control business, I think it is possible their minds can be reprogrammed. Anthony Burgess showed us an interesting take on that with his story, *A Clockwork Orange*. Stanley Kubrick made it into a movie. Check it out. The story poses some interesting questions.

In Criminal Court, claims are made before a judge against someone who has done any or all of the following:

- 1. Murdered someone.
- 2. Stolen someone's stuff.
- 3. Raped someone.
- 4. Assaulted someone.
- 5. Defrauded someone. (This could be either a civil or a criminal case. Fraud usually involves contracts of some sort. However, according to precedents which have been set and you are likely aware of; if the fraud involves a lot of

people; in an investment scheme, for example, and millions of dollars are at stake; the fraud will likely be exposed in a criminal court.)

A sixth criminal claim has been added, due to *human rights* legislation; that being:

6. Anti-Semitism; the expression of a negative opinion of Israel and the Jewish Question. Public expressions of concern regarding Islamic or other religious practices. In otherwords, free speech no longer exists in Canada so be careful what you say, where you say it, and to whom.

There has to be a victim to make the claim. In the case of number six truth is a pendulum; it swings back and forth in favour of the offended, if s/he is Jewish and otherwise for the rest of us. (cf: Noahide Law). Sometimes they are caught and properly dealt with but that is rare since so many of their creed slither about in the law industry.

In the case of deceased persons, the claim is made on their behalf by the Crown or members of the family. Even so, it is basically pretty simple. Like Civil Law, courts do look at precedence for their rulings. However, the court does have parameters within which it makes decisions. Other times we see this court ruling one way, while another rules diametrically opposite; and a criminal minded danger to the community steps off the next bus into your neighbourhood. The law must be consistently applied.

At this point let me sum up a few ideas before we go on to more interesting history to throw more light into the darkness which permeates our present day current events.

There is **Common Law** and **Admiralty Law**. There are basically two types of courts, civil and criminal. Civil courts have to do with contracts and criminal courts have to do with claims.

When a judge makes a ruling at the end of a trial, he or she issues an *opinion*. When the defendant asks the judge, "Is that your opinion, Judge?" The judge will have to answer, "Yes, that is the opinion of this court." When the defendant then says, "I do not accept your opinion," there is nothing further the court can do and the defendant walks out of court.

At this point the court is hamstrung because you did not accept the opinion. You disagreed with the opinion. You are entitled to your opinion and so is the court.

You see, **all court rulings are public opinions**. You have to agree to the opinion. If you do not agree; so be it. If they coerce you, intimidate you, or threaten you, and you find yourself complying with the court's demand, make certain to have it put on the record that you entered into the agreement under, *duress*.

Now that we've spent some time in legal land, let's go back to some important history and see how nefarious schemes and world events line up.

You remember what happened to the Templars and how they morphed into Free Masons? Have you ever taken a look in books about Freemasonry? There are some revealing photos in various books on the Masons. *The Hiram Key* by Knight and Lomas is readily available. Note the photo on page 177 of the softcover edition. It tells you quite a lot about what the masons are into. It is a pretty dark looking ritual; very similar to a ritual

practiced by the **Skull and Bones Society at Yale University**. In the photo noted above, you will clearly see the symbolic pillars of the Temple of Solomon. The pillars have names; Boaz and Jeroboam.

Anyway, in the mid 18th century some ideas began brewing in a German Jewish mind, some ideas which eventually led to the founding of a pseudo secret organization called, **the** *Illuminati*; the Illuminated Ones. Adam Weishaupt, an economics professor, whose ideas about a Bavarian Illuminati, were supported by the Rothchilds was instructed by them to form such an organization as early as 1770. The actual date of the Illuminati's inception was May 1, 1776.

Meyer Amschel Bauer Rothchild was one of the founding members of the new secret society. The goal of the illuminated ones was to begin a very organized takeover of the world. The best way to achieve the agenda was to take control of: world banking, armament sales, all media, governments, education systems, medicine, pharmaceuticals, the Freemasons, and so on. Remember the quote attributed to Mister Rothchild; "Give me control over a people's money, I care not their government, I will control those people." Bear with me and I will tell you a further story about the Illuminati and the shenanigans of the Rothchilds and how this all affects you today in the 21st Century.

In the same year that Freemason **George Washington** became the first president of the United States of America, the Illuminati had managed to ignite a flame which resulted in a whole lot of horrific public decapitations; the French Revolution, is what David Icke called an, 'Illuminati coup d'etat.' In the so called histories of the period, the real story is not told. Since the Illuminati controls publishing, the true story is not available. You are fed, *Les Miserables*, for example. This story is not a true look at the French Revolution.

In France, at that time, the people were some of the luckiest people in Europe. People from other countries wished they were French. The highest minimum wages were paid in France. The peasants owned most of the land, and the Crown was implementing all kinds of positive reforms. **France was on the way to becoming a Christian paradise**.

A thousand mercenaries were hired and imported from Germany, Italy, and the south of France. They were set up to storm the Bastille, an ancient fortress in Paris, used for an arsenal and prison. When the thousand mercenaries stormed the place, there were not lots and lots of guards to stop them. Sure, it was an armory and a prison, but France was at peace, Paris was not plagued with scores of terrorists, and besides, there were only seven prisoners. Four were counterfeiters, two were lunatics, and one was a minor nobleman, who was incarcerated by his family to teach him a lesson.

So, you can see, the storming of the Bastille had nothing to do with releasing hundreds of Miserables, but had everything to do with weapons. The mercenaries were sent to the Bastille to capture the arsenal with which to further the Illuminati's revolutionary plans. Of course, nobody was wise to the Illuminati's involvement behind the scenes. They, just like the Israeli Intelligence service, Mossad, make their war through deception.

After the Revolution was over, and the flower of the French intelligentsia was murdered and ancient blood lines were exterminated, a new Illuminati creature reared its head; Napoleon Bonaparte. More people were killed and more arms were sold to the combatants. The Illuminati bankers became richer. The Rothchilds, who already had a significant presence in Europe, wielded a lot of power and were very clever. They lent

money to all sides. The cause of the conflict, or how many thousands of innocents and combatants bleed into the ground, is of no consequence to the bankers. They get rich, no matter what.

Meyer Amschel had five sons who were brought up in the banking industry. When the sons were of age, Rothchild sent them to the five banking capitals of the world. Nathan was sent to London. He was a significant presence at the stock exchange there. People tended to follow his advice. Unbeknownst to anyone, Nathan had the foresight to install an agent with passenger pigeons at the Battle of Waterloo, on June 18th, 1815. Hence, Nathan knew at least 24 hours before anyone else that Napoleon had been defeated by the English and Prussians. Next morning, June 19th, Nathan walked into the London Stock Exchange and sold off all of his government bonds. This sent a signal to other traders and caused a stampede as everyone followed Nathan's lead. When the price of government bonds was nearly at zero, Nathan bought up the national debt of Great Britain. That truly launched the Rothchilds into the realm of emperors of the world because Great Britain controlled a lot of territory at the time. Those were the times of the British Empire, remember, and the sun never set on that empire, it was that large.

Through the 19th Century, the Illuminati involved themselves in all manner of schemes to further the agenda of world control. All kinds of conflicts and wars were stirred up by their agents provocateur. The bankers made a lot money from arms sales, as governments borrowed from the Rothchild banks to fund their war efforts. Propaganda, through the Illuminati owned media, helped stir the pot; just as today. Our disingenuous press doles out misinformation daily and gets people worked up over all kinds of things. "All the news you need to know." That is what passes for information. What is really going on, of any importance, is not reported.

For example, what do you know about a patented cure for cancer registered with the U.S. Patent Office in the early 1930s. The technology was successfully employed in clinics in the United States between 1934 and 1938. **Morris Fishbein**, the head of the American Medical Association had the technology suppressed. and the inventor's name, Royal Raymond Rife, stricken from the record; just like in times of old, when public records of unpopular dead leaders, were erased. This happened lots of times in the history of Egypt, for example. Fishbein was very likely an Illuminati agent because the Illuminati would lose money if people were made whole. They would be deprived of pharmaceutical sales. They rake in billions from cancer research and treatment; **the cancer industry.**

Anyway, let us move on and take a look at another amazing event in the history of world banking, your government, the law, CANADA REVENUE AGENCY, and how you are being economically murdered.

Almost a hundred years after Nathan Rothchild essentially stole the national debt of Great Britain, seven agents of the Rothchilds and the Illuminati; met together in secret on Jekyll Island, off the coast of Georgia. The seven men who met in one of the stately 'cottages' represented a quarter of the world's wealth in 1910. The following information is copied verbatim from **G. Edward Griffin's amazing book**, *The Creature From Jekyll Island*. On page 5 he lists who these conspirators were:

1. Nelson W. Aldrich, Republican whip in the Senate, Chairman of the National Monetary Commission, business associate of J.P. Morgan and father in law of John D. Rockefeller Jr., who was often heard to say, "to compete is a sin.' By this time corporations

such as international banking were already so huge, they became friends. Directors sat on each other's boards.

- 2. Abraham Piatt Andrew, Assistant Secretary of the U.S. Treasury.
- 3. Frank A. Vanderlip, president of the National City Bank of New York, the most powerful of the banks at that time, representing William Rockefeller and the international investment banking house of Kuhn, Loeb & Company.
 - 4. Henry P. Davison, senior partner of the J.P. Morgan Company.
- 5. Charles D. Norton, president of J.P. Morgan's First National Bank of New York.
 - 6. Benjamin Strong, head of J.P. Morgan's Bankers Trust Company.
- 7. Paul Warburg, a partner in Kuhn, Loeb & Company, a representative of the Rothchild banking dynasty in England and France, and brother to Max Warburg who was head of the Warburg banking consortium in Germany and the Netherlands.

What those men concocted was the Federal Reserve Act which was signed into law in the United States on December 22, 1913, when hardly anyone was present in either Congress or the Senate. Woodrow Wilson, the traitorous president of the United States, later wrote in his journal that he had unwittingly sold out his country. The word, *unwittingly* should be written, *dimwittedly*.

Or traitorously.

What happened, and why it is so important to know this history is because what the Illuminati managed to do was to begin its choke hold on the financial health of the planet.

Consider the following information about banking. When Christians felt that the handling of money, which they called, *lucre*, was kind of filthy, one of the few industries allowed to Jewish people was the handling of money. They early on realized that nobody comes for their gold or silver all at once. As piles grew, eventually bankers began lending out some of that gold and silver at interest. In spite of Biblical admonitions against usury, these Jewish bankers were confident it did not matter because it was all right to charge interest to Gentiles. This process, whereby the bank lends out more than it has in its vaults is called, fractional reserve banking. In other words, the bank has less money on deposit than it has in circulation, by way of promissory notes or bank records. Today banks hardly have any money. The whole enchilada is out there, not in the banks. Try and cash a large cheque at a bank. They will tell you to come back in a few days, because they just do not have the money. It is all a gigantic fraud. On top of that, the paper and debased coinage is fiat money. Fiat means it is pretend money. You give it credence and can carry on commerce day by day; not taking into account the interest you pay on the use of that fancy paper and those commemorative tokens; all with the Queen of England's head on the back. The other factor which plagues fiat money is the inflation rate. Ten cents in 1910 could buy a whole lot more stuff than ten cents in 2010. Where has the money gone?

Since the founding of the Federal Reserve, bank notes printed by them have become an important global currency. Federal Reserve Notes are held as reserves by

many countries. Considering the Federal Reserve is neither a reserve, nor a federal institution, the bank notes are issued by a private bank owned by Illuminati members; the Rothchilds. They also own the Internal Revenue Service, (IRS).

Another important thing to know about banking is that they do not print the interest they charge on their loans. They only print the principal. So, if everyone was to pay off their loans, there would be no money in circulation. However, since they do not print the interest, where is that supposed to come from? Hence, it is impossible to pay off all the loans. So, if there is ever a massive rounding up of the sheeple, the banks will demand the repayments and make a whole lot of people poor or destitute. We are seeing these horrors accruing daily in the first decade of the 21st Century, when people are earning the same wages as decades ago, yet costs and taxes have risen astronomically. Today, people are working harder, longer, for less money, than 20 years ago. How is it possible in a country as *rich* as Canada? The answer is simple.

As more and more corporations were bought up by bigger corporations, who followed the mandate of John D. Rockefeller, 'to compete is a sin,' more and more commercial power has concentrated in fewer and fewer hands. Look at WalMart, for example. They have over 3000 stores, all of them massive, with huge inventories, for cheaper prices than mom and pop's store in the strip mall. WalMart pays their workers just enough to barely live on, necessitating the employees to use their 10% discount to buy food and clothing from their employer. These employees are almost working for free. WalMart reduces everyone's hours, so they do not have to pay benefits and thereby have reduced people to the status of wage slaves. The other box stores, Canadian Tire, Sears, Superstore, The Bay, Zellers... it matters not, they all operate the same to maximize their bottom lines and still be able to pay millions in compensation to their executive class.

Canada used to have a robust economy, with all kinds of regional airlines, and churning factories. The country's money was based on its resources. Canada had a resource and manufacture based economy. Now Canada is a service based economy and many more people are working for minimum wages in a police state where state police can summarily execute a person on the street with tasers. Service based economies are not sustainable and create more poverty.

"Give me control over a people's money, I care not their government, I will control those people."

Meyer Amschel Bauer Rothchild, the arch bankster said those words somewhere around about 1776.. He let everyone know what he was up to; those who heard the words, that is. Well, today the banks control the world through various agencies. The government of your country, the World Bank, the International Monetary Fund, Chicago School Economics, the Trilateral Commission, the Council on Foreign Relations, the Bilderbergers, the Freemasons, Publishing and other media; film and television, Pharmaceuticals, and so on. The world is caught in the slimy tentacles of an octopus and that octopus is the International Banking Cartel.

Since the bank controls the people, one of their most powerful controls are the courts and the legal industry. Hence, who controls the courts; the banks! Remember, the judge sits on a bench which is Latin for, bank! Many bankers are Masons. But, they are not the only masons. Masons are in every profession. Coincidence? Not really. They have an agenda. We'll look at that later on. Let's take a look at two important events of the 20th

Century; the first and second world wars.

Always remember, **the victors write the histories**. All that I will say about the first and second world wars is they happened. But they did not happen like you have been taught. There are many discrepancies about the popular histories of the period. Hollywood is one of the most adept at promulgating the official version. When you remember who controls the media; hence, who controls Hollywood, you understand why they make so many war movies, especially of WWII, Vietnam, and now Afghanistan and lraq. The bankers benefit from the arms sales, but they also benefit from the films they make about the conflicts in which the arms are being used. Have you never wondered how it is that Hollywood has such ready access to all the latest American military technology? One, it is to show American might abroad in popular, widely distributed movies, and two, the same people own it all, ultimately. There is only an illusion of competition. Everything is owned by a very few people; like a pyramid, at the top of which sits the all seeing eye; their international surveillance system, the eye of Big Brother; the Illuminati. The Illuminated Ones, who apparently are Lucifer's friends. Given their track record, I would have to agree.

Given how they have managed to defraud the world with **fiat money**; paper and debased coinage basically fabricated out of thin air; meaning there is nothing backing any of it up, and with this pretend money have put entire nations into debt and brought the people to their knees; I would have to admit, that does reflect some sort of diabolical agenda, would you not agree?

The diabolical agenda is reflected into the code of laws known as Admiralty Law. I have already mentioned it earlier, but now that we have reached the 21st Century in this little history, let us examine the set of laws which have usurped the Common Law and with which many people of the world have been ruled, up until a late 20th century development put it all into a uniform code which is now the law of the world. The U.C.C. is now the law and all human activity, even murder, is an economic factor to which a dollar amount is prescribed.

Admiralty Law, as I stated earlier, is essentially a set of laws which saw their first development in Phoenician cultures. They were a sea faring people who were engaged in substantial commerce throughout a huge area of the Mediterranean, back in B.C.. times. Apparently they were a major force to contend with from about 1200 to 900 B.C. and evolved their culture on the Syrian coast, at the extreme east end of the Mediterranean Sea. They established many colonies, Carthage and Tyre being two of the most important. Anyway, their Admiralty Law was developed to control and supervise commercial activity. The use of living human beings as commercial property developed. People were now legally transferrable to galleys under the complete control of a captain who could decide whether those people lived or died. The rowers of the galley had no choice. They were commercial property and therefore, like all chattels, at the complete mercy of the owner. Some owners were pleasant, some were not. Some unfortunate human beings became nothing more than draft animals. Some cruel owners of draft animals were known to beat their willful animals to death. The lash was always present.

When you are born, Admiralty Law is immediately invoked. Note the nautical language. Your mother's *waters* are broken and you slide through the birth *canal*, and come out, *a live birth*. When you are *registered* you are given an Admiralty name; DOE, John/Joan. It is a *war name*. Written that way, your name is a military name. DOE is a corporation.

The word, *registration* is a word made of three pieces; Regis, which means, the Crown. T, is for T bar accounting. And the word, ration, which means to apportion; to break up into portions. The word registration means, a ration to the Crown. Registration. The ration used is fiat money and information.

You are registered as a live birth and given a corporate name on a certificate with two numbers. At this point you are registered as a chattel of the International Banking Cartel. You are given two numbers on a Canadian birth certificate. The number on the back is tied to your Social Insurance Number; also known as a Slave Identification Number, or S.I.N. On the birth certificates of some countries, one can allegedly see the watermarks of banking institutions. In Canada the birth certificate is printed on bankers' paper. When you feel the paper it feels like paper money. Eventually it will be plastic too, just like the plastic they now use for money in Canada. Apparently coins are to follow. Imagine that, now their money is even more worthless. To mint a plastic token as opposed to, at least, a metal one, like we presently use, will cost the Rothchilds point zero, zero, of a cent and the Queen's smiling face will be on one side.

If you look at the words used in the registration of: DOE, John Q you will clearly see the Admiralty language. The word birth is a place where a ship is tied. The word birth canal is another one. A canal is a waterway for the passage of ships. The mother's *waters* are broken and a new little sailor slides through the canal to his or her birth; the place where s/he is tied and registered like a ship, or more like a chattel of the enterprise which owns the ship; that being the international banksters.

As you likely do know, the Income Tax Act was enacted to help defray the costs incurred by the First World War, a war started by the Illuminati bankers. They caused lots of people to be murdered and generated a lot of public debt. They came up with the idea of heavily graduated income taxes from the **Communist Manifesto** (CM), written by two Jewish gentlemen, Karl Marx and Friedrich Engels. Engels was the wealthy scion of a family of textile manufacturers. He supported Marx. Both lived quite well, thank you very much to the thousands who worked their fingers to the bone; or literally lost fingers and arms in the machines of the Engels' family business. The second principle of the CM calls for such taxes. It is interesting to note, the tax was first discussed in the Canadian Parliament as early as 1917 but enacted in 1919.

In 1919, a nation of people were indentured to the International Banksters and have been paying ever higher income taxes, ever since. Add to that all the other taxes people pay in Canada, it brings to mind the words of Jesus in Matthew 23, where He says about the Sadduccees and Pharisees; two Jewish organizations, 'You load people up with burdens so heavy that their backs are bent over, yet you never lift a finger to lighten the load.' Perhaps it is no wonder that the Star of David is so prominently displayed on the clock face of the Parliament Building in Ottawa.

Admiralty Laws justify state sanctioned, legal robbery of the people. It is legal because in Admiralty Law, Canada is a ship and the people the rowers. The ship is owned, lock, stock, and barrel by the International Banksters. Remember the words of John D. Rockefeller? 'To compete is a sin,'? You believe that all the banks in Canada are all different companies? It is all an illusion. Rothchilds and their minions own it all.

Illuminati members also own the news media. Who do they tell you is the richest man, from time to time? Bill Gates, right? If you believe that he is the richest man,

you have not been paying attention. Roll out the Rockefellers' wealth charts some time. Or what about those Rothchilds? They've been sucking gold for a lot longer than Bill Gates. One estimate of their immense wealth pegs it at a 100 Trillion dollars! You can't begin to imagine how much that is. Bill Gates' hundred billion is but a drop in the bucket compared to that.

Anyway, in Canada you are owned by the bank, as you are in the United States, as well. When you are born, you are essentially offered for sale for which a million dollar public account is set up. Your birth certificate is sold on the common market and mostly owned by banks, but they also sell those certificates and other corporations can own that property. The interest on the bond is your income tax money, which is paid to whoever owns that certificate. Since lots of birth certificates are registered every year, some holders own thousands, if not millions of people, who work and pay the annual dividend; some of which is begrudgingly paid back to make it look like they are doing you a favour. Then, when you get your tax refund, you say, 'thank you.' They howl with laughter when they hear you say that. They have just fleeced you and gave you back a trifle.

Before I learned a few more things about the law and so on, I was subjected to the odd speed trap and paid exorbitant fees for victimless crimes. I paid a fair bit of money to this scam for some years. I drove state of the art foreign made automobiles, have taken driver training courses, and have driven in many places in the world. I am a very well trained driver and was in complete control of my vehicle, on open, safe roads. Yet, I was given tickets from time to time. I used to say, 'thank you,' when I received those contracts from the Royal Canadian Mounted Police member. I do not speed anymore because I am older and wiser. However, I am not concerned about traffic tickets.

If you ask an R.C.M.P. member, they will give you their business card.

A traffic ticket is issued to, DOE, John/Joan. That is your Admiralty Law name; a nom de guerre, a war name, for which you are expected to take responsibility for as a **surety**. However, **you have the right to not contract**. If there is no victim, there is no crime. If there is no crime, there is no law broken. The traffic ticket is issued by a member of the Royal Canadian Mounted Police, which should read, Military Police, since it is a pseudo military, national police force. These police are operating under the auspices of the British Crown, which is only a figure head and not a real political force.

The provinces of Canada are actually sovereign entities. The only real jurisdiction the R.C.M.P. has is in the territories. Since the sovereign provinces have given their loyalty to a central bank controlled federal government, they are allowing the Queen's troops to patrol the streets and roads of CANADA for sheeple to fleece, so those sheeple will return, BANK OF CANADA legal tender with the face of the Queen on it. Those counterfeit bills are debt instruments, which according to the law make them a fraud. One can not pay debt with debt. Remember, the bank does not print the interest, and the money is based on thin air to begin with. The British Crown is close friends with the Rothchilds. Remember, the British Royal Family comes originally from Germany. They changed their family name from, Sachsen-Coburg und Gotha to Windsor in 1917. It was necessary to deflect the people from making a connection to Germany during times of conflict in the 20th Century; conflicts manipulated by the International Bankers whose significant presence is focused in London. The gold price is set there by a Rothchild. The Queen has a palace there, as well.

Rothchild banking began in Germany and spread world wide. Usury became ever

more onerous. The banksters brought Germany to her knees, France, the Netherlands, and every other country where their nefarious plan has taken root, including Canada. Millions have been killed for the banksters' greed. They own you and their control of Admiralty Law fleeces you with false claims and fraudulent contracts. If there is no victim, there is no crime. Remember, Actus legis nemini facit injuriam. No act of law can harm a man. Remember, the quote came from the annals of the Supreme Court of the United States and is seen in Common Law jurisprudence.

In Canada, a lot of intimidation is practiced against the people. Pierre Elliot Trudeau, an Illuminati creation, a Communist, was the darling of media manipulated Canadians. The media made him out to be this James Bond type of character, who had the balls to implement The War Measures Act against those nasty terrorists, the F.L.Q. The man who brought Canadians the War Measures Act is highly celebrated and the Act has never been rescinded. Hence, the only conclusion one can reach is, the GOVERNMENT OF CANADA is at war with the citizens. Hence, a national military police force is in place to enforce their Admiralty Law where everything is, *registered*, even your toothbrush. The registration is on the U.C.code. If you use air miles or other purchaser club cards, everything you buy is registered to you. The Uniform Commercial Code is the law of the world and the bar code has become ubiquitous.

A law for the world was very clearly spelled out in a prescient document, The **Protocols of the Learned Elders of Zion**. When you read through its 90 some pages, you realize that everything in there is coming, or has come true. Forget Nostradamus and take a look at that document. It is still available on the internet.

There was a time, according to an old friend, Lew von Jung, a Ukrainian count who first told me about the document, just for having possession of a copy of the Protocols, in the former Soviet Union, one could be shot, dead.

Another place to check out on the Internet is, www.comeandhear.com. You can have a look through the Talmud, which contains some of the elements which clarify why things are the way they are. The laws spelled out for Gentiles are called, Noahide Laws. These sets of laws are not gentle on Gentiles.

Speaking of Gentiles; **the Queen of England** etc. is the 'upholder of the faith.' The faith she is upholding is The Church of England. The Church of England is a Christian faith which believes in the teachings of the King James Bible. You can find Matthew 23 in that Bible. You can also read the ban on usury in the Old Testament. Yet, the Queen of England's face is on Rothchild's bank notes. BANK OF CANADA, etc. And so many of those bank notes end up in the cash registers of Court Houses across the country. Ching, ching, 'thank you very much,' she says, as she rides by in her limousine waving at the credulous crowd, who have paid for yet another of her holidays in Canada.

Admiralty Law is a military law. It is complex and full of legalistic jargon and dead languages requiring specially trained scholars, called *lawyers*, who still dress in the black robes of Babylonian priests when performing their black art in a high court. When you hire a lawyer, you are giving that lawyer complete control over you, which includes your money. They are paid whether they win or lose. Prosecutors will call the defense lawyer, 'my learned friend,' or vice versa. The judge is always, 'your lordship' or 'my lord,' or 'your honour,' that sort of thing. During times when they can, and you are worth a lot of money, lawyers and judges will discuss your case over coffee in the judge's office. The amount of

your pain; your sacrifice will depend on how long they dance. It has nothing to do with justice and everything to do with money. Time is money. And they like to have lots of it because that is what they have been promised by television, movies, and their university indoctrination. Lawyers can make a lot of money. That is why most people become lawyers; they can make a lot of money. It is a business. It is not about helping people. And, just like priests, they practice their hocus pocus art and use Latin phrases like incantations. Then they affix a blood red seal to their magic papers and thank you very much.

Now, lest you think that all lawyers are on the Dark Side. I do not think that is so. There are some lawyers who understand the corruption and fraud, and are trying to do something about it. However, they face all kinds of possible repercussions. Defamation of character, loss of job, and so on. Those who control our circumstances do not want the truth of this to be known. Ignorance is bliss for them, not for you. Your ignorance is what they feed on. Remember, the truth shall set you free. Knowledge is power. Without power you can not be free.

Something which gives you great power in Canada is the Constitution Act, (Bill of Rights) 1982, copyrighted. Under the Bill of Rights it says, 'Whereas Canada is a land based on the supremacy of God and the rule of law.'

Think about that for a moment. The supremacy of God means the New Testament God because the New World is the land of the New Testament. People came to Canada to flee religious persecution. Canada was the New World. A world for a new beginning with religious tolerance. The fact that intolerance was also practiced by those who escaped intolerance, is an interesting but typical human anomaly. Such are the ways on this mixed up world. Anyway, to continue. The connection with the supremacy of God and the rule of law is the law in which God figures, that being the Common Law, not Admiralty Law which is now the Uniform Commercial Code, a godless mass of verbiage; like the convoluted strings of a spider's web, to ensnare hapless victims. The U.C.C. is spelled out in many, many pages; no body has time to read and digest. It is not a simple law, it is complicated and literally makes murder a commercial enterprise. For everything there is a price.

A price you all have paid, and in many cases are still paying is simply not knowing who you are. Who are you? Who is the entity that activates the body you are in? Who stares back at you in the mirror?

Are you the name you were given at birth? John Doe. Or are you, DOE, John? Are you a, *person*? Are you a, *taxpayer*? Are you a, *citizen*? Are you a, *resident*?

Where do you live? Do you live in a house? Do you live at an address? Where do you lay your head at night? These are questions which you must be able to answer, to really understand where you stand with regard to all the things being done to you by a corrupt corporation called, THE GOVERNMENT OF CANADA and by CANADA REVENUE AGENCY.

Think about who you are, first and foremost.

It's another legal entity for which the government wants you to be a **surety**, so they can keep track of you and control your life. Using that slave identification number gives the CANADA REVENUE AGENCY access to all your financial records pertaining to employment and banking. In Canada it is almost impossible to conduct commerce without that number. You likely will not get a job and can not open a bank account. Without the SIN you're not in.

Regarding the: Social Insurance Number.

The Social is for, Socialism, which is a system whereby you are forced into altruism. The Government takes from you to give to those who have not worked for it. The Insurance part is to make sure you pay. You pay into an insurance program and face many problems when you try to get back some of the massive amounts of money you pay to the GOVERNMENT OF CANADA and CANADA REVENUE AGENCY. Everywhere you conduct commerce, there is a tax. In Canada, your overall tax burden costs you over 70% of your income. Following is but an abbreviated list of the taxes you pay in Canada:

When you add artificially created, *inflation* into the picture, you can quickly see where your money goes. A lot of it goes to the corporation, which is the bank.

Remember, Meyer Amschel Bauer Rothchild said, 'Give me control over a people's money, I care not their government, I will control those people.'

So, now you have a better idea about who owns you and how they do it.

Since the court and its denizens get paid, whether you win or lose, they all get paid. Some get paid a whole lot of money to screw people out of theirs. Is that a fair assessment?

In the Common Law, the Law of the Land, King John the First of England signed a document containing fundamental human rights to protect you from the Crown. See Chapter One. You are protected from the state. King John signed the Magna Charta in 1215 and pledged allegiance to the charter in the name of all future kings and queens of England. 'In perpetuity,' were the words signifying, for ever. Amen.

The British monarchy is paraded in front of Canadians, as if it does not matter what the Canadian Constitution, Bill of Rights Act of 1982, says. The Bill is copyrighted, so be careful when using it in court. The Act opens with the statement, 'Whereas Canada is a country founded on the supremacy of God and the rule of law.' It does not say and the rule of the British Monarchy.

Regarding the Supremacy of God.

Jesus told us we are God's children and we are to call no man, Master. Hence we are sovereign beings; spiritual entities inhabiting human bodies with no one over us but God.

The true rule of the law is; Actus Legis Nemeni Facit Injuriam. I capitalized the words because they are such an important piece of the law. No Act of Law Can Harm a Man. When you study the Magna Charta, that extrapolates on that Latin phrase which is such an important part of this puzzle you are in.

The International Banking cartel owns you. At the top of the pile sit the Rothchilds, a Khazarian Jewish family, with branches in many countries, who want to own the entire world. Next to them are the Rockefellers, (Rockefelders), a 'Baptist' family from America, they too want to own the world. Both families own a good chunk of it. They own you because they control your government through their banks. The governments have generated a lot of public debt, as an enslavement tool. The debts are due to incompetent, or traitorous behaviour by those elected individuals to whom you are giving a whole of money; by force. Through coercion, intimidation, and threats they control most of you and engage you in contracts you enter under duress.

In the United States the central bank is called the FEDERAL RESERVE BANK. The bank is neither, federal, nor is it a reserve. The Bank of Canada is not a government bank, either. The bank notes which you use are issued by privately owned corporate entities who print that money and base it on thin air. Their bank notes bear the face of a British monarch, a close friend of the Rothchilds. She is smiling.

You have possibly read the book, the DaVinci Code, or perhaps, Angels and Demons, by Dan Brown. If not, perhaps you have seen the movies. Or for other reasons, you have come to know something about an actual group of demons, who number but very few, and call themselves, The Illuminati; the Illuminated Ones. Their plans are clearly spelled out in, The Protocols of the Learned Elders of Zion. You can find it on the internet. The Illuminati also spelled out their plans in the Communist Manifesto, also available on the net. The second clause of that manifesto says, 'heavily graduated income taxes.' Read that document and you will see that everything in the Communist Manifesto is essentially true in Canada. Canada is not what you think it is.

Canada is a demarcated land mass in North America from the 49th parallel to the North Pole. We know of Canada because we live here. An amazing country with a varied landscape, from beaches to mountains, lakes, forests, stretching plains, and a friendly, caring people. Yet, there is this other side; the side you have a feeling about. You know there is something wrong.

Under Admiralty Law, Canada was declared to be a ship and the people, like impressed sailors, are made to work that ship and wear out their lives in the service of the corporation which owns them. That corporation is making a lot of money from present day wars, stirred up to further the agenda of the military industrial complex, which is controlled by the members of the Illuminati. You are only a number to them. And it is all a numbers game. Remember, two sets of numbers on your birth certificate. And why were you, registered, in the first place? Remember what the word registered comes from? Regis, which is Latin for, King, the T which divides the two words, as in T bar accounting, and the word, Ration. A ration to the Crown. That ration is sucked from you for the rest of your life because of that. Regis T Ration.

The Law of the Land is Anglo-Saxon Common Law. The Magna Carta forms a basis of that Law. Since Canada is a land mass, the Law of the Land is the Common Law. Canada the land mass is not a ship and we, the people, are not sailors. Since Canada is still subservient to England, hence, the articles of the Magna Carta apply to England's colonies, where her laws also apply. Read the following words from Article 41.

41. All merchants may leave or enter England in safety and security. They may stay and travel throughout England by road or by water, free from all illegal tolls, in

order to buy and sell according to the ancient and rightful customs. This is except, in time of war.

G.S.T. and P.S.T. are essentially, 'illegal tolls.' In the conducting of your commerce, you establish a price on the shelf, you can not then add a surcharge at the till. The price is the price, not the price is two prices. One here and the other there. These taxes interfere with the 'ancient and rightful customs.' Unless of course the government is at war with you. That is a distinct possibility considering you have a national military police force enforcing Admiralty Law, the law of commerce.

Ask and a member of the R.C.M.P. will give you his/her business card. The R.C.M.P. are, for the most part, conducting commerce on behalf of the Crown. Remember, a lot of people feed off the business they generate. Court clerks, judges, lawyers, psychologists, prosecutors, and the various prison personnel who may be involved, all make money thanks to the R.C.M.P's activities. *Crime*, most of which is victimless, generates a lot of *illegal tolls*. If there is no victim, there is no crime committed.

55. All fines rendered to us unjustly and against the law of the land, and all amercements made unjustly and against the law of the land, shall be entirely remitted....

Article 55 of the Magna Carta mentions the word, *amercements*. These are fines determined at the discretion of the person handing out the fine. We all know how fines can vary from cop to cop, court to court.

The Magna Carta is a whole lot more about a number of others things, especially about property rights. You have the right to your property.

Contracts, whether verbal or written must have a mutually beneficial outcome. They must be entered into willingly, without coercion, intimidation, or threat.

All matters before civil courts pertain to contracts. Family court, Traffic court, they are civil courts.

All matters before criminal courts pertain to claims. There has to be a victim for a crime to have occurred. Crimes fall under the following categories: assault, fraud, murder, rape, and robbery. Assualt can be physical or verbal. Today, hate crimes are criminal matters as well. Hate crime is thought crime, like in the novel 1984 by George Orwell. You can be criminally charged with thinking about stuff. Is that not absurd?

As for hate crimes, what is that? If a person expresses a sincere disgust about some group's actions; which contradict his own beliefs, that falls under freedom of speech legislation. If a person presents facts from the public record and lays them on the table for everyone to see and judge for themselves what the official story is and what is really the truth of the matter, and other people draw conclusions and express their sincere disdain of the perpetrators of the reviled acts, that can not be called 'incitement to hatred.' The conclusions people reach from studying the public record, is a right under freedom of speech and conscience. How can anyone take seriously, legislation against consciousness?

In George Orwell's prescient book, 1984, we read of the consequences of the type of legislation I am discussing. If things continue to go as they have in Canada, you soon will

not have the luxury of living inside your own head. Devices already exist which can *read* your mind. When you add that technology to the full body scans being set up in airports around the world, you get the picture, don't you?

Anyway, the point of all of this is to give you a more complete understanding of why things are the way they are.

Chapter Three

Putting it in a Nutshell

"Truth is not an issue in this case,". This quote was made by two judges in Canada when they summed up the cases against two people who expressed an opinion which was contrary to the official story pertaining to the second world war. Since courts look at precedents, if truth is no longer an issue in court, then we are obviously in trouble in Canada.

There are essentially **two courts; civil and criminal**. In civil courts issues pertaining to contracts are discussed. In criminal courts, claims are discussed. There are a number of levels of courts; Court of Queen's Bench, Family Court, Provincial Court, Traffic Court, up to the Supreme Court.

Traffic tickets, indeed ALL citations from Police are contracts. They are issued by a police officer; either a member of a municipal, provincial, or federal force. In all provinces of Canada, the federal police force is present. This organization, according to the British North American Act, which is the founding document for Canada, the R.C.M.P. really only have jurisdiction in the territories. No man or woman in the uniform of a police officer actually has the right to contract. The uniform makes that man or woman a public servant as opposed to a private citizen. Because contracts have to be mutually beneficial, and contractees private, not public human beings, a traffic ticket can not be a valid contract.

Everyone has a right to contract or not to contract.

One has at least 72 hours to refuse a contract.

The Royal Canadian Mounted Police is a federal military police force operating under the auspices of the British Crown. The Queen of England is the head of the organization. The Queen of England is named Elizabeth II of the House of Windsor, a name the royal family exchanged for their real family name, Sachsen-Coburg und Gotha. They changed their name in 1917. The Queen is good friends with the Rothchilds, who print the money on which her face is portrayed. Hence, she sanctions fraud because the bank notes they print are based on thin air, and the debt portfolios which they count as assets. Hence, the bank notes and slugs, passing for coinage, in Canada, and most of the rest of the world, are debt instruments. Since one can not pay debts with debts, the use of the BANK OF CANADA notes and coins is fraud, pure and simple.

The British Crown allows her friends to make money out of thin air and rent it to you for usury which they do not print. Where is all the interest supposed to come from? That is the question, isn't it? If the Rothchilds do not print the interest, if everyone was to pay off their debts to the banks, there would not be any money in circulation and a whole lot more poor people would be the result. Elizabeth II is a figurehead. She really does not have jurisdiction in Canada. Even though Canada has representatives of the Queen to make it all look like the Crown is an actual legal force, it really is not. It is all an illusion. You bow down of your free will, it is up to you whether you are a slave or a sovereign.

When you are born, a certificate, printed on banker's paper, registers you as a life birth and your Admiralty Law name is inscribed as: DOE, John/Joan. You are given two numbers, one on the front and one on the back of the document.

The word REGISTRATION is actually two words separated with a T, which stands for T bar accounting. The two words are: REGIS and RATION. Regis means King and Ration means portion of something. In the case of the birth certificate, the ration to the crown is your identity and its tax obligations. The identity is a corporation.

When you see your name printed in all capitals, either forward or backward, as in, DOE, JOHN/JOAN, or JOHN/JOAN, DOE, that means a person with no rights.

When your name is printed, DOE, John/Joan, or John/Joan, DOE, it means a person with some rights.

Your name, which is only hearsay, is actually written, John/Joan: Doe. The colon denotes, of the family.

Hearsay is not evidence in court.

The Law of the Land is British Common Law based on the following precedents:

Actus Legis Nemine Facit Injuriam
The Golden Rule
The Ten Commandments
The Magna Carta
Habeas Corpus Acts
Statute of Frauds Act

Admiralty Law is the law of the sea; the law of commerce. Today it is manifested as the Uniform Commercial Code, UCC. The UCC is the law of the world now. It is very complicated. It has reduced all human activity to a commercial level. For everything there is a monetary value; even murder. The code book is very, very thick. I doubt if any politician has ever read much of it.

The same goes for the North American Free Trade Agreement, (N.A.F.T.A.), This treaty was negotiated by Canada, Mexico, and the U.S.A, and has resulted in massive devastation of the living standards of Canadians. Now Canada is a service based economy where most of the people are wage slaves of huge multinational corporations.

When a judge renders a verdict, he or she renders an opinion. Always ask the

judge, when she/he has made a ruling against you; 'is that your opinion, Judge?' Then don't say anything anymore. The judge will then say, 'yes, that is the opinion of this court.' Then you reply, if you do not agree with the opinion, 'I do not agree with the opinion of this court.' Then you walk out of the court room with your head held high. Do not wait for the judge to dismiss you. Just make sure you have a body guard with you. They might try to grab you on your way out. Judges and lawyers really hate it when you make the court look foolish. They will do anything to uphold the integrity of the court in the eyes of the public.

Remember, it is all about public opinion in a court of law. You either agree or disagree with that opinion.

Lawyers are agents of the court and must do everything possible to uphold the honour of the court. They serve the court before they serve you, the *client*, behind whose back they laugh, because a client is basically an imbecile; a person of unsound mind.

Lawyers get paid whether they win or lose. Very few are truly honourable, except to their own. However, beware, they are serpents who practice their dark arts in viper pits.

I repeat, CANADA REVENUE AGENCY is a privately owned collection agency with no legitimate claim against your property. Their claim is against the SIN and the straw man which is a corporation called, DOE, John/Joan.

There is no law which makes you, the spiritual entity inhabiting a humanoid body, liable for income taxes.

Heavily graduated income taxes is the second directive of the Communist Manifesto.

SIN stands for Social Insurance Number. It really is a, Slave Identification Number.

Be reasonable in your hourly rate. I suggest a \$100/hr is reasonable. Remember hotel bills and meals, transportation costs and so on, as well. Make sure you send a letter to the clerk of the court outlining your budget. It is best to send it registered mail or by courier. Give them ten days from receipt of your letter for them to respond. ALSO REMEMBER: All correspondence to the court must be on LEGAL PAPER, (8.5 X 14 inches).

In Your Letter to the Clerk of the Court Ask These Questions:

What interest do the judge and prosecutor have in your case. And, will the arresting officer, ie the primary witness be present in court.

Also demand full disclosure and you must see all copies of the original contract/ticket. That means ALL copies: White, blue, goldenrod, pink, and any others.

All these matters must be addressed well in advance of the court date set out on your tickets.

Remember: Always sign your letter, **without prejudice**. Put a colon between your first and family names. Only initial capitals. For example: John: Doe. Sign in **blue** ink, not black or any other colour. **Blue is it**. Underneath your signature write, **authorized agent**.

How to Act Around Police People

First off, be polite. Remember, police are also human beings doing a job. A lot of the time their job can be very unpleasant. Why make their day another unpleasant one? They are not lawyers, nor learned in the law. They are doing a job the best they know how. And, to be fair, most are doing a good job. Remember, they don't have a whole lot of training. Just enough to do the job. What they do not know is that some of the rules they are enforcing are not legal in the Common Law. So, do not take out any frustration or anger or whatever at the police agent. Don't bother discussing fine points of jurisprudence with any member of the uniformed forces of oppression, ie: the police. Just regard the contract s/he gives you and then deal with it out of court, preferably; with a letter and an invoice as per information in this booklet. Or represent yourself and

state your grounds in the Common Law.

If you do end up in court here are some ideas you can use to frustrate the judge:

The judge will say, 'state your name for the public record.'

Your reply: 'Your name for the public record.'

The judge will immediately be frustrated and demand, 'What is your name?'

Your reply: 'What is not my name?

Judge: 'By what name are you called?'

Your reply: 'It depends on who is doing the calling. If it is my wife; she calls me honey. My kids call me, mom/dad. My cat calls me meow....'

The judge at this point might hold you in contempt of court.

Your reply: 'Is that civil or criminal contempt judge?' Then do not say another word. Wait for the judge to answer. The judge at this point will be very flustered because s/he has to make a ruling. Let's say the judge says 'Civil Contempt.'

Your reply: You turn around and look about the court room and ask with whom you have a contract. No one will answer. Then you turn to the judge and point at him or her and ask, 'ls it you judge?'

You see, the judge can not contract from the bench. S/he is now in contempt of his or her own court and can be disbarred.

If the judge rules 'Criminal Contempt.'
